# Take action against those behind razing Molangi hillock: HC

The High Court yesterday directed the government to take appropriate legal action against the people responsible for cutting Molangi hillock in Moulavibazar's Kulaura area to construct a road.

The authorities concerned of the government have been asked to take the action after conducting an inquiry in seven days and to submit a report to the HC after complying with the directive in four weeks.

The HC also issued a rule asking the authorities to explain in four weeks why they should not be directed to take necessary steps to protect and preserve the

hillocks across the country and to restore the original shape of Molangi hillock in Kulaura.

The bench of Justice Farah Mahbub and Justice SM Maniruzzaman came up with the order and rule following a writ petition filed by Human Rights and Peace for Bangladesh.

Writ petitioner's counsel Manzill Murshid told the HC that some influential people including a local representative have constructed a road after razing Molangi hillock.

Lawyer Amatul Karim Swapna appeared for the Department of Environment during the hearing.

A judge said the prosecution was able to prove the charges against the accused beyond doubt, and the accused was given the highest punishment for his offences.

According to the case documents, Akter raped his daughter at his rented house in Hazaribagh when the complainant [victim's mother] went to a nearby house for prayers on the night of April 15, 2018.

Following the incident, a case was filed

with Hazaribagh Police Station against the accused on May 3 that year.

Police arrested Akter in connection with the case, and he confessed his involvement in the crime.

On December 11 that year, police submitted the charge sheet to the court against Akter and the court framed charges on April 3, 2019.

Nine prosecution witnesses gave their depositions to the court in the case.

## Foreign minister of Maldives arrives today

Maldives Foreign Minister Abdulla Shahid is coming on a three-day visit to Dhaka today as the two countries are working to strengthen bilateral relations.

During the visit, Abdullah Shahid will hold a bilateral meeting with his Bangladesh counterpart AK Abdul Momen on February 9, says a statement of the foreign ministry.

Momen and Shahid will also witness the signing of an MoU on cooperation between the Bangladesh Foreign Service Academy and the Foreign Service Institute of Maldives.

Bangladesh and the Maldives share excellent bilateral relation which has been strengthened over the years. Around 80,000 Bangladeshi expatriate workers are currently working in that country.

# Four brick kilns fined Tk 22 lakh in Savar

The Department of Environment yesterday fined four brick kilns Tk 22 lakh in Savar for running their businesses without clearance certificates and permission.

DoE Executive Magistrate Tamjid Ahmed conducted the eviction drive at 11am near Amin Bazar area, Mossabber Hossen Mohammed Rajib, assistant director (Dhaka district) of DoE, told The Daily Star.

He said ABS Bricks and BCM Bricks were fined Tk 6 lakh each as both were

running their businesses without clearance certificate while Fahad Bricks and DBS Bricks were fined Tk 5 lakh each for using topsoil.

Authorities of ABS Bricks and BCM Bricks were asked to shut down their kilns while BCM Bricks was partially demolished, said the assistant director.

Fire service, police and Rab officials were also present during the daylong drive.

The same mobile court also demolished an illegal auto-rickshaw battery recharge centre.

Deputy Commissioner (DC) SM Ferdaus, Superintendent of Police Rifat Rahman Shamim and Civil Surgeon Dr Anwarul Amin Akhanda took the vaccine together in the district hospital.

In Cumilla, vaccination began with warm response from people. Top government and military officials received vaccines on the first day. The district's Deputy Commissioner Abul Fazal Mir received the first dose of vaccine at Cumilla Medical College Hospital around 10am.

In Chapainawabganj, DC Monjurul Hafiz inaugurated the vaccination program by receiving the first dose at 10am in Sadar Hospital.

Later, Civil Surgeon Dr Zahid Nazrul Chowdhury and staff of health department received their vaccine shots. People of the district will be given the vaccine at 20 centres.

In Tangail, a total of 976 people were vaccinated on the first day. A total of 42 vaccination booths have been set up in the district. The district's DC Dr Ataul Goni took the first vaccine.

Our correspondents from Gazipur, Pabna, Munshiganj, Rangamati, Jamalpur, Nilphamari, Munshiganj, Noakhali, Rangpur and Dinajpur also reported that vaccination programme has begun in the districts amid warm response and festivities in the localities.

### VACCINE FOR SOME, PHOTO-OP FOR OTHERS

Meanwhile, a Brahmanbaria lawmaker under women's reserved seat, Umme Fatema Nazma Begum, yesterday faced criticism from locals after she posed for a photo as a vaccine receiver, but did not actually take the vaccine.

The incident happened at Sarail upazila health complex yesterday noon where the lawmaker inaugurated the vaccination programme.

The photo, which was uploaded by one of her staff members in social media, was later removed in the face of heavy criticism from locals.

Contacted, the lawmaker admitted it and said she did it to gain public trust so that mass people become encouraged to take the vaccine.

Similar incident happened at Kumarkhali upazila health complex of Kushtia where the upazila parishad chairman Abdul Mannan Khan posed as a vaccine-receiver but did not take the shot.

Contacted, the chairman admitted it, but did not offer an explanation.
