









Motivate rural people to get vaccinated

PM directs Ansar, VDP members

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday asked the members of Hasina Bangladesh Ansar and VDP to motivate rural people to receive the Covid-19 vaccine to

eliminate the pandemic.
"I would like to ask you [Ansar and VDP personnel] to motivate

rural people to get vaccinated so that all the people of Bangladesh get protection from the global coronavirus pandemic. Our efforts to this end will continue, she said.

The PM was addressing the 41st National Rally of Bangladesh Ansar and VDP at its academy in Shafipur of Gazipur. She joined the event virtually from the Gono Bhaban.

Noting that the Covid-19 inoculation programme has already started in the country, Hasina asked every member of the Ansar and VDP to encourage every person to get vaccinated in due time. Many people are even afraid of injection [getting the shot].

She said the government has taken measures so that people can get vaccinated in time alongside following health protocol. "We seek your [Ansar and VDP] cooperation in this regard."

The premier said people can get registered to get the shot going to digital centres nearby. She urged all to be sincere so that they along with their family members take the vaccine.

She described the Bangladesh Ansar and VDP as the country's largest publicoriented disciplined force.

Hasina asked the force members to

continue their special in protecting country's young generation from drugs, militancy and terrorism. "I would like to ask you to pay special attention so that our children do not slip into a wrong

Mentioning that the

members of the Ansar and VDP always stand beside people, she said the force members fully reined in the arson attacks unleashed by the BNP-Jamaat clique.

The PM said her previous government had started modernising the Ansar after taking office in 1996.

She cited various activities taken by her government, including modernisaiton of promotion and posting systems and trainings, introduction of ration facilities, a separate uniform, medals (for recognition of performance), and making service permanent.

Recalling Ansar's contributions to every movement, Hasina said its commander Abdur Jabbar was martyred in the 1952 Language Movement and its 70 personnel made their supreme sacrifice in the Liberation War in 1971.

At the function, the PM took the salute from a spectacular parade of the Ansarand VDP members. Home Minister Asaduzzaman Khan,

on behalf of the premier, handed special medals to 140 Ansar and VDP members under eight categories in recognition of their bravery and praiseworthy services.

Senior Secretary to Public Security Division Mostafa Kamal Uddin also spoke at the function.

US slaps sanctions against junta leaders

Warns of more action if military uses violence against protesters

The United States yesterday announced sanctions on the leaders of Myanmar's junta and several gem companies, and warned it would act further if the military uses violence against protesters.

A day after President Joe Biden previewed the sanctions, the Treasury Department said it was blocking any US assets and transactions with 10 current or former military officials held responsible for the February 1 coup.
The targets include General Min

Aung Hlaing, the new junta chief, who already was under US sanctions over the brutal campaign against the mostly Muslim Rohingya minority.

But the sanctions also hit new individuals, including the military leaders named to a new cabinet such as Defense Minister General Mya Tun Oo.

"We are also prepared to take additional action should Burma's military not change course," Treasury Secretary Janet Yellen said, using Myanmar's former name.

"If there is more violence against peaceful protesters, the Burmese military will find that today's sanctions are just the first," she said.

The junta has voiced increasingly ominous warnings to anti-coup protesters and deployed tear gas, water cannon and rubber bullets, with isolated reports of live rounds being fired.

The Treasury Department also announced sanctions on three companies dealing in the country's key gem export: Myanmar Ruby Enterprise, Myanmar Impérial Jade Co. and Cancri Co. It said it was designating the three companies because the military controls

also said the United States was cutting off the Myanmar generals' access to \$ billion in funds in the United States.

Meanwhile, Myanmar's general signalled waning patience yesterday with nationwide protests over the military's takeover, ordering demonstrators to return to work or face "effective actions".

His warning comes after a sixth consecutive day of anti-coup rallies condemning the ouster of civilian leader Suu Kyi. The demonstrations have largely been peaceful.

By yesterday evening, army chief General Min Aung Hlaing -- who now holds legislative, judicial and executive powers -- called for civil servants to return to work after days of nationwide

strikes supporting the protests. "Due to unscrupulous persons' incitement, some civil service personnel have failed to perform their duties," he

said in a statement. "Effective actions will be taken." Since the February 1 coup, there has been an outpouring of anger and defiance, calling for the release of Suu

Kyi and other detained senior figures of her National League for Democracy Demonstrators again marched peacefully yesterday in Naypyidaw the capital and military stronghold -

as well as Yangon, the largest city and commercial hub, which saw tens of thousands flood into the streets.

Western nations have repeatedly denounced the coup.

Yesterday, former colonial power Britain welcomed Biden's steps, with foreign secretary Dominic Raab tweeting that "we will hold those responsible to

winter months when river flow is slower. They use it to make bricks, said

Iqbal Hossain of Kharnia village said he witnessed workers load bricks into sacks and throw these into part of the river in front of the respective kiln. This way, they encourage greater silt deposits and expand even further onto the river land.

Though grabbing river land is a criminal offence and the occupiers have been running these brick kilns for the last 12 years, the local administration is yet to take any visible action against them other than sending notices to the brick kiln

According to the Brick Making and Establishment of Bricks (Control) Act 2013, setting up of brick kilns on government or privately owned forests, sanctuaries, agricultural land, gardens and wetland areas is a punishable offence.

One of the brick kilns on the list of grabbers is KPB (Kalapada) Bricks, which occupies 175m of Bhadra's left river bank. Lawmaker from the Khulna-5

constituency (Dumuria-Phultola) and former Fisheries and Livestock Minister Narayan Chandra Chanda, admitted that he owns this brick kiln but denied occupying river land.

"I have not grabbed this land," the MP, also president of the Dumuria Upazila Brick Owners' Association, told The Daily Star vesterday.

"When this char land emerged, it was allocated by the DC office to the landless and we leased it from them [the landless]. If the government takes any measures to dredge the river, we will stop operating the brick kiln and surrender the land to the government."

The other brick kilns found by the

BWDB Khulna to have grabbed river land include Setu Bricks, owned by Dumuria Upazila Chairman Ajaz Ahmed, and KB Bricks, owned by UP chairman of Dumuria Sadar Humayun Kabir Bulu.

According to BWDB Khulna's report, these brick kilns owned by elected officials among others have each grabbed 175m to 250m into the Bhadra river while four brickfields in Gutudia union each occupied 190m-250m of the banks of Upper Shailmari river.

The report shows the upazila chairman's Setu Bricks occupies 230m into the Hori river, and the UP chairman's brick kiln KB Bricks occupies 210m into the left bank of Bhadra.

Contacted, Humayun Kabir Bulu, owner of KB Bricks and UP chairman of Dumuria Sadar, said, "Most of the land has been taken from local owners after signing on a non-judicial stamp over 15 years ago and some land belongs to the Water Development Board, where we are just piling up the

kilns aren't all -- the list of river land grabbers is not complete. Dumuria UNO Abdul Wadud said of the 37 brick kilns in the upazila,18 brick kilns built on river banks have

been listed. "I sought all their legal papers and now I am scrutinising these," he said, adding that the eviction drive will start as soon as this process is completed.

"I am sure most of them occupied river land," the UNO told this newspaper.

Chairman of Atlia Union Parishad Kumar Roy told The Daily Star that there are 11 brick kilns, operating on the banks of the Bhadra in his union, which are degrading the environment and damaging crops.

He said two brick kilns in particular are aggressively occupying river land ignoring the free flow of river. These are located beside the Kharnia bridge.

Saifur Rahman Khan, director of Department of Environment in Khulna, told the Daily Star that at the moment it is not possible to say which brickfields have been built occupying the Bhadra or Hori river or are destroying the environment.

"We give environmental clearances brick kiln, Setu Bricks, in accordance according to certain criteria but the district administration oversees these "I leased the land from a local as a whole, sometimes conducting

"In any case filed under the DSA, the allotted investigation time is 60 days, with an additional 15-day extension. Explain officials

Bangladesh Bank is directed to supply the names, status, and addresses of the officers, who were functioning in its departments concerned from January 1, 2008, to January 1, 2020, and to submit a report on why it failed to detect and prevent the irregularities, illegalities, corruption and money laundering offences during such a long time, the HC said in the full text of its order.

The bench of Justice Md Nazrul Islam Talukder and Justice Mohi Uddin Shamim also ordered the central bank to submit the report to it by February 15.

The court had pronounced the order on January 21 while holding hearing on a suo moto (voluntary) rule issued earlier in this regard.

The same day, the HC bench rejected a petition, filed by Md Asaduzzaman Khan, provisional liquidator of People's Leasing and Financial Services (PLFS) Limited and also the deputy general manager of the central bank, seeking to become a party in the case.

Issuing the suo moto rule, the bench on November 19 last year wanted to know from the authorities concerned what steps were taken to bring home Proshanta Kumar Halder, also known as PK Halder, from abroad in connection with a money laundering case.

Probe forgery of BB document placed with bail petition

HC orders ACC

The High Court yesterday directed the Anti-Corruption Commission to inquire into forgery of a Bangladesh Bank document submitted with the bail petition of convicted lawmaker Mohammad Shahid Islam alias Kazi Papul's wife and daughter in a Tk 148.41 crore laundering case.

According to the forged document, a BB official said there might not be any money laundering on the part of Papul's wife Selina Islam and daughter Wafa Islam from their accounts of NRB Global Bank.

Yesterday, the HC asked the ACC to record statements of Selina, also a lawmaker, her daughter Wafa, their representative Hafez Ahmed and others concerned to find the people involved in the forgery and to submit a

probe report to it within two months. The HC bench of Justice Md Nazrul Islam Talukder and Justice Mohi Uddin Shamim came up with the order after hearing a suo moto rule issued earlier to this end.

ACC lawyer Khurshid Alam Khan told The Daily Star that it has been primarily found true that a forgery has been committed in connection with the BB document submitted with the bail petition of Papul's wife Selina and daughter Wafa in the money laundering case.

BB Deputy Director Md Arefin Ahsan Miah signed the paper, according to the forged document which apparently cleared Selina and her daughter Wafa of money laundering, he said.

The lawyer said in continuation of hearing the rule, the HC summoned the deputy director to appear before it and called for the record from the BB.

The deputy director appeared before the HC bench in line with the court order and told the court that the paper, in which his signature was seen, was tampered.

Central bank lawyer Khan Mohammad Shamim Aziz told the court that there is no similarity between BB's original document with the paper submitted along with the bail petition.

He also said an inquiry needs to be conducted to find the persons involved in this fraudulence.

Sayed Ahmed Raza, lawyer for accused petitioners Selina and Wafa, told the court that his clients were given the document from NRB Global

NRB Global Bank lawyer Motaher Hossain Sazu told the court that his client did not supply any document to the bail petitioners.

Deputy Attorney General AKM Amin Uddin Manik represented the state during the hearing.

Selina and Wafa submitted the petition to the HC on November 26 last year, seeking bail in the money laundering case filed by the ACC.

A Kuwaiti court has sentenced Kazi Papul, an independent lawmaker from Laxmipur-2, to four years in jail in a bribery case. Papul, who is in prison in Kuwait,
