PBI looking

While investigating, PBI found no CCTV footage as Al Jameyatul Ahlia Darul Ulum Moinul Islam Madrasa, popularly known as Hathazari madarasa, campus had no camera inside, said officials.

As a result, the investigating team is now looking for physical evidence, they added.

Meanwhile, the submission date for the report had passed on February 9. Thus, PBI sought more time from court.

Contacted, Nazmul Hasan, superintendent of police (SP) of PBI in Chattogram, said, "We have recorded the deposition of 26 persons under section 161 and already visited the spots including the Hathazari madrasa.

"In the madrasa, there are no CCIV cameras which would record what actually happened on that day [during the unrest]. Now we are looking for physical evidence to dig out the case more."

Six to die for murder

home in Diadanga village on the night of January 14, 2014 and hacked Sultan, 57, his wife Hazera Begum, 44, and their granddaughters Romana, 8, and Anika, 10, to death with sharp weapons.

Sultan's son Hafizur Rahman filed the case against the seven with Bhurungamari Police Station the next day.

The six given death penalty are Mamtaz, Nazrul Islam Majnu, Amir Hamza, Zakir Hossain, Jalal Gazi and Hasmat Ali. Of them, Jalal is a fugitive. Accused Nainul Islam has been acquitted in the case, added the PP.

Taliban call on US to honour withdrawal deal

The Taliban yesterday urged the US to honour a landmark withdrawal deal under which all foreign troops would exit Afghanistan in the coming months, even as violence continues to rage in the war-ravaged nation.

In an 11-point statement, the insurgent group called for the Americans to stick to the agreement ironed out in Qatar last year that paved the way for ongoing peace talks between the Taliban and the Kabul government.

"We urge the American side to remain committed to the full implementation of this accord," wrote the group's co-founder Mullah Abdul Ghani Baradar in an open letter addressed to the American public.

"It is the responsibility and in the interest of all to bring an end to this war, and the implementation of the Doha agreement is the most effective way of ending it.

The statement comes a day ahead of a major Nato summit where the alliance is set to hold its highest-level talks since US President Joe Biden took office vowing to work more closely with allies after four years of tensions under Donald Trump.

The war in Afghanistan and withdrawal plans are expected to be among the most pressing issues discussed during the summit.

Nato Secretary General Jens Stoltenberg on Monday said the alliance would not withdraw its troops from Afghanistan "before the time is right".

Biden's administration is reviewing the deal, while the Pentagon has accused the Taliban of not fulfilling promises that include reducing attacks and cutting ties to insurgent groups such as Al-Qaeda.

Strong 6.2-magnitude quake rocks Vanuatu capital

A strong earthquake struck Vanuatu's capital Port Vila yesterday, with eyewitnesses reporting violent shaking and the US Geological Survey measuring a shallow 6.2-magnitude quake just off the South Pacific island's

coast. "Wow, haven't felt one like that in years. My heart's still in my mouth," local journalist Dan McGarry posted on Twitter, "very large lateral movement".

Authorities said the quake occurred 90 kilometres (56 miles) west of the city at a depth of just 10 kilometres (six miles). According to the Pacific warning centre, there was no immediate tsunami threat.

It was followed by two strong aftershocks of magnitude 5.5 and 5.7, but there were no immediate reports of damage or injuries.

Last week a much larger 7.7-magnitude earthquake struck the region, causing a small tsunami, which was felt as far away as New Zealand.

marketing of notebooks and guidebooks punishable by a maximum imprisonment of three years or a maximum fine of Tk 5 lakh or both.

It also states that if a teacher forces the students of his educational institution to buy notebooks and guidebooks, actions will be taken against him or her.

However, the government will allow publication of supplementary books and education aid books only after approval from the authorities concerned. If a teacher of an educational

institution forces students to purchase supplementary books and education aid books, it will be considered as misconduct and disciplinary actions will be taken against him or her, says the draft law.

The draft act also said a school may arrange additional classes for weaker students, subject to written consent of the parents. This classes will be held either before or after school hours inline with rules or policies framed by the government or a circular or executive order.

Coaching centres for helping jobseekers, admission seekers or improving English proficiency will remain out of the purview of the law, said top education ministry officials.

The draft law also says no teacher can give corporal punishment or harass any student of the educational institution concerned mentally. Violation of this provision will be considered misconduct and administrative disciplinary actions can be taken against the teacher concerned.

It seeks to take actions as per the penal code if any irregularities are detected at non-government educational institutions run by trusts, said a top official.

The education ministry took the initiative to prepare an education law inline with the Education Policy of 2010. The policy had recommended formulation of a law for proper implementation of the policy.

The ministry on January 26, 2011, asked a subcommittee of the education policy implementation committee to draft a law.

The military will be hoping its reassurances will dampen the campaign of daily opposition to its rule and to the ousting Suu Kyi and her government.

UN ambassador Christine Schraner Burgener spoke to junta number two Soe Win on Monday and warned him that the regime's network blackouts "undermine core democratic principles", according to a spokesman.

As well as the demonstrations in towns and cities across the ethnically diverse country, a civil disobedience movement has brought strikes that are crippling many functions of government.

The unrest has revived memories of bloody outbreaks of opposition to almost half a century of direct army rule that

ended in 2011 when the military began a process of withdrawing from politics.

While violence has been limited this time, police have opened fire several times, mostly with rubber bullets, to disperse protesters. Six people were wounded in the central town of Maungmya yesterday when police fired rubber bullets to break up a protest over an arrested teacher, a witness said.

A woman who was shot in the head in Naypyitaw last week is not expected to survive. Zaw Min Tun said a policeman had died of injuries sustained during a protest.

He said the protesters were starting violence while the campaign of civil disobedience amounted to the illegal intimidation of civil servants.

'We will wait patiently. After that, we will take action according to the law," Zaw Min Tun said

Another UK variant causes

More than 100 cases of B.1.525 have been identified globally in total, according to the University of Edinburgh report.

But the roots of the variant go back as far as late December in Nigeria, where 12 cases have now been found, reports thesun.co.uk.

The Edinburgh researchers did not describe if the new variant caused different symptoms, more severe disease or was more infectious.

"We don't yet know how well this [new] variant will spread, but if it is successful it can be presumed that immunity from any vaccine or previous infection will be blunted," Dr Simon Clarke, an associate professor of cellular microbiology at the University of Reading, said.

Meanwhile, UK's vaccines minister Nadhim Zahawi said yesterday Britain will provide Covid-19 vaccine certificates for

its residents if they are required by other countries, although it is not planning to introduce them for use at home.

"Internationally, if other countries will require a vaccine certificate, then I think it's right that we facilitate it," Zahawi told the BBC in an interview.

TRIED TO HACK' PFIZER

North Korean hackers tried to break into the computer systems of pharmaceutical giant Pfizer in a search for information on a coronavirus vaccine and treatment technology, South Korea's spy agency said yesterday, according to reports.

The impoverished, nuclear-armed North has been under self-imposed isolation since closing its borders in January last year to try to protect itself from the virus that first emerged in neighbouring China and has gone on to sweep the world, killing more than two million people.

City mice smarter than country

contributing factor to the successful coping with the rapid and recent expansion of human-altered environments," the researchers write in their study. Thirty-one striped field mice were

Sayed Ziaul Haque, the top commander, and Akram Hossain, the top operative of the militant group that attacked us --have never been caught," Bonya said in the statement uploaded on her verified Facebook profile.

She also said that in the last six years, not one person investigating the case in Bangladesh reached out to her, even though she is a direct witness and victim of the attack

"In January, the state lawyer in the case publicly lied, saying that I did not agree to be a witness in the trial. The truth is, no one from Bangladesh's government or the prosecution has ever contacted me."

However, the Assistant Public Prosecutor Golam Shariar Khan claimed to The Daily

Star that she was summoned on December 11, 2019, to appear as a witness on

December 30. In the statement, Bonya questioned

certain aspects of the investigation. "On February 26, 2015, Avi and I were invited to meet a group of science writers. The people who organised that event kept us waiting for hours. Finally, we met the group in the evening. After the event, we were attacked and Avi was killed. Were the organisers of that event ever investigated? What was the outcome?" she asked.

"Bangladesh's authorities increasingly friendly with Hefazat-e-Islam, the Islamist group of madrasa teachers and students that demanded 'the heads' of secular writers and bloggers in 2014.


