

# Cases, deaths drop globally

Says WHO as Covid-19 vaccination drive gathers pace

The number of new cases of Covid-19 reported worldwide fell by 16 percent last week to 2.7 million, the World Health Organization said.

The number of new deaths reported also fell 10 percent week-on-week, to 81,000, the WHO said late Tuesday in its weekly epidemiological update, using figures up to Sunday.

Five of the six WHO regions of the world reported a double-digit percentage decline in new cases, with only the Eastern Mediterranean showing a rise, of seven percent.

New case numbers dropped 20 percent last week in Africa and in the Western Pacific, 18 percent in Europe, 16 percent in the Americas and 13 percent in southeast Asia.

WHO Director General Tedros Adhanom Ghebreyesus said Monday that the number of new cases had declined for a fifth consecutive week, dropping by almost half, from more than five million cases in the week of January 4.

"This shows that simple public health measures work, even in the presence of variants," Tedros said.

UN Secretary-General Antonio Guterres yesterday called for a global plan to vaccinate against Covid-19, warning that inequities in initial efforts risked both the world's health and economy.

Meanwhile the Covax facility, the global Covid-19 vaccine procurement and distribution effort which aims to ensure poorer countries are also able to access doses, said its final shipment list for the first deliveries would be issued next week, following the WHO giving the green light to the AstraZeneca jabs.

Meanwhile, the EU yesterday said it will launch a programme to study Covid-19 variants and produce "second generation" vaccines against future strains, the bloc's president has said.

The "HERA incubator" programme, which began yesterday, will bring together the pharmaceutical industry, laboratories, health authorities and researchers, Ursula von der Leyen said.

Japan, meanwhile, launched its vaccination programme yesterday, five months ahead of the Tokyo Olympics, as Australia and New Zealand ended snap lockdowns after they successfully brought small outbreaks under control in just days.

With infections topping 109 million and more than 2.4 million deaths, the pandemic has devastated the global economy, and populations are growing increasingly frustrated with financially painful restrictions that authorities and experts say are necessary to fight the virus.

South Africa launched its vaccination programme using a Johnson & Johnson vaccine, after a delayed start caused by concerns about the ability of the Oxford-AstraZeneca formula to shield against a widespread variant of the virus.

Gaza received its first shipment of Covid-19 vaccines yesterday after Israel approved the transfer through its border with the Hamas Islamist-run territory, Israeli and Palestinian officials said.

# Fear of violence grows

Anti-coup protesters in Myanmar stage big rallies; UN envoy fears bloodshed as troops seen heading for Yangon

Myanmar's anti-coup protesters returned to the streets in force yesterday, staging the biggest demonstrations since troops fanned out around the country to quell opposition to the new military junta.

Much of the country has been in open revolt since the military deposed Nobel laureate Aung San Suu Kyi's government at the start of the month and charged her under an obscure import law.

UN special rapporteur Tom Andrews warned that soldiers going into Yangon, as had been reported, could lead to the situation there spiralling out of control.

"We could be on the precipice of the military committing even greater crimes against the people of Myanmar," he said.

Tens of thousands rallied in Yangon, some blockading roads with vehicles to stop security forces from moving around the nation's biggest city.

Police and soldiers were spotted near a key protest junction but appeared to be

hanging back, looking on as demonstrators streamed past.

Yesterday's crowds came in defiance of violent efforts by the regime to bring resistance to heel -- including use of tear gas and rubber bullets -- following nationwide street protests and a disobedience campaign encouraging civil servants to strike.

Demonstrations over

the past two days had been noticeably smaller since troops were deployed around Yangon at the weekend.

But social media platforms had been flooded with calls for a show of force by protesters in the hours before the junta imposed a third consecutive overnight internet blackout.

By noon, there were anti-coup demonstrations across

Myanmar, from the remote highland region of Chin state to a small town in the Irrawaddy delta where parading protesters hoisted Suu Kyi posters.

After her detention in a dawn raid on February 1, Suu Kyi was charged with possessing unregistered walkie-talkies found in her home.

Her lawyer Khin Maung Zaw told AFP on Tuesday she was also charged with violating the country's disaster management law. Further details of that charge have not been made public.

The disaster management law has also been used against deposed president Win Myint for an election campaign event that the junta claims broke coronavirus restrictions.

Her lawyer added that Suu Kyi and Win Myint, both of whom he has yet to have any contact with, were expected to appear via video link during a March 1 trial.

More than 450 people have been arrested since the coup, according to the Assistance Association for Political Prisoners monitoring group.

## Former Indian minister loses #MeToo defamation case

A former minister lost a defamation suit yesterday against a woman who had accused him of sexual harassment, in a verdict hailed as a major victory for India's #MeToo movement.

In 2018, Priya Ramani, a journalist, became the first of a string of women to go public with allegations against MJ Akbar, a former high-profile newspaper editor and later a junior minister in Prime Minister Narendra Modi's government.

Ramani wrote an article in Vogue magazine about the inappropriate behaviour of an unnamed editor the same year and one year later alleged it was Akbar. She said she was 23 when Akbar called her to a Mumbai hotel for a job interview more than 20 years ago and told her to come up to his room where he made inappropriate gestures.

Akbar, 70, who has not been charged with any offence, called the allegations "baseless". Soon after, he stepped down as junior foreign minister and sued Ramani for defamation, saying it had caused "irreparable damage to (my) reputation and goodwill".

#PriyaRamani was the top-trending hashtag on Twitter in India with many hailing it as a major victory that will inspire other victims to come forward.



## US radio host Rush Limbaugh dies at 70

Provocative and polarizing US talk radio luminary Rush Limbaugh, a leading voice on the American political right since the 1980s who boosted, and was honored by, former President Donald Trump, has died at age 70 after suffering from lung cancer, Fox News reported yesterday.

Limbaugh had announced in February 2020 that he had been diagnosed with advanced lung cancer.

Limbaugh espoused an unflinchingly populist brand of conservatism during a daily show broadcast on more than 600 radio stations across the United States. He railed against left-wing causes from global warming to healthcare reform as he helped shape the Republican Party's agenda in the media and mobilize its grass-roots supporters.

Trump, who pursued right-wing populism during four years in the White House, awarded Limbaugh the highest US civilian honor - the Presidential Medal of Freedom in 2020.

Limbaugh ridiculed mainstream news outlets and relished the controversies often sparked by his on-air commentary. Still, Limbaugh's success helped spawn a new class of right-wing pundits on radio, television and the internet, among them Bill O'Reilly, Sean Hannity, Glenn Beck and Alex Jones.

## NEWS IN BRIEF

### Millions without power as deadly cold snap grips US

Millions were left without power as a winter storm gripped the southern and central United States with record-low temperatures in ill-prepared areas, and a tornado claiming three lives. More than 20 storm-related deaths have been registered so far till Tuesday, including in traffic accidents in Texas, Kentucky and Missouri. Weather-related emergencies have been declared in Texas, Alabama, Oklahoma, Kansas, Mississippi and Oregon.

### Gunmen kidnap 42 in Nigeria

Gunmen have abducted 42 people, including 27 students, from a school in central Nigeria, a local government official said yesterday, downplaying initial reports that hundreds had been taken. One student was killed, he added. President Muhammad Buhari, in a statement earlier, condemned the abductions and ordered a rescue operation. Heavily-armed gangs known locally as "bandits" active in northwest and central Nigeria have stepped up attacks in recent years, kidnapping for ransom, raping and pillaging.

### Trump urges Senate GOP to dump Mitch McConnell

Donald Trump urged Republican senators Tuesday to dump Mitch McConnell as their leader in the Senate following his withering criticism of the former US president after his impeachment trial. In his most extensive comments yet on politics since stepping down from power on January 20, Trump also threatened to use his influence against party candidates who don't align with him. He called the longtime senator "dour, sullen" and warned that "if Republican Senators are going to stay with him, they will not win again."

### UN to raise Princess Latifa case with UAE



The United Nations has said it will raise the detention of Princess Latifa, the daughter of Dubai's ruler, with the United Arab Emirates (UAE). Princess Latifa has accused her father of holding her hostage in Dubai since she tried to flee the city in 2018. In secretly recorded videos shared with the BBC, Princess Latifa said she feared for her life. The footage prompted global calls for a UN investigation, while the UK said the videos were "deeply troubling". Princess Latifa's father, Sheikh Mohammed bin Rashid Al Maktoum, is one of the richest heads of state in the world, the ruler of Dubai and vice-president of the UAE. The UAE has close relations with a number of Western countries, including the US and UK which consider it a strategic ally.

take down the content that could malign the prestige and dignity of an elected democratic government.

"In such a view of the matter, this court, exercising extraordinary jurisdiction, thus directs respondent no-5 to prevent further worsening of the situation by streaming through those social media -- Facebook, Instagram, YouTube and Twitter -- of that documentary both nationally and internationally."

The writ petition filed by Supreme Court lawyer Anamul Kabir Emon sought a ban on the broadcast of Al Jazeera in Bangladesh and the removal of "Al the Prime Minister's Men" from the internet.

The bench yesterday heard arguments from Attorney General AM Amin Uddin and BTRC's lawyer Khandaker Reza-E-Raquib.

Amin told the HC that "Al the Prime Minister's Men" scandalised the whole state by calling Bangladesh a mafia state.

In such a situation any citizen has locus standi to move a writ petition, seeking remedy, the attorney general said and cited previous decisions of the SC in support of his argument.

The writ petitioner has filed this petition as a public interest litigation, he added.

When one of the judges asked him whether he supported the writ petition, he said he did not think Al Jazeera should be blocked, but he believed its report "All the Prime Minister's Men" should be removed from digital platforms.

The report made the people's heart bleed and therefore, every citizen

has the right to seek remedy, he said, adding that the writ petition was acceptable.

The attorney general also said the contents and links of the Al Jazeera report should be removed from social media and all digital platforms.

BTRC lawyer Khandaker-Reza-E-Raquib told the court that each and every organ of the state wanted the content removed.

If five crore people have already watched the report, 100 crore more will see it if it is not removed now, the lawyer said, "The Al Jazeera report is constantly hurting us."

On Monday, five of six amici curiae (friends of court) told the HC bench that the writ petition was not acceptable.

Since there is no allegation of violation of fundamental rights because of the Al Jazeera report, the writ petitioner has no logical reason to be aggrieved and move the petition, they said.

The petitioner has not served any legal notice to the government demanding steps to this effect and a decision to block or restrict Al Jazeera may tarnish freedom of speech and freedom of press in Bangladesh. Besides, the laws of the land are not enforceable to restrict freedom of speech outside the country, according to their opinions.

The amici curiae placed at the HC the legal and constitutional interpretations and examples of decisions of courts from home and abroad and the possible consequences of banning the broadcast of Al Jazeera in Bangladesh.

The five experts are: former

attorneys general AJ Mohammad Ali and Fida M Kamal, and senior lawyers Kamal Ul Alam, Probrir Neogi and Shahdeen Malik.

The other expert Abdul Matin Khasru did not clearly state his opinion on the acceptability of the writ petition, but said the HC could order the government over the issue if it felt necessary because the documentary was an attack on the prime minister, the army, and the integrity and solidarity of the country.

Lawyer Anamul Kabir Emon submitted the writ petition as a public interest litigation to the HC on February 9, saying that the Al Jazeera documentary has damaged the image of Bangladesh at home and abroad and hurt the sovereignty of Bangladesh. Contents of the report are not authentic, he said, adding that Al Jazeera had earlier broadcast reports damaging the image of Bangladesh but no action was taken against the people involved.

However, speaking on the issue, BTRC Chairman Shyam Sunder Sikder yesterday said they had earlier requested YouTube and Facebook to remove the Al Jazeera report.

In response, YouTube authorities said that they could not remove the content because it did not violate their Community Guidelines, the BTRC chairman said.

Facebook authorities also said the same, he added. "Now, it will be easier for us to approach YouTube and Facebook again after the High Court directive."

Full text of the HC order was not released yesterday.

## Four sued for sedition

Moshiur Malek, founder and president of Bangabandhu Foundation, filed the case with the court of Dhaka Metropolitan Magistrate Ashok Imam, Atiqur Rahman, bench assistant of the court, told The Daily Star.

After holding hearing, the magistrate recorded the statement of the complainant and took cognisance of the case.

The magistrate will pass an order in the case on February 22, court sources said.

In the complaint, Malek said Al Jazeera on February 1 aired a report which was also published on YouTube and online newspapers.

The report was fictitious, false, fake and fabricated. By broadcasting the report, Al Jazeera tarnished the image of the government and the state at

home and abroad which is tantamount to sedition, the complainant added.

In his statement to the court, Malek said the accused were conspiring to "topple" the country's elected government through this report.

He appealed to the court to issue arrest warrants against the accused through Interpol for their alleged involvement in the offences.

The Al Jazeera report caused a stir in the country and prompted a major backlash from the government.

Earlier in May last year, Tasneem Khalil and Zulkarnain were sued for objectionable posts on social media against the state, Father of the Nation Bangabandhu Sheikh Mujibur Rahman and several important persons of the country.

They were also charged with "tarnishing the image of the nation".

On February 4 this year, Sub-Inspector Md Mohsin Sardar of Ramna

Police Station, also the investigation officer of the case, dropped their names from the probe report as he did not find enough evidence against them.

The IO included the names of cartoonist Ahmed Kabir Kishore, writer Mushtaq Ahmed and Rashtrachinta activist Didarul Islam Bhuiyan in the charge sheet of the case.

But on February 10, Judge Mohammad Ash Sams Joglul Hossain of the Dhaka Cyber Tribunal ordered further investigation into the case filed under the Digital Security Act against eleven people, including Tasneem Khalil and Zulkarnain, after the prosecution submitted a petition, seeking further probe.

The tribunal also ordered the Counter Terrorism and Transnational Crime (CTTC) unit of police to further investigate all the 11 accused and submit the probe report to it by March 23.
