Clamp down on it with an iron hand

PM orders authorities

UNB, Dhaka

Prime Minister Sheikh Hasina directed authorities concerned to curb food adulteration in Bangladesh with an iron hand alongside creating awareness among businesspeople against such offences.

"You will have to make them [unscrupulous businesspeople] understand about such offences on one hand and curb that with an iron hand on the other hand. It's essential to take both measures simultaneously," she said.

The PM was addressing a programme at the city's hotel InterContinental Dhaka, marking the National Food Safety Day-2021. She joined the event virtually from the Gono Bhaban.

This year, the day is being observed with the theme of "Teksoi Unnyan-Somriddho Desh, Nirapod Khadyer Bangladesh" (Bangladesh: A country of sustainable prosperity and safe

said Hasina unscrupulous businessmen sell adulterated or rotten food to earn extra money harming the public health.

"But it is needed to make them realise that they can make the same profit by spending money on the sale of safe food."

Mentioning that a central food testing laboratory is being set up in the country, the premier instructed the relevant authorities to take steps for setting up one food testing laboratory in every divisional city as

She said it is also essential to set up a food-testing laboratory in every divisional city as the government is developing 100 economic zones giving importance to food-processing industries.

Laboratory testing certification is essential to export agricultural products, most importantly the food items, Hasina said, adding that there will be a scope for setting up foodtesting systems up to rural level.

Referring to the safe food plan being implemented in 100 food-

related industries, the PM asked the authorities concerned to execute it throughout the country gradually. "It will have to be taken up to the village

level." EMPHASIS ON BALANCED DIET

Mentioning that the government is giving importance to ensuring nutrition, the PM directed the Bangladesh Food Safety Authority to go for a massive awareness campaign over balanced diet in the country alongside conducting laboratory

She stressed the importance of safe transportation of processed food items. She said the government would develop the postal services further so that it can get food items safely to different destinations.

Hasina urged the people not to keep even a single inch of land uncultivated so that no food crisis can hit the country under any circumstances.

She also asked the authorities concerned to expand their activities to use grading stickers at hotels and restaurants across the country.

The PM highlighted government's various activities and successes in the food sector. She said the previous governments never wanted Bangladesh to be self-reliant in food as they were more interested in food import to help some of their people to make money from the

"I would like to say unequivocally that the Awami League government is not in power to do business but to serve people as their assister."

Agriculture Minister Muhammad Abdur Razzaque and Fisheries and Livestock Minister SM Rezaul Karim also spoke at the function, presided over by Food Minister Sadhan Chandra Majumder.

The PM distributed prizes among the winners of a quiz contest and essay competition arranged marking the 4th National Food Safety Day. On behalf of the premier, the food minister handed the prizes to the

Syndicate teams up with officers

February 11, 2019, and three days later, both of them boarded a flight to UK going through immigration with no

CID officials told The Daily Star this too would have required involvement of the immigration police personnel.

Zain and the woman reached Heathrow where the immigration police quickly identified that she was carrying a fake passport. They sent her back on February 17, 2019.

Immigration police at Heathrow did not stop Zain as he had a valid UK passport.

On her return, the Sylhet airport authority informed the woman's family members and asked them to take her away paying Tk 2.60 lakh plane fare, the woman said in her case filed on February 22, 2019, with the Airport Police Station of Sylhet Metropolitan Police (SMP).

She accused Zain, Mokarram, and Ashraf, a tenant of Zain's relative in

A CID high official, involved in the investigation, told this newspaper, We have already identified some immigration officials involved in the crime but we need Zain's statement to get something concrete."

The officer, however, refused to disclose the identities or details of the immigration officials concerned.

Sources, however, said the CID's THB squad already interrogated six immigration officials.

Sayful Islam, officer-in-charge of Immigration Police at the Sylhet airport, said the policemen on duty at the airport then were transferred as part of a routine.

"I do not know anything about the incident as I was not on duty at that time," he said.

Asked how could someone slip through the immigration with a forged passport, and how could a passport get stamped without a bearer, the OC refused to comment. Ezaz Ahmed, special superintendent

of immigration police at Osmani airport, suggested contacting the investigating agency. "I have taken charge recently," he said.

CID officials said they wrote to National Central Bureau (NCB) of Bangladesh Police seeking assistance of the UK police for interrogating Zain via a video conference two months ago.

In response, the UK police on

Monday sought evidence on how Zain was involved in the crime.

On Tuesday, the CID sent documents and closed circuit television (CCTV) camera footage that shows Zain was with the woman and they left Bangladesh together, sources said.

AKM Akteruzzaman, additional special superintendent of the CID, told The Daily Star that they were trying to reach Zain.

"We have got some more evidence which we are now analysing. Once we get Zain's statement, we would be able to say what and how it actually happened."

This newspaper talked to Md Asraf Miah, the third accused in the case now out on bail.

He said, "I am a tenant of Zain's brother in Kharadipara area of Sylhet. Zain uses my mobile phone when he visits Bangladesh.

"I have no involvement in the case but I was named as Zain used my

"I have never met the plaintiff "After he left the country on February

14, 2019, with the girl, Zain stopped contacting me," added Ashraf.

15 more die from Covid, 391 infected

Fifteen more coronavirus-related deaths and 391 new cases were recorded in the last 24 hours till yesterday morning.

The numbers are slightly lower than Wednesday's when the health authorities reported 16 deaths and 443

So far, 542,268 Covid-19 cases have been confirmed with 8,329 fatalities, data released by the Directorate General of Health Services (DGHS)

Bangladesh reported its first cases on March 8 and the first death on

The daily coronavirus infection rate rose to 2.68 percent yesterday which

was 2.67 percent on the day before. According to the latest figures, the overall infection rate stood at 13.87 percent which was 13.97 percent on Wednesday, and expected to fall further as a mass countrywide coronavirus vaccination drive is underway.

But the mortality rate remained at 1.53 percent, said the DGHS handout. So far, 489,932 patients -- 90.35 percent -- have recovered.

The authorities have tested 3,908,257 samples until yesterday, and 14,603 in the past 24 hours.

Haris's name was also struck off the Interpol's list of wanted people sometime in 2019.

In May, 2018, Josef was granted presidential clemency, according to media reports.

After the inauguration, however, it was learned that the app was not for vaccine registration. It was the "Surokkha Covid-19 Vaccine Prodan App" for nurses to use at the vaccination centres.

Using the app, the nurses at the

vaccination centers can scan the QR

codes on vaccine cards after vaccinating people, and the report will automatically be uploaded to the server. While inaugurating the app, the minister said, "Through this app, our

Covid-19 vaccination programme's

capability has gone one step further." Contacted with the official concerned of the DGHS, he said, "The app is for the employees involved in the vaccination campaign. On the other hand, the work of the Surokkha vaccine registration app is not complete yet.

According to the officials, the DGHS has provided necessary additional information again on Wednesday as per Google's requirement.

Once Google approves, the app will be available on its Play Store.

Earlier, officials said the app would be available on February 4 for mass use. Now, people are registering on www.surokkha.gov.bd website to get Covid-19 vaccines.

As of yesterday afternoon, more than 28 lakh people registered to get vaccines
