7 hurt as three-storey building topples

It was built on a pond in Keraniganj without authorities' approval

At least seven people were injured as a three-storey building, constructed on a pond without permission from the authorities, collapsed in Maddha Charail Playground area of Keraniganj yesterday.

Rahman, deputy assistant director of Fire Service and Civil Defence in Keraniganj, said the building came crashing down around 8:15am, trapping eight people inside.

Later, the members of Fire Service and Civil Defence rushed to the spot and rescued them around 9:30am, he added.

"Ideally, the building should have collapsed a long ago but it stood tall ghostly. Due to the weak soil underneath, the building collapsed," he said.

Meanwhile, the authorities vacated the surrounding five buildings which were constructed on or around the pond even without any foundation.

Utility connections, such as gas, electricity, and water, have been cut off from the buildings. Kazi Mainul Islam, officer-in-

charge of Keraniganj Police Station, said they conducted the evacuation to ensure safety to the residents of nearby buildings.

Nowshin Tabassum Rupa, postgraduate student at Bangabandhu Sheikh Mujib Medical University, said there is almost no use of Bangla in the study of medicine.

National Professor Rafiqul Islam said since Bangla is not the medium of education in higher studies, there are not enough good books.

He said according to the Qudrat-e-Khuda Commission which published the country's first education policy in 1974, the medium of education from primary to higher levels should be Bangla.

"But the recommendation was never implemented. The main reason behind that is our inferiority said the eminent complex," educationist and scholar.

Syed Abul Maksud said Bangla Academy could have played a role, but it was negligent.

"One of the key aims of establishing Bangla Academy was to make the use of Bangla as a medium of education easy. But the institution has obviously failed to do that," he said.

He added that the academy used to publish good Bangla books in the years preceding 1980.

"Had the Bangla Academy and education ministry taken sincere efforts, Bangla would have been established in higher education to a great extent by now," he said.

According to Bangla Academy Act- the time," he said.

2013, it is one of the basic functions of the academy to make available and publish dictionary, terminology, reference grammar, books bibliography and encyclopedia in Bangla. It should also widen and enrich the use of Bangla in science and technology.

The academy, established in 1955, has a division for translation.

In its latest catalogue, the academy has 1,418 saleable books. Less than 100 of those were translated into Bangla from a foreign language. And most of those were published in the early '90s.

A total of 21,527 books were published in the last five years' Ekushey Boi Mela. Of those, only 186 were translations.

Mohammad Mizanur Rahman, director of the division for translation, said, "We are going to launch a new project to publish at least a hundred translated books and we will publish a new yearly magazine titled 'Onubad' from next month."

National Professor Rafiqul said Bangla Academy alone would not be able to do much to ensure Bangla as a medium of education.

The academics and the university authorities will have to make sincere efforts to promote Bangla in higher education.

"We discuss the issue in February and tend to forget about it the rest of

The trio occupied sensitive positions in three major companies that took over 20,000 Bangladeshi workers to Kuwait in exchange for more than KD50 million. Although the company was closed due to legal violations, the workers landed in Kuwait to discover their visas were fake. They were forcibly employed in another company owned by Papul.

Eleven Bangladeshis taken to Kuwait by Papul testified to the court about the exploitation. The workers were charged money for renewing residency visas and even forced in Kuwait. During investigations, all to work against their will for long following a petition filed by the ACC.

Commercial Bank Director Kazi Papul, his wife Selina, their daughter Kazi Wafa Islam and Selina's sister Jesmin.

On July 17 last year, the ACC imposed a ban on all of their foreign travels, saying the embargo would be implemented for Papul after his return to the country.

Later on November 11, the antigraft watchdog filed a case against Papul, Selina, Wafa and Jesmin for allegedly laundering about Tk 148.41 crore. The inquiry is still pending.

The clash ensued in front of the AL party office at Chaprashirhat East Bazar around 4:45pm, police said. It continued till 7:00pm, turning the area into a battlefield.

Meanwhile, Quader Mirza called a dawn-to-dusk hartal in Companiganj upazila today, "protesting the attack on his men".

Besides, he announced that he would hold a press conference at 10:00am today at Basurhat, while Badal called a press conference around noon at Chaprashirhat over yesterday's incident.

According to locals and police sources, Badal, also a former chairman of Companiganj upazila, asked his supporters to come to the Chaprashirhat party office at 4:30pm to exchange views over holding a press conference today against Quader Mirza's recent comments on party leaders.

But before that, supporters of his rival group, led by Charfakira Union Chairman Jamal Uddin Liton, a man of Quader Mirza, gathered there.

The supporters of the two groups got locked into an altercation. At one point, chase, counter-chase and clash took place between them. Bullets were also fired. At least 50 people of the two sides were wounded.

On information, Companiganj police rushed to the spot and fired blank shots to bring the situation under control.

Journalist Burhan Uddin was hit by bullets while covering the incident.

Shortly after the incident, followers led by Quader Mirza, mayor of Basurhat municipality, attacked Badal's house near Chaprashirhat Bazar. They went there in two microbuses and over 100 motorcycles, Badal alleged.

On the other hand, in a Facebook live, Quader

Mirza alleged that his men were attacked by the men of lawmakers Ekramul and Nizam. He claimed that at least his 50 supporters were hurt in the attack.

"If any of our leaders and activists dies, Road Transport and Bridges Minister Obaidul Quader, Companiganj Upazila Parishad Chairman Shahab Uddin, MP Ekramul Karim Chowdhury, MP Nizam Hazari and former Upazila Chairman Mizanur Rahman Badal will be held responsible for this, Mirza Quader said.

He also alleged that his men were shot by his rival group in presence of police.

Mir Jahedul Haque, officer-in-charge of Companiganj Police Station, who was present on the spot, told reporters that during a procession led by Badal, there was a scuffle between the supporters of UP Chairman Jamal and Badal at Chaprashirhat.

After that, some followers led by Quader Mirza went to Chaprashirhat Bazar and another clash took place. At that time, police brought the situation under control by firing shots in the air, he added.

Md Alamgir Hossain, superintendent of Noakhali police, said the clash ensued over the political rivalry etween Quader Mirza and Badal.

Police fired 10-12 bullets to disperse the clashing groups. Riot police have been deployed to fend of further untoward incident in the area, he added.

Quader Mirza has been making comments against corruption and misdeeds committed by AL men in Noakhali and Feni for the last two months. He even on multiple occasions came down heavily on government officials for their alleged involvement with corrupt politicians.

On February 18, Quader Mirza and his followers enforced a half-day shutdown in Companiganj upazila, demanding the transfer of some government officials and punishment of some party men for "their involvement in corruption".

US officially back in Paris accord

The United States yesterday officially returned to the Paris climate accord, with President Joe Biden's administration vowing to make the environmental battle a top priority.

Exactly one month after Biden took office and immediately moved to rejoin, the world's largest economy and second largest carbon emitter was formally back in the 2015 accord aimed at confronting the planet's dangerously rising temperatures.

The re-entry of the United States means that the Paris accord again includes virtually every country after Biden's predecessor Donald Trump made the United States the sole outlier.

"Climate change and science diplomacy can never again be 'addons' in our foreign policy discussions,' Secretary of State Antony Blinken said in a statement saluting the return of the United States.

"Addressing the real threats from climate change and listening to our scientists is at the center of our domestic and foreign policy priorities. It is vital in our discussions of national security, migration international health efforts, and in our economic diplomacy and trade talks."

While praising the Paris accord, negotiated by former president Barack Obama, Blinken said that upcoming climate diplomacy will be crucial.
