











Follow Covid guidelines after shots: PM

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday renewed her call to the people to strictly maintain the health protection guidelines even after receiving the Covid-19 vaccine.

"[You] don't think that all problems will be over after taking the Covid-19 shots. You will have to wear masks always and follow all health guidelines to keep yourselves protected. I hope everyone will do it," she said.

The premier made the call while addressing the Mujib Year Graduation Parade of the 55th Batch Cadets of Bangladesh Marine Academy (BMA) in Chattogram. She joined the programme through a video conference from the Gono Bhaban.

Hasina said though the government is implementing the vaccination programme, all the people should follow all health protection guidelines, including using face masks and keeping their hands

clean always as these are essential.

She said her government was making all-out efforts to ensure all types of health services for the people and it took appropriate measures to that end.

Talking about the graduating cadets, the PM urged them to brighten the country's image at home and abroad through performing their respective

challenging job and tough task.

She said her government found Bangladesh Marine Academy in a very poor state, but it was implementing massive programmes to modernise the academy, set up by Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

Hasina said her previous government had established Bangabandhu Sheikh Muiibur Rahman Maritime University in 2013. The government has recently established four more marine academies which will start functioning this year.

She said the waterway is the most important for riverine Bangladesh and the country is constructing a deep sea port.

The government was creating various educational scopes for the students of

the country, the PM added. "We will have to catch up with the pace of the world. We need to receive the highest education and training to do that. We are creating this scope."
MODERNISING MARINE ACADEMY

About the development of the marine academy over the last 10 years, Hasina said its teaching method was digitised, navigation simulator was set up (in 2019), and the academy got many

international recognitions. Besides, a process is underway to set up Engine Control Simulator at the academy this year for the sake of improved marine engineering training, she said.

The PM also commissioned two training lifeboats at the academy's lake

Cadet Captain Adnan Hasib Shawon was awarded "Shipping Corporation Medal" for the best performance among 192 cadets of the 55th Batch, while the "Honourable President Gold Medal" was conferred on Chief Cadet Captain Abir Md Sadman Noor for the best allround performance.

On behalf of the PM, State Minister for Shipping Khalid Mahmud Chowdhury handed the medals to them.

Plan to vaccinate 15k convicts

The Department of Prisons has finalised a plan to vaccinate for Covid-19 convicts and inmates in 68 jails in the country. Convicts who are 40 years old or

Mamun, inspector general of prisons, revealed the plan to The Daily Star yesterday.

"We were working to ensure vaccine in jails as per the policy enacted by the government As part of continuous discussions, we held talks with the home ministry's senior secretary today

The home ministry asked for a finalised list of over 15,000 convicts, said the IG Prisons.

"After the list is prepared, we will try to complete the registration of inmates

who are 40 or above," he said. There are 83,107 inmates and convicts in the 68 jails of the country, according to yesterday's tally. Among them, around 68,000 have not been convicted of any

inmates, Brig Gen Mamun said they would decide about them after giving shots to the convicts since those inmates could leave jail securing bail or getting

acquitted. He said that it did not mean those inmates would not get the jabs, rather

they would get the shots in later phases. start, the IG prisons said he had talked to the home ministry and now they would

write to it regarding the matter. "We will start ensuring the vaccine soon after the ministry responds. We are hopeful of starting the vaccination in jail

secretary (jail wing) of the home ministry, told The Daily Star yesterday that they have decided in principle to start vaccination in jails.

"We are hopeful of starting it soon,"

he added. At least 18 convicts in Luxmipur jail,

all above 55 years of age, were given the shots on February 9 following an initiative of the civil surgeon concerned. The jail has 625 inmates, of whom

"We will start giving the vaccine after the district civil surgeon approves," he

Shakhawat said the 18 convicts, who go the jabs, did not have any side effects. "Still, we have kept them under observation of the jail doctor and nurse,"

Students protest exam deferral

the NU authorities yesterday said in a statement the postponed examinations of all courses, including the second-year degree exams and certificate courses of 2019 and the final year master's exam of 2018, will begin from May 24. Besides, the first-year admission test

process (2020-2021) will begin on June 8, 2021. The NU authorities have called upon students to prepare accordingly. Meanwhile, police also charged batons

on students of Home Economics College, which is under Dhaka University, as they were staging a demonstration in front of the college demanding continuation of exams, students alleged.

Meanwhile, police detained at least 18 students of different colleges under

the NU for several hours when they went to Shahbagh to stage protests over the postponement of exams.

Besides, students of Chittagong University, Rajshahi University, and various colleges in Sylhet, Chandpur and Netrakona, held demonstrations with the same demands.

Protesting students said their educational institutions have been closed since March 17 because of the Covid-19 pandemic, due to which they lost academic time. Some universities, including NU, had started to hold final

Shahbagh police detained at least 18 of the NU students, who were gathering in the area to stage a protest against exam postponement, said Mohammad Al Amin, a protest organiser and student of Siddweshari College.

He said that they were released after several hours.

"We are giving authorities time till Sunday to cancel their decision of postponing all exams. Otherwise, we will hold sterner programmes," he warned. Students of different colleges of

Netrakona gathered in front of the district Press Club at noon. When they were marching toward the DC office, police charged batons on them, said ahim Khan, a demonstrator.

Akbar Ali Munsi, Netrokona's

police officials were withdrawn to the SP office and they are inquiring into the incident.

In Sylhet, Students from MC College, Sylhet Govt College, Madan Mohon College and several other colleges formed a human chain under the banner of General Students in front of Sylhet Central Shaheed Minar at Chowhatta

"Male police officials charged batons on us around 11:30am, women officials tried to drag us inside the campus," said Ayesha Siddika, one of the protesters of Home Economics College, adding, "We will continue our movement until our demands are met.'

The protest started around 7:00am at Nilkhet intersection. The students later moved in front of their college and were continuing the protest until this report was filed at 2:45pm.

Sanowar Hosen, assistant police commissioner of Lalbagh Zone, said that they tried to disperse the protesters with permission from the college authority.

"However, batons were not charged on them," he said.

Students of Rajshahi University started demonstrations at Paris Road of the university around 11:00am and postponed it at 1:00pm until next Sunday, upon assurance from the authorities,

reported our RU correspondent.

Tomalika Haque, a student of Geology and Mining department, said, "The university authorities postponed our exams as per the instruction of the Education Ministry. We want the examinations to continue even if our dormitories aren't reopened. Seven colleges affiliated with Dhaka University have been successful in realising their demand. It's possible to take examinations on our campus as well."

RU proctor Prof Lutfor Rahman said he will request the vice chancellor of the University to restart the examinations. Students of Chittagong University held a rally in front of the university's

Shaheed Minar. Prattoy Nafak, a student, said that

outside their campuses since Saturday with different demands, including reopening of their educational institutions and halls. Against the backdrop of protests

at Dhaka University, Jahangirnagar University, Rajshahi University and others, the government on Monday announced that all universities would reopen on May 24 after the Eid-ul-Fitr. No examinations will be held before reopening of the universities, but online

classes will continue, Education Minister Dipu Moni announced. The NU cancelled all their exams on Monday until further notice. Dhaka University took the same step the next

Frustrated by the decision, a group of students of DU's seven affiliated colleges blocked Nilkhet intersection and some other roads near the DU campus on Tuesday evening and Wednesday

DU authorities on Wednesday decided to hold all ongoing and previously announced exams of its seven affiliated colleges in the wake of student protests.

Five die, 410 get infected with Covid

Five more Covid-19-related deaths and 410 new cases were reported in the country in 24 hours till yesterday

morning.

A total of 957 people recovered during the same period, said the Directorate General of Health Services in a handout.

With the updated figures, the Covid-19 fatalities climbed to 8,384 and the number of total infections to 544,954 in Bangladesh. The daily infection rate now stands at

2.63 percent which was 2.65 percent on Wednesday, the latest figures showed. The overall infection rate slightly fell to 13.61 percent, which was 13.66 percent on Wednesday.

The mortality rate remained steady at 1.54 percent for the past few days, the DGHS handout said.

So far, 494,755 patients (90.79 percent) have recovered from Covid-19. The authorities have so far tested 4,003,236 samples, including 15,560 in

the same 24-hour period. Bangladesh reported its first novel coronavirus cases on March 8 last year and the first death on March 18.

Dhaka-NJP train service to start on March 26

A new passenger train between Dhaka and New Jalpaiguri (NJP) of India's West Bengal state will start its service on March 26 as part of the golden jubilee celebrations of Bangladesh's independence.

Prime Minister Sheikh Hasina and her Indian counterpart Narendra Modi, who would travel to Dhaka on March 26, are expected to flag off the new train service as part of the efforts to revive the rail connectivity that had existed till 1965 between the two neighbours.

The operation of the nonstop tencoach train between Dhaka and NJP, which will cover a distance of 513km, was discussed at a two-day meeting between a team of Bangladesh Railway officers and Ravinder Kumar Verma, divisional railway manager of India's Katihar division in New Jalpaiguri on Tuesday and Wednesday, reports our New Delhi correspondent.

Mohammed Shahidul Islam, the

divisional railway manager of Paksey division, who led the Bangladesh team to the meeting, told the media in Siliguri on Wednesday that Bangladesh wanted to operate the train between Siliguri and Dhaka. "But Siliguri didn't have the required infrastructure, so it had to be New Jalpaiguri instead," he added.

New Jalpaiguri has the biggest railway station in the northern part of West Bengal and is just six km away from Siliguri. It is a key junction between mainland India and north-

The Dhaka-NJP train would take the same route as the Haldibari-Chilahati train that was flagged off last year.

The name of the Dhaka-NJP train and its fare are yet to be decided, said

Sold in Algeria, waiting for rescue

Without an Algerian embassy in Dhaka, their visas were processed from Islamabad in Pakistan, their passports

"We had even officially sent letters to the ministry in 2019 saying that workers are being recruited for Algeria, for the purpose of being sent to Spain," he said. Copies of these letters show that

take steps immediately to investigate why people are going to informal labour markets, and how they are being trafficked from there.'

prove their claims. A single PVC pipe hanging over muddy cesspool, comprises their bathing area.

Their toilet is a hole in the ground, with raised planks for squatting.

"We were asked to defecate in the open when we got here, but we could not do that, so we created these structures. They docked a day's worth of wages for all those who spent the day constructing a toilet," alleged Sohel Rana in a clip, while another worker wearing a woollen cap and scarf wrapped around his face walked out of

earlier this month.

"Just three days ago, we were allowed to move into these [ship] containers to give us some weather protection. Up until then, and throughout winter, we had been living in an underconstruction building with no doors or even walls to catch the draught coming in from the sea," he said.

The under-construction buildings had damp dirt floors and were littered with construction materials stored in the living quarters of the workers.

The project is in an area called Ouled Abdel Krim and is done by a Chinese company. Tushar, who worked in another project, said, "It was very cold. It used
