### Home from prison but to be laid to rest

As Rab members were taking away writer Mushtaq Ahmed from his Lalmatia residence nine months ago, they assured the family that

he would return home after a short while. Finally, Mushtaq came back -- but dead

A pall of gloom descended on the house "Parampara" at 1/8, in Block-D as his body was brought there around 3:45pm yesterday with his family members, friends and relatives bursting into tears.

His wife Lipa Aktar was shell-shocked and speechless.

"She did not cry. Neither did she talk to anyone. It would have been better for her if she would cry," Dr Nafisur Rahman, cousin of Mushtaq, told The Daily Star yesterday.

Soon after Mushtaq was picked up in early May last year, Lipa told this

Mushtaq Ahmed, the writer, the commentator, the socially conscious citizen, the articulate but moderate voice of dissent and a critical observer of current events is dead. The official cause will be known after autopsy. But the real cause we already know – our cruel system, in which anybody can be picked up, locked in prison, accused of a myriad of vague "crimes" and kept confined for months without trial, without bail, and without explaining the causes of confinement. We have a system where freedom of individuals are mere playthings in the hands of the people in power and there is no redress when such instances occur.

It was the inhuman use of the Digital Security Act (DSA), the unexplained imprisonment over nine months, the six times rejection of bail, the dark maze of the legal entanglements, endless drain of money for obvious and not so obvious reasons, and the unjustness of it all that made the life of writer and commentator Mushtaq Ahmed nothing more than a dark endless hole. The reality was so inexplicably cruel and beyond reason that being alive lost all meaning.

What were the crimes for which Mushtaq was in prison where he died? The controversial DSA allows maximum 105 days for completing investigation and submitting charges. But the investigators failed to comply with it and finally charged him eight months after his arrest.

Outrage all over after Mushtaq's death in custody; call for scrapping DSA gets louder

Condemnation poured in and people from all walks of life, especially students and teachers, took to the streets yesterday expressing anger over the death of writer Mushtag Ahmed in jail custody.

Besides, between protesters and

police left several injured on Dhaka University

Mushtaq died on Thursday while he was an arrestee in a case filed under the Digital Security Act. With the death of this uncompromising voice, the call for scrapping the controversial DSA got louder.

Legal experts said such a death was not only

unacceptable but also shocking.

They said the detention of Mushtaq for over nine months, denying him bail so many times and his subsequent death demonstrates that people's fundamental rights to freedom of speech and thoughts have been squeezed, something which can never happen in a democratic country.

"He [Mushtaq] is a victim of government



repression and [this is al murder of freedom of expression," eminent jurist Shahdeen Malik told The Daily Star.

Calling for scrapping of the DSA, he said such a "medieval" law cannot exist in any democratic country. We can formulate such laws if we don't care

about democracy and want to block criticisms of the government.

Prof Mizanur Rahman, former chairman of the National Human Rights Commission, said, "People's voice is shrinking because of the Digital Security Act. It is an ominous sign for the state."

Terming the death of Mushtaq very painful and unacceptable, he said criticism of the government and sedition are two different things. "Mixing these two up will be a great mistake.

Thirteen heads of foreign missions in Bangladesh have expressed grave concern over the death in custody of writer Mushtaq Ahmed, who died in Kashimpur jail on Thursday, and called on the government to conduct an enquiry

Mushtaq had been held in pre-trial detention since May 5, 2020, under the provisions of the Digital

Security Act (DSA).
"We understand that he had been denied bail on several occasions and that concerns had been raised about his treatment while he was imprisoned," said the joint statement yesterday, expressing condolences to his family and friends.

'We call on the government of Bangladesh to conduct a swift, transparent, and

## Dhaka seeks **UN** assistance

Foreign Minister AK Abdul Momen has requested the UN to provide humanitarian assistance for the Rohingyas in Bhasan Char where a housing facility has been developed for one lakh Rohingyas.

Bangladesh's Permanent Mission to the UN in New York, in a statement, yesterday said, "The foreign minister explained the [UN] Secretary General of the measures taken by the Government in Bhasan Char and requested the UN's support for humanitarian assistance there for the Rohingyas.

The government of Bangladesh built a planned housing facility with Tk 3,100 crores in Bhasan Char that includes hospitals, cyclone shelters, school facilities, high flood protection embankment, while other projects are SEE PAGE 2 COL 1

## Vaccination in Asia gains pace

Indians allowed to choose Covid vaccination sites

The United States hailed progress in turning around its troubled Covid-19 vaccine rollout, as the European Union said it was on track to meet jab targets and Asia's inoculation drive gained pace yesterday.

Brazil hit 250,000 fatalities -- the second-highest national death toll after the United States -- while the worldwide vaccine campaign received the endorsement of Queen

Elizabeth II, 94, who urged people not to be wary of the shot. India said yesterday it will let people choose their coronavirus vaccination centres when the campaign expands next week, effectively letting beneficiaries pick either a

home-grown shot or the AstraZeneca one, unlike now The country will halt vaccinations this weekend to upgrade software used to coordinate its campaign, as it prepares to widen coverage beyond the 11.5 million health and front-line workers immunised since January 16.

But the inoculation campaign has progressed slower than expected due to a reluctance of health and front-line workers to take the home-grown COVAXIN shot that was approved without late-stage efficacy data. Only 11% of vaccinated people have opted for the product developed by Bharat Biotech and the state-run Indian Council of

Medical Research. The decision to give people a choice of vaccines could now speed up the roll-out, Indian officials believe.

President Joe Biden declared the US rollout is now 'weeks ahead of schedule" as he celebrated 50 million doses administered since he took office on January 20, but he warned Americans to keep masking up.

"We're moving in the right direction despite the mess we inherited," Biden said, referring to the program under his predecessor Donald Trump.

The United States is the world's hardest-hit country, with coronavirus deaths crossing the 500,000 mark earlier this week.

# Reckless driving claims 8 lives

Two buses collide head-on in Sylhet; one of them had no fitness certificate

Reckless driving claimed eight lives and left 17 people injured in Sylhet's Dakshin Surma upazila yesterday A bus of London Express, which had been in service

without a fitness certificate for around three months, left Dhaka for Sylhet around 12:45am. The bus driver was driving recklessly and overtaking

other vehicles. The passengers, who became panicked, warned the driver repeatedly, but he paid no heed. It resulted in the tragic end of the journey around 7:00am yesterday when the driver lost control and the vehicle collided head-on with a bus of Ena Paribahan at

fire service officials. Eight people of the two vehicles died in the accident. Of them, four each died on the spot and at Sylhet MAG

Rashidpur on Dhaka-Sylhet highway, said witnesses and

Osmani Medical College Hospital. Our bus driver was hurrying and overtaking other vehicles recklessly. There was fog on the highway. Most of the passengers were worried and we warned him repeatedly. But the driver did not listen to us," said Mohammad Rahel,

a passenger of the London Express bus. He was talking to The Daily Star at the hospital.

Visiting the accident spot and talking to survivors, it has become clear to us that the bus of London Express lost its control, skidded on to the wrong side of the road and collided with another bus that was coming from the opposite direction," said Kobad Ali Sarkar, deputy director of Fire Service and Civil Defence in Sylhet.
