Empty-handed they returned

148 migrants return from Libya as work dries up in war-torn country JAMIL MAHMUD

Bangladeshi migrant workers who returned home from Libya on Wednesday went through severe hardship as their livelihoods were hampered due to economic uncertainty and deterioration of law and order.

The migrants, who returned voluntarily, faced dearth of income opportunities as the North African country was torn by a bloody war.

The 148 Bangladeshis landed in Hazrat Shahjalal International Airport on a special flight Wednesday morning.

They returned with the help of International Organisation for Migration (IOM) and on their return, the migrants were given different support they needed, including food from Prabashi Kalyan Desk set up at the airport by the expatriates' welfare ministry, and Brac Migration Programme.

On Thursday, The Daily Star talked to three of the returnees who shared stories of their sufferings in Libya. Masud Mollah, 43, from Narsingdi, said the value of Libvan currency declined.

He said after entering Libya in April, 2019, he could work only six months and the rest of the time he was unemployed

Masud said his monthly income was barely Tk 15,000, which was not sufficient to support his wife and three children back home after meeting his own expenses.

Besides, the law-and-order situation was deteriorating there, he added

Masud said he reached Libya spending about Tk 3.5 lakh via a middleman who demanded Tk 4 lakh. The SEE PAGE 4 COL 1

Police dispersed protesters in Myanmar's two biggest cities yesterday, firing stun grenades, rubber bullets and guns into the air, witnesses said, as the challenge to the army's bid to re-impose its rule showed no sign of slackening.

At least one person was wounded in the protests in the main city of Yangon, a witness said, and several people were hurt in the second city of Mandalay.

Police were not immediately available for comment. The Southeast Asian country has been in crisis since the army seized power on February 1 and detained government leader Aung San Suu Kyi and much of her party leadership after the military complained of fraud in a November election her party won. The election commission said the vote was fair.

The road that connects Bangladesh's Sylhet to Indian's Shillong through Jaintapur-Tamabil constructed in 1932.

The next year, a bridge was constructed over the Sari river in Jaintapur upazila to finally establish connection between Sylhet and Shillong.

Decades later, in 2000, another bridge was constructed on the river and the older one was declared abandoned.

Although the archaeological heritage was supposed to be removed right after, it still stands still at the heart of the river as a major obstacle.

According National the River Conservation Commission, at least 98 illegal structures, sand and sediments from the upstream are causing serious trouble to the river's navigability.

Citing officials in her party, Myanmar Now website said yesterday Suu Kyi has been moved to an undisclosed location from the home where she was being kept under house arrest in the capital Naypyitaw.

The National League for Democracy(NLD) sources said she had been taken away six days ago, the website reported.

"We don't know where she's being kept anymore," Myanmar Now quoted one senior NLD source as saying on condition of anonymity.

The bus is equipped with sensors and cameras and links Malaga's port to the city centre on an eightkilometre (five-mile) loop it does six times a day.

"The bus knows at all times where it is and what is around it," said Rafael Durban Carmona, who heads the southern division of Spanish transport company Avanza that leads the public-private consortium behind the project.

It can "interact with traffic lights," which are also equipped with sensors that alert the bus when they turn red, he told AFP.

GRABBING, FILLING BHADRA, HORI RIVERS **HC** orders status quo

The High Court has ordered the authorities to maintain status quo on land grabbing, earth filling and operating brick kilns on the land of the Bhadra and Hori rivers in Khulna's Dumuria upazila for three months.

In response to a writ petition filed by Human Rights and Peace for Bangladesh (HRPB), the court on Thursday ordered the government authorities concerned to submit a report to it after complying with the directive.

The writ petitioner said lawmaker of Khulna-5 (Dumuria-Phultola) Narayan Chandra Chanda, also a former fisheries and livestock minister, Dumuria upazila Chairman Ajaz Ahmed, local union parishad Chairman Human Kabir Bulu and many others were reportedly involved in the acts of land grabbing and operating brick kilns on river land, which was obstructing the flow of the rivers

On Thursday, the HC also issued a rule asking the authorities concerned to explain in four weeks why their inaction to stop encroachment, earth filling and operating brick kilns on river land should not be declared illegal.

In the rule, the HC asked the respondents to show causes why they should not be directed to stop such activities and remove the dams built on the rivers by influential people.

Secretaries to the ministries of local government and rural development, water resources, land, and environment and forest, the director general of Department of Environment, the deputy commissioner of Khulna, the assistant commissioner (land) of Dumuria upazila, and other government officials concerned and the local elected representatives concerned have been made respondents to the rule.
