

# Boy dies after being mauled by dogs

A nine-year-old boy died in Dinajpur's Kaharol upazila after a pack of dogs mauled him on Sunday evening.

The deceased was Hriday Shil, son of Abinash Shil of Pouria (Napatpara) village under Mukundapur village in Kaharol Upazila of Dinajpur. The boy was a third-grader at a local primary school.

According to the family members and villagers, Hriday went out of his home to go to a nearby potato field early in the evening on Sunday.

Afterwards, he was returning home alone at around 6pm. On his way back, a pack of five agitated dogs attacked and mauled the boy badly. Hearing his screams, locals rushed to the spot and rescued Hriday.

Doctors at Kaharol Upazila Health Complex declared him dead upon arrival.

"The victim was brought in dead," said Dr Shafiqul Azom, upazila, health and family planning officer. He said the dogs mauled the boy all over his body, but attacks on his neck and throat proved to be deadly and hence the boy died on the spot.

After the attack, a high level of panic is prevailing over the village, said Mukundapur Union Chairman AKM Faruk.

He added that they are trying to come up with solutions to solve the dog overpopulation problem without killing the animals, as there is an instruction to not kill dogs.

AKM Faruk said he has spoken to local lawmakers to find a solution.

Rakibul Haq Emil, chairman of People for Animal Welfare (PAW) said such incidents are rare in the country.

"I have never heard of such a fatal attack from dogs," said the animal rights activist, adding that the dogs might have been agitated due to provocation or untoward behaviour towards them.

# Former UP chairman found dead at home

Police recovered the body of a former Union Parishad (UP) chairman from his house at Satkania upazila of Chattogram yesterday morning.

The deceased is Abdul Haque (75), former chairman of Keochia union of Satkania, said police.

There were injury marks on his head, they added.

Anwar Hussain, officer-in-charge of Satkania Police Station, said on information, police went to Haque's residence around 10am, recovered the body and sent it to Chattogram Medical College Hospital morgue for autopsy.

The OC said the former chairman used to reside in the house alone with a caretaker named Jamir (26).

Police took Jamir into custody for interrogation in this connection, he added.

He said that by the time they launch their operation, 90 percent of the residents will be gone from the area.

"As they are withdrawing from Laldiarchar, we do not have to go for eviction. Now, we will fence up 52 acres of area at Laldiarchar," he said.

He said it is the biggest peaceful eviction operation.

In December last year, the High Court issued an order to CPA to evict illegal occupants of Kamaphuli River and submit a compliance report before it by March 9.

As per the HC order, authorities told the people to remove their belongings by the end of February.

Md Zafar Alam, member (admin) of CPA, told The Daily Star earlier they want to construct a terminal at Laldiarchar.

inquiry committee, and a syndicate. I have always done my job properly. So, I have no comment on this," he said.

Marjan, a lecturer of DU's criminology department, is currently on a study leave abroad. The Daily Star could not reach him.

Both the teachers were demoted on January 28.

A research paper titled "A New Dimension in Colonialism and Pop Culture: A Case Study of the Cultural Imperialism" was published on DU's social sciences journal on December 2016.

In September 2017, DU authorities formed a committee, led by then Pro-VC Nasreen Ahmad, to inquire into a complaint that stated that the paper was copied from write-ups of prominent writers Michel Foucault and Edward Said.

Samia claimed that she applied to change the committee in December 2019, but it was refused.

When asked, DU VC Prof Md Akhteruzzaman said, "We respect her freedom of speech and are careful in preserving her dignity. There is nothing much to talk about in this matter."
