### People's faith in the commission has reached 'zero' level. They are biased towards one party.

Voter turnout was 65.25 percent in the first phase, 61.92 percent in the second, 70.42 percent in the third, 65.86 percent in the fourth and 58.67 percent in the fifth phase, according to EC statistics.

The average voter turnout in the municipalities polls was 65 percent. The figure was much lower than those of the municipal polls in 2015 and 2011.

Elections to 234 municipalities in 2015 were held in one day and the turnout was around 74 percent. Polls to 250 municipalities in 2011 were held in four phases and the average turnout rate was 78 percent.

Municipality elections are held once every five years. Political parties registered with the EC can take part only in mayoral

In the hearing, Jyotirmoy Barua said he had filed it seeking bail for both Kishore Mushtaq but the latter died on Thursday while in

Although the information report (FIR) mentioned that they have deteriorated law and order and situation confusion, it did not mention how they have done so, the lawyer said.

Ťalking about his client, the lawyer said Kishore is a cartoonist and cartoonists, anywhere in the world, criticise different activities of government through cartoons and this is nothing new.

Kishore is also a human rights defender who works for the rights of marginalised people, especially transgender people, said Jyotirmoy, adding that Kishore even received an international award for cartoon while he was in jail.

Citing the document, the lawyer said the complainant had only gotten information after the cartoonist was arrested and his mobile phone and computer were seized.

When the lawyer talked about weak points of the case, the court said this is a new law and there is a shortage of trained people and investigators.

Jyotirmoy replied that in case there was any fault in the case, the accused, not the police, would get the benefit.

The lawyer said as per the law, the investigating officer was supposed to submit charge sheet within 60 days of filing of the case. In default, days can be given and the cyber tribunal can allow 30 more days, meaning the investigation must be completed within 105 days of filing the case, he said.

But the charge sheet was submitted on January 11 and instead of accepting it, the cyber tribunal ordered further

Jyotirmoy said Mushtaq and Kishore were produced before the tribunal on February 23 when an investigation report scheduled to be submitted.

On that day, Kishore told Jyotirmoy that he was tortured in custody and that his right ear was nearly impaired and a scar had developed on his left leg, the lawyer said.

Jyotirmoy said he informed Metropolitan Session Judge's Court verbally but Kishore was not granted bail. Jyotirmoy said there are many faults in the case and they would mention those during the trial stage but his client has a social standing and is now ailing, so he should be

granted bail. He said as per the law, an accused must be produced during a remand hearing but Kishore was not produced before the court during his remand hearing on Sunday.

Chhatra Dal, the pro-BNP students' front, was scheduled to hold the rally in front of the Jatiya Press Club on Sunday morning protesting the move to revoke the gallantry award of late president Ziaur Rahman, and also demanding repeal of the Digital Security Act and an investigation into the death of writer Mushtaq in prison custody. Witnesses said police dispersed the JCD men before they could start the rally.

At least 40 people, including cops, were hurt in sporadic clashes between police and JCD men that lasted for about 40 minutes.

At one stage of the clashes, police entered the press club premises to drive JCD men away. Law enforcers were also seen firing rubber bullets and teargas shells towards the

Yesterday, the JCD staged demonstrations on different university campuses and in districts protesting the police attack and arrests. 'POLICE DEMONSTRATED EXTREME PATIENCE'

Home Minister Asaduzzaman Khan yesterday said police "dealt the situation with extreme patience" during the clashes on Sunday.

The minister was replying to journalists' questions after attending the Police Memorial Day programme in the capital.

The minister said a few cops entered the press club premises and that they fired teargas shells to control the situation. He said the press club authorities should take the responsibility to prevent outsiders from entering its premises.

Protests continued for the fourth consecutive day yesterday demanding justice for the death of writer Mushtaq and abolishment of the controversial Digital Security Act. Around 200 leaders and activists of
