## Faraaz Hossain Foundation, DCI, RSC jointly hold free eye-care camp in Pabna

Distressed Children & Infants International (DCI) and Rights and Sight for Children (RSC), in partnership with Faraaz Hossain Foundation, organised a free eye screening camp at Sreekol Aziza Smriti High School in Pabna Sadar on Sunday, from 10am to 4pm, said a press release.

Dr Enamul Karim and a team of doctors of Pabna Eye Hospital & Phaco Center provided treatment to patients at the camp. The camp's goal was to identify and treat underprivileged people who needed eye surgery, medicine or eyeglasses but were financially unable to seek treatment.

A total of 823 underprivileged children and adults received treatment. Among them, 105 patients were diagnosed with cataracts and 330 with refractive errors, and 285 eyeglasses were provided.

The rest of the refractive error patients

will receive eyeglasses on Monday at the school. Corrective surgeries and eyeglasses will be free of cost. A total of 625 patients received medicine from the camp, and cataract patients will receive surgery from tomorrow at Pabna Eye Hospital.

The camp was held in memory of late Faraaz Ayaaz Hossain, who passed away in the Holey Artisan attack while standing by his friends.

Founder and Executive Director of DCI Dr Ehsan Hoque sent a special message for the eye camp, wishing for great success.

Mosharaf Hossain, chairperson of Pabna Sadar upazila, attended the camp as chief guest. Krishbid Dr Shamsul Hossain; Awal Kabir Joy, chairperson of Department of Social Work, Pabna University of Science and Technology; and renowned businessperson and social worker Humayon Kabir Pavel, Tahmeed Ibne Mazhar from Faraaz Hossain Foundation attended among others.

Forum (BIPF), Manusher Jonno Foundation (MJF), Bangladesh Somajtantrik Dal, Communist Party of Bangladesh (CPB), Bangladesh Environmental Lawyers Association (Bela) and Kapaeng Foundation, expressed solidarity at the event.

Conducting the session, BIPF General Secretary Sanjeeb Drong said, "The plan to establish a five-star hotel on the ancestral land of Mro people is a sin and crime. We can't make such imprudent plans just because we have money."

"It is their ancestral and traditional land. Only they have the right to decide what they will do with it. They have a right to say 'no', and we must respect such democratic rights."

Cultural personality Mamunur Rashid said, "Development doesn't mean only buildings. Why must the natural environment be destroyed by building these structures? Let them [Mro people] live their lives."

Workers Party of Bangladesh General Secretary and MP Fazle Hossain Badsha said, "Chimbuk is a place of natural beauty. A miscreant group like Sikder Group has been permitted to build a hotel there. These miscreants have now turned into the owners of Bangladesh."

"Bangladesh is not a place to look for any corporate group," he added.

Dhaka University Professor Robaet Ferdous said, "There's no quality primary and high school there. Then why will there be a five-star hotel? For whose interest? Is it for corporate people to have fun and

get entertained? I ask the government to establish schools, colleges and quality hospitals there first."

"It has been 50 years since our independence. We believe the state doesn't only need to be neutral in terms of religion, but also race, language and gender," he said, adding that a state should be based on pluralism, not monolithic ideology.

MJF Executive Director Shaheen Anam said, "The demand of the Mro people is only to live on their ancestral land, maintaining their language, culture and livelihood. Is it too much for a community to ask?"

"No democratic and people-friendly government can allow the eviction of such a large number of people," she said, adding that Mro people's lives and livelihood will be endangered in the name of development.

Seeking attention of the prime minister, DU Associate Professor Zobaida Nasreen urged Sheikh Hasina to intervene and save the community's land.

Bela Chief Executive Syeda Rizwana Hasan said, "The constitution says that it is the responsibility of the state to save the environment. If hotels and eco-resorts are being built, then how will there be hills and forests for the next generation?"

"Bandarban itself is a five-star hotel. The entire Bandarban is an eco-resort. Why must there be a separate five-star hotel?" said Rizwana, emphasising the environmental significance of Bandarban.

Jatiya Adivasi Parishad President Rabindranath Soren, CPB central leader Ruhin Hossain Prince and Parbatya Chattogram Nagorik Committee President Goutam Dewan were also present at the event.

The case was investigated by Inspector Md Shafiqul Islam of Jalalabad Police Station, and he pressed charges on May 6, 2018.

In the charge-sheet, Foyzul, his associate Sohag Miah of Sunamganj's Derai upazila, father Mawlana Atiqur Rahman, mother Minara Begum, uncle Mawlana Fazlur Rahman and brother Enamul Hasan are accused.

The investigation officer stated that Foyzul was working at Quran Sunnah Research Centre at Surma Market in Sylhet, after failing to complete his Alim from an Alia madrasa.

Inspired by his Kuwait expatriate uncle Sadiqur Rahman, he started learning more about radical Islamism. After listening to sermons of Muhammad Jasimuddin Rahmani and reading his book, which supposedly promoted the idea of killing a number of notable personalities, Foyzul decided to act.

He then downloaded a book titled "Easy Strategy to Kill Silently", according to the investigating officer.

Meanwhile, he befriended Sohag Ahmed, who also supplied resources to Foyzul, which provoked him to attack Dr Iqbal. Before the attack, Foyzul scouted the campus several times to plan the attack. The plan and attack were carried out by him alone.

In the charge-sheet, Foyzul was accused of attacking, while Sohag of provoking and helping Foyzul and his family to hide his radical mentality and evidence.

However, Jasimuddin Rahmani, whose sermons and books greatly instigated Foyzul, was not indicted in the case.

Sammilito Sangskritik Jote president Golam Quddus, Ekushey Padak awardee Ramendu Majumdar, filmmaker and cultural personality Nasiruddin Yousuff and Lily Chowdhury's son Asif Munier Tonmoy, among others, spoke at that time.

Ekator Ghatak Dal Nirmul Committee, in a statement, expressed deep shock at her death.

"We express our deep condolence to the bereaved family members and recall her (Lily Chowdhury) contribution in enhancing movement against fundamentalism and communalism in Bangladesh," the statement said.

Lily Chowdhury passed away on Monday evening at her Banani residence at the age of 93.
