Targeting users in upscale neighbourhoods, organised syndicates have been smuggling in high-priced crystal meth over the last few years, much to the concern of law enforcers and narcotics control officials.

The highly addictive drug, also nicknamed ice, arrives in Bangladesh from Malaysia, Thailand and Myanmar, and the syndicates often use expatriates travelling back home as carriers, according to investigators.

At least two to three consignments of the drug, each weighing around 0.5kg-1.5kg, have arrived every month over the last three years through the

BASIC BANK SCAMS Fate of 56 cases still up in the air

The five-year tenure of the Anti-Corruption Commission is about to end and a

new one is to take charge this month but the fate of the probes into 56 cases filed in connection with the BASIC Bank loan scam remains uncertain.

Whenever asked about progress in the last five years, the ACC sounded like a scratched record. It always said it had failed to find the Tk 4,500 crore siphoned off from the bank between 2009 and 2013.

Dissatisfied with the ACC's delays, the High Court in 2018 even raised the question of whether the investigation officers was in "connivance with the SEE PAGE 2 COL 1

Existing problems should be resolved thru' discussion

PM tells visiting Indian external affairs minister

UNB, Dhaka

Minister Sheikh Hasina Prime yesterday said the existing problems between neighbouring countries need to be resolved through discussions.

"There might be problems among neighbouring countries. The problems should be resolved through negotiations and discussions," she told visiting Indian External Affairs Minister Subrahmanyam Jaishankar when he met her at the Gono Bhaban.

PM's Press Secretary Ihsanul Karim briefed reporters after the meeting. The Indian minister praised Hasina's

leadership for meeting the eligibility criteria for Bangladesh's graduation from the LDC group to a developing country.

"It's a great achievement. The development of Bangladesh is miraculous," Jaishankar was quoted as saying.

About Covid-19, Hasina said Bangladesh took prompt actions to check the pandemic by engaging all concerned, including physicians, law enforcers, members of the armed forces and the administration.

The PM said Bangladesh launched a nationwide vaccination programme last month. "The [inoculation] programme is being rolled out in phases as it aims to include everyone

She appreciated the support received from India on Covid-19 vaccine.

Hasina said the economy of Bangladesh is progressing despite the pandemic, recent floods and cyclones.

Its remittance inflow has also increased during the period, she added.

She said the government also extended support to Bangladeshi expatriates who returned home during this tough time.

reaffirmed Jaishankar India's commitment to assist Bangladesh in facing the pandemic. "We all of this region face difficulties due to the Covid-19 pandemic."

He said it is a great honour for India to participate in the celebrations of Bangabandhu's birth centenary and Golden Jubilee of the independence of Bangladesh.

The Indian minister said he had a fruitful meeting with his Bangladeshi counterpart AK Abdul Momen over Prime Åinister Narendra Modi's visit to Bangladesh to join the Golden Jubilee celebrations.

Jaishankar presented two books, including one titled "Liberation War of Bangladesh" written by his father K Subrahmanyam, to Hasina.

The Bangladesh premier also gifted seven volumes of a 14-volume book titled "Secret Documents of Intelligence Branch on Father of the Nation Bangabandhu Sheikh Mujibur Rahman" to the Indian minister.

Jaishankar arrived in Dhaka on Thursday morning on a brief official visit to Bangladesh at the invitation of Foreign Minister Momen.

PM's International Relations Affairs Adviser Gowher Rizvi, Principal Secretary Ahmad Kaikaus, and Indian High Commissioner to Bangladesh Vikram K Doraiswami were present.

country's various airports, mostly from Malaysia.

It is sold to affluent people living in upscale neighborhoods -- 10g at minimum Tk 1 lakh, said Detective Branch officials.

Crystal meth is the common name for crystal methamphetamine, a powerful drug that affects the central nervous system. It comes in the form of clear crystal chunks or shiny bluewhite rocks.

Use of the drug poses high risks of stroke, heart attack, teeth decay, and permanent hallucinations, among other short and long-term health effects, according to the website of the US National Institute on Drug Abuse.

Smugglers use different techniques such as calling it a "gold-melting chemical" to deceive law enforcers, according to the officials of Dhaka Metropolitan Police, which is currently investigating a case regarding the smuggling and sale of crystal meth. The case was filed following the

arrest of six people from Bashundhara, Gulshan and Banani areas in the capital n November 4 last year. During the drive, the arrestees were found in possession of around 600g crystal meth. The six include the drug syndicate's

clandestine market of crystal meth has started to grow in Bangladesh.

On Wednesday, a team of the Department of Narcotics Control (DNC) recovered 2kg of it from Teknaf upazila. DNC officials said the consignment

came to Myanmar from Thailand and then entered Bangladesh through the Teknaf border, an established gateway for yaba. Its destination was Dhaka.

Ón June 28, 2019, DNC arrested a Nigerian national from Dhaka with around 500g of ice. It was learnt that the drug came to the man, Ajah Anayochukwa Onyeanwusi, through a parcel service from Uganda.

December 15 last year, Myanmar's On February 27, the department busted a narcotic manufacturing lab officials claimed that they have seized ams or meth from Jhigatola in the capital. The drug reportedly came from Thailand to Bangladesh, said DNC officials.

Modi to visit Tungipara, Barishal

Alongside Bangabandhu Memorial in Tungipara, Indian Prime Minister Narendra Modi is likely to visit Orakandi, a sacred shrine of the "Matua" community in Gopalganj, and "Satipith" in Shikarpur, Barishal, during his upcoming Bangladesh visit.

Modi is set to visit Bangladesh on March 26-27 at the invitation of Prime Minister Sheikh Hasina to join the 50th anniversary celebration of the Independence of Bangladesh, the Birth Centenary of Bangabandhu, and the 50th year of Bangladesh-India diplomatic ties.

The Indian premier is set to visit the Bangabandhu memorial in Tungipara to pay homage to Bangladesh's Founding Father Bangabandhu Sheikh Mujibur Rahman on March 27 and on the same day he is expected to visit Orakandi temple and "Satipith".

Diplomatic sources told BSS that if everything goes well PM Modi is likely to visit Orkandi Temple to pay homage to Harichand Thakur, the founder of the "Matua" community and "Sugandha Shaktipith" (Satipith) in Shikarpur in Barishal district.

Khaleda may take Covid vaccine jabs

BNP Chairperson Khaleda Zia seems to be positive about taking Covid-19 shots, but she is yet to give consent to t, says her personal physician.

Party leaders said there is a question over how 76-year-old ailing Khaleda will be vaccinated as she is not free. She is now staying at her Gulshan home as the government suspended her sentences for 12 months in two phases.

She was freed on two conditions -she will not leave the country and will receive treatment at her home.

"Chairperson Khaleda Zia seems to be positive about taking vaccine jabs as all her staffers have already received the shots. She is not free. It is not possible for her to take shots by going to a vaccination centre. Once we get permission, we will complete the registration process," BNP Vice Chairman AZM Żahid Hossain, also a personal physician to Khaleda, told SEE PAGE 10 COL 1

"These cases and their investigations are still ongoing. As the chairman, I am unable to comment on cases under investigation," he added.

Last month, the ACC chairman hinted lightly at the fate of the 56 cases the commission had filed in connection with the scam in 2015.

On February 8, at the launch of the ACC's 2019 Annual Report during a views-exchange meeting, Iqbal said around Tk 3,500 crore out of Tk 4,500 crore had been returned to BASIC Bank.

"Let's wait and see whether the final report is given instead of charge sheets," he said.

Ironically, neither former BASIC Bank Chairman Sheikh Abdul Hye Bacchu nor any of the bank board members were named as the accused in these cases.

wever, some bold steps were taken by this commission under Iqbal's leadership, that offered some solace to justice seekers.

For instance, the introduction of the anti-corruption hotline, 106, was a milestone. Soon after the beginning of the service, the ACC's call center was flooded with allegations, on the basis of which the ACC nabbed several government officials on bribery charges.

Another commendable task carried out by the commission under Iqbal's leadership was bringing several dark spots of corruption at different government organisations to light -- though its recommendations went mostly unheeded, as the chairman himself recently admitted at the viewsexchange meeting last month.

Asked, the outgoing chairman said there are no better alternatives to systemic reforms for reducing corruption and harassment prevalent in the delivery of public services.

Had the government followed the ACC's recommendations, the systemic anomalies, corruption and procrastination prevalent in the government's service-providing agencies could have been mitigated exponentially, Iqbal observed.

He also suggested that the cabinet division takes up the responsibility of implementing and enforcing the antigraft watchdog's recommendations to ensure corruption- and hassle-free services for the public.

Officials investigating the case said all the arrestees themselves were crystal meth addicts.

Regarding the Malaysian connection, investigators said they have already identified three people, including a relative of Chandan, mainly responsible for maintaining the racket from Malaysia.

Assistant Commissioner of DB police Javed Iqbal Pritom told The Daily Star recently that they have already collected some details of the smugglers living abroad.

The DB official, however, refused to disclose further details for the sake of investigation.

COMES BY AIR, LAND

Crystal meth was found arriving in Bangladesh through different airports until last month.

On February 25, Rab-7 arrested two drug peddlers with this drug during a raid in Muzaffarnagar area of Chattogram.

The arrestees were identified as Shafiul Alam, 34, and Yasin Rana, 50. The elite force recovered 150g of crystal meth from their possession.

"We have primarily come to know that the consignment entered Bangladesh from Myanmar but it may have originated from another country," said Major Musfiqur Rahman of Rab-7, involved with the operation. Replying to a question, he said a According to an intelligence official, methamphetamine goes to Myanmar from Thailand and China to be used in making yaba. Sometimes, Bangladesh and India are used as a transit route, said the official

SMUGGLED IN TRAVELLERS' BAGS Syndicate members often convince expatriates that they want to send a gift to their relatives living in Bangladesh and then put the drug inside gift items like packets of coffee and tea, chocolate boxes or blankets, according to investigators.

The drug is also hidden in silica gel packets, and if anyone asks, the expats are coached to say that these are used for removing moisture, they said.

In a majority of cases, the syndicate's local members receive the packets from the airport as soon as the expatriates clear customs and other checks on arrival.

Quoting the arrestees, a high official of DB said if any expatriate refuses to bring a package to Bangladesh, the syndicate would convince him or her by offering an expensive gift. HIGH SOCIETY CUSTOMERS

Investigators claim to have gathered information of over 100 users of ice in the country -- the list includes businessmen, private university students, and youngsters from rich families in Dhaka.

They also claimed that ice and amphetamines were mainly smuggled from China and Thailand to Myanmar, according to sources present at the meeting.

Director (intelligence and operation) of DNC Kusum Dewan, told The Daily Star recently that they were surprised and worried to know about such a huge quantity of ice recovered in Myanmar.

'We have already increased our vigilance and started collecting information about the sources of ice, added the DNC director.

DB police said they have come to know that the persons involved in smuggling crystal meth from Malaysia are also involved in smuggling the drug from China and other countries. HM Azimul Haque, deputy commissioner of DB (Ramna Division) police, said they have already arrested a number of people and drives are on to arrest others involved in smuggling ice.

This drug is more hazardous than yaba, he told this paper, saying people should be made aware and alerted about the side effects of crystal meth.

On February 14, Abdur Rauf Mia, a deputy secretary of the home ministry, directed the DNC to implement the decision of setting up scanners and dog squads at airports and land and river ports to detect narcotics entering the country.

The decision was taken in the first meeting of the national narcotics control advisory committee, held on December 27 last year, virtually presided over by Home Minister Asaduzzaman Khan Kamal.

Demand 66 writers

Sixty-six writers of Bangladesh have issued a statement demanding justice for writer Mushtaq Ahmed, who died in jail custody, and the abolition of the Digital Security Act (DSA).

Stating that criticising government is a citizen's right in any civilised country, they said that this law [DSA] is contradictory to the 39th amendment of Bangladesh's constitution and the Right to Information Act.

The DSA also goes against human rights, they added.

The government has to accept esponsibility for the death of Mushtaq. The persons responsible for the death have to be identified through proper investigation and punished, they demanded.

Cases against cartoonist Ahmed Kishore and others under the DSA must be withdrawn unconditionally they added.

The DSA is an anti-people and oppressive act. That's why it must be abolished, not reformed, they further mentioned

Unconditional release of those arrested and detained for protesting Mushtaq's death must be ensured, they said.

The 66 writers who signed the statement include Abul Kashem Fazlul Haq, Daud Haidar, Anwara Syed Huq, Jatin Sarkar, Anu Muhammad, Shamim Azad, Prof Serajul Islam Choudhury, Imtiar Shamim, Ahmed Rafiq, Kaber Gayen, and others.

Big haul of meth seized

Director General Ahsanul Jabbar, adding that the estimated price of the recovered substance would be around Tk 10 crore.

The rich people are the usual consumers of the substance, Jabbar told a press briefing at the DNC office in the capital's Segunbagicha yesterday.

Officers said this has been the largest consignment of Ice to be caught in Bangladesh.

On November 6, 2020, the Detective Branch of police recovered 600gram of Ice.

In June, 201, the DNC recovered around 500 grams of Ice.

DNC officials said the highly addictive drug is popular in Thailand.

The seized consignment came from Thailand to Myanmar and then to

Bangladesh, said Jabbar.

He added that officers had information about the stash since six months ago, he said.

Jabbar didn't say where the stash was intended to be sold. "It will be disclosed after further investigation."

A case was filed with Teknaf Police Station against Abdullah and his brother Abdur Rahman, who is on the run now.

Officers still don't know who is behind smuggling the drugs into Bangladesh, Jabbar added.

The DNC laboratory confirmed that the substance was 100 percent methamphetamine.

Jabbar said Ice is 100 times more powerful than yaba pills and it can be smoked in pipes, snorted in, injected or swallowed.

The liquidation process began after the board of People's Leasing informed the central bank in April 2019 about its inability to pay back its depositors' money despite maturity of the deposits.

The HC said the situation in People's Leasing resulted in a few hundred depositors and creditors filing petitions with the court.

"When the country is receiving recognition of acquiring financial solvency at the cost of hard work with unquestionable integrity of the head of the government from foreign countries and international bodies, it is really alarming for the nation to notice that a vested group is hatching plots to destabilise the economic

growth of the country.'

The HC bench wanted to directly consult with the chairman of Anti-Corruption Commission, governor of Bangladesh Bank and chairman of Bangladesh Securities and Exchange Commission (BSEC) for solutions to the predicaments regarding PLFSL and other financial institutions.

It invited them to attend a virtual meeting with the court at 2:30pm on March 9.

"There shall not be presence of any lawyer or any other person at the time of the proposed conference," Justice Muhammad Khurshid Alam Sarkar said in the full text of order.

It said if one of the three officials are unable to attend the meeting, the others would not be required to

attend. Instead, an executive director of Bangladesh Bank nominated by its governor, the ACC's director general and BSEC's executive director must be present in court in person on the same date and time, the HC bench said.

The HC said Bangladesh Bank's lawyer Tanjib Ul Alam on February 23 informed the bench that the central bank was trying its best to pursue the high-ups of the finance ministry to accept a proposal put forward by the bank.

"Under the circumstances, this court considers that it has now become obligatory for this constitutional court to directly consult with the heads of the relevant statutory bodies towards resolution of the impasse," the HC judge said.

Draft Hindu property succession law prepared

National-level coalition emphasises equal inheritance rights for men and women

A draft Hindu succession law has been prepared with emphasis on equal rights of both men and women inheritors to their ancestral properties.

The draft "Hindu Succession Act-2020" has been prepared by the national level coalition "Hindu Ain Pronoyoney Nagorik Udyog", said a press release from Manusher Jonno Foundation, which is the secretariat of the coalition. Different aspects of the law was discussed during a webinar yesterday, the

press release said.

The draft copy of the law will be submitted to the law minister, said Rina Roy, director of MJF.

In the draft law, alongside sons and daughters, the rights of inheritors belonging to the "third gender" has also been included.

According to classical Hindu law, all daughters of a man are not equally eligible to inherit.

Unmarried daughters and married daughters with sons can inherit, while childless widowed daughters or daughters with no sons or with no possibility of having sons are excluded. However, property achieved by Hindu women can be inherited by their male successors, said the MJF release.

Due to inequality in inheriting properties, many Hindu women have to face discrimination and torture, even though the country's constitution guarantees equal rights of all citizens, it said.

Aspects of the draft law was discussed at meetings attended by Hindu lawyers, other professionals and representatives of Hindu religious organisations in different divisional cities, according to the press release.

Yesterday, High Court bench judge Justice Krishna Devnath, lawmaker from reserved seat Aroma Dutta, and Hindu community leaders Kajal Devnath and Milon Kanti Datta, among others, addressed the webinar chaired by MJF Executive Director Shaheen Anam.

First metro train leaves Japan for Dhaka

Expected to reach in April STAFF CORRESPONDENT

The first set of metro train left Port of Kobe in Japan yesterday and expected to reach Dhaka via Mongla port next month.

"The train left the port at 18:00 Japan Standard Time [3pm Bangladesh time]," MAN Siddique, managing director of Dhaka Mass Transit Company Limited (DMTCL) -- the implementing agency of the project -- told The Daily Star.

The first train was supposed to leave the port on February 20, but could not -- due to inclement weather, MAN Siddique told reporters on February 28.

"We hope the train would reach Dhaka within April 23 However, it would depend on weather," he said yesterday.

The train would reach a depot in Dhaka's Diabari area via Mongla port. It will have six coaches with the highest capacity of 2,308 in total, according to DMTCL sources.

Mass Rapid Transit Line-6 or MRT-6, country's first ever metro rail, is being built from the capital's Uttara third phase to Motijheel at the cost of Tk 22,000 crore.

DMTCL, in August 2017, signed a contract with Kawasaki-Mitsubishi Consortium for manufacturing 24 sets of trains for the metro rail. Five sets of train were manufactured within December last year. The second train is likely to reach the depot on June 16, and the third on August 13.

The original implementation period of the project was 2012-2024. Prime Minister Sheikh Hasina later directed that metro services from Uttara to Agargaon be made operational by 2019, and from Agargaon to Motijheel by 2020

Prof Nazmul also claimed that he was a victim of local politics of Chandpur district.

"UGC member Muhammad Alamgir, who led the investigation team, is from Chandpur and served the minister's agenda by making me a scapegoat of corruption done by the previous VC," he said.

UGC had launched an investigation on 45 allegations against Prof Nazmul.

Food security deteriorated in Bangladesh: FAO

United Nation's Food and Agriculture Organization (FAO) has placed Bangladesh in a list of countries that require external assistance for food to brave "severe localised food insecurity". The list includes 45 countries, including nine Asian countries.

Economic constraints due to effects of Covid-19, monsoon floods and high prices of staple foods have worsened food security and resulted in increased need of import or humanitarian aid, FAO says.

The information was revealed in the quarterly global report of crop prospects and food situation, published yesterday by FAO's Markets and Trade Division of under Global Information and Early Warning System on Food and Agriculture.

The report is said to be based on information available as of February 2021.

Despite the government's expansion of social safety net programmes, the report quoted official estimates indicating 30 percent of Bangladesh's total population was poor as of June 2020, compared to 21 percent in June 2019.

While poverty levels increased due to income loss and a decline in remittance caused by the pandemic, the country witnessed recurrent floods throughout 2020, causing damages to the agricultural sector and households, and aggravating food insecurity conditions.

Crop damages and increased demands led to soaring prices of rice, and prices in January 2021 reached its highest. It is more than 35 percent higher on a yearly basis since October 2017, constraining access to food.

Is the future of social media audio only?

Social media, as we know it, might be headed for a big change. In the world of texts, photos and videos, an old trick is making a silent, but stomping comeback audio chat rooms.

The trend started off with a buzzing audio only social networking platform called Clubhouse where anyone can host their own shows while others join in to start a conversation or simply just listen in. The platform has been getting a lot of attention lately in Silicon Valley and has had millions of downloads despite being currently only on iOS and invite-only.

What makes Clubhouse a popular choice with users worldwide is the flexibility to just step in and out of a live call with random strangers, celebrities, icons and stars as well as the ability to garner exposure by creating and hosting their own live shows.

It's a world of exclusivity and flexibility that don't require scrolling, interacting and paying attention to visual cues and offers a heightened degree of exposure to an exclusive audience.

The idea of Clubhouse has gotten so popular that it has prompted social media giants like Facebook and Twitter to step in and launch their own competing products. Facebook

is said to be working on one while Twitter has already launched its own, called Spaces.

Twitter announced on Wednesday that it is opening up Spaces to users. Spaces will allow users to join in talk in 'spaces' and soon, start their own 'spaces' as well.

The move by Facebook and Twitter to copy and release their own version of a competitor's product is hardly new. If records have shown anything, it's that products that generate hype enough to be adopted by giants usually catch on and stay on to live. In the past, Facebook has adopted Snapchat's features to create its own 'stories' feature that has, over the years, became immensely popular.

All these hype about the audio only social media has not only generated buzz, but also attracted security and privacy concerns from regulators. Clubhouse has been accused of breaching privacy and of allowing unmonitored, unfiltered content to pass through in the form of live audio broadcast. The company has said that it is reviewing the allegations and concerns and will soon address them in a future update.

Despite concerns, the buzz is all too loud to ignore and as Facebook and Twitter boards the hype train, it will be interesting to see what the future holds for social media.

Ex-Jamalpur DC will never be promoted

Gazette notification issued

Jamalpur's former deputy commissioner Ahmed Kabir, who was made an officer on special duty (OSD) days after a leaked video showed him in a compromising situation with a female colleague last year, will not get any promotion during his service.

A gazette was published in this regard yesterday.

Secretary to the Ministry of Public Administration Sheikh Yusuf Harun told The Daily Star that Ahmed Kabir was punished following the incident in Jamalpur.

He will not be promoted in future and always will remain as deputy secretary, Harun said.

Ahmed Kabir, who was drawing salary in fifth grade under the 2015 national pay scale as deputy secretary, will now on get it in the last tier of the sixth grade.

He will remain in the same post and the salary will be almost half due to demotion, public administration sources said.

Ahmed Kabir was made OSD in August last year, days after a leaked video showed him in a compromising situation with a female colleague. OSD is a post that rarely offers opportunity for work.

Two video clips from the incident went viral on Facebook. Media reports identified the man in it as the Jamalpur DC and the woman as a staffer at his office.

The room seen in the video clip was found to be inside the DC's office premises

Speaking to journalists, Kabir at that time denied the allegations brought against him, calling it a "conspiracy".

The price increases are attributed to stagnant production, limited imports and upsurge in domestic demand due to Covid-19.

The country's 2020 aggregated output of cereals (rice paddy, coarse grains, wheat) was stagnant at 59.8 million tonnes, registering a mere 0.7 percent increase over the previous year. slightly above the country's

five-year average production of 57.4 million tonnes. This was due to bumper Boro and Aus harvests, offsetting Aman crop losses

Fellowship and Special Research Grant at an event held at Osmani Memorial Auditorium in the capital. The PM joined the programme virtually from

her official residence Gono Bhaban. She said no nation can move forward without science education and research so "you have to continue research and the next generation will do the same following your footsteps".

Hasina said the government has diversified education with the establishment of different types of universities, BSS adds.

"We've emphasised on skilled manpower and that is why we've established 18 new public universities from 2009 to develop human resources," she added. The government has also set up high-tech cities,

hi-tech parks and software technology parks to attain economic development through skilled manpower.

The prime minister said after assuming power in 1996, they saw that there was no allocation for research and science education. "So we took initiatives to establish science and technology universities and kept separate funds for research."

She also stressed on the necessity of making the research and development (R&D) wing of every industrial factory effective and stronger.

She said the government has been setting up 100 special economic zones across the country, where research is essential.

The premier also suggested inclusion of digital devices as new items to the export basket.

Hasina said the country's food production has increased because of research, as researchers have developed salinity-tolerant and drought-tolerant varieties of rice while research on water-loggingtolerant rice is going on.

Vowing to establish Bangladesh as a developed country, she said Bangladesh is marching forward and none will be able to halt its progress. "When coronavirus could not halt it, none will be able to do so anymore. It's my belief," she added.

Mentioning that Bangladesh has already sent Bangabandhu-1 satellite to the orbit, she said broadband internet connectivity is being set up throughout the country now. "We'll move forward using sciences," she said.

About reopening of educational institutions, the prermier said the government will be able to open all educational institutes at the end of this March.

She said teachers and employees of the educational institutes are being given priority in the vaccination programme.

month, the college makes us pay tuition of Tk 8,000," he added.

"Apparently the authorities have been enrolling students despite the suspension from health ministry. Now us students are paying the price. We came here with the dream of becoming doctors but those dreams are being crushed by the greediness of medical college authorities," said finalyear student Ashraful Islam, who enrolled in 2014-15 academic session.

There are 20 students in the college who came from Nepal. They have paid Tk 20,00,000 as admission fees.

Demonstrating students told The Daily Star that the college maintained no facilities relevant to their academic area.

The infrastructure falls short in every aspect, and there are no ICU and CCU facilities.

The medical college claims it has 500 beds, but in reality, it has less than half that number of beds. Patients do not come to the hospital as there are no specialist doctors or aboratory facilities. Moreover, Northern Private Medical College has no affiliation with Bangladesh Medical and Dental Council (BMDC) and Rajshahi University, he alleged. The college among those running the medical college.

has a few lecturers but there are no doctors working as professors, said the students.

Due to these issues, district health authorities visited the hospital a year ago and ordered suspension of all activities.

Chuadanga Scam: Charges framed against four

OUR CORRESPONDENT, Kushtia

A special tribunal in Kushtia framed charges against four people in a case filed over using bamboo sticks in place of iron rods in construction of a government-funded building in Chuadanga in 2015.

The four accused in the case are Monir Hossain, proprietor of construction firm Joy International Limited, Ayub Hossain, in-charge of project equipment procurement at Department of Agricultural Extension (DAE), Abdus Sattar, managing director of construction firm Consortium, and Kamal Hossain.

Ashraful Islam, judge of the tribunal, ordered to frame charges against the four accused on Monday in connection with the filed by the Anti-Corruption Commission (ACC) Office in Kushtia, lawyer Al-Mujahid Mithu said on Wednesday.

According to the case statement, construction work of 3,750 squarefeet plant control office and a building, under Phyto Sanitary Capacity Strengthening Project of DAE, in Chuadanga's Darshana municipality started on December 1 in 2015 at a cost of Tk 2.1 crore.

building The was scheduled to be handed over to the authorities concerned in June 2017.

After completion of about 70 percent work of the project, local people staged demonstration on April 6 in 2016, protesting use of bamboo sticks instead of iron rods in the construction work.

Later, DAE formed a probe committee headed by Marina Jebunnahar, senior monitoring and evaluation officer, who filed a criminal with Damurhuda case Police Station accusing Monir Hossain, Avub Hossain, Kamal Hossain and Abdus Sattar in April 12 the same year.

According to the ACC office in Kushtia, ACC submitted the charge-sheet to the court on November 20, 2018.

Agri-loan, key to farming success Shykh Seraj

provided by the Bangladesh Bank. According to the statistics, in six months, from July to December 2020, banks have given loans a total of Tk 12,077 crore (USD 1420 million) to the farmers, collected Tk 14,091 crore (USD 1657 million) from the farmers at the same time. It means, banks have collected 22.53 percent more agricultural loans, compared to the total disbursement. Although, there was a special instruction from the Bangladesh Bank regarding the payment of instalments, farmer kept on paying off their loan instalments. It can be said that our farmers were at the forefront who worked hard towards a sustainable economy during the coronavirus pandemic. In 2020, Bangladesh Krishi Bank has distributed agricultural loans worth Tk 4,636 crore (USD 545 million) and despite the spread of COVID-19, the bank was able to recover Tk 4,000 crore (USD 474 million) that year. Real farmers are not defaulters and they have proved it even during the pandemic. Whenever they failed to repay a small loan, the law enforcers are always there to arrest them, but the big fish manage to escapes through the loopholes of the law.

It is difficult for a farmer to get a loan as we have prolonged negligence regarding the farmers and farming

sector. According to a 2019 study by the International Food Policy Research Institute (IFPRI), farmers in Bangladesh typically borrow more than 81 percent of loans from various private sources, including NGOs, relatives, private banks and moneylenders. The interest rate of these loans is 19 to 63 percent while the interest rate is nine percent at Krishi Bank. But for some unknown reason.

only 6 percent of the total loan comes farmers and policymakers, popularly from Krishi Bank. IFPRI's survey found that 36.4 percent of the total loans were borrowed from NGOs, where the farmer has to pay an interest of more than 20 percent. According to IFPRI, 19 percent of farmers take loans from relatives. 15 percent from the landowner, 11.4 percent come from moneylenders and 3.6 percent from various associations and cooperatives. Farmers get the largest share of the loan from the Krishi Bank, which is about 15 percent. Large, medium and small farmers together get 36 percent of the total loan while marginal farmers get about 5 percent. The total percentage of loan all the farmers get is 36 percent. Sharecroppers, the farmers who cultivate other people's land on lease, do not get this loan. As a result, they have to rely on loans from other sources, including NGOs.

Small NGOs and associations began to form in the districts and upazilas from the 80s to the early 90s of the last century. Along with other developmental activities, these institutions started a micro-credit programme. Institutions thrive mainly on interest earned from loans. But there is no such change in the farmer I have witnessed. The farmer falls into a debt trap and sometimes carry the burden of prolonged loans that they take from NGOs and local moneylenders. Farmer Rafiqul Islam from Natore, at

known as 'Krishi Budget Krishoker Budget' (Farmers' Voices in Budget, aired on Channel i), said he has never seen any political person become poor while doing politics, but the farmers are not well off doing their profession, which is farming. "We don't have capital, no one thinks about our market, no one talks about us," Rafiqul angrily said. Such anger doesn't only come from Rafiqul, but almost every farmer bears the same agony. Most importantly, the moneylenders expanded their business by capitalizing on the poor state of the farmers and they never want them to get out of this vicious circle of borrowing money from the locally-rich and powerful people.

Usually, the prices of fruits and crops are not that well during the season. So if the crop is preserved, the farmer would probably get a higher price during the off-season. After harvest, a farmer has to sell the crop for two reasons. Small and medium farmers do not have any arrangement for crop storage. After taking loan at a high interest from a moneylender, it becomes obligatory to repay the loan in time. Usually, the farmer has to sell the crop from the land to repay the loan. Otherwise, he will not get a loan from the moneylender for the next crop. According to a recent research report by Bangladesh Rice Research one of the open-air discussion among Institute (BRRI), farmers have to sell 52 that case, they have to submit the lease more earnestness.

percent of their surplus paddy within a month at the beginning of the season. In one to two months 25 percent paddy has to be sold, in two to three months 18 percent and in four months or more 5 percent. However, if the farmer had three to four months to repay the loan and there was a system to save the crop, they could have benefited a lot. Once upon a time in this country, farmers used to get loans by storing grains in food storages. That excellent project called 'Foodgrain storage loan project' was stopped by the muscle power of the moneylenders.

Another problem regarding loans is arranging loans for landless farmers and sharecroppers. According to Bangladesh Bureau of Statistics (BBS), 19 percent of the 35.5 million agricultural households in the country are sharecroppers. According to this calculation, the number of sharecropping families in the country is more than 65 lakh (6.5 million). There are about 23,23,270 (2.3 million) landless farming families in Bangladesh and these families are directly engaged in farming, by leasing other people's land. According to the existing agricultural loan policy of the government, the owner of land up to five acres will get a maximum loan of Tk 2.5 lakh (USD 2964) and they have to mortgage their land. Those who do not Government banks specialized in have land will also get this loan, but in agriculture should come forward with

agreement. But the reality is different. Last year, when the government announced stimulus package for farmers, considering the coronavirus outbreak, Bangladesh Bank promised to provide loans at an interest rate of Tk 4 percent. However, many sharecroppers called me and said they didn't get any loan. They had leased the land but they did not have any contract, since the landowner doesn't usually provide the agreement. This is because if the land is allotted through a written agreement, the landowner has to pay a certain amount of fee to the government.

I can see some ray of hope amid frustration regarding loans. I have always been an optimistic person. I believe that one day everything will be in favour of the farmers. In this crisis of corona, many of us have realized the importance of agriculture. Anyway, I was talking about hope. Last year, I heard that Rupali Bank was giving interest-free loans to farmers for tomato cultivation.

I inquired about their programme with great interest. They gave a loan of Tk 50,000 to 500 tomato growers in Natore through a pilot project. I have repeatedly spoken of such a programme. In my 'Krishi Budget Krishoker Budget' programme, many farmers have shared their bitter experiences on getting loans or failing to receive a loan.

Some have also criticized the debt trap of the NGOs. One day I had a long talk with Rezvi Newaz, special correspondent of Channel i News. I was telling him that in any programme on agriculture, the farmer's end should be considered most. The farmer has to make sure that he gets the right price for his produce. Developing the farming sector and the farmers will be the key to the sustainable development of Bangladesh. I think the real farmer has the right to get a loan at 4 percent interest without any other conditions. Whereas, we see farmers have to take high-interest loans from various NGOs or intermediaries. Where industrialists get loans at 9 to 15 percent interest rate, small farmers have to pay more than 20 percent interest rate. Considering the number of defaulters, write-offs, corruption and irregularities in the banking sector, the government can provide interest-free loans of Tk 15,000 crore to Tk 20,000 crore (USD 1764 to 2353 million) without interest.

Our country is entering the era of agricultural industrialization. Industrialists are investing in farming and agricultural technology is evolving and spreading fast. Small and medium farmers have to survive, otherwise, many will leave the profession and the number of unemployed people will rise. Small and micro-enterprises should be given a chance to succeed. Agricultural loans should be made easy and available.

Modi and Hasina are likely to inaugurate Shwadhinata Sarak that connects India from Mujibnagar; Feni Bridge, Dhaka-New Jalpaiguri passenger train service, and Bapu-Bangabandhu Digital Museum, a memorial for the Indians who were martyred in 1971, officials concerned told this correspondent.

Modi is also likely to visit the memorial of Bangabandhu in a place of worship of the Matua community, in the district.

Dhaka and Delhi are scheduled to sign some MoUs that were discussed in yesterday's nearly two-hour Momen-Jaishankar meeting. The MoUs are on connectivity, trade, water sharing, security, border killing, energy, and post-Covid cooperation.

The Indian minister stressed on connectivity -- rail, road, and waterways.

There are a number of connectivity projects under Indian Line of Credit worth \$7.86 billion. Five rail lines out of total eight that were suspended since 1965 are already operational.

Under MoUs signed between the two countries, India can use Chattogram and Mongla ports to transport goods to its northeastern states. It will allow the landlocked Assam, Meghalaya and Tripura states to access open sea trade routes. India is constructing the roads and rail lines to Sabroom as part of its massive development work in the northeast, according to Indian media.

India-Myanmar-Thailand Trilateral a long-pending issue as the Teesta deal highway to improve connectivity with the Southeast Asian countries.

"India welcomed our proposal and said it will talk to the countries concerned," a foreign ministry source said.

Bangladesh also seeks materialisation of the Bangladesh-India-Nepal Motor Vehicle Agreement. Indian officials say a protocol needs to be signed for this. A Bangladesh official said the government has already submitted a draft protocol to Nepal and was awaiting response.

"The significance of our ties with Bangladesh lies in its centrality for our 'Neighbourhood First' and its growing relevance for our 'Act East' Policy. We see Bangladesh as a key neighbour and a valued partner not only in South Asia but also in the broader Indo-Pacific region," Jaishankar said.

He said after connectivity, India also gives high priority to peopleto-people connectivity, health, education, and culture.

BORDER KILLING

Bangladesh has been raising the issue of border killings before India, urging it to bring the number down to "zero". At a home-secretary-level meeting on Tungipara, Gopalganj, and Orakanda, February 27, Bangladesh asked India to use non-lethal weapons.

According to Ain O Salish Kendra, at least 49 Bangladeshi citizens were killed along the India-Bangladesh border by Indian Border Security Force last year. The figure was 15 in 2018 and 43 in 2019.

the According to Indian government, in 10 years until December 10 last year, a total of 132 Bangladeshis and 95 Indians were killed in BSF firing on the Indian side. During the period, 17 BSF personnel died and 1,110 BSF members were injured in confrontations with smugglers.

Jaishankar said many of the border killings happen deep inside India and the issue was discussed in yesterday's meeting. One needs to ask why the problem is there, he said.

"Every death is regrettable ... so, our shared objective should be no crime no death at the border. I am sure if we can get it right, no crime no death, we can together address this problem effectively.

Covid cases rising again in Europe

Says WHO as 4 nations agree to fasttrack vaccines for new variants

AFP, Copenhagen

The number of new coronavirus cases has risen in Europe after six weeks of decline, the World Health Organization said yesterday.

"Last week, new cases of Covid-19 in Europe rose nine percent to just above one million. This brought a promising six-week decline in new cases to an end, with more than half of our region seeing increasing numbers of new infections," said WHO Europe's regional director Hans Kluge

"We are seeing a resurgence in central and Eastern Europe. New cases are also on the rise in several western European countries where rates were already high," he said. "We need to get $\hat{b}ack$ to the basics. We need to enlarge" the vaccine portfolio, he said.

WHO's Europe region comprises 53 nations and vaccination drives have begun in 45

Meanwhile, Russian Sputnik V shots could soon be doled out across Europe after the EU said it was assessing the vaccine, as Britain and four other nations pushed ahead under a pact to fast-track jabs adapted to fight new strains.

The agreement will avert the need for lengthy clinical studies if authorised vaccines are adapted in future, as long as the manufacturers offer "robust evidence" of their potency and safety, according to the agreement by the ACCESS Consortium.

The consortium comprises Britain's Medicines and Healthcare products Regulatory Agency (MHRA) and counterparts from Australia, Canada, Singapore and Switzerland.

The virus has killed at least 2,561,937 people since it emerged in China in December 2019, according to an AFP tally compiled from official sources yesterday.

US ready to confront China

Says Blinken, vows to engage with Beijing from position of strength AFP, Washington

Secretary of State Antony Blinken has said that the United States was ready to confront China wherever necessary, calling Washington's ties with the Asian power the "biggest geopolitical test" of the century.

In his first major speech, Blinken promised that President Joe Biden's administration will prioritize diplomacy over military action and build cooperation with the world on global challenges such as climate change and Covid-19.

"We will manage the biggest geopolitical test of the 21st century: our relationship with China," Blinken said at the State Department Wednesday.

He vowed to champion the rights of Hong Kong and the ethnic Uighurs, saying that if not, "China will act with even greater

"China is the only country with the economic, diplomatic, military and technological power to seriously challenge the stable and open international system -all the rules, values and relationships that make the world work the way we want it to," he said.

"Our relationship with China will



be competitive when it should be, collaborative when it can be and adversarial when it must be. And we will engage China from a position of strength."

Blinken's remarks come amid a hardening of views in Washington since the turbulent presidency of Donald Trump, who alongside his top diplomat Mike Pompeo made a hard line on China a signature campaign issue and castigated Beijing over the pandemic and trading practices.

Blinken has said he does not fundamentally disagree with Trump on China but believes the United States can be more effective -- through working with allies and, in narrow cases, finding common ground. The Interim National Security

Guidance pointed to climate change, global health, arms control and nonproliferation as areas to seek China's cooperation.

The strategy said that China's leaders too often "behave aggressively and coercively' and vowed that the United States would ["]position ourselves, diplomatically and militarily, to defend our allies.

The Biden administration also pledged to keep up US support for Taiwan, a selfgoverning democracy that is claimed by Beijing.

Blinken also voiced alarm over an "erosion of democracy" worldwide. But he said Biden had no interest in bringing democracy to the world "through costly military interventions or by attempting to overthrow authoritarian regimes by force."

"We have tried these tactics in the past However well intentioned, they haven't worked," Blinken said.

He was likely alluding to the 2003 Iraq invasion as well as the 2011 intervention -- which he supported as part of Barack Obama's administration -- in support of an uprising that overthrew Libyan dictator Muammar Gaddafi, ushering in a decade of chaos.



Observes Indian Supreme Court **OUR CORRESPONDENT,** New Delhi

Expressing a view which is different from a decision taken by the federal government cannot be said to be seditious, India's Supreme Court has observed.

"The expression of a view which is dissent from a decision taken by the central government itself cannot be said to be seditious. There is nothing in the statement which we find so offensive as to give a cause of action for a Court to initiate proceedings," a top court bench said on Wednesday.

The remarks by the bench came while dismissing a PIL seeking action against National Conference President Farooq Abdullah over his comments on abrogation of Article 370 of the Constitution which had given special status to the erstwhile state of Jammu and Kashmir.

A bench of Justices Sanjay Kishan Kaul and Hemant Gupta rejected the PIL and also imposed a fine of Rs 50,000 on the petitioners for making such claims.

The top court was hearing a plea which referred to Abdullah's statement on restoring Article 370 and contended it clearly amounts to a seditious act and therefore he is liable to be punished under section 124-A of the Indian Penal Code.

The petition filed by Rajat Sharma and Neh Srivastava, both belonging to an organisation Vishwa Guru India Vision of Sardar Patel, alleged that the former J&K CM is trying to "hand over" Kashmir to China and thus, he should be prosecuted for sedition.

US House passes police reform act

A sweeping police reform package that bans choke holds and combats racial profiling cleared the US House of Representatives Wednesday, five days before the trial of a white officer charged with murdering African-American George Floyd. The bill is named after Floyd, who died last May 25 at age 46 when then-Minneapolis police officer Derek Chauvin pressed his knee on the victim's neck for more than eight minutes. The shocking killing was caught on video and sparked mass protests across the nation. The George Floyd Justice in Policing Act cleared the House last year but was blocked in the Republican-led Senate, likely scenario for this time too when it heads to senate.

Nearly a fifth of all food

wasted in 2019: UN



Seventeen percent of the food available to consumers worldwide in 2019 -- almost one billion tonnes -- was thrown away by households, retailers, institutions and the hospitality industry, far more than previously suspected, the UN said yesterday. If all the wasted food were packed into 40-ton container trucks parked end-to-end, they would circle the Earth seven times, he said. Nearly 700 million people, meanwhile, go to bed hungry every night, according to UN estimates. Food waste issues will be addressed at the first-ever UN World Food Systems Summit, set to take place in September or October.

Rare 15th century Chinese bowl found at US yard sale



How about this for bargain-hunting? A small bowl bought for \$35 in a yard sale in the US turned out to be a rare 15th century Chinese artifact possibly worth \$500,000. The porcelain bowl -- with delicate floral motifs -- was acquired by a buyer, whose identity is being kept secret, in the northeastern state of Connecticut. Experts said it was painted for the court of Emperor Yongle, the third emperor of the Ming dynasty who ruled from 1402 to 1424. There are only six other such bowls known in the world.

Meghan Markle says Buckingham Palace is "perpetuating falsehoods" about her and her husband Prince Harry, according to part of an interview she has done with Oprah Winfrey.

The explosive claim is the latest salvo in an increasingly heated public relations battle between the British royal family and the US-based couple.

The clip, released Wednesday, came hours after Buckingham Palace said it was investigating claims Markle had bullied household staff in the months after her fairytale wedding to the prince.

"I don't know how they could expect that after all of this time we would still just be silent if there's an active role that The Firm is playing in perpetuating falsehoods about us," Markle told Winfrey.

"The Firm" is a sometimes-derisive name for the British royal family.

Harry and Meghan announced last year they were stepping back from royal duties, in what became an increasingly



acrimonious split from the family.

Their permanent removal from duties was confirmed earlier this year, with the royal household and the couple jockeying to control the narrative of the separation -- and public sympathies.

The interview with Winfrey is due to air in the US on Sunday, and in Britain on Monday.

Harry, who is Queen Elizabeth II's grandson, married Markle in a glittering wedding at Windsor Castle in May 2018.

Their marriage was seen as breathing new life into the centuries-old British monarchy. But relations soon soured and they moved to the US, relinquishing their honorary titles and patronages.

A female doctor was killed in a bomb blast claimed by the local affiliate of the Islamic State (IS), in the eastern Afghan city of Jalalabad in yet another targeted hit, officials said yesterday, just days after three women media workers were gunned down in the area.

Journalists, religious scholars, activists and judges have all been victims of a recent wave of political assassinations across Afghanistan, forcing many into hiding -- with some fleeing the country.

In the latest incident, the doctor was killed after a magnetic bomb was attached to the vehicle she was travelling in, according to a spokesman from the provincial governor's office. A child was also injured by the explosion.

Meanwhile, in the country's restive east, at least seven members of Afghanistan's persecuted Hazara ethnic group were brutally murdered, officials said Thursday.

The group of migrant Hazara labourers had their hands bound behind their backs and were shot to death late Wednesday, according to Nangarhar provincial council member Ajmal Omar.

screening mechanism for online video streaming services, dominated in the country by Amazon and Netflix and which currently are aired freely.

The US streaming platforms have faced complaints from lawmakers belonging to Prime Minister Narendra Modi's Hindu nationlist party and others that some of the shows promote obscenity or offend religious beliefs.

"We are of the view there should be some screening of these types (of content). What they are showing? They are showing pornography also," Supreme Court Justice Ashok Bhushan said.

Traditional film viewing in India, home to the thriving Bollywood industry, has changed as fewer people go to cinema halls and web series have become common, Bhushan said.

The remarks came as the Supreme Court heard a plea from Amazon's head of India content for Prime Video, Aparna Purohit, for protection against arrest in a case involving a controversial political drama "Tandav", a Hindi word for "fury".

Tandav stars top Bollywood actors but has been battling police and court cases which allege the show depicted Hindu gods in a derogatory manner and offended religious beliefs.

The court will continue to hear the case today. Bhushan has asked the government and the


platform to submit details of any regulations that currently govern online video platforms.

Content on these platforms is not subject to vetting. But the government has ordered that the platforms classify content into five categories based on the age groups it would be appropriate for.

Purohit's counsel told the Supreme Court her case was one concerning freedom of expression. Last week, the executive was questioned for nearly four hours by police in Uttar Pradesh in a separate case filed against the show.

Purohit approached the apex court after a state court rejected her request for anticipatory bail, saying the Tandav series hurt religious sentiment and she must cooperate with police.

Amazon this week issued a rare public apology for "Tandav", saying some scenes that were found objectionable had been edited or removed.

Graduating in the shadow of a **PANDEMIC**

Graduating and navigating the start of your career can be daunting even under normal circumstances. The Covid-19 pandemic added more challenging aspects to this experience. The mental toll of taking on a job for the first time amidst a pandemic has weighed down on many young individuals.

Muyeed Murshed, an EEE graduate of BRAC University, co-founded the start-up Catch Bangladesh in 2017. Due to the pandemic, he had to face uncertainties for the future of his business. "Initially I was scared, but after doing some research, I realised that the job market in Bangladesh was not heavily affected due to the pandemic," he said. "Some renowned companies were carrying on their recruitment process at the same rate as before. Moreover, due to the unique circumstances, some organisations implemented friendlier hiring practices." Muyeed elaborated that certain multinational companies have introduced a virtual internship programme, which allowed young professionals from different parts of the country to be eligible, without leaving their homes.

On the other hand, Atish Kabir*, a CSE graduate from IUB, noticed a lack of opportunities on online job portals, especially for full-time employment. "I already completed an unpaid internship. I expected to attain a full-time job after that, but it has been slim pickings for me," he said. "I am working as an intern again at another company, but I hope I will be promoted soon." For many like Atish, navigating the purely virtual nature of applying for jobs, attending exams and appearing for Zoom interviews has been difficult.

Leeyana Rahman, an EEE graduate from BRAC University, had been trying for a while to get a job. "It has been tiring to keep tabs on every relevant job opening and following up with them. When I got rejected from my dream job in the final interview, I decided I needed a break," she said.

Fariha Mahzabin's thesis was delayed, and she also felt the impact of the lack of faculty

complete my undergraduate education. During that time, I lost all inspiration for studying abroad, as I had previously hoped to do," he said. Atanu's family faced financial instability due to the pandemic. Consequently, he picked up freelance jobs, whilst continuing his studies.

Most universities in the country do not hold convocation ceremonies annually. So, this aspect of graduating has not been visibly impacted. Yet, finishing up their undergraduate education from their homes was a strange and sad experience for these students.

Established in 2017, The Johnson & Johnson One Young World (JJOYW) Scholarship Program recognises young leaders who are striving to leave behind an extraordinary impact in healthcare. Awsaf Karim, Founder of Oroddho Health, received this prestigious scholarship. The programme is set to begin on March 15 with a six-month accelerated training, organised by Johnson & Johnson and conducted by trainers from renowned universities. This will be followed by individual coaching from senior Johnson & Johnson leaders.

The highlight of the programme is the One Young World Summit 2021, where the scholars will get to interact with renowned personalities, including Kofi Anan, Prof Dr Mohammad Yunus, J K Rowling, Emma Watson, and Meghan Markle. It will officially end in September, with the scholars being promoted to One Young World Delegates.

The platform provides peer support through their Facebook page. After registering as a client, the person seeking help is assigned to a dedicated member. "If any client requires professional help, we refer them to one of our partner psychologists, and arrange therapy sessions for them at low prices" Awsaf added.

Oroddho Health's Facebook group, Project Uddipok, promotes mental wellbeing of the youth. They encourage creative activities such as art and music to keep the members engaged and active during these difficult times.

Their e-book, *Heal-Ink*, features true stories from people who triumphed over their mental health issues. "We are planning to make the book an annual publication, with a new volume releasing annually," Awsaf added. Their future plans also include collaborating with a team of psychologists, who will provide professional services free of cost, around Bangladesh.

Anondolokey, a hostel for women and girls in Bashundhara, was founded by Moriom Mannan around six years ago. Ahead of International Women's Day (March 8), she talks about her journey with *Star Youth, The Daily Star.*

What began as Moriom's idea of being able to live fearlessly and comfortably around women, became a driving force for her in 2018.

She took part in Bangladesh's Quota Reform Protests to peacefully get the points across, but never imagined that she would be tormented in the streets, and detained by the police for more than 24 hours.

Moriom was living in Dhaka, away from her family in Khulna, before the incident. When she went back to Khulna, she was not welcome. Her family was more concerned about what people were saying about her, as opposed to being concerned about her well-being.

The people at Anondolokey also turned their backs on her. After returning to Dhaka, she found refuge in a hostel at Indira Road. She met a woman named Fatema Khatun by the end of 2018, and they formed a close bond.

Fatema inspired Moriom to continue her work towards Anondolokey instead of aban-

doning it, and eventually, became a shareholder of the hostel. Moriom shared that Fatema is one of the most important people in her life. Her support was essential for Moriom to tread on with her dream to build a safe space for women and girls.

Moriom rents out rooms to women who find it hard to arrange accommodation, as independent individuals. She also provides space to destitute women, free of cost.

Throughout the pandemic, Moriom wit-

nessed an influx of women renting out space to take breaks from their otherwise exhausting lives. She accommodated a pregnant woman and several injured women for weeks, because they were craving space and time for themselves. A young girl's aunt left her with Moriom since the girl's mother passed away and her father abandoned them prior to that. Moriom took the girl's responsibility without any hesitation.

A European woman took refuge under Moriom's care, after she was violated at home. Last year during Ramadan, Moriom cooked meals for rickshaw pullers around the hostel, alongside cooking for the 17 women under her care. "At the cost of wanting to help as many women as I can, I was hurt several times by unfaithful people, but the women at Anondolokey add value to my life," she said. Anondolokey operates under certain strict rules. For example, the women are required to inform Moriom about their whereabouts, in case they plan to come home late.

"In the future, I hope to pay off my debts and get more renters for the empty rooms that I procured," Moriom added.

As a progressive and understanding woman, she is making our community a better place through her efforts.

A case that holds the answers to big questions

Will justice be allowed to run its course?

CCORDING to a report published by this newspaper on Thursday, a CID probe has found L hat former Faridpur Awami League leader Sajjad Hossain (alias Barkat) and his brother Imtiaz Hasan (alias Rubel) amassed Tk 2,535.11 crore beyond their known sources of income. They did so under the protection, and with support, of at least eight other accused in a money laundering case, including the brother of a former minister, according to the probe. Only Tk 9.75 crore of the amount was found in their bank accounts, while the rest was siphoned off abroad.

This is perhaps the first time that a charge sheet has been submitted against someone connected to such a high-profile political family. And we are encouraged to see law enforcers going after these crooked individuals for their widespread corruption, despite their political associations. Once this family was untouchable-as the litany of corruption and wealth gathered all happened due to political protection.

These are not your run-of-the-mill criminals. Their rags-to-riches stories unfolded under political protection And we are finally beginning to see the powerful patrons they had getting exposed. That being said, we also have to express our apprehension about whether this investigation will go to the very end—or whether there will be some political compromise or wheeling and dealing going forward, letting these people escape justice. The reason for the apprehension is simple: we have seen so many instances before where law enforcers go forward only to take a step back later. Only recently, we have seen the son of a high-profile politician being charged with all sorts of crimes, but then suddenly the cases were mysteriously dropped.

So if the government wants to claim that nobody is above the law, this should be a test case of a fair dispensation of justice. With that in mind, we hope the law enforcers are allowed to go through with their investigations without any outside interference or political pressure. Let justice take its own course.

26,695 rape cases filed in last 5 years!

But why is the conviction rate still three percent?

CCORDING to a report by the office of the Inspector General of Police (IGP) submitted to the High Court recently, a total of 26,695 rape cases have been filed across the country in the past five years. As the incidents of rape are on the rise, the number of cases being filed in these incidents have also increased. However, when it comes to the conviction rate in rape cases, the situation is as grim as it was before. Reportedly, the conviction rate in rape cases is still only three percent, with around 97 percent of the accused getting acquittal from the court While the Women and Children Repression Prevention Tribunals (present in all 64 districts of the country) must finish the trial of the rape cases within 180 days of framing charges, the tribunals are not being able to complete the trials within the stipulated time. Delays in filing cases and conducting investigations are like a norm here while submitting the charge sheets takes years in some cases. There is also the culture of rapists intimidating the victims and their families so that they don't file cases or withdraw the cases that have already been filed. In such cases, the rape survivors rarely get protection from the law enforcers. Arbitration or out-of-court settlements are still a reality. And the legal system is still not friendly to the rape survivors in a society that often blames the victims, instead of the rapists, for the rape. Moreover, while ensuring compensation for rape survivors and their families is as important as the prosecution of rape cases, the issue has been largely ignored. We know that a law has been drafted to address compensation for victims of violent crimes, including rape, but it could not be finalised in the last 14 years! However, the High Court recently issued a rule directing the government to ensure compensation for rape victims, which is a positive development. It is also good to know that a monitoring cell has been formed in line with the HC directive to monitor whether the trials of the cases filed under the Women and Children Repression Prevention Act 2000, are completed in 180 days. We hope the cell will discharge its duty efficiently. However, it worries us to learn that a HC bench has recently issued a condition that the accused in a rape case will be granted bail if they marry their victims in jail, given that there was a previous relationship between them. There are so many critical factors including the legal loopholes that contribute to the delay in ensuring justice to the rape survivors. All these factors must be addressed efficiently by our legal system and the society at large to ensure that the conviction rate in rape cases increases. Only with an increased conviction rate may we see a decrease in rape cases across the country.

Why is personal freedom such a plaything of the law enforcers?

Arresting people on flimsy grounds is not rule of law, but its aberration

SN'T personal THE THIRD freedom VIEW one of the most cherished and universally celebrated principles of our civilisation? Isn't guaranteeing this freedom the most sacred task of a MAHFUZ ANAM modern state?

Hasn't individual freedom been recognised as one of the fundamental rights of every person, and as such enshrined in the UN's Universal Declaration of Human Rights? Hasn't that right been pledged to each and every citizen in every constitution of every modern state? Doesn't this-the guarantee of freedom to all-form the very basis of our own constitution? If all the above questions reflect irrefutable truths, then why are we so indifferent, so disrespectful, when it comes to assuring this fundamental right to our citizens?

One of the realities of the present-day administrative and justice systems that worries us deeply is the utter disdain with which personal freedom is treated by people who are in a position to decide whether a citizen will be free or in prison-the government, its law enforcement agencies and, we're afraid, even the justice system. We arrest people so easily, deny bail so swiftly, grant remand at the asking, and care nothing about what it means to the individuals who are at the receiving end of this seriously questionable process.

The provision for bail in our laws is there to ensure the freedom of the accused (not to be confused with a convicted person) while the investigation and trial are on. The bail is a right because the person has still not been found guilty. He has only been accused and the judicial process may find him innocent. So, denying an accused bail is actually punishing him before the judicial pronouncement has been made. Doesn't it amount to miscarriage of justice?

We make the above points not to point out the deficiencies of our justice system-which must also be addressed if justice is to have a real meaning for our people, especially the poor-but to underscore the more fundamental and vital flaw of our habit of undervaluing the notion of individual freedom.

Take the three recent cases for example. Photojournalist Kajol got bail on his 14th attempt while being in jail for seven months and "missing" for two. Cartoonist Kishore got bail on the 7th attempt after being in jail for 10 months. Poor Mushtaq tried for bail seven times, unsuccessfully, and later he died in prison, after 10 months since his arrest

psychologically and mentally. On top of it must put their heads together to make the 3) that the law be amended to safeguard all, physical and mental torture added to a burden that he was unable to cope with. We must immediately move away from the casual and cavalier attitude we take in granting and not granting bail. Personal freedom should only be denied when a person is an "immediate" danger to society and when his staying "free" poses some sort of a threat to others for which the person concerned needs to be denied his freedom and put into prison.

Did any of the above fall into that category? The RAB members who arrested him, the police that kept him incarcerated, the public prosecutors who pleaded against their bails, and the judges who repeatedly denied them bail must answer the question as to what necessitated their being in jail while their cases were being investigated.

Even the dreaded DSA, in section 40, specifies that the investigating officer must complete his work in 60 days. Then, with due permission, it can be extended to an additional 15 days. A further 30 days can be granted by the Tribunal, making for a maximum time of 105 days that an investigating officer can take to complete his investigation.

Kajol got bail after more than 210 days in prison, and Kishore after over 270 days. process of arrest and bail more aligned to the global standards of fundamental rights.

The Digital Security Act (DSA) has not only been a cause for serious injustices to many of its victims but also an example of how self-defeating we sometimes can be, and how we end up damaging our own international image that could have easily been avoided.

Just the other day, the UN recommended Bangladesh for its graduation into the group of developing countries from 2026, and at the same time, the UN High Commissioner for Human Rights, Michelle Bachelet, said, "Bangladesh urgently needs to suspend the application of the Digital Security Act and conduct a review of its provisions to bring them in line with the requirements of international human rights law." One was a global acknowledgement of our success, and the other a criticism of a draconian law that has done us more harm than good.

Let there be no doubt that moving away from the LDC status is a tremendous success for Bangladesh. Given its severely challenging development hurdles and dysfunctional politics of the eighties, nineties and early twenties, few people

When the honourable judge denied bail to Mushtaq, was the fact that he was already in prison for 270 days, and that the investigating authority had gone way past the legally allowable time of maximum 105 days, taken into consideration? Should this failure of the investigating officer be seen as the "weak" nature of the case? Shouldn't this have almost automatically qualified Mushtaq for bail?

According to available information, the investigating officers in all the three above cases did not seek any permission from the higher authority or from the Tribunal for the extra time they took for investigation. Therefore, the only legally allowable time available to the officers concerned was 60 days. The extra time they took were all outside the scope of the law. Instead of denying Mushtaq bail, the judge may have seen it fit to upbraid the investigating officer for failing to do his duty on time. To us, this is a very important point and we urge our respected higher judiciary to take it up suo moto as it concerns the constitutional question of guaranteeing for fundamental rights and implementation of the law. If we still believe in the fundamental principal of our law that a "person is innocent till proven guilty", then we must stop treating "accused" persons as "guilty" and punishing them by denying bail, which is a right of an innocent person.

had expected Bangladesh to rebound as it did. The stability and continuity provided by the present government-which needn't have come at such denigration of democracy-contributed significantly to our present robust economic growth.

However, in the midst of that successful and creditable journey, the government suddenly decided to institute the Digital Security Act, the ostensible reason being the expanding digital universe and the need to control cybercrimes. Our journalistic instinct alerted us to the fact that the real purpose was something else. Though we-representatives of Sampadak Parishad, BFUJ and ATCO—were invited to address our concern to the relevant Parliamentary Standing Committee (we were not invited at the ministerial-level drafting stage, though we were a vital

the interest of journalists. We believe that while formulating the rules for this law, opportunity exists to meet many of our demands and make the law acceptable to all."

Now, looking back over two and a half years since the enactment of the DSA, it appears our apprehensions have proved to be more than justified, and the whole process appears to be drenched in bad faith. There was not even an iota of sincerity in what was being said. The promises that were made by Law Minister Anisul Huq and then-Information Minister Hasanul Haq Inuthat this law would not be used to curb the free press and against professional journalists-have all proved to be hollow. I recall the express commitment by the aforementioned ministers: that during the process of formulating the "Rules" for this law, provisions would be made to accommodate the fears and concerns expressed by the media representatives so that misuse does not occur. In fact, the "rules", as they now exist, maintained all the anti-free press provisions, and in some instances, have made the implementation even harsher.

Our protest against the DSA has been continuous and unrelenting since its enactment in September 2018. Yet it needed the death-in-custody of writercommentator Mushtaq to stir some rethinking. We welcome the granting of bail by the High Court to cartoonist Ahmed Kabir Kishore on his 7th attempt. There are credible claims of torture on Kishore that we demand be investigated.

While we welcome the comments made by our law minister to the BBC, that no one will be arrested or sued under the Digital Security Act (DSA) before investigation, we saw one person arrested under DSA on the same day, Tuesday, in Dinajpur, for allegedly spreading "fabricated information with ill intention". On the same day, a court in Khulna rejected the bail petition of a person belonging to a socio-political group. He was picked up on February 26 and sued under the DSA. The minister's comments will have to be backed up with some immediate and credible actions for us to have faith in his words.

As Bangladesh aspires—and we all rejoice at it—to become a developing country, and at a later stage, a developed one, we must not only build infrastructure for the economy, but must also build "infrastructure" for good governance and justice. We must make our legal system modern so that it can dispense justice fairly, expeditiously and without political influence. A modern judicial system is just as important and necessary as anything else we do to modernise ourselves.



Apparel diplomacy for the post-LDC era



Developed Country (LDC)

status is both a matter of pleasure and of pride for every patriotic person of the nation. After the committee's recommendation for Bangladesh to become a developing nation, the proposal now will be sent to the United Nations Economic and Social Council (ECOSOC) for its endorsement in June this year. The UN General Assembly is scheduled to finally approve the proposal in September. In the recommendation, three

eligibility criteria for graduation such as per capita income, human assets, and economic and environmental vulnerability were considered, all of which Bangladesh met in the second triennial review of the LDC category by the CDP. We all know that our Readymade Garments (RMG) industry, which accounts for more than 83 percent of the country's total export earnings, has largely contributed to this graduation. So this is especially a happy occasion for all

the apparel entrepreneurs, workers and professionals in the country.

However, the growth of our RMG industry has been accelerated by the fact that Bangladesh as an LDC enjoys dutyfree market access to the European Union (EU)—which accounts for more than 60 percent of our total apparel exportsunder the EU's Generalised Scheme of Preferences (GSP)

After graduating to a developing country status from an LDC, Bangladesh will no longer be eligible for the GSP facilities. But Bangladesh will have the opportunity to continue to enjoy dutyfree access to EU countries if it can attain the GSP Plus. In order to be awarded the GSP Plus status, a country must fulfil two criteria set by the EU—namely, products that qualify for GSP Plus must be in the top seven largest exports from the country (apparel is the largest in Bangladesh), and the three-year average of exports of that product cannot exceed 6.5 percent of the total import of that product into the EU. Here, Bangladesh faces an issue, as its apparel export to the EU already accounts for about 9 percent of the latter's total apparel import from the world.

Therefore, Bangladesh needs "apparel diplomacy" to negotiate with the EU and convince them that this threshold should be extended to 12-13 percent, given that the apparel sector is the lifeline of Bangladesh's economy and also considering the EU market's importance

to the industry as a whole.

In view of the impact of the Covid-19 pandemic on our economy, the UN's CDP has recommended that Bangladesh be provided with a five-year time till 2026, instead of the usual three years, to prepare for the transition. In these five years, Bangladesh will remain eligible to get dutyfree access to the EU under the GSP. During this transition period, we need to continue our apparel diplomacy to confirm the GSP Plus for the post-LDC period.

It would not be an exaggeration to say that Bangladesh currently possesses some of its finest and talented apparel diplomats led by the Senior Foreign Secretary who himself has proved his mettle in the field. What we need is close collaboration between the industry and the government to secure Bangladesh's interests in the changing apparel landscape. It's worth mentioning here that the export threshold was extended from 4 percent to 6.5 percent when Pakistan was awarded with the GSP Plus. So, I believe with the industry insights, expertise of our civil servants, and the vision of the government, Bangladesh is well-placed to pursue the required apparel diplomacy for securing the extension of the threshold to around 12-13 percent.

Forming a joint taskforce with the Ministry of Foreign Affairs, Ministry of Commerce, and Bangladesh Garment Manufacturers and Exporters Association (BGMEA) would be really effective to

perform the required apparel diplomacy for attaining GSP Plus.

Nevertheless, our RMG industry can no longer just depend on the two traditionally preferred business markets: the USA and the EU. While we need apparel diplomacy to keep the benefits of the traditional markets alive, we should also explore and exploit non-traditional markets like Japan, South Korea, Russia, Latin American countries, and even China and India.

The recommendation for Bangladesh's graduation came at a time when the country is ready to celebrate the 50th anniversary of its independence and the 100th birth anniversary of the Father of the Nation, Bangabandhu Sheikh Mujibur Rahman. So, it's a moment to celebrate and also an occasion for making our footings stronger. Further strides in the economic journey of any country come with certain conditions. We can no longer expect to rely on favourable or subsidised trading terms-we have to learn to evolve, adapt and survive among the fittest. We need to develop an industry that is fitfor-purpose for the years ahead. It's time to pursue active apparel diplomacy from both our government and representative trade bodies to ensure the continuation of a fruitful relationship with our largest apparel trading partners.

'ACC guidelines can help prevent systemic graft in government offices'

Iqbal Mahmood took charge of the Anti-Corruption Commission (ACC) five years ago with the goal of curbing graft. During these years, he took several bold steps like bringing reforms in the enquiry and investigation processes, introducing a hotline service and pinpointing loopholes and pockets of corruption within government organisations. Yet he had to face criticism for the long delay in investigating the BASIC Bank loan scam and failing to nab the big fishes. As the ACC chairman nears the end of his term this month, he shares his experience, achievements and expectations with The Daily Star's Mahbubur Rahman Khan.

How do you view your journey at the ACC?

First of all, the Anti-Corruption Commission (ACC) is a statutory body tasked with combating, preventing and controlling corruption and also promoting the best practices in professional conduct. My responsibility as chairman has been laid out in the Anti-Corruption Commission Act of 2004. It states that my sole duty is to execute the ACC's legal mandate to fight against corruption. This inherently puts the chairman in a precarious position as a just, indiscriminate application of the law will undoubtedly cause some negative opinions. Our goal has always been to let the law take its due course. I can say with utmost confidence that the commission has functioned in accordance with the law during my tenure.

I carried out my responsibilities with absolute impartiality. I am privileged to have had the support of the civil society, the media, politicians, the administration, my fellow colleagues and the public in general during the last five years. And I would like to take this opportunity to express my sincere gratitude to all those who supported the anti-corruption mission of the commission.

Can you recall any particular struggle you've had while bringing major changes in the ACC during your tenure?

After joining ACC, I thought about how we could turn ACC into an institution that people could rely on. It is my firm belief that no institution can achieve its goal without public support. Without an integrated action plan, it is not easy to deal with offences like corruption. Hence, we took the initiative to formulate an action plan for the ACC, and in 2017, the ACC's Five-Year Strategic Action Plan was approved. This plan details multi-dimensional initiatives regarding inquiry, investigation, prosecution, administration, monitoring, evaluation and prevention. Before the approval of this strategic plan, the commission consulted with the media, members of civil society, NGOs, teachers, students, bureaucrats, politicians, development partners, etc. Including vital members of society in forming our plan resulted in it being an instrument that would enable us to effectively and unwaveringly work for the people of this country. We started our journey with confidence. The public will be pleasantly surprised to know that the ACC has apprehended approximately one thousand perpetrators involved in corruption cases without the use of any firearms during my tenure. Even though ACC officials arrested offenders in the late hours of the night and, sometimes, were attacked by miscreants and suffered injuries, we did not slow down our operations. We have become successful to an extent that the public can rest easy knowing that no one is above the law. The law will apply to all people regardless of their position, and will inevitably take its course.

of the money involved with the BASIC Bank scam, while we've seen the IOs being able to trace the money in PK Halder's case so quickly. Why this difference? Is it a failure on the part of ACC? This is a question I get asked often, and rightly so, because of the gravity

of the crime. One has to take into account that these cases were lodged with the ACC before its restructuring. These cases and their investigations are still ongoing. As chairman, I am unable to comment on the cases under investigation, but it is a fact that the commission has already instructed the IOs to trace the destinations of the siphoned money relating to the BASIC Bank scam. The IOs are working tirelessly to complete the investigations. In the meantime, many new cases generated from the BASIC Bank scam were lodged, and many more will be lodged in the coming days. These are ongoing matters, but the perpetrators will

reforms than our guidelines. The systemic anomalies, corruption and procrastination prevalent in these organisations can indeed be mitigated exponentially after thorough examination and strict implementation of the laid-out recommendations

The Cabinet Division, being responsible for matters concerning the ACC and for inter-ministerial coordination, can take up the responsibility of implementing and enforcing these recommendations as per their discretion. The public would be pleased to know that some of the recommendations were, or are, already being implemented by some of the government agencies.

There was renewed hope after the introduction of 106 hotlines. But we've seen a drastic drop in the number of bribe-mongers caught red-handed after the enactment of the Public Service Act 2018, which prohibits arrest of any public

undoubtedly be brought to justice in due time. In order to carry out this justice effectively, the ACC has to complete a transparent, detailed and credible investigation.

One of the commendable jobs of the commission during your tenure was enquiring into servant on criminal charges without the government's approval. Isn't it one kind of interference in ACC's work on fighting corruption? What is your opinion?

I can confidently say that the ACC did not stop nabbing bribe-mongers after the enactment of the Public Service Act, 2018. On the contrary, a significant number of public servants were caught red-handed while taking bribes. More than 16 trap cases were launched during 2019 with the goal of catching bribe-takers red-handed. Similarly, in 2018, the commission made 57 arrests, while in 2019, the number rose to 123, which was about 116 percent higher than that of the preceding year. This indicates that the Public Service Act did not hamper the ACC's operations. The purpose of the act is to prevent government officials from engaging in corrupt practices, especially while carrying out public duties. The ACC seems more comfortable with dealing with illegal asset cases rather than handling real-time corruption. What are the reasons behind it? Taking legal action against entities in possession of ill-gotten wealth is a legal mandate of the ACC. Moreover, article 20 of our constitution states, "The State shall endeavour to create conditions in which, as a general principle, persons shall not be able to enjoy unearned incomes ... "

The commission proceeds with legal action on the basis of specific allegations relating to offences as stated in the Schedule of the Anti-Corruption Act of 2004. This has nothing to do with comfort or preference, but everything to do with the exact fulfilment of the commission's legal mandates. The National Board of Revenue

According to the Transparency International Corruption Perceptions Index, Bangladesh's status has deteriorated. What can be done to reduce the magnitude of corruption in the country? Corruption is a global problem. It is rampant in many countries of the world. Recently, the TI published

to assets but often controversy is created at the time of enquiry and investigation, as the ACC found those illegal. Where are the loopholes? How can these be resolved?

The main functions of the National Board of Revenue are to assess, collect and manage taxes or duties for the exchequer. Generally, the tax collectors are less concerned about the sources of income. On the other hand, the responsibility of the Anti-Corruption Commission is to take lawful action against those who have earned assets beyond known sources of income. Pursuant to sections 26 and 27 of the ACC Act of 2004, and the Money Laundering Prevention Act of 2012, action is taken against entities that have accumulated assets by means of taking bribes, engaging in corruption or via any other illegal means. The ACC is bound to

its report on the Global Corruption Perceptions Index in which Bangladesh seems to have moved down in rank. During the same time period, the TI published another report (The Global Corruption Barometer: Asia 2020) where it was indicated that 86 percent of the people in Bangladesh had confidence in the ACC. This goes to show that not all factors were considered in generating these reports. This is natural as these organisations operate as outsiders, and as a result, are unable to take into account all aspects of our situation in Bangladesh.

Empirical data, which they have less of, is vital in order to look at the bigger picture. We should treat these reports as optional tools in our arsenal which we may or may not learn from—in other words, less focus on hard numbers and more

focus on actual groundwork. The reality of this world is that it more often does not correspond with concrete values and data. Whatever comes our way, we will have to analyse, adapt and overcome. Things have always been this way. Therefore, it is not worth our time denying that corruption in Bangladesh persists in a wider expanse. The commission has devoted much of its effort to combatting, controlling and preventing corruption and will continue to do so. As we have learned over time, hard work will pay off, resulting in better days in the future.

What needs to be done to make ACC more vibrant?

The commission is constantly working on revising, modifying and reinventing its legal tools and techniques. Whatever we might lack in capacity we make up for it in our sincerity. This is a continuous process. I believe we should continue to emphasise the need for engaging with the public as, according to our constitution, all the power in the Republic of Bangladesh belongs to the people. We should create an environment where people have a bigger platform and role in fighting against corruption. We still have a long way to go regarding raising public awareness against fighting corruption, but we are well on our way there.

What is your plan after retirement?

I have had the opportunity to serve the nation in various capacities for the last 40 years of my life. I have many good memories. However, the harsh reality is that I feel I was unable to give enough time to my family. I plan to make up for the lost time with them. I also have plans to pass on my experiences and knowledge to the future generation so that I am able to serve my beloved country in another capacity (teaching).

The court may decide whether to grant Iqbal bail in the cases if the ACC failed to submit the charge sheets in two and half months, the HC said in the verdict.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Mohi Uddin Shamim gave the orders while disposing of 20 bail petitions filed by Iqbal.

The countdown to the two-and-ahalf month period will begin the day the ACC receives a copy of the verdict, Deputy Attorney General AKM Amin Uddin Manik told The Daily Star.

The ACC filed the 21 corruption cases in 2015 accusing the businessmen and bankers of embezzling around Tk 700 crore by inflating the prices of mortgaged properties of borrowers at the bank.

Iqbal, who was sent to jail on July 12, 2019, secured bail in one of the 21 cases from the HC earlier.

The HC yesterday asked the state and the ACC to explain why Iqbal should not be granted bail in the remaining 20 cases, DAG Manik said.

Hearing the petitions on Wednesday, the HC bench said the accused caused financial damage to the state and the inflating of the prices of properties must stop.

Merits of the cases will go to waste and the corruption accused will get bail if it took so long to submit the charge sheets, the bench observed.

On Wednesday, the HC heavily rebuked the ACC for its failure to submit the charge sheets in more than five years.

"If the corruption watchdog fails to discharge its responsibility, how the corruption and irregularities will be eradicated?" it said.

Lawyer Momtaz Parvin represented Iqbal, while Khurshid Alam Khan and AKM Fazlul Hoque the ACC during the hearing on the rules.

According to a Bangladesh Bank enquiry, between 2009 and 2013, about Tk 4,500 crore was swindled out of BASIC Bank.

"I said I did not and that this was a conceptual cartoon about nature healing the world during the pandemic," said Kishore.

Kishore said they showed him one cartoon after another and asked about the characters he drew -- they asked regarding all of the female characters if they were the PM, and regarding all the male characters if they were the Father of the Nation.

"I got mad and asked, Bangabandhu has a mark on his face, does this cartoon have one? They then hit me on the leg with a thick stick with a steel knob on the tip. There were four sticks displayed in the front to hit me with," he said.

Kishore lashed back and said they don't understand cartoons.

"A person got up, and slammed both sides of my head with his palms.'

Kishore felt a searing pain shoot through his left ear that is when his ear drum burst, he said.

The interrogation went on for a while, and each time Kishore fought back and refused to give in to their line of questioning, he was hit. "They hit me at the back of the head because my cap was up.

He was hit on the back, on his legs, behind his head. "They asked me for the passwords of my email and social media accounts. But by then I was not hearing anything in my right ear, which was bleeding. So, they had to write out the instructions for me, and I responded in writing," he said.

They continued interrogating him about the "I Am Bangladeshi" Facebook page, which used to share his posts, and asked him about how he knew Swedish-Bangladeshi journalist Tasneem Khalil, Hungary-based businessman Saer Zulkarnain, and Germany-based blogger Asif Mohiuddin. They also repeatedly interrogated him about a prominent businessman who had featured in one of his cartoons

In addition, Kishore said that he was interrogated about radical extremists and about whether he was involved in the blogger killings.

"I said that my friends were the ones being attacked and killed," he said.

"I was in the room for between four and five hours. That is when they hauled him out. He saw that his entire I heard the azaan once, and there was a strong smell of petrol which made me sneeze. There was also a lot of noise from cars," he said.

At one point, Kishore told them that he needed to go to the bathroom, or that he would soil his clothes. "The bathroom was not smelly or dirty but there was a lot of blood on the floor. I was still blindfolded, but I saw from beneath the edge of my blindfold," said Kishore.

He requested that the blindfold be removed while he uses the toilet, but his captor prodded his back with a stick and ordered him to walk up front and urinate.

After a while, he was sent back to the first room.

"I was in a lot of pain and blood was pouring out my 'Dhaka-Metro Sho-1812' or something like that. There nose and ears, but I was determined to not stay in there. I even stood up and opened the door, but two people came up and said they would kill me if I move. They told me they had not done anything to me yet."

In the early hours of the morning, a person with a crew cut came into his room and gave him stale pulao and meat to eat.

A few hours later he was taken back into the interrogation room, and round after round of questioning and torture continued.

"I lost sense of time and days. I was only fed twice -- the first one was the spoilt pulao and the second was a packet of something, but there was so much pain in my mouth that I could not eat," said Kishore.

At one point, during evening time, Kishore said his captors took him to Rab-3's office in Khilgaon.

Khaleda received treatment at Bangabandhu Sheikh Mujib Medical University Hospital when she was in jail.

She is suffering from rheumatoid arthritis, diabetes, and ophthalmological and dental ailments

The BNP chairperson landed in jail on February 8, 2017 after being sentenced to five years' imprisonment by a special court in Dhaka in the Zia Orphanage Trust graft case.

On October 30 the following year, the High Court enhanced her punishment to 10 years after dismissing her appeal in the case.

The former premier was convicted by another special court in Dhaka in the Zia Charitable Trust corruption case on October 29, 2018. She was sentenced to seven years' rigorous imprisonment by the court.

He said the journey took around 40 minutes.

"I counted the minutes meticulously. They did not beat me inside the car, but when I kept asking why I was arrested, they just said 'Don't talk so much'," he added.

In between, the car stopped at a place and the men stood on the road and ate iftar. "I realised I could lift up the cap using the two index fingers of my handcuffed hands, and when the car stopped, I lifted only enough to be able to see through the rim," said Kishore.

He said the place where they stopped had a mechanical roadblock. As the men ate, Kishore took a few minutes to gauge his captors.

There was a house and a person got out of the house and went into a car -- I did not see his face but I saw his shoes. He was wearing moccasins. There was a person sitting in the seat in front of me. In his hand he had a cell phone and I caught a glimpse of the screen -- there was a map of some sort and a black text box with numbers. He kept moving the numbers around his screen with his fingers," said Kishore.

After iftar, the car resumed its journey again. "When the car stopped, I was told to get out. I tripped and stumbled and fell down, and it was then that they shoved and dragged me. I was dragged into a room, still blindfolded," narrated Kishore.

He felt his way around the room and found three plastic chairs. "The floor was tiled, but it felt old, scuffed, damp and slimy. There was an air-conditioned room nearby, because as I was brought into this room, I felt a blast of cold air coming from somewhere. A person came in -- he took my hands, which were cuffed in front of me, and cuffed them behind my back," said Kishore.

He kept begging for food, saying that he is diabetic and cannot go long periods without eating, but nobody responded.

'After a long while, they took me into another room -- it was a long walk from the room where I was being kept. They sat me down on a hard chair. There were things attached on the handles and the legs of the chair. They opened my blindfold and said in English, 'If you look

The minute they took my blindfolds off, cameras started flashing. That's when I saw Mushtaq [Ahmed, the writer who died in custody on February 25]. He said, 'Be proud man! You have not done any crime!'

'Mushtaq was smelling strongly of urine. He too had been picked up a few days ago, and had been beaten a lot. He was electrocuted in the genitals. There were newspapers on the floor and I asked Mushtaq to use that to clean himself. He took off his underwear and threw it away -- I saw that it had excrement in it. He had defecated in his pants from the torture, he told me," said Kishore.

An assistant superintendent came to question them.

"I asked to go to a bathroom, but requested a clean bathroom... and the officer took me to their personal bathroom. The officer told someone to clean the blood from the ear. I was also given biscuits and tea once," said Kishore.

The duo was taken to Ramna Police Station at dawn. "The duty officer asked me if I was tortured, and I wanted to say yes, but Mushtaq stopped me, saying that we could not tell the truth, or we would be tortured more," said Kishore.

Hours later, they were taken to the court and thus began their 10-month ordeal in prison.

"Mushtaq and I were in different prisons, different cells. I only saw him on February 23. I got to know about Mushtaq's death from another inmate who got the newspaper. He saw the news of Mushtaq's death," said Kishore.

And it was at that point when the man, who had up until then been describing the horrifying torture that was inflicted upon him with an impassive, defiant face, broke down in tears at the mere mention of Mushtaq.

"I am having to hear that it is because he died that I am free. I did not want freedom like this. Mushtaq told me 'let's get out, get fit and go see Mt Everest'. We were supposed to get out together," he wept.

On March 4, Kishore's lawyer Barua appealed to the court of Metropolitan Magistrate Mohammad Jashim to accept a complaint against the Rab members under the Torture and Custodial Death (Prevention) Act, 2013.

"A few days ago, the jail authority phoned the victim's wife saying that Rupam was in bad condition and was being treated in hospital. They also said they will bear the cost of Rupam's treatment and asked them [Rupam's family] not to worry," said Bhulon Lal.

"Following the information, the victim's wife submitted a plea before the court to shift her husband to hospital from jail on February 28. The court granted the plea. Later, she was able to meet her husband at CMCH, where she found injury

"The incident took place between with the court against Rupam, after 24th and 25th February at Sangu-1 of the jail territory," he added.

Speaking to The Daily Star, Md Shafiqul Islam, the accused jail super, said, "The allegation is baseless. We are the custodians of the prisoners and there is no room for torturing a prisoner for confessions inside the jail," adding that Rupam was admitted to CMCH on February 25 because of diabetes.

He also said the Rupam was suffering from some kind of infection in his groin, which was later operated on by doctors while he was in hospital.

"A five-member probe committee was formed by the jail authority to investigate the incident," added the jail super.

The sources, wishing not to be named, said that PM Modi has also desired to visit Rabindra Kuthi Bari in Kushtia and the ancestral home of Bagha Jatin, a revolutionary leader against the British rule, in Kushtia.

An official of Bangladesh mission here said, "It was almost certain that the Indian PM is visiting Orkandi temple but his visit to 'Satipith' and other areas are not confirmed yet.

He said separate groups of Indian High Commission officers in Dhaka and Bangladesh security personnel have already visited these areas to examine security aspects there ahead of the high-profile visit.

However, media reports here said that Modi would pay the visit to Orakandi temple to win over the "Matua" community voters ahead of the West Bengal state government polls scheduled to begin on March 27.

The state assembly election would be held in eight phases.

The "Matua" community votes are believed to be a decisive factor in the North 24-Parganas and Nadia district as the BJP and TMC (Trinamool Congress) are involved in a huge tussle to win over the voters there.

Besides, Indian External Affairs Minister S Jay Shankar will visit Dhaka tomorrow to set agendas regarding the upcoming visit of Prime Minister Narendra Modi to Bangladesh.

According to PM Modi's visit schedule, he will arrive in Dhaka on March 26 by a special aircraft and will leave Dhaka for New Delhi on the next day after wrapping up his two-day Dhaka visit. It would be Modi's first foreign visit after the Covid-19 pandemic.

On the first day [March 26], the Indian PM will join the celebration programmes with other dignitaries, and the next day, he will hold a summit with his Bangladesh counterpart Sheikh Hasina, Bangladesh high commissioner sources told BSS recently.

The challenge facing the Tigers is a multifaceted one. They returned to international cricket after a long pandemic-induced gap with the West Indies series at home, following a number of series cancellations last year. "After home quarantine for the first seven days, on the eighth day we went to practice in small groups. Everything was good and it was walk inside the hotel premises for 30 minutes a first-time experience with such quarantine [protocols] and coming to the New Zealand tour. As sportsmen we try to adjust ourselves

The vibes were good within the Bangladesh camp after the start of training. "In today's practice, we mostly worked on our fielding short and high catches. Because there's a matter of weather and windy conditions here, we practised catching in order to adapt to that. Then we also undertook batting and bowling in short sessions. There was also a little fitness training at the end as we haven't been able to work on fitness in seven days. We did some running as per the trainer's instructions. As more days pass, I will be looking to adjust better with the short practice session.

The positivity of the camp was reflected in Saifuddin saying they would like to take back result this time around. The all-rounder а echoed ODI skipper Tamim's sentiment of changing the record.

"There obviously are expectations [to win matches] because we are a very good team in ODIs. So, if we can all play at our best, if the day is ours, then, of course, the result will talk in our favour. Besides, there are also T20s. And as we are yet to fill in the achievement column [in New Zealand], we will try to ensure we can take something back this time around," Saifuddin said.



The United Nations human rights chief yesterday called on Myanmar's security forces to halt their "vicious crackdown on peaceful protesters" and urged the military to release people unlawfully detained since the February 1 coup.

Michelle Bachelet said that more than 1,700 people have been arbitrarily detained and that arrests were escalating. They included 29 journalists arrested in recent days, some charged with incitement to opposition or attending an unlawful assembly.

coup, but the actual death toll could be much higher, she said in a statement, citing figures her office has been able to verify.




