Border Guard Bangladesh shod dead an alleged cattle smuggler at Bongaon border in Sunamganj on Saturday

Kamal Miah (35) from Islampur Uttarpara village in Sadar upazila died on the way to Sylhet MAG Osmani Medical College Hospital, said his relatives.

Kamal Miah, a member of a cattle smuggling group, was confronted by a BGB team patrolling at the border while he along with others was bringing 25-30 cattle from India, BGB sources said.

Following an altercation, the group of around 30-35 people attacked BGB personnel with sharp weapons, they

Lt Col Md Maksudul Alam, commanding officer of 28 BGB Battalion in Sunamganj, said, "BGB opened fire on the attackers in self-defence. The attack left one BGB man injured.

BGB officials said a bullet hit Kamal in the back.

Injured BGB Lance Nayek Thui Hola Mong Marma was admitted to Sunamganj District Sadar Hospital with hand and head wounds, they said.

Denying the allegation of smuggling, Rajib Ahmed, a relative of the deceased, said Kamal was returning home with his own cows that crossed the border.

Sunamganj Sadar Police Station Officer-in-Charge Shahidur Rahman said the body will be handed over to the family after autopsy at MAG Osmani Medical College

BGB filed a case with the police station in connection with the attack on them, the OC said, adding that no complaint was lodged by the deceased's family.

Bangladesh condemns | Compensation drone attacks in Saudi | FROM PAGE 3 Arabia by Houthis

Bangladesh has strongly condemned the drone attacks targeting Abha, the South-western city of Kingdom of Saudi Arabia, by Houthi rebels on February 10 and 17.

The attack hit a parked commercial aircraft causing damage on February 10, but the second attack was intercepted and destroyed by the Joint Coalition Forces before hitting targets.

Following the attempted attack on Riyadh, the Arab Coalition also confirmed that it was monitoring the launching of a number of explosive drones by the Houthis in Yemen, and said it had intercepted and destroyed one targeting Jazan and at least four others targeting the Kingdom's southern cities.

These unprovoked acts by the Houthi rebels undermine the peace and security in the region," said a foreign ministry

statement yesterday. It said Bangladesh calls for immediate cessation of such attacks and reiterates solidarity with the brotherly Kingdom of Saudi Arabia in the face of such aggression.

Bangladesh also expressed full support to the Kingdom against any threat to its security and territorial integrity.

337 promoted to deputy secretaries

The government has promoted 337 officials to the rank of deputy secretary.

The Public Administration Ministry issued two gazette notifications in this regard yesterday. Those who got promoted have been asked to send their joining letters to sal@mopa.gov.bd.

However, the court did not impose fine above this minimum limit in any of the 44 cases under the 2000 Act, indicating that Tk 100,000 is treated as a ceiling rather than a baseline in practice, it mentioned.

The report recommended amending Section 15 of the Nari O Shishu Nirjaton Domon Ain 2000 so that compensation is a matter of right and not a matter of judicial discretion.

It also recommended enacting the Crime Victims Compensation Act drafted by the Law Commission in 2007, so that a Crime Victim Compensation Fund is established in every district.

It further recommended providing training on restorative justice through the Judicial Administration and Training Institute to Nari O Shishu Nirjaton Domon Tribunal judges on principles of victimology.

UN Women Bangladesh country representative Shoko Ishikawa said, "Compensation is the bare minimum that ought to be provided as reparation to survivors of sexual and gender-based violence."

"It is therefore critical to ensure that the legal framework for compensation for survivors of rape and other forms of Sexual and Gender-Based Violence is strengthened in Bangladesh in line with the reform proposals set out in

Sara Hossain, honorary executive director, BLAST said, We hope this report encourages lawmakers, lawyers, academics and activists alike to refocus some much needed attention to ensuring that every rape survivor has effective access to remedies and reparation.'

The author of the report Tagbir Huda, Research Specialist at BLAST, said, "Âs we celebrate our graduation from the Least Developed Countries (LDC) category, it is essential that we reinvest some of the country's wealth in activating the Crime Victims Compensation Fund proposed by the Law Commission back in 2007, so victims of violent offences, such as rape survivors are able to get some compensation irrespective of the outcome of the criminal prosecution."

According to the case statement, Rubel was locked up with other prisoners at ward-15 of Karnaphuli Bhaban's top floor inside prison.

When assistant chief prison guard Kamal Haidar started counting the inmates around 6:30am on Saturday, he found that Rubel was missing.

The case statement said failing to find him, Kamal inquired with prison guard Nazim, who said Rubel went out of the ward around 5:15am.

Assistant chief prison guard Yunus Mia echoed Nazim. Following that, the jail authorities searched for Rubel but to no avail, said the case statement.

Talking to The Daily Star, several jail officials said there are around 30 CCTV cameras on the jail premises. Apart from that, the drains connected to the jail are also grilled. They said all the possible spaces where an inmate may hide have been searched thoroughly.

Meanwhile, a deputy jailer said several vehicles carrying garbage and kitchen products enter the jail every day. Those vehicles should be investigated as well, he added.

Besides, it was not possible to climb over the boundary wall without any support, he added.

Another prison official said the loopholes in the high security jail should be detected and fixed. This incident has raised questions about the overall security system of the prison, he added.

A departmental case was lodged against Kamal Haider, assistant chief prison guard, he said. The suspended prison guards are Yunus and Nazim.

A three-member committee, led by DIG prisons (Khulna division) Md Sagir Mia, has been formed to investigate the incident, he added.

Contacted, Sagir Mia said the committee will start working from today.


