## KHALEDA'S SENTENCE Law ministry opines for 6 more months of suspension

The law ministry yesterday gave its opinion for extending the suspension of BNP Chairperson Khaleda Zia's jail sentence for six more months.

### An appeal to the chief justice

'Tarnishing the country's image' needs defining

In Bangladesh, when we think, talk and seek justice, we think of the courts. And that is how it should be. Among the courts, the higher we go -- meaning the High Court, the Appellate Division -- the more important they become as symbols of justice. On the very top of that edifice sits the chief justice (CJ) who personifies and his office embodies, so to speak, the highest level of our justice system. It is to that person and to that office that we, as citizens, look up to as the last resort when we become victims of injustice. It is to the CJ, and the institution he heads, that we go when everything else fails us. That is how central this institution is to our freedom and rights and that is why it should be revered.

On Sunday, the CJ was presiding over a three-member bench of the Appellate Division of the Supreme Court and hearing a bail petition concerning Golam Sarwar, 61, who was arrested by the Rab under the Digital Security Act on March 15, 2020. The High Court granted him bail in October, 2020, (after 7 months) for a year on health grounds.

## 33PC POSITIONS FOR WOMEN Major parties not there yet

All major political parties have failed to meet the 2020 deadline of reserving at least 33 percent of all committee positions at local and national levels for women while the Election Commission is doing nothing about it.

The commission is still in the dark as to which parties have or haven't met the deadline, unaware of the percentage of female representation in central committees of all the political parties -- not to mention those at the grassroots level.

Reserving at least 33 percent of all committee positions, including that of the central committee, for women by 2020 is a pre-requisite for any political party's registration with the Election Commission in line with the Representation of the People Order, 1972.

This target came about following an amendment to incorporate this provision into the RPO in 2008, and failure to meet this means the EC can cancel registration of a political party, according to EC officials.

The deadline ended more than two months ago.

Based on the numbers of female members of the major parties' central committees, as reported in The Daily Star last year, AL, BNP and almost all other parties fall short of the 33 percent target.

Only five parties claimed to The Daily Star that women made up one-third of their central committees. They are Gono Front, Bangladesh National Awami Party, Jatiya Gonotantrik Party, Zaker Party, and Khelafat Majlis.

Bangladesh Mahila Parishad General Secretary Maleka Banu and women's rights activist Farida Akter are frustrated about the EC's inaction over the political parties' failure in this regard.

## UK part of Bangladesh's economic success

TDS: How do you evaluate the 50 years of relationship between Bangladesh and the UK?

Dickson: It is a very strong relationship. There was very strong UK public support for Bangladesh's independence in 1971. Bangabandhu's first visit after release from Pakistani jail was to London. Bangabandhu then returned to Bangladesh via Delhi on a Royal Air Force aircraft.

Our relationship was built on a multitude of things. We have a very successful development relationship. For many years, Bangladesh has seen significant economic success and the UK has been a part of that.

We have a very well-integrated and successful Bangladeshi community of some 600,000 in the UK. Four British citizens of Bangladesh origin are now members of the British House of Commons.

So, there is a very strong people-to-people relationship. Also, we have a strong and growing relationship on trade, counterterrorism, and defence.

TDS: How will you celebrate Bangladesh's 50 years of independence and diplomatic relations with the UK?

Dickson: We had plans for high-profile programmes, but it won't be

## No revealing of identities of rape victims: HC

The High Court yesterday ordered the government to immediately take necessary steps to stop online and print news media and electronic media from publishing and broadcasting identities and photographs of rape and sexual assault victims in line with the relevant law.

In response to a writ petition, the court asked four high-placed officials to submit separate reports to it after complying with the directive in 30 days.

The four are: secretaries to the ministries of information and home affairs and the chairmen of Bangladesh Press Council and Bangladesh Telecommunication and Regulatory Commission (BTRC).

The HC also issued a rule asking the respondents to explain in four weeks why their inaction and failure to stop publishing and transmitting news which refers to the character of the victims, humiliates or defames the victims and their family members should not be declared illegal.

In the rule, the court also asked the respondents to show cause as to why
