## **CHILD MARRIAGE DUE TO COVID** 10m additional girls at risk

Says Unicef report, estimates 650m girls, women alive today were married in childhood

The outsized impact Covid-19 has had on women in some countries could result in an additional 10 million child marriages in this decade, according to a new analysis released yesterday by Unicef.

"School closures, economic stress, service disruptions, pregnancy and parental deaths due to the pandemic are putting the most vulnerable girls at increased risk of child marriage," said a study titled "Covid-19: A threat to progress against child marriage."

That trend, if confirmed, would represent a serious retreat from recent years of progress against child marriage.

In the last 10 years, according to the study, the proportion of young women globally who were married as children had declined by 15 percent, from nearly one in four to one in five. That progress "is now under threat," said the study, released on International Women's Day.

"Covid-19 has made an already difficult situation for millions of girls even worse," said Unicef executive director Henrietta Fore.

"Shuttered schools, isolation from friends and support networks, and rising poverty have added fuel to a fire the world was already struggling to put out." Girls who marry in childhood, the

study said, are more likely to experience domestic violence and less likely to remain in school. They face an increased risk of early and unplanned pregnancy, and maternal complications and mortality. Isolation from family and friends can take "a heavy toll on their mental health."

Meantime, pandemic-related travel restrictions and physical distancing have made it harder for girls "to access the health care, social services and community support that protect them from child marriage, unwanted pregnancy and gender-based violence," while making it more likely that they drop out of school.

The report estimates that 650 million girls and women alive today were married in childhood, about half of them in Bangladesh, Brazil, Ethiopia, India or Nigeria.

Afghan women leave journalism in droves as violence soars

#### AFP, Kabul

Nearly 20 percent of Afghan women journalists have quit or lost their jobs in the past six months, a media watchdog group said yesterday, as a wave of murders targeting the press has intensified in the war-torn country.

The Afghan Journalists Safety Committee said that more than 300 women had left the industry in recent months, citing the "wave of targeted killings" as one of the main reasons -along with financial difficulties caused by the coronavirus pandemic.

The report comes as the world marks International Women's Day and less than a week after three female media workers from Enikass TV were gunned down by militants in the eastern city of Jalalabad in an attack claimed by the local Islamic State group affiliate.

Another woman working for the station was murdered in December. Enikass said yesterday it had asked all remaining women staffers to stay home until security improves.

"I love journalism but I also love to

Journalists, religious scholars, activists and judges have all been victims of a recent wave of political assassinations across Afghanistan, forcing many into hiding and some to flee the country.

The killings have been acutely felt by women, whose rights were crushed under Taliban rule from 1996 to 2001 which included a ban on them working

officials Intelligence have previously linked the attacks against women to demands at ongoing peace talks in Doha -- between the Kabul government and the Taliban -- for their rights to be protected.

### **BRAHMAPUTRA DAM** Start construction within yr

Tibetan Communist Party official urges China **REUTERS**, Shanghai projects for the 2021-2025 period.

China should aim to begin construction of a controversial hydropower project on the Brahmaputra river within the year, a senior Tibetan Communist Party official said in comments published yesterday.

Comprehensive planning and environmental impact assessments for the project should be completed as soon as possible, Che Dalha, chairman of the Tibetan Autonomous Region, said in a delegation briefing issued by China's parliament.

Tibet should "strive to launch construction within this year," he said.

China's plans for a giant hydropower project on the river, known in Tibet as the Yarlung Tsangbo, have stirred fears in India it could disrupt downstream river flows, worsen water shortages and even cause flash floods.

The river flows for about 2,900 km (1,800 miles) through Tibet, India and Bangladesh into the Bay of Bengal.

The "Yarlung Tsangbo downstream hydropower base" was listed in China's new five-year plan last week as one of the country's major energy development work as soon as possible.

China could build up to 60 gigawatts (GW) of generation capacity on the river, state media have reported, which would make it the world's biggest hydropower project, overtaking China's 22.5 GW Three Gorges Dam.

A Chinese diplomat said late last year the project was at a "preliminary planning and demonstration" stage.

As a lower riparian State with considerable established user rights to the waters of the trans-border rivers, the Indian government has consistently conveyed its views and concerns to the Chinese authorities and has urged them to ensure that the interests of downstream States are not harmed by any activities in upstream areas.

India is considering plans to build its own dam on the river to increase its water storage capacity and counteract the impact of the Chinese project, an official said last year.

According to Tibet's five-year plan proposals published in January, the region aims to "research and promote" the project and begin related engineering

### HK leader praises China's plan to install 'patriots' AFP, Hong Kong

Hong Kong's leader yesterday praised China's plan to ensure only "patriots" remain in politics, denying the move was a purge of the opposition.

Chief Executive Carrie Lam ruled out any need to consult the public on the changes, as they were decreed by Beijing.

Legislation to vet all election candidates in Hong Kong is currently being discussed by China's rubber-stamp parliament and is expected to be adopted on Thursday.

China has said only those deemed "patriotic" will be allowed to stand.



Critics say the radical

overhaul of the city's already limited democratic system will demolish what remains of the prodemocracy opposition and ensure only loyalists remain, an argument that Lam rejected yesterday.

"The improvements to the electoral system are not designed to favour someone, it is designed to ensure that whoever is administering Hong Kong is patriotic," Lam, a pro-Beijing appointee, told reporters after returning from the gathering in Beijing.

"The decision timely, necessary, lawful and constitutional, and the central authorities' leadership and decisionmaking power are unquestionable."
