# Maintain highest possible caution

Says PM on Covid; infection rate crosses 5 percent

With the Covid infection rate on the rise, Prime Minister Sheikh Hasina yesterday urged the people to follow the health safety protocols to check the spread of the virus in the country.

She made the call at the weekly cabinet meeting at the Secretariat, joining it virtually from the Gono Bhaban, reports BSS.

Cabinet Secretary Khandker Anwarul

Islam briefed reporters later. "Wherever we are -- vaccinated or not -- we should follow three protocols -- wear facemasks, maintain the highest possible caution and crowd less in public places such as recreational sites or social events," Anwarul quoted the PM as saying.

At the meeting, Hasina said, "We don't think that we are in a comfort zone. Yes, we are in a much better position ... it doesn't give us the certainty that we are in a comfort zone.

Over the last few days, experts have been suggesting not to be at ease at this moment as the country saw the highest infection rate in the last summer.

The PM said, "It cannot be assured that Covid infection would not peak

"The peak [Covid infection] was in the high summer though all of us thought it would happen in winter... April, May and June [this year] will be our high summer and that is why our experts suggest that we remain cautious in these months.

No one is fully protected with a single shot of vaccine. All are advised to

wear facemasks even after inoculation, she told the meeting.

In reply to a query about steps to encourage people to wear facemasks, the cabinet secretary said they are observing the situation and carrying out different campaigns to that end.

Motivational programmes are being carried out in unions and upazilas to make the people aware of the health protocols to curb the spread of the virus, he mentioned.

Meanwhile, at least 912 people tested positive for the novel coronavirus across the country in 24 hours till 8:00am yesterday, taking the total number of Covid cases to 552,087, according to

The number was 606 on Sunday.

The daily infection rate rose to 5.13 percent yesterday. It was 4.98 percent on Monday and 4.3 percent on Sunday, according to DGHS data.

Bangladesh reported its first Covid case on March 8 last year and the first death on March 18.

### One step forward

Attending the event virtually, Sheikh Hasina said Bangladesh expects the bridge to help the country conduct trade more smoothly with Nepal and Bhutan alongside India.

"We're creating a new era in South Asia, providing connectivity to India. I think the Maitri Setu will further connect the two nations and play a significant role in business, trade and economic development.

"The event is taking place at a time when we are celebrating the birth centenary of Father of the Nation Bangabandhu Sheikh Mujibur Rahman, golden jubilee of Bangladesh's independence, and 50th year of Bangladesh-India diplomatic relations," she added.

The prime minister also expected the Maitri Setu to significantly improve the socioeconomic condition of the people of Tripura and the surrounding northeastern states of India. She hoped it will also contribute towards improving the livelihoods of those living on the Bangladeshi side of the bridge.

She said Bangladesh's growth trajectory and its geographic location make it an extremely attractive South Asian neighbour.

As one of the global leaders in textile production, Bangladesh carved its

distinct path and has become a favoured destination for foreign investment, she

Hasina said Bangladesh is ready to maximise its locational advantage as a connectivity hub between South and Southeast Asia.

"We believe the cross-border transport systems that Bangladesh is developing with India is an important step in this regard and will enable us to play an important role in regional trade and commerce," she said.

The Feni bridge is a testimony to the Bangladesh government's continued commitment to support India in strengthening connectivity in the region, particularly for the northeast of India, said Hasina.

She recalled that India opened up its border in 1971 for Bangladesh's people to support their struggle for freedom.

"Today, we're building a prosperous region together. I wish [for] successful operation and utilisation of the Feni Maitri Setu."

Modi thanked the Bangladesh government and Hasina for the cooperation in the completion of the bridge project.

Due to the bridge over the Feni, Tripura state's capital Agartala will become the city nearest to an international sea port in India, said Modi.

It is poised to herald a new chapter for trade and people-to-people movement between India and Bangladesh, our New Delhi correspondent reports, quoting a statement of Indian Prime Minister's Office (PMO).

With this inauguration, Tripura has now become the "Gateway of North East" with access to the Chattogram port of Bangladesh, which is just 80 kilometres from Sabroom, it said.

Modi also inaugurated and laid the foundation stone of multiple infrastructure projects in Tripura during the event, via video conferencing, reports India TV news.

The Indian National Highways and Infrastructure Development Corporation Ltd started the project at a cost of Rs 133 crore, said the PMO statement.

Modi also laid the foundation stone for setting up an Integrated Check Post at Sabroom, which will help ease the movement of goods and passengers between the two countries, provide new market opportunities for products of north-eastern states and assist seamless movement of passengers to and from India and Bangladesh, the Indian PMO

The project is being taken up by the Land Ports Authority of India at an estimated cost of about Rs 232 crore,

Saiful Islam, an inspector of PBI in Rangpur, filed the 367-page charge sheet against the five persons, including Rahenul, yesterday noon before the court.

Court sources said that PBI pressed charges against Rahenul and two other women Meghla and Suravi, under the Women and Children Repression Prevention Act, while human trafficking charge was pressed against Kalam and Babul, who were arrested from Lalmonirhat.

ABM Zakir Hossain, superintendent of PBI in Rangpur, confirmed to the local journalists.

A court source, quoting the charge sheet, said that accused Rahenul Islam, who was then posted to Haragachh Police Station, built an affair relationship with a tenth grader girl of Haragachh Municipality in Kaunia upazila of Rangpur.

Rahenul went to the rented house of Sumaiya Parvin Meghla, taking the tenth grader victim on October 18 last

There he raped the girl. Later, Rahenul himself had dropped the girl at her home at around 10:00pm.

Babul and Kalam raped the girl ngain later that night. After the rape, the girl became sick.

Police rescued the girl the next day from the rented house of Meghla. Afterward, the girl's father filed a

case with Haragachh Police Station accusing Rahenul and Meghla. The case was later handed over to

PBI in Rangpur. The PBI high officials said the

victim gave her testimony before the court. Rahenul also confessed his involvement with the incident.

DNA testing was also conducted on the victim and the accused. It was a gang-rape, as the police investigation found, said the SP.

In contrast, the time to cross border points handling similar volumes of traffic in other regions of the world, including East Africa, is less than six hours.

The northeastern part of India is particularly isolated from the rest of the country and connected only through the 27-km-wide Siliguri corridor called "chicken's neck". This leads to long and costly routes. Goods from Agartala, for example, travel 1,600 km through the Siliguri corridor to reach the Kolkata port, instead of 450 km via Bangladesh.

Cargo transported by train also has to be transloaded at the border, because of restrictions on the use of freight wagons of foreign railways. Cargo shipped between Bangladesh and India in seagoing vessels has to be transshipped in Colombo or ports in East Asia, such as Singapore and
