10 LOCOMOTIVES FROM HYUNDAI Minister now questions order itself

Stays mum on company's breach of contract; says probe into order specs on

After years' of process, 10 locomotives bought from Hyundai Rotem reached Bangladesh without the alternators specified in the contract, but the railways minister is now questioning the order itself.

Bangladesh Railway (BR) in May, 2016, floated a tender for procuring the 10 metre-gauge locomotives and some other equipment under a project funded by the Asian Development Bank (ADB).

After a long bidding process, in which different government bodies and the ADB were involved, BR in May 2018 signed a deal with South Korean Hyundai Rotem for Tk 297.63 crore.

The locomotives reached Bangladesh in September and it was discovered that Hyundai delivered the locomotives with TA-09 alternators, violating the contract that specified the TA-12 model.

Railways Minister Nurul Islam Sujan at the Rail Bhaban yesterday said the alternators, an important component of the diesel-electric locomotives, specified in the contract should have been different. He said they were looking into as to why the "applicable" alternators, which according to him is the TA-09, were not selected in the first place.

Ron Sikder's bail extended until April 11

A Dhaka court yesterday extended the bail of Ron Haque Sikder, managing director of Sikder Group, until April 11 in a case filed over abducting, torturing, and opening fire on two Exim Bank officials over a loan permission.

Dhaka Metropolitan Magistrate Rajesh Chowdhury passed the order after a hearing on two petitions -- one for granting Ron's permanent bail and the other for exempting him from personal appearance in the court.

The prosecution submitted a petition seeking cancellation of Ron's bail. It said Ron and his brother Dipu Haque Sikder, who is now abroad, abducted, tortured and opened fire on two Exim Bank officials after they refused to sanction a loan of Tk 500 crore.

Mamata 'attacked' after filing nomination

West Bengal Chief Minister Mamata Banerjee was allegedly attacked yesterday by about 4-5 people in Nandigram where she had gone to file her nomination for the upcoming Assembly elections, reports said.

Sources said she has sustained injuries in her leg.

The accident occurred barely hours after she filed her nomination from Nandigram in Purba Medinipur district yesterday.

Mamata alleged that four-five men manhandled her in Barolia at Nandigram and she suffered an injury in her leg after being pushed. She also complained of chest pain. She was scheduled to return

Bhutto's telegram to Bangabandhu

BHUTTO'S TELEGRAM

In a telegram sent to Bangabandhu Sheikh Mujibur Rahman on March 11, 1971, Bhutto expressed his willingness to come to Dhaka immediately to work out a solution so that the National Assembly session could be held soon. He urged Bangabandhu to work together to build a "new system" where there would be no discrimination among provinces as well as among citizens.

KEEP ECONOMY IN FULL GEAR

Tajuddin Ahmad, general secretary of the Awami League, in a statement today said the people's movement had attained unprecedented heights. It had been made possible because every person in his own sphere had taken it as his sacred duty to implement, in spirit and



in substance, all the directives of Bangabandhu issued in the name of the people of "Bangladesh", he added. He urged people to be prepared to foil the conspiracy of the vested interests and the anti-people forces to destroy the economy of "Bangladesh". The statement called upon people engaged in various economic activities to follow rigorous discipline in every respect for the victory of the people's cause.

The statement also contained several directives for government and non-government organisations. The ports were allowed to operate

Govt, CNNIC to team up to showcase Bangladesh

The government is going to team up with US-based CNN International Commercial for showcasing Bangladesh's achievements on the global stage.

China, Russia to launch lunar space station

Russia and China unveiled plans Tuesday for a joint lunar space station, as Moscow seeks to recapture the glory of its space pioneering days of Soviet times, and Beijing gears up its own extraterrestrial ambitions.

Though Moscow was once at the forefront of space travel -- it sent the first man into space -- its cosmic ambitions have dimmed thanks to poor financing and endemic corruption.

LNG SUPPLY India keen on cross-border pipeline

Stressing the need for South Asian regional power co-operation, India yesterday said it was exploring with Bangladesh a proposal for supplying refined-LNG through cross-border pipeline and establishment of an LNG terminal.

"We are working assiduously to promote the sub-region comprising Bhutan, Bangladesh, Nepal, Myanmar and India as an energy hub," Indian Foreign Secretary Harsh Vardhan Shringla said.

He was addressing the inauguration of the South Asia Group on Energy (SAGE), organised by Research and Information System for Developing Countries (RIS), in New Delhi.

KSA promises to vaccinate Bangladeshi migrants

Says no one will be forced to leave

The Kingdom of Saudi Arabia (KSA) has assured that all Bangladeshi migrants -- regular or irregular -- would be vaccinated and that they won't be forcibly sent back to Bangladesh.

State Minister for Foreign Affairs Shahriar Alam said this to journalists at the foreign ministry yesterday, following a 10-day visit to the KSA and the United Arab Emirates (UAE).

Referring to his meeting with Saudi Foreign Minister Adel bin Ahmed Al-Jubeir in Riyadh, he said he expressed gratitude to Saudi authorities for providing treatment to the Bangladeshi migrants in

One in three women endure abuse: WHO

Pandemic deepening the problem

One in three women have already suffered physical violence or sexual abuse, the World Health Organization said, warning that the coronavirus pandemic was deepening the problem.

In a report, the UN health agency found that around 30 percent of all women and girls over the age of 15 -- around 736 million people -- have already been victims of such violence throughout their lifetimes,

mainly at the hands of intimate partners. "Violence against women is endemic in every country and culture, causing harm to millions of women and their families," WHO chief Tedros Adhanom Ghebreyesus said in a statement on Tuesday, adding that the problem "has been exacerbated by the Covid-19 pandemic".

Dr Claudia Garcia-Moreno, who co-authored the report, acknowledged that experts were still waiting for the full data
