Providing Eyecare to People

Each upazila to get community vision centre: PM

UNB, Dhaka

Sheikh Minister Prime yesterday said the Hasina government will community vision centres in all upazilas across the country in phases to provide better eyecare services to local people.

"Eyecare services are costly. General people can't afford these. I'm not only the prime minister, but also the daughter of the Father of the Nation. So, it's my responsibility to ensure healthcare services for every national of the country. I've been trying to perform this responsibility as well," she said.

The PM was inaugurating operations of community vision centres set up at 70 upazila health complexes in 20 districts under five divisions via video

Hasina joined the virtual inaugural ceremony, held at the National Institute of Ophthalmology and Hospital in the capital, from the Gono Bhaban.

She said the government has already taken up a plan to establish 110 more community vision centres at the upazila

The PM said healthy people are needed to properly take the country forward. "Healthy people are required to build a healthy Bangladesh.'

Mentioning that the government is providing free vitamin-A, different vaccines and medicines to people, Hasina said, "We've been creating scopes so that people can stay healthy everywhere."

Later, she exchanged views with locals and stakeholders of three upazilas -- Pirganj of Rangpur, Nachol of Chapainawabganj and Haluaghat of Mymensingh -- through the video conference

Health Minister Zahid Maleque also spoke at the function conducted by Principal Secretary Ahmad Kaikaus.

Health Secretary Abdul delivered welcome speech, while Director of the National Institute of Ophthalmology (NIO) Prof Dr Golam Mostafa described the NIO activities briefly.

Golam Mostafa said the prime minister inaugurated operations of community vision centres in 20 upazilas in 2018.

He said there is a plan to set up 110 more community vision centres in the

country by June 2023. Stating that the government has transformed the country into "Digital Bangladesh", Hasina mentioned that now it has become easy to get healthcare services as there has been marked

development in telemedicine systems. "Now people can avail themselves of the services from expert physicians through the telemedicine system staying at home. Now our Bangladesh is Digital Bangladesh. So, we've taken the digital services to the

doorsteps of people," she added. Hasina said the congenital (birth) blindness has almost removed from the country as the government provides treatment to pregnant mothers.

Now people get healthcare services and 30 free medicines from community clinics across the country, she said, adding that locals, particularly women, can easily get the services and medicines from the clinics.

About Covid-19, the PM called upon all to follow the health protection protocols, including wearing face masks, washing hands frequently to remain clean, and thus check the coronavirus.

Hasina also urged people to get vaccinated in a disciplined manner after registration so that no chaos occurs in the Covid-19 vaccination centres as happened in the past.

Smooth railway traffic not soon

In January, the railways ministry wrote to the Chinese government for the third time to expedite the process for signing the loan deal, laying emphasis on the importance of the synchronisation of the two projects to get the desired

Railway officials said completion of one project without the other will not olve the gridlock in rail traffic.

Meanwhile, the Prime Minister's

costs to be cut, railway officials told The Daily Star they feared delays in project implementation may cause cost calation.

As per the negotiations, the contractor is set to take four years to complete the project after launching the

Besides, the "block section" -- the distance from one station to another -between Joydebpur and Bangabandhu Bridge (East) Station is relatively long, meaning each train has to wait longer to make way for another. Then comes the delay

Bangabandhu Bridge.

Trains have to run at the "restricted speed" of 20 kilometres per hour while crossing the bridge. It takes around half an hour to cross the 7km stretch between the bridge's east and west stations, they added.
THE DUAL PROBLEM

Railways Minister Nurul Islam Sujan, on several occasions, said the problems regarding the delay in train schedules on this route cannot be resolved until the construction of the rail bridge and the dual-gauge double line from Joydebpur to Ishwardi is complete.

Back in January 2016, the government took up the project to construct a dedicated double-line rail bridge over the Jamuna river and after a long delay, physical work of the project started in August last year.

Once the 4.8km bridge is constructed under the Tk 16,781 crore project by August 2024, 88 trains can run

smoothly per day, project officials said.

The government took up the Tk
14,250.61 crore project to turn the 174-km
Joydebpur-Ishwardi section into a dualgauge double line in November 2018. BR completed negotiations with

China Civil Engineering Construction Corporation for implementing the Ín March 2019, the railways ministry sent a letter to the Chinese government,

requesting them to sign the deal. In the

Then, in September last year,

the PMO formed a high-powered committee to review the costs of three railway projects supposed to be implemented with Chinese finance and by Chinese companies.

Following the committee recommendations, the PMO directed the railways ministry to reduce the costs of two projects -- one of which was the Joydebpur-Ishwardi project.

As per the directives, Tk 1,495.52

crore has to be slashed from the project's contract price -- Tk 11,586.68 crore -- approved by the Cabinet Committee on Government Purchase for the Joydebpur-Ishwardi rail line expansion project. The amount is 12.91 percent of ne contract price.

BR, at a meeting on December 9 last year, decided to discuss the PMO decision with the Chinese contractor and re-send the procurement proposal to the Cabinet Committee on Government Purchase. The meeting also formed a three-

member committee led by the then Additional Director General (infrastructure) Dhirendra Mazumder, who took charge as BR DG early last month, for this task Contacted, BR DG Dhirendra Nath

said they have already sent the proposal to the contractor for the cost-cutting and they are now reviewing it. "We hope to get their reply soon," he told The Daily Star on March 4.

Regarding the delay in loan sanctioning, Dhirendra Nath said, "In that case we will ask the contractor to speed up their work. We will reduce the lead time.

"Works of the project can be done quickly as it will be a new line."

He added, "It will be good for us if the decision is taken as early as possible.

BANGLADESHI SHIPBREAKER'S DEATH **UK** court allows

his widow to pursue claim for compensation

A Bangladeshi woman whose husband died dismantling an oil tanker in a local shipyard was given the green light this week to keep pursuing a claim for compensation from a UK company linked to the vessel in a test case for the

shipbreaking industry.

Britain's Court of Appeal threw out a request by London-based shipbroker Maran (UK) Ltd for the negligence case to be dismissed, the second appeal the company has lost.

Hamida Begum's husband, Khalil Mollah, 32, fell to his death in 2018 while breaking up the tanker Ekta in the Bangladesh port of Chattogram, home to one of the world's largest ship-breaking yards, where vessels are dismantled for scrap metal.

Her UK-based lawyers said working conditions in Bangladesh's yards were known to be dangerous and argued Maran bore responsibility for Mollah's death by selling the tanker to an intermediary knowing it would probably end up in Chittagong.

British lawyers representing Begum launched the legal battle in April 2019.

Covid cases keep rising

1,051 test positive, six die in a day

Bangladesh is seeing a continuous rise in the number of daily Covid-19 infection cases as it recorded 1,051 fresh ones in the last 24 hours till yesterday morning. Six more coronavirus-related deaths

were reported during the period, according to the Directorate General of Health Services (DGHS).

Though the daily infection rate fell slightly to 5.82 percent from 5.98

percent on Wednesday, the number of patients rose to 1,051 yesterday from . Wednesday's 1,018. The mortality rate also came down

to 1.53 percent from 1.54 percent for the past few weeks, the DGHS said in a handout. With the latest figures, the Covid-19

atalities climbed to 8,502 and the total infections to 554,156, the handout added. Besides, it said, 1,307 people

ecovered from the virus infections

during the period. So far, 507,920

patients -- 91.66 percent -- have recovered. Bangladesh reported its first cases on March 8, 2020, and the first death
