## Ruling party has robbed the peace of people: GM Quader

Jatiya Party Chairman and deputy leader of the opposition GM Quader yesterday said Bangladesh cannot be called a democratic state due to "autocracy" and lack of good governance.

He said it is not possible to practice democracy because of what is happening in the country in the name of parliamentary democracy

"Anarchic situation like that in Noakhali's Bashurhat has been created all over the country. The imbalance of power has given birth to corruption and misrule in the country, he said while welcoming around 50 leaders and activists of different parties who joined Jatiya Party at a programme at the JP chief's Banani office.

GM Quader said that autocracy is on the rise in the name of parliamentary democracy since the handover of power by late president HM Ershad in 1991.

"The ruling party has robbed the peace of people of the country through tender manipulation, nepotism and extortion. Politics of looting has begun since 1991 and the common people are being tortured by the political activists," he said.

## Sylhet city AL leader suspended

Sylhet city unit of Awami League suspended its organising secretary Saleh Ahmed Shalim

over an allegation of extortion against him. The decision came from an emergency meeting of the AL unit on Wednesday night after a case was filed against him, said its president Mashuk Uddin Ahmed.

The city unit AL issued a show-cause notice to Saleh and formed a three-member committee to investigate the matter, he said. Saleh is also councillor of ward-22 of Sylhet City Corporation and a lawyer of

Sylhet District Bar Association. voluntary organisation Trinamul Nari Uddokta Society" was planning a fair on Shahjalal Upasahar field.

Its organiser Anita Das Gupta filed a case with Shahporan Police Station on March 6 saying Saleh demanded a huge sum to hold the fair. As he failed to get the extortion money, he stopped the fair's arrangement.

Despite repeated attempts, correspondent could not reach Saleh as his phones were found switched off.

# Child marriage

UNFPA Deputy Representative Eiko Narita said for girls who are married off, the pregnancy rate is higher than that of women who got married later. This can lead to adverse health consequences.

Veera Mendonca, Unicef representative of Bangladesh, said poverty has increased substantially in the pandemic, and it is a key driver for child marriage. She urged the government and other organisations to work together to make an impact in stopping child marriages.

Women and Children Affairs Ministry Joint Secretary Md Mohibuzzaman said UNOs are major stakeholders for stopping child marriage. "But, child marriage is a social issue, because people who live in marginal areas consider marrying off their child as one less burden," he said.

The mix method survey was conducted by interviewing 21,258 respondents, including married and unmarried girls aged between 10 and 19 years, parents having at least one daughter aged 10-19 years, local government representatives, UNOs, Department of Women Affairs officials, marriage registrars, local leaders, school/ college teachers and police officers.

The highest number of child marriages

took place in Barguna, with 1,512 girls forced into marriage, 1,272 in Kurigram, 1,222 in Nilphamari, 1,041 in Laxmipur and 884 in Kushtia, it mentioned.

A total of 5,089 respondents also mentioned that there were unexpected pregnancies during Covid-19, to demands of husbands and in-laws, husbands staying home for longer periods, disruption in family planning services, and much more, it found.

Respondents also mentioned witnessing 1.7 incidents of child marriage per day.

Barguna had the highest percentage of respondents (88 percent) who reported at least one child marriage during the Covid-19 period, followed by Laxmipur (63 percent), Khulna (56 percent) and Nilphamari (56 percent).

MJF's violence against women and girls coordinator Arpita Das and senior manager Shaikh Giasuddin Ahmed presented the information at the event.

The webinar came up with some policy recommendations, including monetary support to families with children in case of large scale emergencies such as Covid-19, and a national campaign highlighting negative impacts of child marriage and debunking the perceived positive theories.

## Voting ends in SCBA elections

A two-day voting for electing new leadership of the Supreme Court Bar Association (SCBA) ended yesterday afternoon.

Some 5,676 lawyers out of total 7,722 cast their votes in the election held at the SCBA auditorium in Dhaka, Md Rabiul Hasan, administrative officer of SCBA, told The Daily Star.

He said sorting of ballots will start at 9am and vote counting will begin after the Juma prayers today. The results will be announced once the counting is finished, he added.

SCBA sources said the main contest will be between panels of Awami Leaguebacked Bangabandhu Awami Ainjibi Parishad and pro-BNP Bangladesh Jatiyatabadi Ainjibi Oikya Panel.

Former law minister and AL MP Abdul Matin Khasru, and former BNP lawmaker Md Fazlur Rahman have been nominated for president post from the respective panels.

Economist Dr Debapriya Bhattacharya, distinguished fellow of CPD; Lilian Mercado, regional director of Oxfam in Asia and Danny Sriskandarajah, CEO of Oxfam Great Britain also spoke at the programme.

#### ENSURE RELIEF REACHES THE RIGHT PEOPLE

Meanwhile in another session of the conference, grassroots organisations stressed on ensuring proper access to social safety net programme at the root level by strengthening the monitoring system and dissemination of information about the government aid in the community level

During the session on food relief, speakers urged the government to ensure the right people receive the relief and to raise awareness of where to file complaints if irregularities occur in relief distribution

Sharing an experience, Abdul Halim of Susheel from Satkhira said, "In our area we have 12,000 poor ethnic minorities, but only half of them received the relief.

Wahida Akter from the NGO Lighthouse said, "Many sex workers were deprived of relief during this pandemic. We expect that they get registered properly and the aid reaches them in the right time."

Manusher Jonno Foundation Executive Director Shaheen Anam said that during this pandemic, women and children were the worst sufferers, and poor families were harassed while collecting relief.

"We need to think of a way out so that such incongruity doesn't take place in the future," she added.

"We tried to tell them that Bangladesh has become a land of opportunities," an official concerned told The Daily Star.

"We said trade and investment is what we need. However, it does not mean we don't want aid at all, but it should be aligned to national development priorities and facilitate trade and investment," he

The official said Dhaka and Canberra can develop partnership on human resource development, especially in vocational training, including curriculum development and teachers' training.

Australian High Commissioner Jeremy Bruer said Australia truly looks forward to stronger economic cooperation as Bangladesh graduates from LDC status.

He said both countries enjoy excellent bilateral relations because of historical ties, people to people contacts, shared values and common aspirations for peace, progress and prosperity.

A foreign ministry statement said Australia reaffirmed its commitment to support Bangladesh's Covid-19 recovery.

The talks also involved productive exchange of views on durable solution to the Rohingya crisis and on climate change. Bangladesh stressed that if the

Rohingyas could not be repatriated within a short span of time, it would have regional ramifications. Officials also acknowledged shared

security interests, including cooperation in cyber security, fighting transnational crime, countering terrorism, and human trafficking.

Both countries agreed to commemorate the 50th year of establishing diplomatic relations in 2022.

## Taposh said DSCC has earmarked a Tk

981 crore project to develop the canals. For the short-term plan, the DSCC mayor said, "To reduce waterlogging in the next rainy season, we have started cleaning the culverts, canals and have already removed 75,000 tonnes of garbage and silt.

Taposh said they have identified the areas where there was waterlogging last year and have invited tenders for the development works, adding that the work will be finished by May.

"Most of the pumping stations and sluice gates DSCC has got from Wasa are out of order," Taposh informed. "We are now using the city corporation's fund to make them functional."

The DSCC mayor said a project in Dholaikhal, funded by the World Bank, is expected to start after the coming rainy season or early next year. This will solve waterlogging in some areas in the old part of the city, he added.

On the issue of existing workforce, Taposh said they have already prepared a new organogram with a demand for additional workforce which will be sent to the public administration ministry soon

### DEMARCATION, WASTE MANAGEMENT THE KEY: ATIQUL

DNCC mayor Md Atiqul Islam said they too have laid out short-mid-long term plans to address the waterlogging

Although the plans are almost similar to that of DSCC, disconnecting sewerage connection from storm water drain, encouraging people to set up a safety tank, and plugging in those solid household waste connections with canals and lakes are some key short and mid-term targets of the DNCC.

About recovering the canals from the encroachers, Atiqul said they have decided to take an innovative approach to demarcate the canals under their jurisdiction.

have already completed demarcation work through digital mapping, using drone services on four canals. Now we will take vetting from the DC office on the digital mapping after completing some necessary processes. After this, we will set up boundary pillars based on the demarcation," he said.

The demarcation pillars will be set up so that encroachers move away along with their structures from the canals

"If they do not do it, the city corporation will evict them," said the DNCC mayor, adding that they will plant trees on the banks of the canals and will set up bicycle lanes.

Atiq said solid waste is the main barrier to the smooth flow of water in DNCC's canals.

"If we can ensure the desired depth and width of the canals, water will flow throughout the year which will also help prevent the canals from becoming mosquito breeding grounds," he said. He said the city corporation is also

taking initiatives to prevent people from dumping waste into canals. "We are going to appoint additional staffers to conduct cleaning works everyday throughout the year," he added.

The mayor also said a public notice has been issued through newspapers

asking residents of DNCC to disconnect sewerage lines of their own buildings from canals and storm drains and set up their own septic tanks and shock wells by the next 60 days.

"We will conduct mobile court drives starting from Gulshan area. This is because Gulshan lake has become heavily polluted due to the dumping of sewerage water," said the mayor.

The city corporation will form a committee in this regard, he said, incorporating experts who will give proper advice on their plans.

### 'DSCC, DNCC MUST WORK TOGETHER'

Iqbal Habib, joint secretary of Bangladesh Paribesh Andolon, said the two city corporations will have to include solid and liquid waste management under their plan. "Otherwise it will not be possible to protect the canals and maintain the drainage systems," said Habib.

He said the city corporations should involve city residents and their plans must be executed on time.

"The city corporations will have to build awareness among people, especially those living beside the canals, so that they do not dump their solid or liquid waste and they can discourage others from dumping

waste into the canals," he said. He said the two city corporations must work together, under an integrated master plan.

"They will also have to ensure that the canal network covers up to the river and they will have to remove all obstacles to ensure proper connectivity," said Habib.
