



Forgotten graveyard for unforgettable war heroes

A 1971 mass graveyard remains in shabby state due to lack of maintenance by authorities concerned in Shakhari Kathi village of Bagerhat's Kachua upazila.

In the graveyard, the then government in 1996 constructed a memorial plaque bearing the names of 31 martyrs.

Now, the names of the martyrs have become faded and plasters have started decaying in the concrete plaque.

As there is no boundary fence, people are now using the graveyard as a motorcycle parking yard and waste dumping place. Even, farmers now use the graveyard as cattle rearing space, said locals.

Freedom fighters and family members of the martyrs expressed their frustration over it and demanded government's immediate measure to preserve the graveyard.

"If the memorial cannot be preserved, it will be destroyed. The next generation will forget the heinous killing by Razakars and sacrifices of our valiant freedom fighters," said Nimai Chandra Das, 69, a freedom fighter, who now lives at Raghudautta Kati village under the same upazila.

He was an eyewitness of the heinous killing in Shakhari Kathi Bazar.

"In the afternoon of November 5, 1971, Razakars raided Shakhari Kathi Bazar and captured at least 42 people. Then, the killers tied people's hand, kept standing in row and opened fire," he was describing the incident.

Another eye witness Akkas Uddin Zamadder, 60, of Alokdia village in the

same upazila, said the 42 bodies were kept in two boats. Then, the bodies were taken to Ramchandrapur which now popularly known as the Char of the Bishkali river. The bodies were buried in a pit there.

Monilal Das was one of the victims of the mass killing.

His son Ananda Lal Das said, "As a family member of a martyred freedom fighter, we did not get anything from the

government. Our only satisfaction is that my father's name has been inscribed in the memorial plaque. But now, it is also decaying. We want immediate preservation of the graveyard and the memorial."

Contacted, Kachua Upazila Nirbahi Officer Sujit Debnath said a process remains underway to construct a monument and to preserve the graveyard area covering around 20 decimals of land.

Covid-19 turns marginalised students into child labourers

About 80 percent of them are students of different educational institutions

The closure of educational institutions due to Covid-19 has affected regular learning activities of many school children in Lalmonirhat. Due to the pandemic situation, especially marginalised students in the district have dropped out and engaged in child labour.

Although ten-year-old Ayub Ali from Fulgachh village in Lalmonirhat Sadar upazila was promoted to Class V from Class IV through auto-pass, he has never got a chance to turn the pages of a book.

Because his day labourer father Mostak Ali sent him to work in a motorcycle mechanic shop in the district town in June last year.

Now his father wants to see him a motorcycle mechanic, said Ayub.

Ayub added his studies have been stopped due to the pandemic and closure of the school.

Rajesh Chandra of Bhatibari village in Sadar upazila said he was promoted to Class VI through auto-pass. But when he was the student of Class V, he had to quit his study and join a motorcycle mechanics shop in the town as a labourer in May last year.

Although he wanted to continue his study, the Covid-19 pandemic shattered his desire, said Rajesh.

"My son stopped studying due to closure of the school. I have sent him to work in a motorcycle mechanic shop and he is now earning Tk 60 to Tk 70 every day," said Rajesh's father Samiran Chandra Barman.

Bhaborjan Roy, a motorcycle mechanic at Uttara Road in Lalmonirhat town, said at least 20 guardians brought their children to him to build

them as motorcycle mechanic. He has managed to keep three of them in his garage. The three are students of class four, five and six.

Rafiqul Islam, a representative of a non-governmental organisation named Lalmonirhat Unnayan Songsta, said a number of child labourers in the town's businesses and technical centres have increased during the coronavirus situation.

He added that eighty percent of the child labourers are students of various educational institutions. Especially children from poor families quit their studies out due to the pandemic and closure of schools.

Lalmonirhat District Primary Education Officer Golam Nabi said the dropout rate will be known after reopening of schools.

in the early days of March, 1971. PIA's fleet of Boeings flew the troops in. Due to India's embargo on over-flights all Pakistani aircraft had to take a detour via Sri Lanka. The 9 Division from Quetta, under Major General Nazir Hussain Shah, and 17 Division from Kharian under Major General Shaikat Riza, were being flown in.

Khadim Hussain Raza, then general officer commanding 14 Division in East Pakistan, writes in his memoir that at the beginning of Tikka Khan's induction (March 6, 1971) as head of the Eastern Command the president's policy stipulated that the troops had to be confined to the cantonments and nothing was to be done to provoke an incident. East Pakistani leaders, including Bangabandhu and Bhashani, continued to protest the military build-up. They called upon people not to provide any support in the movement of military convoys across the country. In some cases, there were active resistance against such strengthening of armed forces. In Chittagong, for example, workers, taking their own initiative, suspended unloading of MV Swat that carried the first reinforcements from West Pakistan.

The military buildup in East Pakistan was seen by Indians as a tactic to cover the Bengalees into diluting their demands. [Srinath Raghavan, 1971: A Global History of the Creation of Bangladesh, Permanent Black, 2013, pg. 58]

of Badda Police Station to produce the four before it. Police did not produced them before the court. They did not file any petition in this regard either, court sources said yesterday.

Contacted, OC Md Parvez Islam of the police station said, "Police are yet to get any court summon on taking the witnesses to the court."

Tipu was shot dead around 7:30pm on March 13, 1999, on Airport Road in Khilkhet area when he was in a car. Later, Gen Aziz filed a murder case with the police station.

The CID pressed charges against six accused, including top listed criminals Sanjiddul Islam Imon, Mohammad Islam Munna, Shamsur Rahman Mona, Anisur Rahman Zaved, Tarique Saif Mamun, and Sagor Hossain Osman, on July 22, 2001.

Court framed charges against the six on December 10, 2003.

Till May 22, 2011, 32 prosecution witnesses, including complainant Gen Aziz, out of 41 prosecution witnesses testified.

During yesterday's hearing, Imon was present in the court. Mona and Mamun were absent, Osman died during trial, while Munna and Zaved are on the run.

"We are trying our best to produce the witnesses before the court so that the case is disposed of as early as possible," Anwer Shahadat Shawan, special public prosecutor, told The Daily Star.

"Most of the remaining witnesses are also not appearing before the court due over security concerns as the accused are top listed criminals," he added.

Daudkandi highway police.

Locals said the fire might have originated from the gas cylinder of the bus.

The deceased were Rakibul, 70, of Daudkandi upazila, and his two-and-a-half-year-old Shafin.

Nine critically injured were sent to Dhaka Medical College Hospital, while two others were undergoing treatment at Daudkandi Upazila Health Complex.

Jamal Uddin, doctor of the health complex, said condition of the injured were critical.

Locals and firefighters doused the fire.

Aminul Islam, assistant superintendent of highway police (Cumilla circle), said this incident caused huge traffic jam on the Dhaka-Chattogram highway.
