Worrying spike

S African variant also found; 12 variants active

Following detection of the UK variant, the South African variant of coronavirus has been detected in Bangladesh, according to global genome-sequencing database GISAID.

According to the database, the South African variant -- also known as B.1.351 or 501.V2 -- was first reported from Bangladesh on January 24, which was already also found in the UK and the US.

There are 11 other variants including the UK one in the country, which were found earlier in multiple countries, according to data from GISAID.

News of detection of the South African variant comes when Bangladesh is seeing a steep rise in daily new infections and positivity rates of the highly transmissibly virus.

On February 21, a steady fall in the positivity rate had reached 2.33 percent, which spiked to 9.48 percent yesterday -- a fourfold rise. Daily new infections had been

as low as 845 on March 8, which more than doubled to 1,773 new daily cases.

Deaths have also risen to 26 yesterday from 18 on Sunday.

Unlike the UK variant, the preliminary work suggests the Oxford-AstraZeneca vaccine offers "limited" protection against mild disease from the South African variant, but experts say it should still protect against severe disease, reports BBC.

Modi on twin missions

Flies in on March 26 to join Mujib Borsho celebration, connect Matua factor for West Bengal polls

Indian Prime Minister Narendra Modi's scheduled visit to Bangladesh will not just be confined to attending the Mujib Borsho celebrations, he will tie up some loose ends of his script for the high-octane West Bengal polls.

As per his programme schedule, the Indian premier is expected to visit a sacred shrine of "Matua" community at Orakandi in Gopalganj district, a move the political analysts believe is aimed at wooing hearts of the Matuas across the border.

After arriving in Dhaka on March 26, Modi will fly off to Orakandi on March 27, the day West Bengal goes to the first of the eight-phase elections. Modi will pay respect to Harichand Thakur, the founder of the Matua sect, who was born there on March 11, 1812.

Forex now for dev projects

For the first time, a fast-track project gets 524m euros from foreign exchange reserves as govt opens BIDF for infrastructure development

In a first-ever move, the government is going to use €524.56 million from the ballooning foreign exchange reserves for a development project.

This is being done as part of a plan to use the money from the reserve for

The government formed Bangladesh Infrastructure Development Fund (BIDF) to lend the money from the forex reserves for the dredging of a channel for Payra Port, a seaport in

Initially, investments will be made to be financed through BIDF. from the BIDF to the port and power sectors. The annual investment target from the fund would be no more than \$2 billion, according to finance ministry documents.


The government would pick those projects for the foreign currency loans that would have a high rate of return so that it can repay the loans also in the foreign currencies, said the

The capital and maintenance dredging of Rabanabad Channel of Payra Port scheme is the first project

A tripartite loan agreement was signed yesterday between the Finance Division, Payra Port Authority and Sonali Bank Limited to finance Tk 5,417 crore (€524.56 million) for the infrastructural development project.

Prime Minister Sheikh Hasina joined the signing agreement virtually from the Gono Bhaban.

Sonali Bank would finance the Ramnabad Channel dredging project. Bangladesh Bank will issue the loan to Sonali Bank at an interest rate of SEE PAGE 2 COL 1

Around over 3.5 crore Matua people live across the state.

The politically active community is a decisive factor in 30 out of the total 294 assembly constituencies. Besides, it has indirect influence in around 63 seats, they say.

Travel back in time with old sculptures

Four unrecorded antiquities found in Sylhet monastery opens up new horizon of archaeological research

Four ages-old stone sculptures, so far academically unrecorded, have been found at a monastery in Sylhet city and can open up a new avenue of studying art and heritage of ancient Shrihatta.

These antiquities -- two Vishnu idols, a miniature Ganesh statue and a Shiva Lingam -- are worshipped by Hindu devotees at the Shree Shree Balaram Jeu Akhra (monastery) in

Mirabazar area. Some researchers think the Shiva Lingam could be from the period between 15th and 16th century and the three other sculptures from 10th

to 12th century. "These are very important antiquities for the history and heritage of Sylhet," said Prof Mozammel Hoque of archaeology department at Jahangirnagar University.

Historians and researchers said the Balaram Akhra was built

around three hundred years ago by a zamindar named Madan Munsi.

Gopika Shyam Purkayastha, vice president of its managing committee, said one of the Vishnu idols was found during a reexcavation of a canal for renovation of a bridge in 1973. The same year, the second one was found while digging a pond near the monastery. The height of both the idols is

seven feet three inches.
