Secys start talks in Delhi today

Bangladesh and India hold the watersecretary level meeting in Delhi today ahead of Indian Prime Minister Narendra Modi's visit to Bangladesh on March 26-27.

Water Resources Ministry Secretary Kabir Bin Anwar and his Indian counterpart Pankaj Kumar will lead their respective sides in the meeting.

"Our water secretary is already in Delhi ... Water-sharing issues of six rivers and other things will be discussed," Foreign Minister AK Abdul Momen told reporters at an event at the Foreign Service Academy yesterday.

Dhaka and Delhi began watersharing talks on six rivers -- the Manu, Muhuri, Khowai, Gumti, Dharla and Dudhkumar -- in August 2019 after the two countries failed to sign the Teesta water-sharing deal due to West Bengal Chief Minister Mamata Banerjee's lastminute opposition in 2011.

This has been an issue of friction in the bilateral relations, but India says the state government approval is a precondition, as per the country's constitution, for such deals on common rivers.

"Teesta [deal] was final. Those who were present in the meeting told us in each page, initials were there. We know why it has not been signed then. India repeatedly said they stand by the deal. We raise the issue in all the meetings between the two countries," Momen

Not only the Teesta, he said, the two governments are working on watersharing of six other rivers. The two countries have 54 rivers in common, but the treaties on water-sharing were inked only on two rivers -- the Ganges in 1996 and the Feni in 2019.

The two sides also spoke of collecting data on the amount of water used by the two countries from each of the rivers, Malik Fida A Khan, a member of the committee and executive director at the Centre for Environmental and Information Services Geographic

(CEGIS), had told this correspondent.

Malik Fida said once the data on water usage by the two countries is shared, they can develop a water-sharing framework agreement.

A member of the Bangladesh delegation told this correspondent that Bangladesh wants basin-wide river management, which requires sharing of data on environmental flow of the rivers, joint studies, dredging etc.

The official said Bangladesh wants withdrawal of 153 cusec water from the Rahimpur canal for an irrigation project. Bangladesh also wants a joint study on

the optimum use of the Ganges water. "We will discuss these issues in the meeting," he added.

Our New Delhi correspondent adds: the water secretary-level meeting in New Delhi is expected to discuss the issue of withdrawing water from the Feni river for Sabroom town in Tripura for which an MoU was signed with Bangladesh during Prime Minister Sheikh Hasina's visit in October 2019, official sources

The MoU allows India to withdraw 1.82 cubic feet per second (cusec) of water (equal to 51.4 litres per second)

The sources said talks are also expected on a possible Memorandum of Understanding (MoU) for drawing water from the Surma river.

Worrying spike

According to local experts, if the South African variant is already in the country, it is a cause of concern for the country as it can spread more rapidly.

The South African variant was detected in a sample sent to Bangladesh Council of Scientific and Industrial (BCSIR) for Research sequencing by the National Institute of Laboratory Medicine and Referral Centre on Jan 21, its Director Prof Dr Abul Khair Mohammad Shamsuzzaman told The Daily Star yesterday.

The BCSIR sent the data of the sequencing back to the referral centre in early March, after which the centre forwarded it to the Institute of Epidemiology, Disease Control and

This newspaper learnt that the authorities of BCSIR have submitted 93 new genome sequencing data to the GISAID database last week.

Noted virologist and member of the National Technical Advisory Committee on Covid-19 Prof Nazrul Islam, however, had a slightly different take.

"If we analyse the severity of infection, and considering the growing transmission among the young people, we can see a similarity with the UK situation after the new variant was detected there. Most probably, the South African variant is also contributing to the rise in transmission," Prof Nazrul Islam told The Daily Star yesterday.

He also opined that there is no scope to reopen educational institutions in this context.

"We have to enforce health rules right now," he urged.

Meanwhile, Health Minister Zahid Maleque yesterday also said they have instructed all hospitals across the country to stay prepared to tackle the rising number of Covid-19 patients.

"We are seeing transmission increasing. Covid-19 positivity rate has crossed seven percent [on Sunday]. Deaths too have increased. Yesterday [Sunday], 18 died which we have not seen in the last two and a half months. We are very panicked and worried about it," Zahid Maleque said following a meeting in his office at the

NYC pays emotional tribute to more than

30,000 Covid deaths

New York, the US city most bereaved by the coronavirus, paid a moving tribute Sunday to its 30,258 dead, one year after the start of the pandemic.

"More New Yorkers lost than in World War Two, Vietnam, Hurricane Sandy and 9/11 put together. Every family touched in some way, and for so many families a pain, a pain that is raw," Mayor Bill de Blasio said during a live virtual ceremony, after calling for a moment of silence to honor the victims.

The Democratic mayor heralded the health care heroes" who "saved lives, sometimes at their own expense.

He also called on New Yorkers to remember the good times. "No matter what happens, no one can take away the dances you've already danced," he said, speaking in Spanish as he quoted Colombian writer Gabriel Garcia Marquez, in a city where a third of immigrants are of Latin origin.

World leaders

"It shows the depth of our friendship with the countries. They have confidence in the leadership of Bangladesh, and so they are coming here despite the pandemic," he said.

According to foreign ministry cultural officials, Lanka, Indonesia, Japan, South Korea,

troops from Bangladesh as well as India, Vietnam, Sri Nepal, Turkey, Malaysia, and Brunei would perform during the celebrations. The themes of the events were

named "Bhengechhe Duar, Eshechche Jyotirmoy" on March 17; "Mohakaler Tarjoni" on March 18; "Jatokal Robe Padma, Jamuna" on March 19; Tarunner Alokshikha" on March 20; "Dhangshastoope Jiboner Gaan" on March 21; "Banglar Mati, Amaar Mati" on March 22; "Narimukti, Sammya O Swadhinata" on March 23; "Shanti, Mukti O Manabatar Agradoot" on March 24; "Gonohattyar Kalratri O Aloker Obhijatra" on March 25 and "Swadhinatar 50 Bochchor O Agragoti'r Subarnorekha" on March 26.

The programmes would be broadcast ive on electronic and social media.

Momen said there might be some problems due to the movements of foreign guests' and urged all to be accommodative as the occasion was extraordinary.

The minister said several MoUs would be signed with countries whose heads of states or governments would be visiting Bangladesh.

"At least three MoUs will be signed with India. We are still working on those. One of those will be on disasterrisk reduction and the rest are between some institutions of Bangladesh and India," said Momen.

Foreign Secretary Masud Bin Momen said all the countries, whose heads of state or government are coming, would ink some MoUs with Bangladesh. Those are in the process of finalisation, he said.

Asked if Bangladesh invited all Saarc neads of state or government, Minister Momen said Bangladesh also invited Afghanistan, but received no response.

He said Myanmar has not been invited because "we don't know who is o be invited from Myanmar".

State Minister for Foreign Affairs Shahriar Alam, Secretary (East) at the Foreign Ministry Mashfee Binte Shams, and Foreign Ministry Chief of Protocol M Amanul Haq also spoke at the press conference.

"So in such a view of exigency of the issue, this court on exercising judicial review basing Article 102(2) of the Constitution thus suo motu direct the respondent no. 5 [BTRC] to take effective and immediate measure requesting the owning company of those social medias, that is Twitter, Facebook, Instagram & YouTube not to upload or stream the documentary as mentioned above nationally and internationally any further through any link and website as mentioned in the prayer portion of the writ petition," the HC bench said.

1 percent. The latter will disburse the loan to Payra Port authorities at 2 percent interest rate.

The repayment period is 10 years,

excluding a three-year "grace period", finance ministry documents said.

The prime minister said, "Instead of borrowing from others repeatedly, we have to develop our infrastructure with our own money... It will also benefit the country and give us confidence. We can show the world what we can do.

"As a developing country, we have to be self-reliant. We have to work with our own funds. We will improve our country and that is our goal. We need to do a lot more to achieve that goal.

The prime minister said the government's endeavour was to find ways to utilize the surplus forex reserve in profitable development works. "That's why we have thought of forming a fund from where the investors can take loans."

The country's reserve touched a new milestone of \$43 billion riding on robust flow of remittance, a fall in imports caused by the pandemic and a recent uptick in exports.

Bangladesh Bank Governor Fazle Kabir said, "Since we are graduating from the LDC to a developing nation, we need to keep a substantial amount in the reserve. Therefore, we must be vigilant in spending the fund."

He said the interest rates and other hidden costs of the loans that the country takes from foreign countries are

quite large.
"If the fund from the forex reserves is used carefully, it will help the country save on foreign currencies," the governor

On July 6 last year, Sheikh Hasina talked about taking loans from the forex reserves at a meeting of the Executive Committee of the National Economic Council (Ecnec).

She ordered preparing a guideline or roadmap based on detailed analysis of the viability of using a portion of

the forex reserves to provide loans for profitable projects.

In September, the central bank submitted a concept paper to the finance ministry on using the foreign exchange

The district administration took the two antiquities in its custody and handed them over to the Balaram Akhra after a decade. Cracks were found on the hands of both the idols and they were repaired and recoloured later on.

Talking to The Daily Star, Gopika Shyam said the Ganesh idol and Shiva Lingam were handed over to the monastery between '60s and '80s. The managing committee has no

information about how the Ganesh idol,

which is two feet three inches tall, ended

up here. "But it is certain that the donor was a resident of Sylhet town," said The Shiva Lingam, two feet one inch tall, was donated by Ashutosh Sharma, father of local freedom fighter Chandan Sharma, in 1965. It was in the family temple at their Raynagar residence, said

Chandan's son Amitabh Sharma, a local

school teacher. Previously, four ancient Vishnu sculptures were found in Sylhet region. Kamalakanta Historian Chowdhury in his book titled "Copper Plate of Sylhet", published in 1967, mentioned three of those. One was found at a pond in Ambarkhana area of Sylhet, the second at a temple in Jagannathpur of Sunamganj and the third at Panchakhanda Basudeva Angan in Beanibaza of Sylhet.

Panchakhanda Basudeva Angan, an ages-old temple, also houses idols of a Dhyani (meditating) Buddha and a Garudashin Vishnu (Lord Vishnu sitting or riding on Garuda, a mythical bird-like creature). The Daily Star ran a report on these two in October last year.



Vishnu is worshipped as the Supreme Lord by the followers of Vaishnavism, a major Hindu denomination alongside Shaivism, Shaktism, and Smartism And Shiva Lingam is a symbol that

represents Lord Shiva. Finding both the Vishnu idols and Shaiva sculptures in the same area suggests that there could be coexistence of followers of Vaishnavism and Shivaism in this region, said Prof

Mozammel Hoque.

About the Shiva Lingam, Amitabh Sharma said, "It was worshiped at our family temple throughout generations. But we don't know anything about its The history of Sharma Brahmins is

very old in the region.

The Shiva Lingam has five layers that represent "Pancha Bhoota" or five great elements -- Earth, Water, Fire, Air and Space. Its presence in Sylhet points to

the influence of South Indian followers of Shaivism in the region, he said. Prof Mozammel Hoque said, "Such a Shiva Lingam is rare in Bangladesh; particularly there is no academic record of finding any Shaiva sculpture in Sylhet

region. On the other three sculptures, he said the designs of the idols suggest that they could be from 10th to 12th century.

"We did not find any documents mentioning these four ancient sculptures. Recovery of these sculptures hints that there might be more such antiquities in this region," he said.

"It has created a new horizon of historical and archaeological research in Dr Dilip Kumar Das Chowdhury,

principal of Srihatta Sanskrit College in

Sylhet, said ancient Srihatta was full of temples -- for followers of Vaishnavism, Shivaism and Shaktism. So more antiquities may be found if a proper excavation is initiated, he
