A three-member team of University Grants Commission (UGC) has visited Begum Rokeya University, Rangpur (BRUR) and Hajee Mohammad Danesh Science and Technology University (HSTU) to investigate various complaints of corruption, irregularities and anomalies filed separately in 2019.

The team, headed by UGC Member Dr Bishwajit Chanda, visited BRUR on Sunday and HSTU yesterday.

The UGC officials stayed at BRUR for around 12 hours, reaching there at 10am, while they stayed at HSTU campus from 10am to 4pm.

The other team members were UGC Senior Assistant Secretary Jamal Uddin and UGC Member Dr Abu Taher.

Charges framed against BLAST employee

A Cox's Bazar court yesterday framed charges against an employee of Bangladesh Legal Aid and Services Trust (BLAST) in a defamation case of Tk 100 crore filed by Border Guard Bangladesh (BGB) last year.

The court of Senior Judicial Magistrate

Tamanna Farah in Cox's Bazar passed the order in presence of the accused, said BGB's lawyer Md Sazzadul Karim. Ábdul Sukkur, a lawyer for the BLAST

employee, said, "We have submitted a petition to the court for my client's acquittal, but it was rejected.

Asked, Borkot Ali, a lawyer of BLAST, also said they had filed an application under Section 241(A) to discharge the employee from the charges, but the application was rejected. He did not want to make any further comment on this issue.

MISHAP ON BRT LINE-3

Work resumption could take a month: officials

Resumption of construction works near Dhaka Airport for Bus Rapid Transit Line-3, which witnessed two accidents on Sunday that left six workers injured, may take up to a month, officials

Meanwhile, a probe committee formed by road transport and highways division (RTHD) has started their work and would visit the spot today, they said. Besides, a team of Dhaka Transport Coordination Authority (DTCA) also visited the spot yesterday.

At least six workers, including three Chinese nationals involved in construction of BRT Line-3, were injured as a part of a launching girder fell on them while they were working near Dhaka airport.

The accident took place hours after a pier cap of an elevated section of the same BRT line collapsed early on Sunday, exposing serious weaknesses in

A launching girder is a type of gantry crane used for lifting and installing girders of viaducts.

Of the injured, four got released from Evercare Hospital while two were still in hospital with one Chinese national in intensive care unit, a hospital

The Tk 4,268-crore project, which witnessed several revisions of both cost and deadline, is being implemented by Dhaka Bus Rapid Transit Company Limited (DBRTCL), a government-owned company, to set up a 20.5km line for dedicated bus service from Dhaka airport to Gazipur.

Three government agencies -- Roads and Highways Department (RHD), Bangladesh Bridge Authority (BBA) and Local Government Engineering Department (LGED) -- are involved in the implementation of various segments of the

The portion of the line near the airport where the accident took place is being carried out by RHD with their contractor -- China Gezhouba Group Co

DBRTCL Managing Director Shafiqul Islam said it would take at least 15 days and up to one month to fix the launching girder and works of this portion would remained suspended till then. There is only one launching girder for this portion, he added.

The project was supposed to be completed in between December 2012 and 2016, but has SEE PAGE 4 COL 3

Environment ministry tells JS body



Professor Muhammad Munirul Islam (1936-2021)

Professor Munirul Islam passed away peacefully on Friday, 12 March, 2021 at his home in Dhaka. Born in Chittagong, he was the son of Justice M. Idris and Begum Kulsum Idris.

A Professor of Physics at the University of Connecticut, USA, he was elected a Fellow of the American Physical Society and retired as Professor Emeritus in 2007. Prof. Islam was a Kali Narayan Scholar of Dhaka University and received his doctorate from Imperial College, London.

His lifelong research focused on developing a theoretical model for the structure of the proton, which is being evaluated by Large Hadron Collider (LHC) experiments at CERN, Geneva.

He shall be missed dearly by his family and friends.
