

CHECK-UP OF KISHORE Medical board formed at DMCH

Dhaka Medical College Hospital (DMCH) authorities yesterday formed a three-member medical board for check-up of cartoonist Ahmed Kabir Kishore.

"We got a letter from the court to form a medical board yesterday [Monday]. As per the directions of the letter, we formed the medical board," DMCH director Brig Gen Nazmul Haque told The Daily Star yesterday afternoon.

The board members are: Prof Sheikh Nurul Fatah Rumi of ENT department, Fakhrul Amin of Orthopedic department and Prof Hafiz Sardar of Medicine department.

Earlier in the day, Kishore was taken to DMCH for medical check-up as per the High Court's March 14 order, said Kishore's elder brother writer Ahsan Kabir.

On March 14, the HC also asked the director of DMCH to form a three-member medical board to examine the torture that Kishore suffered in custody from May 2 to May 4 last year.

On March 10, Kishore filed a case under the Torture and Custodial Death (Prevention) Act-2013, seeking redress.

He did not mention the name of any law enforcement agency or officials, instead choosing to file charges against a group of unidentified people. The judge also took the case into cognizance and recorded his statement that day.

Kishore, who was prosecuted under the controversial Digital Security Act, languished in jail for around 10 months. He got out on bail on March 4.

After his release, he revealed to the media how he was brutally tortured before he was shown arrested on paper in the case.

Visiting the Boimela premises yesterday, this correspondent could hear little beyond the incessant sound of hammering and the buzzing noise of chainsaws. Those who are done building their stalls are now busy with painting.

Publishers are regular faces at the ground -- to monitor and supervise the construction. They spoke to this correspondent about the thought that went behind stall and pavilion designs. Known for their design artistry, Boimela is home to lots of shapes and colours during its runtime.

Among the popular publications, Anannya has already finished erecting theirs. They are now focusing on painting. True to form, Katha Prakash is at it with their innovative pavilion designs, while Anya Prakash is creating intrigue with theirs.

As inauguration looms, publisher of Biswa Sahitya Bhaban Tofajjal Hossain said, "We're trying to wow our visitors with our stall designs. We're working hard for it."

The Boimela will be home to 522 entities this year, with 32 of them leasing pavilions. Bangla Academy will also have its own pavilion. Like every year, the fair will have little mag corner this time too.

There will also be four shades this year, mostly due to the forecast of rain and storm for the month.

Till afternoon on Fridays and Saturdays, the fair will continue to be specially organised for children.

The book fair is also known for its patriotic fervour, and this year will be no different. There will also be a special focus on Mujib Borsho and golden jubilee of the independence. Both themes will grace everything in the fair, from publications to aesthetics.

To mark the 50th year of the Independence, this year's fair will showcase these five decades with distinct presentations, said organisers.

Tension mounts over CCC panel mayor race

Tension is mounting among the councillors of Chattogram City Corporation (CCC) over the elections to panel mayors, scheduled to be held tomorrow.

This time around, many councillors are showing interest in becoming panel mayors, according to sources. They are mostly divided into two groups -- councillors who are known as followers of late CCC mayor ABM Mohiuddin Chowdhury and those who are followers of former CCC mayor AJM Nasir Uddin.

As per rules, two councillors from general seats and a female councillor from reserved seats would be elected panel mayors by the votes of 55 councillors. Panel mayors are usually elected between the first and third general meetings of the council.

Meanwhile, city corporation sources said the new mayor, Rezaul Karim Chowdhury, has no direct involvement in this election, whereas the previous mayors used to be directly or indirectly involved with the panel mayor elections.

The correspondent talked to a number of CCC councillors who, wishing anonymity, admitted the polarisation.

"In the last polls in 2015, the mayor played a vital role in the panel mayor elections...All the three elected panel mayors were his followers," said a councillor. "But the situation has changed this time, as the number of elected councillors who are followers of Mohiuddin Chowdhury is more than that of the previous mayor."

Dr Yunus exempted from court appearance

The High Court yesterday exempted Grameen Telecom Chairman and Nobel laureate Dr Muhammad Yunus and its Managing Director Md Ashraful Hasan from personal appearance before the court in connection with a contempt of court rule.

Dr Yunus and Md Ashraful virtually appeared before the HC bench of Justice Md Mozibur Rahman Miah and Justice Md Kamrul Islam Mollah at 11am yesterday in compliance with its February 18 order.

The bench set April 22 for holding hearing on the rule.

During yesterday's hearing, Rokanuddin Mahmud and Mustafizur Rahman Khan -- lawyers for Dr Yunus and Md Ashraful -- told the court that their clients did not violate any court order.

The petitioners, who filed the contempt of court petition, were not terminated from their service and they have been working

DSA formulated to muzzle free speech

Speakers tell rally in capital

Leaders and activists of progressive students' organisations have called upon the government to abolish the Digital Security Act (DSA), saying that it is being used to muzzle people's freedom of expression.

They also sought justice for the death of writer Mushtaq Ahmed and torture of cartoonist Ahmed Kishore in custody.

Under the banner of Progressive Students' Organisations, students, teachers and writers yesterday held a protest rally in front of the secretariat where speakers made the demands.

Quoting a report by human rights organisation Odhikar, Mohammad Tanzimuddin Khan, professor of International Relations Department of Dhaka University, said about 195 persons have been victims of extrajudicial killing each year between 2010 and 2020.

DSA was enacted to save people responsible for the extrajudicial killings, he opined, adding that the act is formulated to muzzle people's freedom of expression.

Researcher and activist Maha Mirza said, "We fought for the liberation of the country for our freedom of expression and security. But after the 50 years of liberation, we are holding protest rally for our freedom of expression."

"We're being made accused of sedition for criticising the government... Taking the advantages of the act, is being
