## VIOLENCE IN NOAKHALI Freedom fighter, Mirza sued in two cases

Two cases were filed with a speedy trial tribunal in Noakhali yesterday in connection with violence in Companiganj upazila on March 8 accusing a freedom fighter and Basurhat municipality mayor Quader Mirza.

One of the cases was lodged by Arjuman Parveen, wife of freedom fighter Khizir Hayat Khan, who is the president of Companiganj Awami League.

In the case statement, Parveen alleged that Mirza, the younger brother of ruling AL General Secretary Obaidul Quader, along with his supporters attacked Khizir at an office in Basurhat's Rupali Chattar area on March 8 afternoon.

The attackers assaulted Khizir, leaving him seriously injured. They also tore his clothes, alleged Parveen.

The case was filed against 97 named accused, including Mirza, and some 56 to 60 unnamed accused, said plaintiff's lawyer Harunur Rashid Hawlader.

The other case was filed against Khizir and his followers.

Iqbal Hossain Swapan, a member of Companiganj upazila unit Sramik League and also a supporter of Mirza, lodged the case accusing 196 named persons, including Khizir, and some 50 to 60 unnamed ones.

In the case statement, Swapan alleged that a group of people, led by Khizir and the upazila unit AL Organizing Secretary Mizanur Rahman Badal, attacked Mirza and his supporters while they were in a meeting at Basurhat city unit AL office at Rupali Chattar on March 8 afternoon.

After accepting both the cases, the tribunal's Senior Judicial Magistrate directed Companiganj Police Station Officer-in-Charge (OC) Mir Jahidul Haque Rony to investigate the incidents and submit probe reports before the

court within 10 working days. Contacted, Mirza and Khizir blamed each other for the incident.



## Nato chief says defence spending up despite pandemic

Nato Secretary General Jens Stoltenberg yesterday said European allies had increased defence spending in 2020 despite the economic pain inflicted by the coronavirus pandemic. "Despite the economic impact of Covid-19 2020 was the sixth consecutive year of increased defense spending across European allies and Canada with an increase in real terms of 3.9 percent," Stoltenberg told a press conference to mark the launch of Nato's annual report.

Risk "with such a large number of candidates'

A member of the Covid-19 National Technical Advisory Committee and former BSMMU Vice-Chancellor Dr Nazrul Islam told The Daily Star yesterday, "Covid-19 fatalities and infections are increasing. So, there is a risk of holding the exam with such a large number of candidates."

Around 4.75 lakh candidates

applied for the exam after the 41st BCS circular was published in November 2019 to appoint 2,018 vacant posts in different cadres.

Among the 41st BCS candidates, 211,000 are from Dhaka, 37,000 from Rajshahi, 35,000 from Chattogram, 32,000 from Rangpur, 28,000 from Mymensingh, 16,000 from Sylhet, and 12,000 from Barishal, among others.

Among the 351 centres in seven divisions, there are many centres where 3,000-4,000 candidates will sit for the exam.

According to the public health expert, managing these numbers is a big challenge.

"But if PSC thinks that they must

hold the exam, then they must follow the health guidelines. Candidates have to follow the hygiene rules from the time of entry to the time of exit, everything -- sanitising, masks -- is needed," said Dr Nazrul Islam.

Former secretary and PSC member Shahjahan Ali Mollah, in charge of conducting the 41st BCS exam, told The Daily Star yesterday the exam will be held in strict compliance with the hygiene rules.

"We have given 11-point instructions this [Tuesday] evening. Everyone has to come to the centre wearing a mask and can pass inside by having their temperature measured. If someone's temperature is high, they will be taken to a separate room. Seats

## Rules needed to stop corruption suspects from leaving country

#### HC observes

The High Court yesterday observed that a specific law or rules need to be formulated soon regarding imposition of embargo on corruption suspects or accused's leaving the country.

There is no specific law or rules for banning the people, against whom inquiries or investigations are running in connection with corruption allegations or cases, from leaving the country though they have rights to free movement according to the constitution, the court said.

"We hope that the Anti-Corruption Commission and the ministries concerned will take necessary steps to enact a law or formulate a rules to this effect soon," said the HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman.

The bench also ruled that the special judges' courts concerned will take decision whether such people against whom inquiries or investigations are underway can go abroad until a law is enacted or rules are framed to this effect.

The HC bench said it will give necessary guidelines in the full text of the verdict later on.

The court came up with the judgment after it heard a writ petition filed by one Ataur Rahman from Narsingdi challenging the ACC's action to restrain him from going abroad as a graft allegation against him was being inquired. The court declared the ACC's action illegal and allowed Ataur to go to

illegal and allowed Ataur to go to weden where he lives with his family.

Deputy Attorney General Sarwar Iossain Éappi told The Daily Star that the ACC issued a notice on August 2, 2020, asking Ataur, known as Sweden Ataur, to submit his wealth statement to the commission.

After he submitted the statement, he anti-graft body started an inquiry into his wealth and on December 20 that year, the commission issued a letter to the immigration police to

refrain Ataur from going to Sweden. Ataur then filed the petition with the HC challenging the ACC's action to prevent him from going abroad, Sarwar said.

Ataur's lawyer Munshi told Moniruzzaman this correspondent that his client runs a business in Sweden.

He has given the details about his asset to the ACC in line with its notice, he said, adding that there is no legal bar to his client to go abroad

A mob yesterday attacked SM Munim Lincoln, Upazila Nirbahi Officer (UNO) of Jibannagar in Chuadanga, as he tried to free a tractor that was held by the locals for killing a man.

Police rescued the UNO almost an hour after he was attacked around 12:30pm.

According to locals, Ohidul Biswas, of Bathangachhi village in Maheshpur upazila of Jhenaidah, was riding a bicycle in Jibannagar's Katapole village with his son.

A locally made mud-laden tractor was going on the wrong side of the road and hit the bicycle, leaving Ohidul dead on the spot and his eight-year-old son critically injured.

On information, agitated locals confined the tractor and put a barricade on Jibannagar upazila road.

At one point, UNO Lincoln reached the spot with a police team and tried to calm the crowd. He also asked the locals to release the seized tractor.

As he asked the locals to release the tractor, they chased the UNO and police team and threw brick chunks at them. The UNO was also locked in a house in the area for about an hour.

Local people complained that the soil was being cut illegally from government land and then transported in unlicensed transports like tractors, Nasimon, Karimon etc.

A union parishad member in the area said a number of earth lifters are active in the area. They are continuously lifting soils from canal, river bed and selling to brick kilns.

"But the administration is not paying any heed," he said, seeking anonymity.

Saiful Islam, officer-in-charge of Jibannagar Police Station, said the UNO was taken to Jibannagar Upazila Health Complex. He received first aid there and then went to his residence.

The OC said additional police were deployed in the area.

The Upazila Nirbahi Officer has filed a case against unknown and unnumbered people in the area alleging obstruction of government work.

On the other hand, the family of the dead has filed another case against the tractor driver and helper.

The dead body was sent to Chuadanga Sadar Hospital.

The Daily Star, however, could not reach UNO Lincoln over the phone after repeated attempts.

# Mass protests in Bolivia over expresident's arrest

Tens of thousands of Bolivians answered an opposition call Monday for protests against the arrest and detention of former president Jeanine Anez on charges of leading a coup d'etat against her socialist predecessor Evo Morales.

Conservative Anez, 53, was placed in pre-trial detention Sunday after she was arrested on charges of terrorism, sedition and conspiracy. "It wasn't a coup. It was a fraud,"

read a banner held by one of the protesters who defied the dangers of the coronavirus pandemic to attend marches, sit-ins in front of prosecutor's offices and peaceful gatherings in the capital La Paz and in the cities of Cochabamba, Sucre, Trinidad and Santa Cruz.

In Santa Cruz, the country's economic capital, some 40,000 people assembled in the Christ the Redeemer Square, which has only been the site of right-wing demonstrations in the past.

The arrest brought a rebuke from the Organization of American States (ÖAS), which on Monday expressed "concern about the abuse of legal mechanisms that once again have been transformed into instruments of repression by

the governing party. "The Bolivian judicial system is not in a position to provide the minimum guarantees of a fair trial," the office of OAS Secretary General Luis Almagro said in a statement.
