# Confusion reigns over Salim's JS fate

HC upholds his graft sentence, but no judgment clarifies which court's

According to Article 66 (2)(d), "A person shall be disqualified for election as, or for being, a member of parliament who has been, on conviction for a criminal offence involving moral turpitude, sentenced to imprisonment for a term of not less than two years, unless a period of five

This applies to sentences by any court, Khurshid said, adding that the Jatiya Sangsad Speaker can take necessary steps to cancel the parliament membership of Haji Salim

This provision means someone like Salim, who was initially sentenced to 13 years in prison on two charges -- 10 years for graft and three more years for concealing information -- in 2008, would not be able to contest parliamentary elections or hold the office of a member of parliament until five years after serving his jail

The HC bench on March 9 acquitted him of the charge of concealing information.

Haji Salim's lawyer Sayed Ahmed Raza, however, said his client would move an appeal before the Appellate Division of the Supreme Court,

parliamentary memberships were not cancelled as their appeals are pending with the appeals court, he added.

Meanwhile, ACC counsel Khurshid Alam Khan told this correspondent that only eight appeals, including that of Haji Salim, out of 27 have been disposed of by the HC in around six years after the apex court overturned acquittals of the accused in corruption cases filed during the rule of the military-backed caretaker

Between January 2014 and June 2015, the Appellate Division had scrapped the HC acquittals of 35 people, mostly politicians and their family members, and ordered the HC to expeditiously hold re-hearings of their appeals against convictions handed down by the lower courts.

Among them, former AL Relief and Disaster Management Minister Mofazzal Hossain Chowdhury Maya and former BNP lawmaker Monjurul Ahsan Munshi were acquitted by the HC on rehearing of their appeals.

Former BNP lawmaker Hafiz Ibrahim's three years' imprisonment was upheld by the HC on rehearing his appeal and he has already served his jail sentence.

Hafiz Ibrahim's lawyer Sabbir Hamza Chowdhury told The Daily Star that his client had been declared qualified for contesting the last parliamentary election.

In November 2017, the HC commuted jail terms for former BNP minister Nazmul Huda from seven to four years and ruled that his wife Sigma Huda's three years' jail sentence would be considered as served out because she had earlier served time in

The HC upheld a lower court verdict that sentenced BNP leader and former state minister for civil aviation Mir Mohammad Nasiruddin to 13 years and his son Mir Helal Uddin to three years in jail.

Nazmul Huda, Mir Nasir, and Mir Helal are now on bail granted by the apex court as they surrendered Malik told this correspondent that to the trial court in line with the HC verdicts.

The other accused whose acquittals were cancelled by the top court include former BNP state minister Amanullah Aman and his wife Sabera Aman, former AL lawmaker Joynal Abedin Hazari, Hafiz Ibrahim's wife Mafruza Sultana, former AL lawmaker Mockbul Hossain (now deceased) and his wife Fatema Tahera Khanam, former commissioner of customs Jahurul Haque and his wife Afia Haque, and former Islami Oikya Jote lawmaker Mufti Shahidul Islam (now deceased), according to ACC lawyer

The Maldives president, his wife Madam Fazna Åhmed, Maldivian Foreign Minister Abdullah Shahid and Economic Development Minister Fayyaz Ismail arrived in Dhaka on Wednesday to join the twin celebrations of Mujib Borsho and golden jubilee of Bangladesh's independence.

Solih also attended a dinner hosted by President Abdul Hamid before leaving for Malé last night.

### Act before it's too late

The last time the country recorded a higher positivity rate was on December 13, 2020, 10.63 percent of samples tested positive for coronavirus.

"Unless we increase the number of tests to one or two lakh, we will never know the level of transmission. Bangladesh yesterday said they will intensify efforts to ensure people are maintaining health

coronavirus infections in the month of March again. Already around 16,000 people got infected in the month at an average of 1,000 daily, whereas the figure was only 11,061 in February," said Benazir Ahmed, Inspector General of Police (IGP), yesterday.

Due to the sudden rise of Covid-19, police will undertake a nationwide special awareness programme from March 21 so that every people of the country take preventive steps, said the police chief.

Police will continue the awareness with the slogan "habit of wearing mask, Covid-free Bangladesh". The IGP disclosed the steps taken by

police to prevent the ongoing surgeof coronavirus while addressing reporters at Bangladesh Police Auditorium in Rajarbagh. He said "everyone has to follow strict

hygiene rules. Masks should be worn, hands should be washed repeatedly with soap. Hand sanitisers should be kept if necessary.' Replying to a query about forcing

people to wear masks, the police chief said, "We do not want to say that right now. We want to inspire people to wear masks with motivation and awareness. "Moreover, why should we need to

be encouraged to wear a mask? I hope people will wear masks for themselves and their families out of a sense of responsibility," he said.

Community police and beat police will work to create awareness and free masks will be provided if needed, said the IGP.

Asked about police allowing big political events and gatherings, the IGP aid the issue of permission depends on the situation. "We have to strictly follow hygiene rules at every event even if given permission," he said.

Regarding the restrictions in kitchen markets, the police chief said it will depend on the situation and everything will be implemented in phases as required by circumstances.

## Pollutants 10 times the limit in winter

potential at the hospitals' environment in Dhaka, Bangladesh".

According to a global report published on Wednesday, air quality of Bangladesh was the worst in the world, while its capital Dhaka was the second worst air polluted city last year. The study on the three health care

institutions was conducted by health care professionals and academicians in two periods -- pre-monsoon and winter. It found that air quality remains worse during both the periods. example, the

concentration of PM 2.5 at the three healthcare institutions was  $52.28\,\mu\text{g/m}3$ during pre-monsoon which is double than the NAAQS permissible limit. In winter, the average concentration of PM 2.5 was 222.53 µg/m3 which

is around eight times higher than the AAQS permissible limit, the report said. The WHO's ambient air quality permissible standard is 25 µg/m3 while is  $55 \mu g/m3$  for NAAQS.

Speaking to The Daily Star, Prof Abdus Salam, key author of the study and also a chemistry teacher at Dhaka University, said indoor air quality worsens due to various activities of the people and it indicates the unhygienic condition at hospitals.

To improve the indoor air quality at

concerned should focus on the overall hygiene situation and reduce crowding by patient's attendants at hospitals, he added.

The first-of-its-kind study on indoor air quality of hospitals in the country also said toxicity potential (TP) values at the three installations were 10 times higher than normal, which means the environment there could aggravate patients' health.

"Extremely high TP values indicated potential severe health consequences of the healthcare professionals and patients in indoor hospitals environment," the report said.

showed higher particulate matter (PM) concentrations than other indoor sampling locations at the DMCH. The ward was most crowded and filthy among all the sites in the hospital, the study found.

It also said unhygienic environment and movement of people increased outdoor particulate concentrations inside the hospitals.

can improve the air quality inside the hospitals, adding that cooking inside the wards should be stopped.

Contacted, DMCH Director Brig Gen Nazmul Haque said they were working on improving the environment inside the hospital.

"The hospital is overcrowded and people's movement is big inside the hospital. We try to keep our hospital clean but it is not possible to keep it clean all the time especially when the hospital is overcrowded," he told The Daily Star.

Be-Nazir Ahmed, former director disease control) at the Directorate General of Health Services, said poor air quality inside a hospital indicates that there is high possibility of infection which is dangerous.

The hospital authorities must identify the sources of dust. There is no alternative to cleanliness. There is a serious lack of cleaners at hospitals. We have to engage more cleaners in keeping the hospitals clean.'

Modern equipment should be used to make the indoor environment clean, he added Indoor and outdoor air pollution

led to 1.23 lakh deaths in Bangladesh in 2017, according to a study titled The State of Global Air 2019.

Long-term exposure to outdoor and indoor air pollution contributed to nearly five million deaths from stroke, diabetes, heart attack, lung cancer and chronic lung disease in 2017.

The High Court yesterday granted bail to Erfan Salim, son of Dhaka-7 lawmaker Haji Md Salim, in a case filed over attacking a navy officer in the capital's Dhanmondi in October last The bench of Justice Jahangir

Hossain Selim and Justice Md Badruzzaman delivered the verdict after hearing a petition filed by Erfan seeking bail in the case. There is no legal bar for Erfan to

#### 5 lakh to sit for BCS

PSC Chairman Sohorab Hossain old The Daily Star yesterday afternoon that everything was set for the exam.

"We will hold the exam amid strict adherence to Covid-19 health guidelines," he added.

The two-hour exam will start from 10:00am.

Around 4.75 lakh candidates applied for the exam after the 41st BCS circular was published in November 2019 to appoint 2,018 vacant posts in different cadres.

Among the 351 centres in seven divisions, there are many centres where 3,000-4,000 candidates will sit for the exam.

On Tuesday, the Directorate General of Health Services (DGHS) proposed that the government not reopen educational institutions and hold any public examinations, including BCS, in the wake of the rising number of Covid-19 patients.

In Tuesday's meeting at the Prime Minister's Office, the DGHS officials also suggested going for a complete lockdown to curb transmission.

The high-ups at the PMO, however, opined that the authorities concerned will make a decision on such issues and asked the DGHS to strengthen enforcement of health safety guideline and reopen the Covid-19 hospitals that were shut down earlier.

In this context, there has been discussion on social media about whether tomorrow's examinations would be held or not.

"We have only one day left before the exams. We have sent question papers and other logistics to different exam centres. Examinees have also come to the divisional cities. It is tough to stop the exam now,' Shahjahan Ali Mollah, a member of PSC, said Wednesday night.

In the last several days, the transmission of novel coronavirus had been gradually rising every day with experts fearing spread of the new strains of novel coronavirus, including those first detected in the UK and South Africa.
