Conservation work of Boro Kuthi starts Staff Correspondent, Rajshahi

The Department of Archaeology has started conservation works of Rajshahi's Boro Kuthi yesterday. The historic building bears the history of Dutch indigo and silk business in the 18th century.

Rajshahi Mayor AHM Khairuzzaman Liton inaugurated the works at a function organised at Boro Kuthi premises by the Department of Archaeology.

The department is spending Tk 4.85 lakh for the initial conservation works, deputy director Nahid Sultana said in her speech.

After the initial works, more will follow in the future in order to turn the building into a museum, she said.

The two-storied building with 12 rooms was used as the centre of silk and indigo trade by Dutch and British traders.

After the fall of Nawab Siraj-ud Doula in 1757, the Dutch East India Company purchased it and sold it to Robert Watson and Company in

After the partition of 1947, the building housed government supplies for a while.

Rajshahi University acquired it in 1953 and used it as its administrative building and later turned it into a teachers' club.

Rajshahi City Corporation has been bargaining with RU for handing it over to the Department of Archaeology since 2011.

In 2018, the department declared the building as a protected archaeological site.

In his speech, Mayor Liton said the conservation works is being undertaken so that it will attract visitors to the site.

Besides, protection, relief and recovery refers to ensuring safety, physical and mental wellbeing, security and respect for women and girls' rights, as well as their specific needs during and after conflict, emergency and disaster situations.

Gender specialist Sheepa Hafiza said the action plan is an "important, contemporary and inclusive" instrument. If it is implemented effectively, there will be no need

for doing many other things regarding women's safety, she said.

Kashfia Feroz, director of Girls' Right Project of Plan International Bangladesh, said the action plan's implementation is challenging as coordination gap appears when multiple organisations work together.

BNPS Executive Director Rokeya Kabir said women mainly face challenge from non-state actors such as religious fundamentalists who propagate hate crime.

It is essential to work against hate speech, she said.

Nazneen Ahmed, senior research fellow of Bangladesh Institute of Development Studies, said sufficient budgetary allocation for peace-building programme is essential. Besides, women's economic empowerment is important, she said

Prof Sayema Haque of Dhaka University's economics department emphasised proper monitoring and evaluation while implementing the national action plan.

Considering post-Covid-19 situation is essential while renewing the action plan in future, said Meghna Guhathakurta, executive director of Research Initiatives Bangladesh.

Deputy Commissioner Farida Yasmin of Dhaka Metropolitan Police said cybercrime against women is a big concern.

Police received 691 complaints of cybercrime within 48 hours of launching a cyber-support facility for women in November last year, she added.

Tania Sharmin, programme analyst on women, peace and security at UN Women; Shima Moslem, joint secretary of Bangladesh Mahila Parishad; and rights activist Falguni Tripura; among others, spoke at the event.

Five others' death sentences commuted, one acquitted

the city's Sadar Road area.

The High Court yesterday confirmed death penalties of five convicts for killing Gazipur's Jubo League leader Jalal Uddin Sarkar more than 17 years ago.

At the same time, the HC commuted death sentences of five other convicts to life imprisonment and acquitted another accused in the murder case.

Jalal Uddin, then Jubo League president of Kapasia upazila unit in Gazipur, was hacked to death in Balkhela Bazar area on August 17, 2003 following a political dispute.

On November 30 in 2015, a Gazipur court sentenced 11 people to death in connection with the murder case.

Yesterday, the HC bench of Justice Shahidul Karim and Justice Md Akhtaruzzaman delivered the verdict after hearing the death reference and appeals of the convicts challenging the trial court verdict.

The five convicts, whose death penalties were confirmed by the HC are Joj Mia, Al Amin, Faruque Hossain, Md Belayet Hossain Baltu and Md Abdul Alim.

Joj Mia and Al Amin are absconding while Faruque, Belayet and Alim are in a condemn cell, Deputy Attorney General Bashir Ahmed told The Daily Star.

He said the HC bench confirmed their death penalty as their direct involvement in the killing has been proved.

DAG Bashir said the HC commuted the five convicts' death penalties as they did not directly hit Jalal although they participated in the killing.

He also confirmed the other five convicts whose death penalties have been commuted to life imprisonment are Farhad Hossain, Md Ataur Rahman, Mahbubur Rahman, Halim Fakir and Jewel.

Among them Farhad and Ataur are in jail while

Worker succumbs to injuries in steel factory accident STAFF CORRESPONDENT, Ctg

A worker of Bangladesh Steel Re-rolling Mills (BSRM) Ltd died at Chattogram Medical College Hospital (CMCH) on Wednesday night, from an injury sustained while working in the factory.

The deceased was identified as Joynal Abedin (52), hailing from Sandwip upazila of Chattogram, said police sources.

Omar Shoaeeb, assistant manager (public relation) of BSRM, said Joynal was appointed by a third party at the BSRM SML factory in Mirsarai upazila.

He was injured in the scrapyard of the factory on Wednesday while working there, and was rushed to the upazila health complex. From there he was shifted to CMCH for treatment.

"He died at the hospital on the same day while undergoing treatment there," he added.

Inspector Jahir Hossain of CMCH Police Outpost said the worker died at Ward No. 28 with the injuries.

The BSRM official said the company has started investigating the reason behind the accident.

registered the SIMs with fake identities. They sold the raised credit to top-up outlets and embezzled Tk 13 lakh. In October 2019 and January 2020, they stole a total of another Tk 72 lakh in the same way.

The official said that the individuals maintained contacts with various top-up agents to whom they sold the mobile phone credit at discounted rates. Later, the mobile operator found it had not received the cash against the credit to those post-paid SIMs.

When Grameenphone sensed the fraud, it froze the suspicious SIMs which held back huge sums of money. However, by that time they had stolen lakhs of taka.
