### Massive fire razes homes

'Four refugees including two kids die'



Four Rohingyas, including two children and a woman, were reportedly killed and hundreds of others were injured in deadly fires that burned several thousand shanties at Balukhali refugee camp in Ukhiya, Cox's Bazar, yesterday.

The fire started around 4:00pm and firefighters almost doused it an hour later. But another wave of fire broke out shortly after 11:00pm and was still burning down shanties at the densely populated camp as of 12:30am, locals said. Rohingya community leaders and officials told The



Prime Minister Sheikh Hasina yesterday shared her vision of fostering friendship in South Asia to optimise utilisation of natural resources, alleviate poverty and work together to tackle the challenges of climate change.

The PM said a large number of people in South Asia is still living below the poverty line and many are still going to bed every night with hunger.

"Many are deprived of the minimum necessities of life," she said.

#### Covid cases, deaths climb

Daily new cases 7-month high, another 30 die

As deaths from Covid-19 and the number of new cases continue rising, experts fear the transmission rate may rise further in the coming weeks.

They suggested boosting Covid-19 transmission control activities by increasing daily tests and isolating the positive cases.

Yesterday, the health directorate reported 28 coronavirus-related deaths - the highest number of daily deaths recorded in more than 10 weeks.

On January 7, the Directorate General of Health Services (DGHS) reported 31 deaths. Since then, both deaths and new cases declined till mid to late February, after which the trend reversed and new infections crossed the 1,000 mark on March 10. From March 9, the

### Vaccine drive loses steam

Many in rural areas know little about the campaign; experts say registration process complex, full of hassles

Jahur Ali, a 44-year-old worker at a stone quarry in Tetulia, was utterly clueless about the ongoing Covid-19 vaccination campaign.

"I didn't know that the vaccination campaign is going on. I've come to know about it from you just now," Jahur, who collects stones from the Mahananda River near Bangladesh-India border, told this correspondent in the second week of this month.

He, along with several others, was busy picking up stones from the riverbed and putting those in baskets. Joining the conversation, one of his co-workers, Md

Shahidul, 30, said, "I have heard about it [the vaccination campaign]." He, however, didn't know that the Covid vaccine was being administered at Tetulia Upazila Health Complex,

only half a kilometre away from there. This correspondent then talked to a group of women at nearby Eidgah Basti Guchchagram. A brief conversation with them made it clear that they had very little knowledge

about the countrywide vaccination campaign. "I have heard about the vaccination campaign. But I do not know where I can get it. None [of the health workers] contacted us," said Jahanara Begum, 40, a domestic worker. Asked whether they would take the vaccine, they

### Water tariff in Dhaka set to rise again

Dhaka Wasa has again proposed hiking water prices by five percent for residential and commercial uses from July 1. According to the

proposal, to be placed before a meeting of Dhaka Wasa Board today, the prices of each unit (1,000 litres) of water will be Tk 15.18 for residential use and Tk 42 for commercial use, up from the current prices of Tk 14.46 and Tk 40 respectively.

The company also wants to raise sewerage charges at the same rate, Wasa sources said. SEE PAGE 5 COL 1

The MoUs were inked after the bilateral talks between Bangladesh and Nepal at the Credential Hall of Bangabhaban in the evening.



He was suffering from breathing problems, he added.

Atiqullah, who was born on August 29 in 1951 in Munshiganj, was also a former vice-president of Brothers Union Club and general secretary of Shishu Shasthya Foundation.

He founded Janakantha in 1993. At the beginning, the paper was the only daily in Bangladesh that was printed and published from different regions of the country simultaneously through its microwave system with its own set-up of local press and offices and distributed early in the morning all over the country. But currently Janakantha is being printed, published and circulated throughout Bangladesh from its Dhaka

Atiqullah was arrested by law enforcers in March 2007 and faced a number of false cases on different charges, including patronising criminal activity, corruption, and "carrying out propaganda against the government".

He was even sentenced to jail for over 40 years. Atiqullah was relieved from all cases after the Awami League government came to power in 2009.

Atiqullah established the Globe Janakantha Shilpa Paribar in early 1969 when he was 17 and a college student. He started the business by borrowing Rs 1,200 from his brother and brother's friend on a commitment to give them 50 percent of the profit that he would earn from the business.

In the meantime, he got a golden opportunity in the month of March 1971 when the price of betel leaf (pan) jumped to Rs 175 a kg in West Pakistan. The leaf cost only Rs 3 a kg in then East Pakistan, now Bangladesh.

Atiqullah joined the Liberation War and fought at sector-2. After the war, he completed his graduation and engaged himself in full time business with the money he earned before independence.

He founded Globe Insecticides Ltd in 1978, the pioneer and the largest manufacturer of domestic insecticides mosquito coils, smokeless MAT with electric mosquito destroyer and aerosol insecticides -- with the technical cooperation of Earth Chemical Company Ltd, Japan.

In 1990, with a technical assistance from China, Atiqullah established a heavy industry called Globe Metal Complex Ltd.

He also founded Globe Khamar Prokalpa Ltd in 1997 and Globe Janakantha Bhaban, which houses Construction Ltd, a real estate company,

more than 50 people from different occupations in and around Tetulia bazar in the second week of this month.

Most of them said they were yet to get the jabs, while only a few said they or elderly members of their families got vaccinated.

According to upazila health officials, 3,550 doses of Oxford-AstraZeneca vaccines had been supplied to Tetulia upazila, and around 3,000 of those were administered till yesterday.

Launching the campaign on February 7, the government planned to inoculate 70 lakh people across the country in the first month. But it missed the target as a total of 49,11,902 people have so far been vaccinated.

Yesterday, the daily count of people who took jabs dropped to 70,933, which was around two lakh in the third week of February.

Talking to The Daily Star, Dr Md Abul Kashem, upazila health and family planning officer in Tetulia, said, "I make phone calls to those who got registered. We make public announcements in the bazar area twice a week. However, the response remains very poor. Only 34 people came to get jabs yesterday

The level of awareness about vaccination was found to be low among most of them especially the day

Nasima Begum, a health assistant at Rangpur Sadar Hospital, said, "I visit the households in my area regularly and encourage people to take vaccines. Most of the time, I doubt whether they will actually take jabs."
"REGISTRATION A BIG DEAL"

The government started the vaccine registration process on www.surokkha. gov.bd on January 27.

To take vaccine, one has to sign with necessary information, uding national identification including number and mobile phone number. Upon completion of registration, the recipient has to carry a printed copy of the registration document to the vaccination centre.

Amid poor response, the government lowered the minimum age for getting the vaccine to 40 years. Despite this, the response has not increased notably.

As of yesterday afternoon, a total of 62,82,884 people got registered.

Experts say the entire registration process is a "big deal" for the majority of people as it is quite complex and full of hassles.

In a recent visit to Moghbazar, Shantinagar and several other neighbourhoods in the capital, scores of small shops were seen displaying advertisements offering help for Covid-19 registration in exchange for

Dr Shafiun Shimul, associate professor of health economics at Dhaka University, pointed out three reasons behind the low response to the vaccination campaign.

"Firstly, many people do not know well about the vaccination campaign. Secondly, the registration is a big deal, and lastly, there is reluctance among people to get jabs," said Shafiun, who is leading a Covid-19 vaccine response

Echoing his view, Dr Zakir Hussain, member of the working group of Bangladesh Health Watch, said, "The government could not sensitise people to the fact that everybody is at risk of Covid-19. The government's current method of communication is not appropriate for the masses.'

He is also of the opinion that there should be no age limit for getting vaccinated.

"People aged below 40 go outside every day. They are the super-spreaders. But we have excluded them from the priority list. It should be revised," he

Countries in the basin of the Himalayas are prone to earthquakes, cloudbursts, avalanches, landslides, flash floods, while coastal regions like Bangladesh are under threat of frequent floods, tidal surges,

earthquakes, heavy rains, or droughts. "Global warming, climate change has made the countries of our subcontinent the most vulnerable. We are the worst sufferers of the consequence of climate change, though we are not contributing to this change. We can temporarily protect ourselves through adaptation, but the adaptation process will fail to provide sustainable protection unless the current trend of climate change is restricted.'

The premier said as the current president of the Climate Vulnerable Forum, Bangladesh has been urging world leaders to take immediate steps to tackle climate change. The Dhaka office of the Global Climate Adaptation started working on tackling the effects of climate change in South Asia.

### 'Mitali Express' to be announced on Saturday

Fares for new train from Dhaka to India's New Jalpaiguri fixed STAFF CORRESPONDENT

Bangladesh and India are going to announce launching of the new passenger train, which will run between the two neighbouring countries, on Saturday, Railways Minister Nurul Islam Sujan said

Prime Minister Sheikh Hasina and her Indian counterpart Narendra Modi, who is scheduled to be in Bangladesh on March 26 and 27, will jointly give the announcement, he said.

"This is going to be a historic moment. This will be a big achievement for communication between the two countries," the minister said at a press briefing inside Rail Bhaban.

However, the train's operation between Dhaka and West Bengal's New Jalpaiguri (NJP) will start after the Covid-19 situation reaches normalcy, he added.

The railways ministry in October last year announced that Bangladesh and India were planning to introduce a passenger train service on Dhaka-Siliguri route from this March to mark 50 years SEE PAGE 4 COL 5

This correspondent spoke to six syndicate members including the VC. Of them, three members said the agenda was "only discussed and yet to be finalised" while two others said the decision was finalised, and one declined

The VC said, "The proposal was finalised as the majority of members

Eleven days after the meeting, chief engineer of the university Abul Kalam Sikder issued a letter to the businessman to take further steps in this regard. The letter also stated that the engineering office gave permission to construct the building and name it after the businessman, who is also an

Pro-VC of administration, Prof Samad on Match 14 wrote to the VC opposing the decision and opined that the names of martyred teachers of the University should be prioritised.

### 4 more cases filed against PK Halder

The Anti-Corruption Commission (ACC) yesterday filed four more cases over the laundering of about Tk 248.5 crore from International Leasing and Financial Services Limited (ILFSL), accusing 30 people.

Former managing director of now-defunct NRB Global Bank PK Halder is made prime accused in the cases.

So far, the anti-graft watchdog has filed 25 cases for laundering of about Tk 1,871 crore from ILFSL. Sixty-seven people are made accused in the cases.

According to the case statements, Halder took loans from financial institutions against at least two dozen nonexistent companies created by him. In some cases, he used part of the funds to repay loan instalments taken against his several fictitious firms. The investigation officer did not find the existence of these organisations.

Kolasin took loan of about Tk 60 crore, Drinan Apparels Tk 60 crore, Wintel International Tk 68.5 crore and Neutrical Limited Tk 60 crore from ILFSL.

Managing director of Drinan Mohammad Abu Rajib Maruf, Director of Wintel Sukumar Saha, chairman of Kolasin Atoshi Mridha and proprietor of Neutrical Swapan Kumar Mistri are among the accused in the four cases.

Meanwhile, an accused -- Shubhra Rani Ghosh, a director of Ookayama international, was arrested at Dhaka airport yesterday in connection with a laundering case.

# 'Yaba dealers using expats as carriers'

Man held with 10,000 pills in pickle jars at Dhaka airport; directives issued for steps to avoid impact on labour market

With an aim to stop narcotics smuggling from Bangladesh to abroad through expatriates, the airlines have to ensure that their passengers packed their own luggage.

Foreign Minister AK Abdul Momen came up with the suggestion after the director general (DG) of Department of Narcotics Control (DNC) said that a tendency of getting involved with narcotics smuggling was found among Bangladeshi workers going or staying abroad.

DNC DG Muhammed Ahsanul Jabbar said this at the first virtual meeting of the National Narcotics Control Advisory Committee on December 28 last

DG Jabbar also said such illegal practices could have a negative impact on the labour market. In response to that, the home ministry's security service division's secretary has asked all officials concerned to take necessary action in this regard.

Home Minister Asaduzzaman Khan Kamal, who presided over the meeting, said anti-narcotics awareness among those going abroad has to be

Muhammad Abdur Rauf Miah, deputy secretary of the home ministry, issued the written directives regarding the virtual meeting on February 14.

### 72 get anticipatory bail

The High Court yesterday granted anticipatory bail to another 72 Awami League leaders and activists from Basurhat area under Companiganj upazila of Noakhali for four weeks in two separate violence and arson cases The HC also ordered the accused ruling party men to surrender to the

trial court concerned in four weeks in connection with the cases.

The bench of Justice Mustafa Zaman Islam and Justice Khandaker Diliruzzaman came up with the orders following eight separate petitions filed by the accused seeking bail in the cases filed against them.

Earlier in the day, the accused petitioners appeared before the HC bench for anticipatory bail in the cases.

Companiganj's former upazila chairman Mizanur Rahman Badal and Sub-Inspector of police Mahfuzur Rahman filed the two cases with Basurhat police station on February 19 and 22 respectively, following a clash between two groups of local AL men over a political dispute on February 19, said SS Arefin Junnun, petitioners' lawyer.

He said the HC granted them bail as there is no specific allegation against them and no casualty took place in the incident.

ACC petition seeks stay on HC verdict to formulate law

Anti-Corruption Commission yesterday moved a petition before the Supreme Court, seeking stay on the High Court verdict over formulating a specific law or rule regarding imposition of embargo on corruption suspects or accused from leaving the country.

After a brief hearing, Chamber judge of the SC's Appellate Division Justice Obaidul Hassan adjourned hearing till March 28.

ACC lawyer Khurshid Alam Khan submitted the petition. In the petition, the commission said if

ACC is to take permission from the special judge's court for imposing embargo on any corruption suspect or accused leaving the country, the inquiry or investigation against him or her will face obstacles. Delivering verdict on a petition, the HC on March 16 observed that a specific law or

rule is needed soon regarding imposition of embargo on corruption suspects or accused leaving the country.

After 55 years, rail communication between the countries via Chilahati-Haldibari route resumed in December. Freight trains were supposed to be regular since then, but that did not happen yet.

The fare for Chilahati-NJP would be Tk 1,235 for a chair, he added. The 10-coach train would have 864 seats.

#### COX'S BAZAR UNDER RAIL NETWORK WITHIN DECEMBER 2022

The minister yesterday said Cox's Bazar will come under rail network within December

Despite project of the first track witnessing 51 percent physical progress till February, the minister expressed hope while talking to journalists at Rail Bhaban.

The deadline for building a dual gauge single rail line from Chattogram to Cox's Bazar is June next year. "Works [of the project] is ongoing to meet the target, and progress is satisfactory," he said.

"We have kept six more months as grace period, and if we cannot complete the project within June, then we will be able to complete it within the grace period. We will be able to connect Cox's Bazar with rest of the country through rail by December 2022," he said.

Contacted, project director Mofizur Rahman yesterday said, "We are hopeful about completing the project works within December next year, if no major obstacle

In the case of having to revise project deadline, he said, "We will take decision in this regard three months before the deadline's expiry."

### Water tariff in Dhaka set to rise again

The Wasa MD has already given his consent to increase the price, said officials.

The move comes at a time when the people's income has been hit hard by the pandemic. The country is seeing a sharp spike in the Covid-19 infection rate for the last few

Wasa last year had increased the price of water by 25 percent. Before that hike, the prices of water were Tk 11.57 and Tk 37.04 per unit for residential and commercial uses respectively.

Last month, a study by South Asian Network on Economic Modelling (SANEM), a research organisation, found that the poverty rate in the country has doubled in

The organisation interviewed 5,577 households across the country last year, and found that 42 percent of them were below the poverty line. The rate was 21.6 percent when the same group was interviewed in 2018.

There are allegations that residents of many city areas, including Jurain, are supplied with poor quality of tap water. Besides, many face acute shortage of drinking water and don't have access to sewerage network.

A group of residents of Jurain had staged a demonstration in front of the Wasa's Karwan Bazar headquarters on April 23, 2019, demanding supply of pure water.

The image of Mizanur Rahman, a resident carrying a jug full of dirty water as a sarcastic gift of "sherbet" for Wasa Managing Director Taqsem A Khan for saying "water supplied by Wasa was 100 percent safe" is still fresh in the minds of Dhaka residents. 'WASA PROPOSAL ILLOGICAL'

Terming the price hike proposal illogical, Chairman of Institute of Water and Environment M Inamul Haque said Dhaka Wasa increases the price of water and sewerage charges but the city dwellers are not getting better service.

He said the quality of tap water in many city areas did not improve, and many residents depend on private deep tube-wells

Inamul said many areas of the capital still remain out of the coverage of Wasa's sewerage

Wasa Chairman Golam Mostafa said the company increases water price by five percent every year to adjust with inflation. The board meeting would be held today

and if it endorses the price hike proposal, the new price would be effective from July 1, he About the coronavirus situation, Mostofa

said they were not hiking the price much considering the pandemic although there was still a huge gap between the production cost and price of water.

"We only earn half of the production cost of water and we have to increase the price gradually to have a sustainable future for the company," he said.

Asked whether they would send the proposal to the LGRD ministry for approval, he said the Wasa board can approve proposals for hiking the price by up to five percent every

The Dhaka Wasa can increase the water tariff by five percent in consultation with the government as per section 22 of the Dhaka Water Supply and Sewerage Authority Act,

Wasa MD Taqsem said they want to hike the tariff by only five percent to adjust with

About increasing sewerage charges, he said they realise the charges only from clients in the city's 18 to 20 percent areas which are under coverage of sewerage network.

"We have a master plan to bring 100 percent of areas under the sewerage network. Once the plan is implemented, we will realise sewerage charges from clients across the city,'

"The transmission trend is a steeply rising one. The transmission pattern suggests the

# She paddles rickshaw-van breaking free from decade of torture

Like any other women, Saptomi Rani Mungli,

in her early life, used to dream of having a family filled with love and happiness. However, her dream was shattered as she had to undergo inhuman torture by her in-laws and her

She finally parted with the torturous relationship eleven years of her tying the knot. Leaving her husband's home, she took shelter at her emaciated parental home in Joypurhat's

But things became more complicated there as she did not have any means to feed her

Akkelpur upazila.

family members, including her elderly mother. She never wanted to be a burden to her widowed mother.

Initially, she started selling betel leaves to generate income after returning to her parental home. However, the earnings were not enough to feed her family. With such low earnings, it was not possible to continue the studies of her three kids as well.

"I had become so distraught then", she said. She had no savings to start any business in the area. Finally, Mungli had decided to grab the handle of a rickshaw in 2015 as profession. "The earning was relatively low for the first few months. Things started improving gradually.

"Now, I earn around Tk 500 per day", she said. Besides, other rickshaw pullers of the area are so helpful to her, said Mungli.

Mungli, the daughter of Bodha Mali, of Bishnupur village under Akkelpur Upazila of Joypurhat was born in an ultra-poor family. Her parents married her off to Bital Mali, son of Kashinath Mali, at Baman village under Kalai Upazila in 2002.


She was just 16 then.

A bicycle, half tola gold and Tk 20,000 were given to Bital as dowry.

"I was taking time to adjust with everything at my new home", she said adding her in-laws and husband did not take time to start inflicting inhuman torture on her.

All the family members used to torture her almost every, she said while shedding drops of

"They often beat me up with sticks. If I

protested, they would gag me," Mungli said.

"My husband even seared my skin with burning mosquito coil and cigarette. As the torture was unbearable, I would often come back to my parental home to get relief. But, they [her parents] forcibly sent her back to her inlaw's house due their chronic poverty."

"They used to torture me more after my return", said Mungli.

She bore the traumatic relation for 11 years. In the meantime, she also became mother of three children.

Finally, Mungli left her husband forever in 2013, with her three children, to start a new life. "I allowed her to stay here as I could not see her distress anymore ", said Shepali Mali, the

mother of Mungli. Talking to The Daily Star, Mungli said

pulling a rickshaw-van is a pretty laborious job.

Although her body ached much, she never quit. These days, she is plying a battery-run rickshaw, which is a bit comfortable. "I ply it from morning to evening every day ", she said adding "the money I get plying the rickshaw is

enough to manage my family. All her three children are studying now, she said. "It is my only dream to help my children grow with proper education," she said.

Selim Mahmud, chairman of Tilakpur UP, said that Mungli stays at a shabby house with her mother and children. The UP administration is trying to allocate

a house for them from the prime minister's special fund. "She earns money through honesty that is an

example to others", he said.

A policeman was injured in an attack allegedly by a group of Awami League (AL) activists yesterday while the latter were observing a half-day hartal, expressing dissatisfaction over Sunday's judgement of a case filed for killing Public Prosecutor Habibur Rahman and his brother in Shariatpur

Injured Bulbul Ahmed, a police constable, took treatment at Shariatpur Sadar Hospital.

"Some 25 to 30 protesters waylaid my motorcycle in front of Shariatpur Court around 9:30am while I was going to the court for official purpose," Bulbul told The Daily

Although he introduced himself as a policeman, the protesters beat him up for defying the hartal, he added.

Officer in Charge (OC) of Palong Police Station Aslam Uddin said they detained Forhad Hossain Dhali and Sohel Rana Joy for their alleged involvement in the attack. Shariatpur municipality Mayor Parvej Rahman John and

his followers called a half-day hartal yesterday, said Anal Kumar Dey, general secretary of Shariatpur district unit AL. Meanwhile, John, son of slain Habibur Rahman, during a protest rally yesterday claimed that some key accused in the case were acquitted from the charges.

On Sunday, Shariatpur Additional District and Sessions Judge Mohammad Shawkat Hossain sentence six people to death, four others to life term imprisonment and another three to two-year imprisonment in the double murder case. Meanwhile, 39 other accused in the case were acquitted

from as charges brought against them could not be proved, according to the verdict. On October 5 in 2001, Public Prosecutor (PP) Habibur Rahman, also joint general secretary of district unit AL, and his brother Monir Hossain were shot to death at their

residence in Shariatpur Sadar upazila.

The following day, slain Habibur's wife Jinnat Rahman filed a case with Palong Police Station in this connection.

#### India, Pakistan set for watersharing talks

India and Pakistan will hold the first meeting in three years of a commission that deals with water rights on the Indus River today, the two sides said yesterday, illustrating a broader resumption of diplomatic ties. The Permanent Indus Commission, set up under the Indus Waters Treaty of 1960, is set to meet in New Delhi on March 23 to 24, said two Indian officials that deal in bilateral water issues. Pakistan's foreign ministry spokesman Zahid Hafeez Chaudhri confirmed the talks will take place. He noted that the Commission is supposed to meet at least once a year under the treaty that governs water usage on the Indus and its tributaries that flow through the two countries.

#### Biden aides had ties to large tech companies

Top Biden administration officials had previously undisclosed ties to large corporations including tech giants Microsoft Corp, Alphabet's Google and Facebook Inc, financial disclosures by the White House show. According to the filings with the Office of Government Ethics, National Security Advisor Jake Sullivan served on an advisory council for Microsoft from 2017 through May of last year. He was paid \$45,000 last year, according to his disclosure, a copy of which was seen by Reuters. Sullivan, who oversees an interagency response to January's cyberattack on Microsoft's Exchange email software, holds between \$50,000 and \$100,000 of stock in both Microsoft and Alphabet and owns between \$15,000 and \$50,000 of Facebook stock, the disclosure shows.

#### Trump to launch own social media platform: ex-aide



Donald Trump plans to return to social media soon, using "his own platform" after being banned from Twitter and other outlets, a former advisor said Sunday. "I do think that we're going to see president Trump returning to social media in probably about two or three months," Jason Miller told Fox News. "It's going to completely redefine the game, and everybody is going to be waiting and watching to see what exactly president Trump does, but it will be his own platform," said Miller, who held senior posts in both of Trump's presidential campaigns. Trump's provocative use of social media was a defining feature of his presidency, as he drew 88 million followers to Twitter and often used tweets to slam his critics or to announce personnel changes or significant policy shifts.

#### China detains three tourists for vandalising Great Wall

Three tourists who vandalised China's Great Wall -- one of the country's most popular historic landmarks -- have been detained and fined, officials said yesterday. Two men and a woman were detained Sunday after scrawling their names on the wall with a key, wire and other sharp objects, administrators of the Badaling special tourism zone said in a statement. Around 70 kilometres from Beijing, Badaling is the most popular section of the wall for tourists. The statement did not offer details on the amount they were fined or the length of their detention. Under China's law for protecting cultural relics the fine for carving or scrawling on a historic building

is less than 200 yuan (\$31).

### Israel confiscates pass of Palestinian FM

Israeli authorities confiscated the VIP border pass of Palestinian Foreign Minister Riyad al-Maliki upon his return to the West Bank from a meeting at the International Criminal Court, a Palestinian official said on Sunday.

Ahmed al-Deek, an official at Maliki's office, told Reuters the Israeli move was linked to Maliki's meeting with ICC lead prosecutor Fatou Bensouda at her office in The Hague

Israel's Walla news website cited unnamed Israeli officials who said Maliki's ICC visit was the reason for the revocation of his VIP card, an Israeli-granted pass that enables dozens of senior Palestinian officials to move freely through border crossings.

Israeli Prime Minister Benjamin Netanyahu's office declined to comment and the Israeli foreign ministry did not respond to a request for comment.

"This is the Foreign Minister of the State of Palestine. He doesn't represent himself. He represents the State of Palestine, and we regard this as an attack against the State of Palestine," said Deek.

He added that Israeli officers detained and questioned Maliki's aides for 90 minutes at the Israeli-operated border crossing between Jordan and the West Bank.

Deek said that the minister left the crossing without the card. It was not clear when it would be returned to him.

Bensouda announced this month she would formally investigate war crimes in the Palestinian Territories, a move welcomed by the Palestinian Authority and denounced by Israel. On Friday, ICC prosecutors said they have sent Israel and the Palestinians notifications of the opening of a war crimes probe, a move that leaves the parties with one month to seek a deferral.

### **EU** imposes China sanctions

Beijing responds by blacklisting EU individuals, entities

The European Union yesterday imposed sanctions on four Chinese officials, including a top security director, for human rights abuses in Xinjiang, the first sanctions against Beijing since an arms embargo in 1989 following the Tiananmen Square

Accused of mass detentions of Muslim Uighurs in northwestern China, those targeted with sanctions included Chen Mingguo, the director of the Xinjiang Public Security Bureau. The EU said Chen was responsible for "serious human rights

Beijing also announced sanctions on 10 Europeans including parliamentarians and scholars, as well as four entities, in retaliation against the EU's approval of sanctions over Beijing's crackdown on the Uighur minority.

This move, based on nothing but lies and disinformation, disregards and distorts facts," said China's foreign ministry in a statement, adding that it was a gross interference in its internal affairs. In its Official Journal, the EU accused Chen

of "arbitrary detentions and degrading treatment inflicted upon Uighurs and people from other Muslim ethnic minorities, as well as systematic violations of their freedom of religion or belief".

Others hit with travel bans and asset freezes were: senior Chinese officials Wang Mingshan and Wang Junzheng, the former head of China's Xinjiang region, Zhu Hailun, and the Xinjiang after the United States and Beijing is both a big Production and Construction Corps Public market and a major investor which has courted Security Bureau.

China denies any human rights abuses in Xinjiang and says its camps provide vocational human rights, is deeply worried about the fate of training and are needed to fight extremism, reports Reuters.

While mainly symbolic, the sanctions mark a ignificant hardening in the EU's policy towards China, which Brussels long regarded as a benign trading partner but now views as a systematic abuser of basic rights and freedoms.

They are also likely to inflame tensions between Brussels and Beijing. The EU had not sanctioned China since it imposed an arms embargo in 1989



following the Tiananmen Square pro-democracy crackdown. The arms embargo is still in place.

All 27 EU governments agreed to the punitive measures, but Hungary's foreign minister, Peter Szijjarto, called them "harmful" and "pointless", reflecting the bloc's divisions on how to deal with China's rise and to protect business interests.

China is the EU's second-largest trading partner poorer and central European states.

But the EU, which sees itself as a champion of the Uighurs. Britain, Canada and the United States have also expressed serious concerns.

### 26.5m Nigerian children lack access to water: Unicef

Nearly one-third of Nigerian children lack access to enough water, the UN children's agency Unicef said yesterday, calling for urgent measures to address the problem.

In a statement marking World Water Day, Unicef said more than 1.42 billion people -- including 450 million children -- are living in areas of high or extremely high water vulnerability in the world.

This means that 1 in 5 children worldwide do not have enough water to

meet their everyday needs," it said.
"The figures in Nigeria are particularly worrying, with 26.5 million Nigerian children experiencing high or extremely high water vulnerability -- or 29 percent of Nigerian children," the UN body said. About 100,000 Nigerian children are said to die annually of water-related

"The world's water crisis is not coming -- it is here, and children are its biggest victims," said Peter Hawkins, Unicef's representative in Nigeria.

"When wells dry up, children are the ones missing school to fetch water. When droughts diminish food supplies, children suffer from malnutrition and

"When floods hit, children fall ill from

waterborne illnesses. And when water is not available in Nigerian communities, children cannot wash their hands to fight off diseases," he added. According to Unicef, over 86 percent of

Nigerians lack access to a safely managed drinking water source.

"The problem is compounded by poor drinking water quality and lack of equity in access," it said.

Unicef said despite "some progress" by Nigeria, "there is still much more work to be done in the country to ensure that all Nigerians have access to adequate and quality water and hygiene services."

#### **ESPIONAGE TRIAL FOR SECOND CANADIAN**

### Beijing-Ottawa relations go into free-fall

The trial for Michael Kovrig, the Canadian detained more than two years ago in China on espionage charges, started yesterday, with relations between Ottawa and Beijing in free-fall.

The hearing comes days after the closeddoor trial of another Canadian man, with both detained in apparent retaliation for Canada's arrest on a US extradition warrant of Huawei executive Meng Wanzhou.

Yester, day police cordoned off an area outside the Beijing court as Canadian diplomats were denied entry and turned

Kovrig, a former diplomat, was detained in 2018 and formally charged last June with spying at the same time as his compatriot, businessman Michael Spavor.

Jim Nickel, the charge d'affaires of the Canadian embassy in Beijing, told reporters that the hearing had started and that access for diplomats "has been denied."

"We're very troubled by the lack of access and lack of transparency in the legal process," he said.

A court official told reporters no entry was allowed because the trial is a national security case.

Representatives of 26 countries had gathered outside the building yesterday, Nickel said, and were "lending their voice" for Kovrig's immediate release.

The US is "deeply concerned at the lack of minimum procedural protections granted the two Canadian citizens", William Klein, Acting Deputy Chief of Mission of the US Embassy in Beijing, told media outside the court.

# Prosecuting Pakistani Perpetrators in absentia

TAPOS KUMAR DAS

The establishment of the International Crimes Tribunal, Bangladesh (ICTBD) in 2010 created high hopes that justice for the 1971 genocide might finally eventuate. Keeping pace with the public expectation as of March 2021, the ICTBD has resolved 42 cases involving the 1971 atrocities, and more than five hundred cases await investigation; yet, none of these implicates any of the Pakistani perpetrators who planned, commanded, and executed the genocidal acts throughout the liberation war.

There is a mistaken assumption which Pakistan takes for granted that the 1973 Delhi Agreement and 1974 Tripartite Agreement relieved the Pakistani prisoners of war (POWs) from all sorts of accountability for the 1971 genocide. Speaking truly, while signing the Tripartite Agreement, Pakistan "condemned and deeply regretted" the 1971 atrocities and appealed to the Bangalees to "forgive and forget the mistakes of the past" in order to promote reconciliation. In response, Bangladesh agreed not to proceed with the trial "as an act of clemency" to achieve "reconciliation, peace, and friendship in the subcontinent."

Paradoxically, the hostility between Bangladesh and Pakistan has gradually intensified due to the denial of the atrocities by the latter which also brings back the accountability and recognition of genocide cards to the table. In November 2015, in an unprecedented

For long, Pakistan has been denying the widespread and systematic nature of its genocidal acts to the utter disregard of the victimisation of the Bangalees. This trend of denial and falsehood has reinforced the claim for accountability and recognition of the 1971 genocide. Of the international law scholars, Robertson suggests that "there can, in any case, be no amnesty for an international crime like genocide. The deal in Delhi was not a bar to prosecutions, however many years later". As the limitation is

not a bar against the prosecution of

violative of the Tripartite Agreement.

the 1971 atrocities might symbolize minimal justice against the denial of the liability by Pakistan. Yet, despite available evidence on hand, bringing Pakistani perpetrators to justice would be a critical challenge. Presumably, they would not be appearing before the ICTBD voluntarily; neither Pakistan would cooperate to ensure their appearance, nor any intervention either by Bangladesh or any international community compelling their attendance is likely to happen. In this backdrop of impunity, prosecuting them in absentia might be a practical approach for imposition

the killing of Lebanese Premier Rafik Hariri and many more. Article 22(1) of the Statute of the STL permits trial in absentia if the accused expressly and in writing waives his or her right to be present; or, has not been handed over to the Tribunal by the State authorities concerned; or, has absconded or otherwise cannot be found and all reasonable steps have been taken to secure his or her appearance before the Tribunal and to inform him or her of the charges. While conducting a trial in absentia article 22(2) requires the STL to ensure that the accused has due notice of the charges via all possible

International Crimes (Tribunals) Act 1973 permits the ICTBD to prosecute in absentia, when on account of the failure of the summons or warrant, the Tribunal has reason to believe that the accused person has absconded or concealed himself from the trial. Moreover, section 44 of the Rules of Procedure allows the ICTBD to admit a wide range of evidence unconnected to human testimony. Like the STL, the ICTBD may, to represent the interest of the absconding offender, appoint a state sponsored defence counsel. Besides, if the offender is convicted, a right to appeal in the Appellate Division of the Bangladesh Supreme Court is guaranteed under section 21. Seemingly, in case of trial in absentia the ICTBD is equipped to offer same level of fair trial standard as is prescribed by the Security Council

Curiously, the provision of in absentia trial remained absent in the original scheme of the ICTBD statute; so, its inclusion in 2012 led to the assumption that the Prosecution office perhaps at that point of time actively considered establishing accountability of the perpetrators whose appearance might not be secured even after due diligence. To our disappointment, the Prosecution Office however failed to capitalise the avenue allowing Pakistan much leverage to outrightly deny the 1971 genocide.

Against Pakistan's repeated denial of liability, our political vulnerability to draw international support for the international investigative or prosecutorial justice necessitated a quest for alternative avenues for genocide justice. Hence, in absentia trial of Pakistani perpetrators might be a timely response against the culture of denial. From the perspective of retribution, in absentia trial might be of little significance; yet, its impact in restoring historical truth might be instrumental. Nevertheless, the Government must conceive of the political advantages likely to gain by establishing individual and state responsibility for the 1971 genocide and support the Prosecution Office to investigate and prosecute the charges against surviving Pakistani perpetrators. Their prosecution in absentia would end the impunity that has been haunting Bangladesh for the last fifty years and be a step towards availing international

> move, Pakistan officially denied any "complicity in committing crimes or war atrocities" in 1971. The Khyber Pakhtunkhwa Provincial Assembly of Pakistan passed a resolution in 2013 urging Bangladesh not to "revive the issues of 1971" and "terminate all cases registered". While the prosecution progressed in Bangladesh, the National Assembly of Pakistan often adopted resolutions expressing concern and condemnation for the execution of leading perpetrators pursuant to the ICTBD's verdicts. In September 2016, the Pakistani Parliament also asked Islamabad "to seriously raise at all the international forums" that the proceedings of the ICTBD were

genocide, even today the perpetrators of the 1971 genocide could lawfully be prosecuted under national or international jurisdiction.

Ideally, the International **Humanitarian Fact-Finding** Commission may be engaged as per the Geneva Conventions, or a Fact-Finding Commission may be constituted under the UN mandate to inquire about the international humanitarian and human rights breaches during the 1971- armed conflict. An international prosecution either under the UN mandate or bilateral agreement between Bangladesh and Pakistan can also settle the issue of state responsibility and individual accountability for the 1971 genocide. In the present international political setting, arranging an international prosecution seems impossible; also, there is valid concern regarding our foreign missions' capacity to bag international support for any International Fact-Finding Mission to examine the 1971 atrocities.

Hence, prosecuting the Pakistani perpetrators at least the surviving top commanders in the ICTBD for

of historical liability. Internationally, there are instances of trial in absentia on account of atrocious crimes; encouragingly, Bangladesh's national jurisdiction, particularly Statute of the ICTBD also allows prosecuting a perpetrator in his/her absence.

During the emergence of international criminal law, article 12 of the 1945 Nuremberg Charter empowered the Tribunal to take proceedings against a perpetrator in his absence, if he was not found or if the Tribunal in the interests of justice found it necessary to conduct the hearing in his absence. Pursuant to this mandate, the Nuremberg Tribunal prosecuted Martin Bormann, the Chief of Nazi Party Chancellery and Secretary of Hitler, in his absence, for his involvement in war crimes and crimes against humanity, and sentenced him to death. In the recent past, in absentia proceedings received much legitimacy due to the UN Security Council's approval. Under its resolution no. 1757 [ 30 May 2007], the Security Council established the Special Tribunal for Lebanon (STL), to investigate and prosecute the terrorist attack that led to

means including publication in the media or communication to the State of residence or nationality; and, he has an opportunity to defend himself through a defence counsel of his choice either paid by him or by the Tribunal. Moreover, if refused by the accused, his representation by counsel should be ensured by the Defence Office of the STL. The Statute further provides that in case of conviction in absentia, the accused, if he or she had not designated a defence counsel of his or her choosing, shall have the right to be retried in person before the Tribunal, unless he or she accepts the judgment.

In prosecuting perpetrators in absentia, the resolution no. 1757 is of practical importance mainly for the reasons that due to the Security Council's primacy in international political setting, its resolution enjoys status of the highest law in the international legal order; and, the criteria it prescribes, if imitated by any national or international tribunal, could effectively encounter the concerns regarding legality and legitimacy of the in absentia trial.

## Compensating victims of fire

Law Desk

On Wednesday, March 17, a fire incident took place in the ICU of Dhaka Medical College Hospital. Three of the ICU patients died after being relocated. This is one of at least three recent incidents of fire outbreak in Dhaka Medical College Hospital including a fire in the general ICU of the Hospital in early January. A five-member committee on behalf of the health ministry, a nine-member committee on behalf of the Hospital and a four-member committee on behalf of the fire service have been formed to investigate the fire incident.

Similarly, last year, fire broke out in the coronavirus isolation unit of the United Hospital, the victims of which filed writ petitions before the High Court Division for compensation. Although the High Court Division ordered the Hospital to pay Taka 30 lakh to each victim's family, the decision was later stayed by the Appellate Division. The Constitution of Bangladesh provides protection from arbitrary deprivation of life under Article 32 and the court has, in the past, held that compensation may be awarded in cases of established unconstitutional deprivation of the fundamental right to personal life or liberty of the person concerned, while exercising writ jurisdiction. The duty of care is more

strongly established when the concerned party is a public authority.

In cases of death or injuries occurring as a result of wrongful or negligent acts, the injured person or the family member of the deceased person can institute a suit under the Fatal Accidents Act, 1855. While disposing of the said case the court has discretion to award such compensation. However, the suits instituted under this law often take many years to be disposed and has shown little effectiveness.

Furthermore, the CCB Foundation v Bangladesh case, the court relied on an Indian judgment and observed that "in instances where public functionaries are involved and the matter relates to the violation of Fundamental Rights or the enforcement of public duties, the remedy would still be available under the public law notwithstanding that a suit could be filed for damages under private law".

Therefore, there is growing acceptance of awarding compensation under public law for negligence, inaction or wrongful acts of public bodies resulting in deprivation of fundamental rights of the people. Although the judiciary has taken a progressive approach in this regard, there still remain concerns as to the speedy and effective implementation of these orders.

# Refund of advance VAT or turnover tax from Government treasury

Bangladesh has proudly graduated from the LDC and now SDG or Ease of Doing Businesses are the beacons or lighthouses Bangladesh is proceeding towards. To make Bangladesh a manufacturing hub, imports are still an integral part of the journey towards this development. An importer is required to pay Advance Tax (AT) at import stage at the rate of 5% on the taxable value of imported goods, which seems to be an obstacle for Bangladesh to overcome in the Ease of Doing Business indicator of World Bank. This requirement of payment of AT is the introduction of one of the unique features of the Value Added Tax and Supplementary Duty Act, 2012 (VAT & SD Act) and the Value Added Tax and Supplementary Duty Rules, 2016 (VAT & SD Rules) both of which came into force on July 1, 2019.

Initially, the business communities and the associations opposed this inception strongly as they articulated that most of the importers' import of goods lie with having credit facilities from the banks, therefore cost of doing business will increase manifold if some amount is paid in advance and kept in the custody of the government for some time. Though the Revenue authority said that this introduction of AT will widen their expansion of network as well as will help them to obstruct money laundering through mis-invoicing, the entrepreneurs and manufacturers had been demanding withdrawal as the payment of AT will increase their cost of production. They will be in trouble to repay to their banks and the paid AT which is unadjusted will be stuck in the government treasury for quite some time. Worthy to mention that, this payment of Advance Tax is refundable and the concerned importer can adjust such advance tax as a decreasing adjustment in that tax period

or subsequent 4 (Four) tax periods. If not adjusted, the businesses will have to apply to the relevant Commissionerate. But when the importers are seeking refund to the Commissionerate, in practice, the Commissioners are becoming unable to refund suo moto and then the importers do not have any other option but to go for writ for the refunds. This necessity of taking resort to litigation is putting burden on the

Once the processes of application have been followed by the importers properly, the Commissioner is bound to refund the amount within three months after the application for refund has been made to the Commissioner. Not refunding the same by the



Commissioner within this stipulated time is violative of the fundamental rights of the importer.

According to one provision, any person who has paid an AT but is neither registered nor enlisted may, in the prescribed manner, make an application to the Commissioner for a refund of such advance tax and the Commissioner shall, after receiving such an application, dispose it in the prescribed manner. The language of these subsections imply that the Commissioner is bound to refund the AT if any application for refund is made by neither a registered nor an enlisted person. Would a Commissioner be bound if application is made by a registered or an enlisted person? It is legally presumable that a

Commissioner should be bound. But in reality, this is not happening and the business concerns are not getting refunded easily.

Some unnecessary burdens have been imposed on the importers for seeking refund of the AT. Concerns like House building, Land Development, or Property Development get facilities of adjusting in the Returns indefinitely and can apply for refund any time, but for all other business concerns, the excess amount of money after adjustment in the monthly Returns (Mushak-9.1) shall be carried forward and may be deducted over the following 6 (six) tax periods, after which any remaining excess money shall be refunded in accordance with the provisions of this Act. It is recommended that, all concerns should get similar facility of adjusting in the Returns indefinitely and should be given chance to apply for refund anytime. Or the Commissioner will refund the amount to the importers suo moto after 6 (six) tax periods has been adjusted in Return.

AT is like guarantee of a due and the guarantor should get redemption once the due is paid. Once the due is paid, process of redemption should be a smooth one. Therefore, refund in relation to paid AT should also be a simple process. In the above circumstances, some more Recommendations are: Manufacturers should be exempted from paying AT; only Commercial importers or traders may be burdened with such imposition; the commissioners should have the sole discretion to recommend for refund of the AT and the recommendations of the Commissioners should be given priority by the VAT Enforcement Department of NBR.

### Sharp rise in Covid-19 infections worrisome

Govt must respond in a manner befitting the gravity of the crisis

**7** E'RE deeply concerned about the manner in which the Covid-19 positivity rate in Bangladesh has started climbing again. The daily rate reportedly went up to 10.29 percent in the 24 hours preceding March 21 morning, in a nearly onepoint jump from the previous day's rate. Meanwhile, the infection and death figures have been hovering over 2,000 and 20, respectively, over the last several days. Also, more people are turning up to get tested at the centres this month compared to February. The rise in our Covid-19 figures are apparently consistent with the global situation, with the Deutsche Welle reporting on March 19 that some 97 countries had reported more cases in the past two weeks compared to the previous 14 days. If the current trend holds, we may soon have a situation where the government may have to consider imposing a lockdown or other forms of restrictions on movements again to contain the virus.

Clearly, with only 48,40,969 individuals vaccinated as of March 21 in a country of over 167 million, we're far from a situation where the mass vaccination campaign would start to affect growth charts. Countries where there is a robust vaccination campaign in place are expecting to be able to soon bring down the numbers (the EU even claimed to have a target of achieving herd immunity by mid-July). In our case, however, not only have we failed to inoculate the targeted population in the first month of our nationwide vaccination drive by a wide margin, we have also failed to come up with a plan to boost recipient numbers by ironing out problems in widening the coverage. The government has to keep in mind that to contain Covid-19, the speed and coverage of vaccine rollout are key.

One possible reason linked to the recent rise in infections is the UK variant of the virus. Researchers tied with the Monash University have also stressed the need to investigate if any of the 34 unique mutations of the virus found in Bangladesh are responsible for the rise, and to find out whether our Covid-19 vaccines are effective against them. The virus apparently mutated a total of 4,604 times in Bangladesh from April to the first week of December last year, and the absence of our own research and even vaccines means we're ill-prepared to respond properly to the threat of the local mutations, if it indeed

These problems and threats call for a more robust, targeted and coordinated Covid-19 response from the authorities. Since a successful anti-virus campaign requires giving equal attention to tracing, testing, treating and vaccinating, the government has to ensure it does so without exception. Besides rigorously enforcing the health safety guidelines, it must trace all potential Covid-19 carriers, especially those traveling from outside, reinvigorate the existing testing and treatment regimes, and of course bolster the vaccination drive in a manner dillydallying.

### Salinity getting worse in coastal areas

Govt must take urgent steps to reduce it


recent survey, titled "Gender-responsive Coastal Adaptation" and carried out by the United Nations Development Programme (UNDP), has brought to light the hardships faced by people of the coastal areas. According to the survey, 73 percent of the people living in five coastal upazilas of Satkhira have to drink saline water on a daily basis. Among these people, another 63 percent face difficulties even in getting this brackish form of water due to not having access to any other source of drinking

UNDP has run the survey on a total of 66,234 households comprising of 271,464 people, and found that the salinity levels of 52 percent of the ponds and 77 percent of tube-wells in the coastal regions were higher than the ponds and tube-wells situated in any other parts of the country. Although the permissible salinity level in drinking water is 1000mg per litre, on average, people of the coastal areas consume water with a salinity level between 1,427mg and 2,406 mg per litre, which has serious health effects. The situation gets even worse during the dry season, when the salinity level of tube-well water in some parts of Satkhira goes up to 6,600mg per

A report published by The Daily Star on March 22, 2021 shows that in coastal areas, most people spend more than two hours per day in fetching water, as they have to commute more than a kilometre for this purpose. The UNDP survey has converted this time into monetary value on the basis of the government-run programme "Kajer Binimoye Khaddo (Food for Work)" and discovered that people of the coastal regions are losing around Tk 2,463 on a monthly basis due to spending productive hours in collecting drinking water.

Experts have given important suggestions to solve the problem. Rainwater harvesting, for instance, can ensure supply of safe drinking water during dry seasons. Also, the destruction of coastal ponds by saltwater shrimp farming has to be prevented. Another way of mitigating the problem is by setting up water desalination plants, where water collected from the Bay of Bengal or salinated rivers will be stored in giant tanks and later purified, although the environmental costs of such an enterprise must be taken into consideration as well. The government must sit with the experts and find sustainable solutions to this serious situation and alleviate the sufferings of the people in these areas.

# A cancelled 1971 conference in Pakistan sends a message



institution Pakistan had to cancel an academic conference about 1971. The virtual conference, scheduled for five days beginning on March 23,

was organised jointly by the School of Humanities and Social Science of Lahore University of Management Sciences (LUMS) and the Institute of Pakistan Studies of Quaid-i-Azam University. The conference was expected to be attended by several academics from South Asia, particularly from Bangladesh and India. The conference, titled "Commemorating 50 years of the 1971 War: War, Violence and Memory", was supposed to feature presentations on the 1971 war, the genocide in Bangladesh and related issues. Although the conference was planned for quite some time, the organisers made the announcement on March 19 of holding the conference. But within 24 hours, the organisers faced such immense pressure that they could not take the risk of holding the event. Although there has not been any reference to any pressure by the LUMS, those who follow social media, such as Twitter, know the extent of belligerent attacks on the organisers. The vitriol was

This incident is another example of the magnitude of intolerance and insidiousness in South Asia. Unfortunately, there are too many examples of such pugnacious acts. Yet, it should not be considered as another incident in Pakistan that shows the lack of forbearance. Instead, two aspects of the incident warrant attention of those who follow Pakistan, whether from Bangladesh or elsewhere. They have implications and messages for the entire region. Firstly, questioning the official narrative has been considered unacceptable. Secondly, the act of silencing or censoring those individuals or organisations who are trying to offer a different narrative has been franchised; it has now been handed over to individuals loyal to the dominant or official narrative.

Who are the actors of the incidents in Pakistan? Whether there was any pressure from the government is yet to be known, but we can safely assume that the government will not be unhappy with the results. It is well known that the Pakistani establishment, particularly the Army, intends either to avoid the question of the 1971 war, especially the genocide in Bangladesh, or regurgitate their own version of history. The "conspiracy theory"



for 1971 involving India, Russia, even the USA, is so deeply ingrained in the psyche of the establishment that it is reproduced in school texts. In 2010, I had the opportunity to scrutinise some of the texts of Grades 9 and 10. Although it was of no surprise that reference to genocide was missing, the unfounded narratives were a revelation to me. This was being done by the Pakistani state, deliberately, even after four decades of 1971.

Khurshid Kamal Aziz, in his superb study titled "The Murder of History" published in 1986, showed how "history" is being murdered every day in Pakistan. Yvette Claire Rosser's study of school texts in India, Pakistan and Bangladesh highlights how history is manipulated by nation states and politicians to forge a national identity. Her PhD dissertation at the University of Texas at Austin in 2003, titled "Curriculum as Destiny: Forging National Identity in India, Pakistan, and Bangladesh" examines the social studies text and argues that "When history is

seen as a tool to mold a nation's youth, interpretations of historical events are often manipulated in response to current events, as heroes become villains across the borders of neighbouring countries, and opposing political parties within nations vie to control the grand narrative of the nation state." In the case of Pakistan, it is not only the 1971 war, but the history of Kashmir and Baluchistan, that hold the same issue. That is why LUMS had to cancel a conference in 2015 on

Notwithstanding the direct censorship imposed by the state, incumbents often encourage its supporters to get the job done for it. It happens in Pakistan as well as in India. Since the BJP came to power in 2014, the frequency has grown exponentially. Denying visas to invited speakers of conferences, and physically assaulting speakers at public events by BJP supporters have happened in the past. This January, an undersecretary of the Education Ministry issued an apparently innocuous memorandum about some guidelines regarding organising webinars by state-supported educational institutions. The memo states that these

institutions must secure prior approval from the ministry of external affairs for organising any international online conferences/webinars. A list of topics is included for which the permission will be required; it reads: "security of State, Border, Northeast states, UT of J&K, Ladakh or any other issues which are clearly/purely related to India's internal matters'

These incidents in Pakistan and India are not only interventions on academic freedom; they have become a regular matter. These are efforts to make the official narrative of history the only history. Such an effort is also discernible in Bangladesh in various manners. Among the legal measures, the most obvious is the Digital Security Act 2018, particularly Article 21. However, the shrinking of space for dissent and freedom of expression is not a result of a single law, although a law can be highly injurious—the supporters of the incumbent can create a climate of fear through direct and indirect pressure. Intimidation, threat and potential violence can and does silence contrarian voices. Those who have been subjected to such harassment in Bangladesh would be able to understand the gravity of it, how frightful the experience can be. Others adopt silence, in fear.

In India, for quite some time, intellectuals, writers, researchers and academics have been fighting the battle against the saffronisation of history. It is not an easy task, neither was it meant to be, yet they have remained steadfast. In Pakistan, in recent years, progressive intellectuals have questioned the official narrative of 1971. The cancellation of the conference and the vicious attacks on the organisers only show the difficulty of the task ahead of them. Their efforts, like those in India and elsewhere in South Asia, have a message—concerned and conscientious persons cannot have the luxury of avoiding this struggle. It is obligatory for intellectuals to speak truth to power.

The conference at LUMS has been cancelled; however, the message it sent is loud and clear.

# Regional integration in the Bay of Bengal: In search of a new agenda

other stakeholders in the Bay of Bengal region and beyond agree on the need for greater integration in this region. The Bay of Bengal

Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC), founded in 1997, offers a platform to carry the regional integration agenda forward. However, the progress in the integration process in the Bay of Bengal region has remained slow. Also, achievements, in terms of trade, connectivity and cooperation, have been little and segmented.

In the context of an interdependent and interconnected world, the national economic and security priorities of the countries in the Bay of Bengal region are strongly connected to collaboration across boundaries. Yet, the question remains, given the record of slow progress, whether there is any prospect of deeper integration in the Bay of Bengal region.

While the importance of trade and investment integration—through trade in goods and services, removal of tariff and non-tariff restrictions and promotion of a regional investment and trade nexus—is critical, deeper regional integration in the Bay of Bengal needs favourable political economy factors.

The political economy perspective shows how various actors influence

CADEMICS, national and regional decision-making contexts, as well as the impacts their actions (or lack of actions) have on the integration process. The interplays of different actors shape the political economy perspective. In this context, the role of official institutions (at the regional level and in respective countries) entrusted to carry out the regional integration process is vital.

> As a result, the functioning of the BIMSTEC Secretariat and relevant ministries in member countries is critical. Furthermore, the integration process is influenced by the roles of the private sector, private sector associations, civil society organisations and media. The status of regional connectivity and regional trade facilitation in BIMSTEC

Finally, while we talk about the political commitment for regional integration, we should keep in mind that political commitment is not strongly exogenous. It is also dependent on certain factors like domestic politics, bilateral political relations between countries, the country's overall development strategy, and external factors beyond this region, primarily geo-political ones. We often blame bureaucrats for the slow progress in regional integration. However, it is the political elite that finally decides. Unless clear messages and signals are there from the political elite, bureaucrats can hardly make any progress. The lack of effort for integration in the BIMSTEC region is not primarily an economic or bureaucratic problem; it is primarily a political economy problem. There is a need for agreement among the elite—both political and economic—at the regional level. While the economic elite feel the necessity of integration, the political elite are divided. Regular consultations, peopleto-people connectivity, interactions among political and economic elites, and promotion of political liberalism can help to reach a "regional political agreement"

BRAC's play-based Early Childhood Development model has proven remarkably effective, even in the most challenging contexts as well as in stable communities. In the Rohingya refugee camps, BRAC Play-Labs have captured the local games, language, toys and culture, with the philosophy of

promoting healing, learning needs and growth to support children in very difficult circumstances. These learnings have helped expand Play Labs to children in Tanzania, Uganda, and others. Even through the Covid-19 pandemic, new technologies and approaches, like utilising local radio stations, have allowed us to continue to reach children in their homes and ensure they don't miss out on this critical developmental period. Additionally, in six countries where BRAC has been running its microfinance programme, it is now adding products like agriculture extension loans and loans focused on youth and adolescents.

Historically, NGO development programmes have been run the world over by Western and Northern actors. With the growing influence of Bangladesh, we have now established a Southern model for development, where Southern innovation and values are promoted. Currently, 160 Bangladeshis are working and playing leadership roles in their own areas of disciplines in 10 countries around the world for BRAC, supporting those countries to grow in their own right.

This Southern approach to uplifting the poorest and most marginalised among us is a radical transformation in the humanitarian and development sector, and impacts the lives of not only Bangladeshis, but people all over the world. Bangladesh should be just as proud of its accomplishments in the development sector and celebrate its role as a leader in Southern innovation as much as it celebrates its cricket team.

# The business of being a female online entrepreneur

something you want. Anything. No, really. Be it a set of frosted cupcakes, a piece of jewellery, or homemade sushi rolls. Or, perhaps, a very specific outfit that only exists in

your mind—until a

photo of it appears on your Facebook newsfeed in the form of an ad (better known as a "sponsored post") All you need to do after that is message the Page that posted the ad, enquire about the product's price (a process formally referred to as "inbox for price"), quality, quantity, delivery timeline, etc, and give them all the details they will need in order to make sure the product reaches your hands within usually—one to five working days.

It's that easy, and a bit scary for being so easy. Let's leave worrying about robots taking over for a different day, though. Instead, let us wonder: is every transaction made online as simple for the seller as it is for customers?

When the Covid-19 pandemic set in around last March in Bangladesh, it wasn't long until we all got desperately bored of being stuck in our homes, worrying (often panicking) about The Future, and turning to quirky distractions. Luckily, we had the internet and soon realised that we weren't the only ones whipping coffee or suddenly turning into pros at cooking, baking, painting, etc—the rest of the world was going through the same. In fact, some of us got so good that we felt confident enough to earn some cash from our newly-found hobbies.

A year later, while many have returned to their pre-pandemic lives, the fad of pastimes dusted off, for quite a few people, those hobbies actually turned out to be serious

business —literally. While Zarrin Tasnim (owner of Cravory, an online food shop where she sells her homemade sushi rolls and desserts) has always had a knack for cooking and finding joy in feeding others, it wasn't until the pandemic hit that she felt her products could fill a gap in the market for delicious and affordable food that is also different from

what's usually on the market. "Soon after I started offering them through Facebook groups, my customers started appreciating my food and they would further encourage their peers to try them," Zarrin tells me, "I got a surreal amount of appreciation and love from some very amazing people."

Of course, it was a challenge to find many ingredients during the lockdown, but especially ones which Zarrin needed because they belonged to a foreign cuisine

But given how delicate some of her cakes are, and how new the business of delivering food still is in our country, the young baker had been in for a rocky beginning. "For some time, I struggled to find a good delivery service," says Naseeha, mentioning that some of the cakes did suffer mishaps because of unsuitable delivery services. "But thankfully, my customers were very understanding and supportive about it. I do use a reliable service now, but it took me some trial and error to

and were not always available even before the pandemic. A second challenge was delivering the food to customers properly, and this was felt greatly by home baker Naseeha Nuzhat Rahman as well.

Naseeha has been baking for years, conjuring up unique and decorative cakes for her friends' birthdays and other occasions. But seeing all the hard work and carefullyselected ingredients she put into her baking, her friends insisted on paying her for her craft, and also encouraged (nay, nagged) her to turn it into a business like she had always wanted to. That is how Bucklebury Ferry, Naseeha's online bakery, came to be in September last year.

reach this point."

Although the average time taken for a delivery to be completed has shortened significantly over the past few years (from at least two days to orders now being delivered the next day after placing them, or even on the same day in cases of urgency), both sellers and customers still face age-old issues such as delays in delivery, and products being displaced or damaged. However, it is usually the seller who has to refund the customer for a lost product. And if a customer is unable to receive a product one day, the delivery company has to hold the product for another day and the seller will often have to pay the company a fine for said delay.

Though some have the tendency to not take online businesses seriously, most of the population is by now well aware of how accessible almost every kind of service and product has become, thanks to social media platforms and the internet at large.

Another prevalent issue is when sellers make or order a product (from international websites) for individual customers, but the customers often "disappear" when the product is ready or cancel the order once the product arrives to the seller. This certainly incurs a loss given that the customised product may not be sellable to other customers of the business. While some sellers do require their customers to make a partial advance payment in order to avoid such situations, this is not possible for newer businesses as they need to gain credibility with their first few batches of orders.

But beyond all of these hurdles, some young entrepreneurs have to deal with personal issues which trickle into business matters, threatening to majorly hinder their aspirations.

Azmery Khan, a business student who had always wanted to run a business of her own, was finally prepared to pursue that dream when the pandemic hit. As such, the first few months of her business, Aurora (which mainly stocks imported jewellery and clothing items), were uneventful until she was gradually able to sell some of her initial stock. Now, her business' group and page on Facebook both have over 3,000 members and likes, respectively. However, when asked what the biggest challenge she faced in conducting her business has been, she spoke of two major ones. "Firstly, my father doesn't know that I have a business of my own," Azmery stated, "And, secondly, I started my business with zero [outside] investment. I am still struggling, but at the end of the day it's worth

The same kind of familial opposition is mirrored in Naseeha's experience. "Growing up, I often talked about being a chef and I

would be discouraged, as my family preferred more academic fields. Even when I was brainstorming for Bucklebury Ferry, their disapproval and worries about how it would affect my education delayed me [starting my business for quite some time. And I can't help but think I'd be in a better position now, if I had started sooner."

Though some have the tendency to not take online businesses seriously, most of the population is by now well aware of how accessible almost every kind of service and product has become, thanks to social media platforms and the internet at large.

It is not news that a greater number of barriers exist for women entrepreneurs than what are in place for men. However, despite all of this, it is undeniable how much more convenient it is now for women to own and operate their own businesses, utilising their skills and crafts remotely and still finding immense success. And the three stories presented above are surrounded by thousands of similar (almost identical) ones, given how all such entrepreneurs have one bittersweet experience in common: that of being a Bangladeshi woman.

So while Naseeha hopes—with caution to someday be completely reliant on her online bakery, Zarrin and Azmery are everoptimistic about the future of their respective businesses, given the upward trajectory of the popularity of online shopping in Bangladesh.

Regardless, until the robots assume all duties, it is a welcome sight to see women (young and old) breaking down the societal walls of convention, without ever having to leave the house.

#### Europe can

Most have since resumed using the vaccine after the European Medicines Agency found it "safe and effective".

AstraZeneca Plc said yesterday its Covid-19 vaccine developed with Oxford University was 79% effective in preventing symptomatic illness in a large trial in Chile, Peru and the United States, paving the way for it to apply for US approval.

The vaccine was also 100% effective against severe or critical disease and hospitalisation, and was safe, the partners said, releasing results of the late-stage human trial study of more than 32,000 volunteers across all age

The data will give credence to the British shot after results from earlier, separate late-stage studies raised questions about the robustness of the

AstraZeneca said an independent safety committee conducted a specific review of the blood clots in the US trial, as well as cerebral venous sinus thrombosis (CVST), which is an extremely rare blood clot in the brain, with the help of an independent neurologist.

The London-listed company said the panel found "no increased risk of thrombosis or events characterised by thrombosis among the 21,583 participants receiving at least one dose of the vaccine. The specific search for CVST found no events in this trial."

These results are great news as they show the remarkable efficacy of the vaccine in a new population and are consistent with the results from Oxford-led trials," Andrew Pollard, who runs the Oxford Vaccine Group,

AstraZeneca said it was preparing to submit the data to the US Food and Drug Administration and for a launch in the United States should it win Emergency Use Authorization, reports Reuters

University of Oxford professor Sarah Gilbert told BBC radio that work to prepare the submission will take a few weeks.

Meanwhile, British Prime Minister Boris Johnson said yesterday he was "reassured" EU leaders do not want blockades on vaccine exports, while Ireland's leader warned a threatened ban would be "very retrograde"

Britain has urged the European Union not to halt exports of AstraZeneca's Covid-19 vaccine in response to a shortfall in deliveries to the bloc from the Anglo-Swedish firm.



forces' lethal violence. against peaceful protesters must end," said Andrea Gacki, director of the US Treasury's Office of Foreign Assets Control. "We continue to stand with the people of Burma."

There was no immediate response from the junta, which has shown no sign so far of being swayed by international condemnation of its

At least 250 people have been killed so far in the crackdown on the protests, according to figures from the Assistance Association for Political Prisoners (AAPP) activist group.

Three people were killed in Myanmar's second city, Mandalay in renewed unrest yesterday, including a 15-year-old boy, witnesses and news reports said.

EU foreign ministers adopted the travel bans and asset freezes on the individuals at a meeting in Brussels. So far, the EU has an arms embargo on Myanmar and it has targeted some senior military officials since 2018.

"We are going to take sanctions against 11 persons involved in the coup and the repression of the demonstrators," EU foreign policy chief Josep Borrell said.

German Foreign Minister Heiko Maas told reporters before the meeting that the crackdown "has reached an unbearable extent, which is why we will not be able to avoid imposing sanctions".

### Fear, despair grip them

People of 89 other families in the area have also been living in fear since a mob of Hefajat-e-Islam supporters wreaked havoc in the village, saying that someone from the community criticised their leader Mamunul Haque on Facebook.

Shahidul Islam Swadhin, the main accused, and 32 others have been arrested in two cases.

Police have set up two outposts in the village to ensure safety of the community, said Najmul Huq, officerin-charge of Shalla Police Station.

Hefajat-e-Islam held a rally in Derai, Sunamganj, on March 15, where its Amir Junayed Babunagari and Joint Secretary General Mamunul Haque spoke.

Word spread the next day that a young man named Jhumon Das Apon had criticised Mamunul in a Facebook

That evening, hundreds of people from Kashipur, Chondipur, Nachni and several other villages in Derai gathered at Dharain Bazar. Some of the people in the crowd were openly talking about attacking Hindu people's houses at Noagaon, witnesses told The Daily Star.

Locals, who were against a wholesale attack, detained Jhumon from Shaskhai Bazar and handed him

to police.
"People gathered in Dharain Bazar after someone used the microphone in a mosque and announced, 'Gather for a rally to save Islam.' The next morning, someone from the mosque announced there will be demonstrations in Shalla," Monful

Begum, a resident of Nachni, told this correspondent.

Liton Chandra Das, a resident of Noagaon, said, "When they gathered in the morning, we thought they were going to the government offices as they had announced before. We didn't think they would attack us.'

Al-Muktadir Hossain, nirbahi officer of Shalla, also said the crowds of people were supposed to hold a rally on March 17. "In the morning, when they gathered at Dharain, we went there to talk to

On the night before the attack, Shalla Upazila Chairman Chowdhury Abdullah Al Mahmud went to Kashipur village, which is not far from the hindu houses, and tried to calm the mob.

"I talked to locals and Union Parishad members. They said there would be no further agitation," he told this correspondent.

Freedom Fighter Jagat Chandra Das, 73, said, "The upazila chairman told us nothing will happen. But we The upazila nirbahi officer said,

"The attack on the village by a part of the mob was completely sudden, unplanned and uncontrollable." The mob that gathered in Dharain, first attacked a Kali temple in the

village around 7:00am, said Adhir Chakraborty, who looks after the temple. "They attacked the temple hours before they attacked the houses. This proves that they gathered to attack the Hindu people. There are houses of six freedom

fighters in Noagaon. All of their houses were attacked.

Freedom fighter Anil Chandra Das said, "I told them I'm a freedom fighter, but they didn't listen and they were furious.

Freedom fighter Jagat Chandra Das said, "They've humiliated us, I wish I were dead.

His son Liton Das, said, "I heard them say 'it's a freedom fighter's house', and then they attacked our

Jhumon's wife Sweetie Chandra as was beaten up by the mob.

"I, my six-month-old child, and sister-in-law went under the bed when they attacked. They found me... they tried to hit my head, but missed and cracked my arm. Then they held a knife to my throat and took away my jewelleries and savings," she said.

Seven temples along with the idols

at people's homes were destroyed. Ashim Chakraborty, the village priest, said they stole a stone idol of Bishnu believed to be aged almost 1,000 years.

the President's House and Martial Law Headquarters. Members of Awami League's Shwecchashebok Bahini began the day early in the morning, singing in chorus the tunes of "Joy Bangla", while hoisting Bangladesh's flag at Bangabandhu's residence. A crowd of Bangalees thronged in front of the house to hear orders for the next course of action from Bangabandhu

Awami League activists went to consular establishments, requesting, and sometimes demanding, that the Bangladesh flag be flown. The Soviets and British had hoisted the Bangladesh flag while the Iranian, Indonesian and Nepalese had flown the Pakistani flag. The Chinese had initially hoisted the Pakistani flag but had been forced by students to replace it with a Bangladesh flag. The Americans did not fly either flag. # Hassan perplexed by Shakib's allegations and the timing

Bangladesh Cricket Board president Nazmul Hassan yesterday said that he is yet to see the interview

that Shakib Al Hasan gave to Cricfrenzy, an online news portal, on Saturday.

"I don't know. They [board directors who were at a meeting with Nazmul at his residence in Gulshan on Sunday night] told me about it [the interview] but I did not see it, heard it or read about it. They came to the meeting about the New Zealand tour and then said that Shakib said this and that. I told them that I do not have any other thoughts except for the New Zealand tour as the next ODI is tomorrow (Tuesday). I cannot say anything about it now. Let the series finish or at least let tomorrow's match end and then I will talk about it [Shakib issue]," Hassan told The Daily Star.

But Hassan heard bits and pieces of that interview in the media and from board directors, and the BCB boss questioned how a national player can say anything against any of the former national team members.

"He [Shakib] is the team's best player. Now, being a national player who was also the team's captain once, he cannot say anything



against the team. According to the rules, he cannot do that. He has signed an agreement with us and it clearly mentions that he cannot say anything against the board or any board member. This is what the rules entail. Forget the rules, as a person, one should have minimum respect towards the seniors. Why would I, being a national player, say anything against players like Akram [Khan] or [Naimur Rahman] Durjoy? Just because you [Shakib] are a good player, does that give you the authority to say anything against them? If he had anything to say, he could have said it in person to them," added Hassan.

"What has happened suddenly that he had to say things by naming Akram or Durjoy and by questioning Durjoy's performance for the development of HP squad? I don't understand the ill-timing of this topic. It came up just after Bangladesh lost to New Zealand [in their first ODI]? I actually can't believe it.' Hassan also wondered why

players always inform the board of their intentions regarding skipping a tour right at the last moment.

"When he [Shakib] said that he did not want to tour South Africa [back in 2017], we were a bit shocked. We needed to think and get a few players ready beforehand. We needed to play a few other players before that to make them ready for such a series. We were also shocked when we heard about his ban at the last moment just before the India series. Now he shocked us by saying at the last moment that he does not want to go to Sri Lanka. These things are actually unexpected. And then, Tamim, after going to New Zealand, is saying he won't pay T20s. I mean what is the problem if they let us know beforehand?" said Hassan.

And according to Hassan, while players have the right to choose which format or which series they want to play, it still is the foremost duty of a player to put his national team before any franchise league.

# Can batsmen land a punch in Round 2?

All eyes will be on the batsmen after a disappointing showing in the first game when Bangladesh take on

New Zealand in the second ODI at the Hagley Oval today, fighting to stay alive in the three-match series.

Tamim Iqbal and his men will not find much inspiration from Bangladesh's record at the Hagley Oval, which has been the case in all venues in New Zealand.

The Tigers suffered thrashing defeats in the two ODIs they played in Christchurch, losing by 77 runs and eight wickets back in 2016 and 2019 respectively.

On their latest sojourn, things have not changed much. In the first ODI in Dunedin the visitors were bundled out for 131, the first time they had been shout out

below 150 since September 2018. Bangladesh's top order, and in particular skipper Tamim, will have to come up with a better approach. Opener Liton Das and number three Soumya Sarkar also need to find a way to provide a solid start that has remained missing

against the Kiwis in their own backyard. A lot has been said over the seamfriendly conditions in New Zealand and the Hagley Oval is also expected to offer some bounce and swing for the pacers, and the home side will expectedly have an advantage on that front as Trent Boult broke the Tigers' backs with four wickets in the first ODI.

"Batters need to take more responsibility and all the players, from top to bottom, will have to give their best," said middleorder batsman Mohammad Mithun through a video message to the media yesterday. "There's always the discussion [about] where the game tends to slip away from us in the first 10 overs, especially in the batting department.

"Generally, pitches in New Zealand offer high-scoring games and definitely we have to score around 260-270 or else it's always difficult to put up a fight against New Zealand. No matter how the pitch behaves, we have to adjust to win the game and give something for the bowlers to defend.

It will be interesting to see whether the team management includes pace bowling all-rounder Mohammad Saifuddin in place of pacer Hasan Mahmud. Apart from that, head coach Russell Domingo might want to give one more opportunity to the batsmen who looked clueless and



"They took away all of my savings and the gold jewellery we had for my daughter's wedding. We managed to flee minutes before they attacked," 55-year-old Jhorna Rani Das said, describing the attack on her house.

Her four daughters have gone to their uncle's home and are too afraid to return to Noagaon village in Shalla, Sunamganj, where houses of Hindu people were vandalised in a communal attack on March 17.

After losing their job in a garment factory during the lockdown, her two daughters came back home in April last year. "Now we are completely broke."

### India reports worst day in months

Some hospitals begin to run short of beds REUTERS, New Delhi

India reported its most Covid-19 cases and deaths in months yesterday, on the first anniversary of the start of a chaotic nationwide lockdown that left many people jobless and shrank the economy.

Authorities reintroduced some curbs to slow the spread of the virus, especially in the western state of Maharashtra, which accounted for nearly twothirds of the 46,951 new infections and the majority of the 212 deaths.

Some hospitals in the country's worst-affected districts have begun to run short of beds, and there is a rising clamour for the immunisation campaign to be widened to cover more people, instead of just the elderly and those suffering from other health conditions.


The United States targeted Myanmar's police chief and an army special operations commander with sanctions yesterday over the government's deadly

### Govt raises allocation by 81.25pc

Seeks to boost pandemic-hit rural economy

The government has increased the allocation for its Money for Work and Test Relief (TR) programmes by 81.25 percent for the current fiscal year to revitalise a pandemichit rural economy and provide money to people through development of rural infrastructure.

The original allocation for the two schemes 1,216 crore. Following the increase by Tk 987.77 crore, the amount now stands at Tk 2,203.77 crore. The money will be spent for construction and repair of roads and development of infrastructure in rural areas.

Md Mohsin, secretary to the Ministry of Disaster Management and Relief, said an additional amount of around Tk 2.5 crore was allocated for each upazila. The allocation was increased during the Mujib Borsho, he added.

The secretary said the rural infrastructures at the upazila level would be changed through the implementation of this initiative and people would have extra cash in hand, which would give a big push to the rural economy.

If such an initiative can be continued for next two or three years, it would help improve the lives of the rural people, he added.

### Europe can have immunity by July

Says EU commissioner; AstraZeneca's Covid jab found safe, effective in new trial data

Europe could have herd immunity against Covid-19 by July, a European Union commissioner has said, as incoming jabs are expected to speed up the continent's sluggish vaccine rollout.

The note of optimism comes even as several European countries have started reimposing restrictions as they contend with surging coronavirus infections, and after mixed messaging on the safety of a key jab.

"Let's take a symbolic date: by July 14, we have the possibility of achieving immunity across the continent, Thierry Breton, the EU's commissioner for the internal market told French broadcaster TF1.

'We're in the home stretch, because we know that to beat this pandemic there's just one solution: vaccination. The vaccines are arriving," he said.

More than a third of France's population is now under renewed lockdown, while frustrations over virus curbs spilled into weekend demonstrations in Germany, Amsterdam, Bulgaria and Switzerland.

Europe's battle to prevent a deadly third wave of infections has been complicated by a patchy vaccine drive that included several nations temporarily halting AstraZeneca's shots in response to isolated cases of blood
