Police, not Hefajat, sue one under the DSA

Jhumon was detained on March 16 and sent to jail the next day on charges of violating section-54 of the Criminal Procedure Code (CrPC).

He alegedly criticised Hefajat-e-Islam leader Mamunul Haque on Facebook.

OC Najmul said, "When we detained him, local Hefajat leaders told us that they would sue him. Since they have not done that and a court has already sent him to jail under the CrPC, we had to file the case.

"The closure of primary, secondary and higher secondary-level institutions is likely to be extended till the Eid holiday in coordination with the closure of universities," Minister Dipu Moni told reporters earlier in the day following a discussion organised to mark the Genocide Day at Bangabandhu

Avenue in the capital yesterday. The decision will be taken after a meeting with the National Technical Advisory Committee on Covid-19,

On February 22, the government announced that in-person classes at public and private universities would resume on May 24, after Eidul-Fitr, and that all dormitories of universities would reopen on May 17.

The government on March 17 last year closed all educational institutions, aiming to contain the spread of coronavirus. The closure led to cancellation of exams and left academic calendars in disarray.

Educational activities of around four crore students were being hampered due to the closure.

The government started TV education for primary and secondary students so that students could make up some of the losses.

Authorities of many schools, colleges and universities also started online classes, but many students could not access these regularly due to the lack of digital devices and/or internet facilities.

The pandemic led to the cancellation of the Higher Secondary Certificate and equivalent exams, originally slated for April 1, 2020.

The government also cancelled last year's Primary Education Completion, Junior School Certificate and their equivalent exams due to the pandemic.

Primary and secondary students were promoted to the next grade this year without any annual examinations.

medical care facilities, learning centres, women and child support centres -- were razed to the ground by the inferno.

Yesterday, this correspondent came across the "Lost and Missing Child Information Centre" at Balukhali camp set up by Brac, where parents crowded to report their missing children.

At the centre, this correspondent talked to Mohammad Azmat of camp-8(e).

"When the fire broke out, we ran for our lives. But my seven-year-old son has been missing since. I registered his name here, in the hopes of getting him back," said Azmat, who was one of those in the queue to report their missing children.

"Without my child, I can't even focus on rebuilding my shelter," he added.

An NGO official, preferring not to be named, told The Daily Star that

150 such information centres have been set up across the four affected camps, where parents come to submit their child's name every day.

Humanitarian organisations, including Brac, International Refugee Council and Danish Refugee Council, are working and coordinating on the ground to generate information about

missing children. Apart from this, child protection agencies established child-friendly spaces to receive lost children.

As of Wednesday, 24 children were received by child protection units and 17 were reunited with their families, a camp-in-charge who wished to remain anonymous told The Daily Star.

According to the Refugee Relief and Repatriation Commissioner's office, the fire that raged in four camps on Monday claimed 11 lives, burnt down 10,000 shanties and displaced around

It was a mortar shell

which was used in the war.

"It was made in a Pakistan ordnance factory (PoF). Inspecting the incident, we understand that the mortar exploded as the three dead tried to cut it with an electric blade."

The law enforcers also found a fuse of the mortar shell on the spot and defused it, he said.

The mortar shell exploded around 4:00pm last Wednesday.

Three men -- Borhan Uddin, 40,

Wahedul Islam, 32, Masud Rana, 35, of the same upazila -- were killed in

Sources said Habibur got the mortar shell a year ago from some laborer of his area. During the expansion work

of the Dhaka-Rangpur highway, the laborers got this mortar shell.

As a local political leader, Habibur took it from them and had hidden it at his home for the last one year.

Later, once he shared it with his partner Borhan, he was forced to hand it over to Borhan.

Habibur is a ward sectary of the Jatiya party in Mokamtala union and an accused in a domestic violence

"We have yet to get a schedule of when the doses will arrive. We hope that we will get a considerable amount early next month," Nazmul Hassan Papon, managing director of Beximco Pharmaceuticals Ltd, the local agent of Serum, said.

The country is expected to receive 10,908,000 shots of the Oxford vaccine by May, thanks to the global arrangement called Covax, he added. There will be no shortage of vaccine

New cases have continued to rise for "As per our contract, we want the third consecutive day vesterday.

DGHS reported 3,587 new cases detected in the 24 hours preceding 8:00am yesterday. This was the daily highest in the last nine months. On July 2 last year, the number of new cases was 4,019.

The number of confirmed cases rose to 5,84,395 yesterday.

In the same 24 hours, 34 people died from Covid-19, taking the death toll to 8,797. The death rate stands at 1.51 percent.

Against a total of 27,045 tests yesterday, the positivity rate was 13.26 percent while the overall positivity rate was 12.94 percent.

At least 1,985 Covid-19 patients recovered during the period.

The total number of recoveries now stands at 5,29,894 with a recovery rate of 90.67 percent.

Libya militia leader shot dead

Libyan militia leader Mahmoud al-Werfalli, wanted by the International Criminal Court for alleged war crimes, was shot dead in the eastern city of Benghazi

on Wednesday, security sources said. Werfalli, a member of forces loyal to eastern military strongman Khalifa Haftar, was "shot dead with his cousin, Ayman, when unidentified gunmen opened fire on his car," said one source

who requested anonymity. The pair were seriously wounded, before being pronounced dead on arrival at Benghazi Medical Centre, located near the scene of the

shooting, another security source said. The ICC issued a first warrant for Werfalli's arrest in August 2017, accusing him of having ordered or personally carried out seven separate rounds of

executions of 33 people in 2016 and 2017. In July 2018, the ICC issued a second arrest warrant for Werfalli for his "alleged responsibility

for murder as a war crime". The court said he "allegedly shot dead 10 persons in front of the Bi'at al-Radwan Mosque"

in Benghazi on January 24 that year. Born in 1978, Werfalli was a commander of the Al-Saiqa brigade, an elite unit that defected from Libya's military during the 2011 uprising that toppled and killed dictator Moamer
