# VIRUS CURBS ON SHOPS **Owners** take to the street

Demand they be allowed to keep stores open

Shop owners and employees of New Market, Bashundhara City Shopping Mall and Sadarghat areas in Dhaka took to the streets to protest the government's decision to keep all shops and malls closed during the seven-day restriction to contain Covid-19 surge.

Rajshahi Byabshayee Oikya Parishad, a platform of 110 businesses, also protested the government's move.

All the groups demanded that the government allow traders to keep their shops open while maintaining health guidelines.

The seven-day restriction is set to be enforced from 6:00am today.

Several hundred shop owners and employees of New Market and nearby markets and shopping malls blocked adjacent roads for two hours from 3:30pm in protest at the directive.

Witnesses said the protesters smashed windows of several cars while road closures caused severe traffic congestion.

Our main demand is to keep the market open for a few hours because our families depend on our income. If the shops are closed, that would bring on uncertainty in our lives. We want to keep the shops running while maintaining safety guidelines," said Sohel Rana, an employee of a shop at New Market.

Protesters said they had suffered a lot due to last year's closure. They do not want any repetition.

#### Nor'wester 4 crushed by falling trees in Gaibandha STAR REPORT

At least four people were killed when trees crushed them during a nor'wester Gaibandha yesterday afternoon.

Hundreds of houses trees and crops were damaged in Rajshahi. At least 30 poles of streetlights were uprooted in Rajshahi

city. The Bangladesh Inland Water Transport Authority (BIWTA) suspended the operations of all ferry services in the evening due to storms.

Gaibandha Deputy Commissioner Abdul Matin told The Daily Star that the storm started around 3:30pm. The four were killed in three upazilas of the district. We have given Tk 10,000 to each of the deceased's family. The death toll could

increase, said the DC.

The deceased are: Moyna Begum, 60, of Sundarganj upazila, Simuli Akter, 25, of Fulchari upazila, Zahanara Begum, 50, and Abdul

New York Times reported today that Chuadanga had been designated the provisional capital of independent Bangladesh. The designation was made by Dr Ashabul Haq Joarder, who was regarded as the leader of the resistance forces in this area of the country He called himself their chief adviser, added the report. Dr Haq Joardar, reported New York Times, said fighting would continue until the new nation is consolidated. The report further stated, "Unlike the case in other towns in the area, which were in the hands of disorganized groups of Sheik Mujib's supporters, there appears to be some order in this town of about 35,000 people. Many have left, but the town has yet to see any fighting.

Nasa's Ingenuity mini-helicopter has been dropped on the surface of Mars in preparation for its first flight, the US space agency said.

The ultra-light aircraft had been fixed to the belly of the Perseverance rover, which touched down on the Red Planet on February 18.

# 'We must win'

Anti-coup protesters decorate Easter

eggs in Myanmar; junta issues warrant for dozens of celebrities

Opponents of military rule in Myanmar inscribed messages of protest on Easter eggs yesterday while thousands of others were back on the streets, denouncing a February 1 coup and facing off with the security forces who shot and killed two men.

In the latest in a series of impromptu shows of defiance, messages including "Spring Revolution", "We must win" and "Get out MAH" - referring to junta leader Min Aung Hlaing - were seen on eggs in photographs on social media.

"Easter is all about the future and the people of Myanmar have a great future in a federal democracy," Dr Sasa, international envoy for the ousted civilian government, said in a statement. Sasa, who uses only one name, is a member of a largely Christian ethnic minority in the predominantly Buddhist country.

Opponents of military rule have mounted a civil disobedience campaign since the military overthrew the elected government of Nobel laureate Aung San Suu Kyi, that has included creative shows of defiance promoted on social media.

Young people in the main city of Yangon handed out eggs bearing the messages of protest, pictures in posts showed.

Crowds have returned to the streets day and night to reject the return of military rule after a decade of tentative steps towards democracy. Numerous candle-lit vigils took place overnight.

The Assistance Association for Political Prisoners (AAPP), an activist group monitoring casualties and arrests, said the toll of dead had risen to 557, as of late Saturday.

In the capital, Naypyitaw, two men were killed when police fired on protesters on motorbikes, the Irrawaddy news site reported.
