# 'Lockdown' goes lightly on first day

The government restrictions, imposed to rein in the rising number of Covid-19 cases and deaths, were not enforced strictly on the first day yesterday.

Many city dwellers continued to disregard health safety rules even in this grave situation. They did not wear masks, let alone follow social distancing.

Streets in the capital were less crowded, large malls remained closed, but shops in alleys were open. People thronged those shops.

Intercity and long-haul buses did not operate but cars, auto-rickshaws and

rickshaws ruled the thoroughfares.

Commuters suffered during the morning rush as government offices and private firms were open on a limited scale.

Many rode rickshaws while many others took auto-rickshaws to get to work, spending extra. Some had to change vehicles multiple times and even walk to work.

Most shops on main roads could not avert the law enforcers and had to remain closed. Shops and convenient stores in neighbourhoods were open for business as

In some places, law enforces were seen asking people to follow health guidelines. A SEE PAGE 2 COL 3

# Despite dearth, govt to press on

Even after a dearth in the supply of the Oxford-AstraZeneca vaccine, the government has decided to continue administering the first dose and to start giving the second dose of the Covid-19 vaccine as scheduled.

"The Prime Minister has made it clear to follow the prefixed rollout plan for the second dose of the Covid-19 mass vaccine inoculation scheduled to start from April 8." Cabinet Secretary Khandker Anwaru Islam told reporters yesterday.

During the briefing after the weekly Cabinet meeting, he also said that the government has enough stock to begin administering the second dose. "I had a conversation with the health director general. There will be

no problems. While we are administering the vaccine in hand, more will come," Islam added. The health directorate also issued a fresh directive on April 4 saying that

administering the first dose will continue simultaneously along with the The countrywide vaccination campaign will continue during the 'lockdown" and the month of Ramadan, said a circular from the

Directorate General of Health Services (DGHS). The decision was taken at a meeting of the Covid-19 Vaccine Preparedness and Deployment Core Committee on Sunday.

Those who have received the first dose will receive a confirmation text message for the second dose from April 5 onward, said the DGHS circular. It also said that from tomorrow Beximco Pharmaceuticals Ltd will start transporting the Oxford-AstraZeneca vaccine to different district-level government storages as per the distribution list.

#### Mob torches Saltha UNO's office, 2 cars

**Enforcement of Covid** curbs sparked it

Locals said Assistant Commissioner (land) Marufa Sultana went to Fukra Bazar under Sonapur union and tried to enforce the Covid rules around 6:30pm. Ansar members, who accompanied her, beat up a man for having tea with others violating the rules, the locals alleged.

At one stage the official left the scene and police from Saltha Police Station went there and clashed with the crowd.

# Slow response brings us here

In the first week of last month when the country started seeing a resurgence of Covid-19 infections, healthcare experts sounded alarm, urging the government to take immediate measures to rein in the surge before it goes out of control. The government's response to a looming crisis, however,

was iackadaisicai. The authorities blamed people's reluctance to follow: the health safety guidelines for the spike and relied largely on procedural work such as sending letters to district

administration for enforcing the guidelines and limiting mass gathering.
Even in the fourth week of last month when Covid cases

as well as deaths from the virus kept soaring, the health directorate officials ruled out any possibility of re-imposition of a shutdown. It did not spell out any measures to deal with the situation that had the signs of an impending crisis. Then on March 30, the government issued an 18-point

directive to curb the rapid surge in cases. By that time, the country was already on course to see the highest infection rate ever. But nowhere in the 18-point directive the government hinted about any restriction or lockdown.

Two days later, the countrymen saw a careless act on the part of the health directorate as it allowed the holding of the entrance test for medical colleges without considering the health hazards it could pose.

# Challenging for BJP; TMC feels at ease

As voting for the third phase of the West Bengal election takes place today, the Trinamool Congress (TMC) will focus on keeping its traditional bastion intact while India ruler Bharatiya Janata Party (BJP) will try to end its duck in the battle for 31 Assembly seats.

The third phase of the election will be held across three districts -- Howrah, Hooghly and South 24 Parganas -- where Muslim voters play a key role, according to experts.

The ruling TMC won an overwhelming 29 assembly seats from these constituencies in 2016, while National Congress and Communist Party of India (Marxist) shared the other two.

The BJP on the other hand not only failed to win a single seat, but got just 6.91 percent of the votes. The party, however, managed to increase its votes to 37.45 percent in the constituencies that consisted of these 31 seats in 2019 Lok

Sabha (National Election) polls. In third phase, the main challenge for the TMC is to ensure that it keeps its Muslim votes intact. The worrying factors for the TMC is a possible split of Muslim votes between TMC and the coalition of CPM, Congress and the Indian Secular Front of Abbas Siddiqui.

# Death toll 29, 7 still missing

Twenty-nine bodies were recovered and seven people remained missing till last night after a passenger launch

capsized in the Shitalakkhya river in Narayanganj on Sunday. Among the deceased are 15 women, six children and eight men, said Narayanganj Sadar Upazila Nirbahi Officer Nahida Barik. The bodies were handed to family members

Families of each of the deceased were provided with Tk 25,000 for funeral expenses on behalf of the district administration, the UNO said.

Rescue operations to trace the seven missing persons were going on when this report was filed around 8:00pm.

The launch named Sabit Al Hasan left Narayanganj Launch Terminal for Munshiganj with nearly 50 passengers around 5:56pm on Sunday. Around 15 minutes later, it sank near the third Shitalakkhya Bridge at Koylaghat of Syedpur area when it was hit and dragged by a tanker.

Immediately after the accident, Bangladesh Inland Water Transport Authority (BIWTA), Fire Service and Civil Defence, Coast Guard and Police joined the rescue operation.

Five bodies were recovered on Sunday night, but authorities concerned had to halt the rescue operations around 2:00am yesterday due to adverse weather.

After a four-hour break, the BIWTA resumed the rescue operation around 6:00am yesterday. A rescue vessel of BIWTA started its operation to salvage the sunken launch around 10:00am.

The capsized launch was pulled out of the water around 12:20pm, said Abdullah Arefin, deputy assistant director of Fire Service and Civil Defence in Narayanganj.

Maharashtra announces night curfew

India has reported a record rise in coronavirus infections, becoming only the second country after the United States to register more than 100,000 new cases in a day, as hospitals in its worst affected state are overrun by

Maharashtra, home to India's financial and entertainment capital Mumbai, recorded nearly 60,000 cases in the last 24 hours.

The struggling state authorities tightened the evening curfew to allow only people involved in essential services out of their homes from 8:00 pm to 7:00 am.

The region of 110 million people will also see weekend lockdowns, with gatherings of over four people banned and places of worship and restaurants

In Mumbai over the weekend, one of Bollywood's biggest stars, Akshay Kumar, became the latest celebrity to test positive.

"Ram Setu" that Kumar was making was halted after 45 crew members also

# Challenging for BJP

This worry is quite logical as Abbas Siddiqui, custodian of the famous Furfura Sharif shrine in Hooghly, has a huge number of young Muslim followers mostly in Howrah, Hooghly, and North and South 24 Parganas.

However, to woo voters in its third phase campaign, it targeted the TMC over corruption issues in the Amphan relief fund as the three districts were

worst affected during last year's cyclone. The TMC on the other hand banked on its welfare schemes like "Duare Sarkar", "Swastho Sathi" and

'Kanyashree" to counter the BJP.

Both the parties filed candidates for all seats while the CPIM has fielded 13 candidates, All India Forward Bloc filed two candidates, Revolutionary Socialist Party filed one, Congress nominees are contesting in seven seats and in eight Indian Secular Front has fielded its

In today's polling, bigshots like BJP leader and former Rajva Sabha MP Swapan Dasgupta is contesting from Tarakeshwar in Hooghly, BJP leader and popular actress Tanushree Chakraborty contesting from Shyampur in Howrah, former Minister and senior CPIM leader Kanti Ganguly is contesting from Raidighi under South 24 Parganas, West Bengal Speaker Biman Banerjee is contesting in Baruipur Paschim and prominent TMC leader Saukat Molla is contesting from Canning Purba Assembly seat.

In today's poll, around 78 lakh voters will exercise their franchise to decide the fate of 205 candidates.

A total 618 companies of central forces were deployed for the third phase to guard 10,871 polling stations, all of which have been marked "sensitive" by the Election Commission.

Of 31 assembly seats, 16 are in South 24 Parganas, seven in Howrah and the remaining eight in Hooghly.

The fourth phase of polling, when 44 constituencies will go to polls, is scheduled for April 10.

# 'Lockdown' goes lightly on first day

Rab mobile court fined some for violating the rules.

Meanwhile, shop owners and employees in New Market and nearby areas demonstrated for the second straight day yesterday, protesting the government decision to put restrictions "on their businesses".

The situations outside Dhaka were almost similar, reported our correspondents.

Traders and businessmen in Rajshahi, Chattogram, Kushtia, Jhenaidah and Panchagarh staged demonstrations, demanding shops be allowed to remain open.

On Sunday, the Cabinet Division issued an 11-point directive to be followed from 6:00am yesterday to 12:00am on April 11 to contain the spread of the virus in the country. Punitive actions were supposed to be taken against violators of the directives.

The government's restrictions come at a time when the country reported 7,075 new infections yesterday with a positivity rate of 13.39 percent. Another 52 people died from the virus in 24 hours ending 8:00am yesterday, taking the death toll to 9,318.

Two correspondents of this newspaper visited the capital's Mirpur, Ibrahimpur, Bhashantek, Shyamoli, Tejgaon, Farmgate, Karwan Bazar, New Market areas and found most of the shops in the alleys open.

The circular said while shops and malls would stay closed, they would be allowed to sell products online. Besides, sellers would have to follow the health safety guidelines and no buyers would be allowed in person, the circular read.

In the morning, many had to come out of home as the restrictions were not applicable to office-goers and transports involved in maintaining law and order, emergency services, relief distribution, health services, and electricity, water and gas supply, fire, telephone and internet services.

Besides, banks remained open

from 10:00am to 12:30pm. Industrial units and factories were allowed to stay open. Amar Ekushey Boi Mela remained open from noon to 5:00pm.

Despite being a mode of public transport, auto-rickshaws operated and carried passengers, often more than their capacity. Many passengers were seen sharing rides.

Many people took bike rides, even though it was prohibited as per the restrictions.

Many passengers in Rayerbagh area of the city's Jatrabari staged demonstrations on the Dhaka-Chattogram highway, demanding transport so that they could go to

A good number of garment factories are situated in the city's Mirpur area. As these factories were out of the purview of the restriction, many workers were seen walking in groups to their factories.

## No sehri, iftar at mosques

Religious affairs ministry announces guidelines

The Ministry of Religious Affairs yesterday said people will not be allowed to have iftar and sehri at mosques during Ramadan.

To curb the spread of Covid-19,

the ministry notification said soap, water, hand washing facilities or hand sanitisers should be available at the entrance of each mosque, and everyone must wear a mask.

People should come to the mosque after performing the ablutions and Sunnah prayers at home, it said, urging people to wash their hands with soap for at least 20 seconds while performing the ablution. The notification, signed by Deputy Secretary Sakhawat Hossain, also said

carpets should not be laid in mosques and each worshipper has to bring their own prayer mat. The entire mosque should be cleaned with disinfectants before each prayer. Social distancing must be ensured

during prayers. Children, the elderly, and those engaged in taking care of the sick should refrain from praying in congregation, the directive further mentioned Soaps and hand sanitisers should be kept where worshippers perform

ablutions in the mosques. Prayer mats

and caps kept in the mosque should be avoided. Khatibs, imams and mosque management committee members have been asked to implement these

directives, said the notification. If these are not complied with, the administration and law enforcement agencies will take action against those concerned.

# Commuters bear the brunt of it

On the first day of the countrywide seven-day lockdown, port city commuters suffered immensely due to acute shortage of public transport. For office-goers, the situation remained the same as the previous few days, as they were subjected to the demand of reaching their workplaces, which remained open even though there weren't nearly enough

While visiting different areas including Bahaddarhat, Muradpur, Chawkbazar, Panchlaish, Rahattarpool, Katalganj, Badurtala, Kapasgola, and Chandpura, this correspondent found clusters of office goers waiting for a bus or a human haulier in every intersection throughout the day.

However, very few public transports were plying the roads, and they had to maintain the government mandated 50 percent seat capacity limit. As a result, rickshaws and motorbikes were seen dominating the roads.

Many bikers were seen carrying contracted passengers, but even that couldn't balance out the overwhelming imbalance between passengers and their demand for a ride.

"Lockdown or no lockdown, my office is still open," said a frustrated Minhaz Uddin Mahmud, who works at a private firm in Agrabad. "I have managed to come to Chawkbazar bus stand on a rickshaw half-an-hour ago. I've been waiting for some kind of a motorised vehicle ever since."

Asked whether he knew public transports would be limited during the lockdown, he said, "Does it matter to me? I have to get to my office anyway. If the government didn't want people to get out, why couldn't it

# Same crisis, a year later

Experts urge action to curb Covid-19 in Sylhet, before things go out of hand

Dwoha Chowdhury, Sylhet

On April 5 last year, Sylhet MAG Osmani College Hospital Assistant Professor Dr Md Moyeen Uddin tested positive for Covid-19. He was the very first of such patients in Sylhet, and was the first doctor of the country to have succumbed to the virus on April 15.

A year later, Sylhet is among the districts with the highest Covid-19 cases, with 11,043 cases and 225 deaths till yesterday, according to the Divisional Health Office

According to a list prepared by Sylhet Health Department based on multiple factors, the district is at fifth-highest risk of Covid-19. Sylhet has been under high risk for many reasons, including inbound UK returnees carrying new strain of Covid-19, failed institutional quarantine system for returnees and lax vigilance of

administration when imposing health

As a result of such negligence of authorities and citizens, Covid-19 dedicated hospitals in Sylhet were overwhelmed with 161 patients yesterday.

Dr Chayan Roy, acting resident medical officer of Sylhet Shaheed Shamsuddin Ahmed Hospital, said, "We're maxed out every day, and there is no bed available at the ICU [intensive care unit], although many infected patients in the regular ward need ICU support."

The 100-bed hospital, dedicated for treating Covid-19 patients, has only 16 ICU

"Unlike the very first months of the pandemic, patients are now coming in worse conditions, and are demanding more oxygen. We're struggling to manage more inbound patients," the doctor explained.

# Covid cases keep rising in Barishal

With coronavirus infection rate increasing in Barishal every day, the district administration has instructed people to strictly follow health guidelines.

However, people seem to be oblivious to the risk, said

Dr Basudeb Kumar Das, Barishal divisional health director of Directorate General of Health Services, said now 35-40 people are being infected every day. From the end of February to the first week of March, the infection rate was 2 to 3 percent in the division and currently it's 22 percent. The total number of patients on March 31 was 1,1267. Now the figure is 11,554.

A total of 204 people died of Covid-19 in the division

According to DGHS in Barishal, 77 people were infected in six districts of the division from March 13 to 19 while 226 were infected in seven days from March 20 to 26. On Saturday, 77 tested positive.

Meanwhile, doctors at Sher-e-Bangla Medical College Hospital said they do not have any empty ICU bed left at this major hospital

# 21 police personnel hurt in B'baria road crash

At least 21 policemen, including two police inspectors and two drivers of vehicles carrying police were injured when a passenger bus collided with two pickup vans in Brahmanbaria yesterday morning.

The accident took place around 8am on the Cumilla-Sylhet highway in West Medda Markazpara area of the district town when the Econo Paribahan bus coming from Dhaka collided with pick-up vans, confirmed Additional Superintendent of Police Md Roish Udo

Police arrested the bus driver and helper from the spot.

All the injured policemen came from Kishoregani district. They were deployed to carry out special duties to maintain law and order situation after the Hefazat-e-Islam mayhem in Brahmanbaria from March 26-28. Md Roish Uddin told The Daily Star that six of the injured, including a

driver, were in critical condition.

They were sent to National Orthopaedic Institute and Hospital in Dhaka.

Arifuzzaman Himel, on-duty doctor at the emergency department of Brahmanbaria General Hospital, said six of the injured had been referred to Dhaka as their condition was critical. Five other injured were admitted to a hospital and 12 were given first aid.

The ASP said, "Members of police got out of the district police lines in two pickup vans for their duty. Later, the Econo Paribahan bus coming from Dhaka collided with pick-up vans carrying the policemen, leaving them injured. Both the bus and police vehicles were damaged in the crash.

# Fewer than half of smokeless tobacco makers pay taxes

Finds study

A significant number of smokeless tobacco (SLT) manufacturers in Bangladesh have managed to slip away from the government's tax net, anti-tobacco platform Knowledge for Progress said yesterday, referring to a recent

The platform said informal nature of SLT production was the main impediment in ensuring tax compliance in the sector, according to a press release.

Findings of the study "Factors Inhibiting Smokeless Tobacco Tax Payments by Smokeless Tobacco Manufacturers Operating Outside the Tax Net in Bangladesh" was disclosed during a webinar jointly organised by National Heart Foundation, Dhaka Ahsania Mission, Ubinig, and Voice and Knowledge for Progress -- also known as Progga.

Conducted with assistance from Campaign for Tobacco Free Kids, the study revealed that of 483 SLT manufacturers, 435 zarda and 48 gul producers, only 218 pay taxes.

Also, 33 percent of 88 SLT manufacturers in 29 districts do not have valid trade licence.

It said 91 percent manufacturers produce SLT products manually, with an estimated monthly gross turnover of Tk 2.7 crore.

The study recommends a reform of the SLT tax structure, with a view to safeguard public health and increase revenue National Board of Revenue Member Zakia Sultana said

SLT use should be reined, not only for the sake of revenue but also for public health. In the 2019-20 fiscal, SLT sector contributed Tk 30.6 crore

as revenue, Progga said. SLTs are severely detrimental to health and responsible for causing oral, oropharyngeal and other types of cancers,

go for a complete shutdown and declare a general holiday?' This correspondent reminded him of the government's instruction to keep offices open with limited staff and ensure transportation by office vehicles. This astonished Minhaz.

"They will never do something like that until the government compels them to. But no such initiative from the government will be taken, and as always, we employees will have to bear the brunt," he said.

"If the government wants to curb Covid-19 cases, it should go for all out shutdown for at least two weeks," said Bahaddarhat's Rashed Mahmud, another office goer. "You see how close people are standing, waiting for vehicles. You see how shops are open, and people around them are gossiping without their masks on. If people do not stay home, how will the transmission be controlled?"

Meanwhile, almost 90 percent shops in main thoroughfares were closed, while roughly two-thirds of shops in the lanes and by lanes remained shut.

While mobile courts were seen in the main thoroughfares, lanes and by lanes were found almost without surveillance. At the city's Oxygen intersection, executive magistrate Fahmida Afroz was conducting mobile court drives. She said the court was fining people Tk 100 for not wearing face

Contacted, SM Nazer Hossain, central vice-president of Consumers Association of Bangladesh, said the government should ensure that private offices provide their staffers with vehicles during the lockdown. The government instructed all offices to run with limited

staff and carry them with own vehicles, but there's no monitoring of this. The district administration has to ensure Echoing the same, Dr Mahfuzur Rahman, convener of

Public Health Right Protection Committee, Chattogram, said alongside the main roads, the government has to ensure lockdown in lanes and by lanes, otherwise the number of cases will not be curbed. Local committees in every area should be involved in this

regard, he said. Contacted, Sumani Akter, additional district magistrate of Chattogram, said mobile courts cannot go to every vicinity due to resource limitations, and so pubic awareness is key to

the success of the lockdown. "When the government announces lockdown, that means it passes a signal to everyone that the situation is alarming.

#### Palestinians approve 36 groups to run in May vote

Palestinian election officials announced Sunday that 36 candidate lists had been approved to run in legislative elections set for next month, the first Palestinian polls in 15 years. The vote, which precedes a presidential election called for July 31, is part of an effort by the dominant Palestinian movements -- Fatah secularists and Hamas Islamists -- to boost international support for Palestinian governance. Groups had until Wednesday to submit their lists of candidates to contest in the May 22 legislative polls. Individual names on each list are due to be published today, but the Palestinian electoral commission announced on its website

that it had approved all 36 applications. President Mahmud Abbas's Fatah movement, which controls the Palestinian Authority in the Israeli-occupied West Bank, is contesting the polls, as is Hamas, which has run the Israeliblockaded Gaza Strip since 2007.

#### Putin signs law allowing him

to serve two more terms Russian President Vladimir Putin yesterday gave final approval to legislation allowing him to hold office for two additional six-year terms, giving himself the possibility to stay in power



until 2036. The 68-year-old Russian leader, who has already been in power for more than two decades, signed off on the bill yesterday, according to a copy posted on the government's legal information portal. Putin proposed the

change last year as part of constitutional reforms that Russians overwhelmingly backed in a vote in July. Lawmakers approved the new bill last month. Putin was first elected president in 2000 and served two consecutive four-year

#### Vietnam's pandemic response leader sworn in as president The man behind Vietnam's successful handling

of the coronavirus pandemic, Nguyen Xuan Phuc, was formally sworn in as president in Hanoi yesterday. Phuc, 66, was Vietnam's prime minister for the last five years, a period in which the economy boomed, and his government's Covid-19 response won plaudits at home and abroad. Following secret voting yesterday, Phuc scored the maximum votes among the almost 500-member rubber-stamp national assembly. "This is his well-deserved award," said Nguyen Khac Giang, a Vietnamese politics expert from New Zealand's Victoria University of Wellington.

# Prince says he will disobey army orders

Jordan's estranged Prince Hamza said in a voice recording released yesterday that he would disobey orders by the army not to communicate with the outside world after he was put under house arrest and accused of trying to destabilise the country. The government has accused Hamzah of involvement

in a seditious conspiracy to "destabilise the kingdom's security", placed him under house arrest and detained at least 16 more people.

But 41-year-old Hamzah, who says he has been ordered to stay inside his Amman palace, vowed he would defy orders limiting his movement and communications, in an audio recording posted on Twitter late Sunday.

"I don't want to make moves and escalate now, but of course I'm not going to obey when they say you can't go out, you can't tweet, you can't communicate with people, you're only allowed to see your family," he said.

Hamzah, a former crown prince who was stripped off that title by Abdullah in 2004, has emerged as a vocal critic of the monarchy, accusing Jordan's leadership of corruption, nepotism and authoritarian rule.

In a video he sent to the BBC on Saturday he bemoaned "incompetence that has been prevalent in our governing structure for the last 15 to 20 years and has been getting worse". He charged that "no-one is able to speak or express opinion on anything without being bullied, arrested, harassed and threatened".

# Myanmar protesters clap to denounce junta

Protesters in Myanmar clapped together yesterday in the latest show of dissent against the military junta, as a regional bloc prepared for talks on the crisis that has killed nearly 600 people.

Clapping began in various parts of the main city Yangon at 5:00 pm in response to a call by protest organisers, residents

The gesture would honour "Ethnic Armed Organisations and Gen Z defence youths from Myanmar including Yangon who are fighting in the revolution... on behalf of us," Ei Thinzar Maung, a protest leader, wrote on Facebook.

Despite the killing of at least 564 people by the security forces since the February 1 coup, protesters have been coming out every day, often in small groups in small towns, to voice opposition to the overthrow of an elected government led by Aung San Suu Kyi and the return of

The movement, which some protesters

are calling a "spring revolution", has included street marches, a civil disobedience campaign of strikes and quirky acts of rebellion organised via social media.

Yesterday, one person was killed in the central Sagaing region when security forces broke up a protest, the Myanmar Now news outlet reported. Earlier, demonstrators with placards of Suu Kyi and signs calling for international intervention marched through the secondbiggest city Mandalay, images posted on ocial media showed.

Brunei, chair of the 10-member Association of Southeast Asian Nations (Asean), threw its support yesterday behind a regional leaders' meeting to discuss Myanmar.

After talks between Malaysian Prime Minister Muhyiddin Yassin and Brunei Sultan Hassanal Bolkiah, Brunei said both countries had asked their ministers and officials to make the "necessary preparations for the meeting.

#### Blogger crowdfunds to pay damages

AFP, Singapore

A Singaporean blogger said he had crowdfunded almost \$100,000 that he was ordered to pay as damages for defaming the prime minister by sharing an article on Facebook.

Leong Sze Hian was sued by Singapore's Prime Minister Lee Hsien Loong after sharing the piece, which linked Lee to the money-laundering scandal at state fund 1MDB in Malaysia.

Critics say the case is the latest example of the government seeking to silence dissent online in the tightly regulated city-state.

A court last month found in Lee's favour and ordered the blogger to pay the prime minister Sg\$133,000 (US\$99,000) plus costs, which are yet to be determined.

Leong launched an online fundraising drive and said late Sunday more than 2,000 people had contributed the full amount after 11 days.

"We hit 133k, thanks to all Singaporeans," he wrote on Facebook. "It's thanks to your help that we had the courage to face

The article that Leong shared, originally published on a Malaysian news portal, alleged that Lee was the target of an investigation in neighbouring Malaysia over the 1MDB

Billions of dollars were looted from the investment vehicle in a scandal that involved Malaysia's former leader Najib Razak and his inner circle.

Lee took the stand at the start of the trial in October and accused Leong of making "malicious and baseless" allegations that had undermined the government's "integrity and honesty".

# There is an acute need for independent legislation in relation to data protection

**Omar H. Khan** is a Barrister-at-Law of Lincoln's Inn and an Advocate of the Supreme Court of Bangladesh. He heads one of the top full-service corporate law chambers in Bangladesh, namely, Legal Counsel. Legal Counsel provides legal services to a large number of corporates from various sectors for over decades and is also known for its legal innovations and pro-bono services. Law Desk, The Daily Star talks to him on the following issues.

Law Desk (LD): How would you evaluate the growth of commercial laws in Bangladesh since Independence?

Omar H. Khan (OHK): Since independence, Bangladesh has taken various initiatives for ensuring sustainable economic growth. In the recent years, the growth has been magnificent. Various laws relating to trade and commerce have been enacted. The Consumer Protection Act, the Competition Act, several amendments to the Companies Act,

In pursuit of sustainable achievement, it is aspired that more commercial laws shall be enacted and updated for addressing the ever-increasing demands, particularly in relation to data protection, intellectual property laws, laws related to businesses conducted through digital platforms, CSR etc.

the BIDA Act, the One-Stop Service Act, regulations in relation to listed companies, laws related to special economic zones, Public-Private Partnership Act, Money Laundering Prevention Act, codification of the labour laws are only to name a few. Enactment of such laws, regulations, policies along with ratification of international trade related agreements,

treaties etc., give a very positive ray of hope. In pursuit of sustainable achievement, it is aspired that more commercial laws shall be enacted and updated for addressing the everincreasing demands, particularly in relation to data protection, intellectual property laws, laws related to businesses conducted through digital platforms, CSR etc.

LD: What are the key legal matters a corporate should consider in conducting their business?

OHK: Before starting a venture, the appropriate legal structure of the business and the pros and cons associated therewith needs to be carefully identified. Upon establishment, the necessary licenses need to be procured. Apart from ensuring legal and regulatory compliance in general, one needs to also be mindful of whether any sector specific laws are applicable to them. It is important to consider compliances with the applicable laws and regulations, timely submission of different regulatory returns, full compliance with the income tax and VAT obligations, audit obligations, etc. In fact, large corporates maintain independent departments/divisions to ensure different aspects of compliance and corporate governance. For SMEs, while engaging large manpower may not be viable, they still need to ensure all the compliances in full.

LD: In your opinion what are the three fastest-growing corporate law areas in the world and how effectively the laws of Bangladesh address such growing need?

OHK: There are many legal areas



which are growing rapidly. In my opinion, the following are three of the fastest-growing areas of corporate laws in the world:

i) Digital Security Laws: Bangladesh has recently enacted the Digital Security Act 2018 for ensuring a safe cyber space and it also has an Information and Communication Technology (ICT) Act 2009 which addresses a wide range of information and communication related matters. However, I feel there is still an acute need for independent legislation in relation to data protection.

ii) Mergers & Acquisitions (M&As): M&As are growing all over the world. Bangladesh, even being a fast-growing economy, its M&A environment has still been in an immature stage. Nonetheless, it should also be noted that although public M&As are rare, the Bangladeshi market has been primarily driven by private M&As.

Moreover, Bangladesh has even witnessed one of its biggest crossborder acquisitions in recent times on a tobacco company and mergers of 2 telcos. With regard to the legal environment, it is observed that laws such as the Companies Act 1994, the Competition Act 2012, laws and regulations relating to Securities, etc. are all in place. We shall focus on smooth implementation of these laws with additional attention on easing the foreign exchange regulations in order to avoid unwarranted delay and procedural difficulties in M&A transactions. iii) Labour and Employment Laws:

There has been a continued growth of this particular area of corporate law over the years. Bangladesh Labour Act was enacted in 2006 (repealing 25 pieces of legislation and codifying largely all labour laws in one piece of legislation), along with the Bangladesh Labour Rules in 2015. It should be noted that the BLA has been amended 5 times since 2006. Moreover, recently Bangladesh EPZ Labour Act 2019 has also been enacted. Considering the organic growth in economy and ever-changing employment conditions, such laws need to be constantly updated.

LD: How competitive is the corporate law practice in Bangladesh and what attributes helped you to stand out?

OHK: Corporate law practice in Bangladesh is, indeed, very competitive and it really takes tremendous hard work and determination to stand out in such a field. # Addressing gender inequality during Covid-19 pandemic

The 2021 theme for International Women's Day is "Women in Leadership: Achieving an equal future in a COVID-19 world". As the world gradually sets its sight on rebuilding the world after the COVID-19 pandemic, questions of gender equality have become more pertinent than ever. In many ways, the pandemic has brought into focus the existing facets of inequality and has made more prominent the urgency of addressing these inequalities to better prepare for the future. With that in mind, it's important to evaluate the impacts the past year has had on women and girls of the country.

Experts have repeatedly brought to attention the need to view the pandemicinduced crisis through a gendered lens and have brought attention to the increased vulnerability to which women were subjected as a result of not only physical restrictions due to lockdown measures, but also lack of access to income, healthcare and for girls, education. Surveys have noted an increased incidence of child marriage - schools have been shut down since March 2020, creating both social and economic burdens on parents leading them to opt for marrying their daughters off. A significant rise in incidence of domestic violence was reported by rights organisations, the plight of which was exacerbated by limited access to legal and medical support for victims. Thousands of female workers, largely those who worked in the RMG sector and in the informal sector as domestic workers, lost their jobs or faced significant reduction in pay.

In the backdrop of these growing concerns, some legislative and judicial developments having bearing on women's rights have taken place. Although not all have received unanimous support, they require some reflection.

The most notable legislative development in 2020 was perhaps the introduction of death penalty as a punishment of rape. In the face of countrywide protests, an Ordinance was passed (later enacted by the Parliament) amending *Nari O Shishu Nirjatan Daman Ain 2000* which made death penalty the highest punishment for rape. The law previously punished rape with life imprisonment. The quantum of

punishment under the law left no room for sentencing discretion and combined with the shortcomings in the prosecution and trial level meant that convictions under the law were rare. As such, the increase in punishment without any effective improvement to the investigation and trial process is unlikely to result in any significant change. Although it may be too early to evaluate the deterring effect of the higher penalty imposed by the amendment, it is worth noting that according to the survey of *Ain o Salish Kendra*, 160 reported

proper implementation of this law.

According to the reports of Bangladesh Bureau of Statistics, incidence of child marriage has increased by 13% during the COVID pandemic, making this the highest rate of child marriage in the country in the past 25 years. Child marriage rates significantly increased during May, June, July, August and September. The Child Marriage Restraint Act 2017 penalises the solemnisation of underage marriage. However, the Act creates an exception for

underage marriage in 'special circumstance',



cases of rapes took place in about the last three months 2020 after the passage of the amendment and 84 cases of rape were recorded in January 2021 alone.

Increased incidence of domestic violence was reported by various surveys and reports of rights organizations. According to the statistics of Ain O Salish Kendra, 554 women were victims of domestic violence of which 367 died and 90 committed suicide. 218 women were subjected to violence for dowry of which 89 died as a result of the abuse and 18 committed suicide. Although the National Helpline for Violence against Women remained open during the lockdown, providing effective legal, medical and psychosocial support to victims within the existing constraints proved to be a challenge. The Domestic Violence Act 2010 provides certain remedies for victims of domestic violence; however, the lack of adequate number of government funded safety shelters and trained personnel hinder thus effectively removing a minimum age of marriage. As per rule 17 of the Child Marriage Restraint Rules 2018, the parties to the marriage or their parents and legal guardians may file an application to the appropriate court along with the necessary legal documents for marriage in special circumstances. Although the Rules seek to clarify the controversial provision of the law, the absence of a minimum age of marriage leaves room for its misuse and creates valid concerns about the wellbeing of girl children with increased vulnerability to child marriage.

To work towards the goal of an "equal future in a post-COVID world", it is imperative that laws are properly amended to reflect the country's commitment to international standards of equality and non-discrimination. It is equally important that a holistic and coordinated effort is led by all stakeholders in the effective implementation of the laws.

# Judiciary participating in law-making **An analysis on the Southern Solar Power Ltd Case**

In the 2019 case, Southern Solar Power Ltd and another v Bangladesh Power Development Board and others [(2019) 2 LNJ] the High Court Division of the Supreme Court of Bangladesh (HCD) held, "the Constitution of Bangladesh empowers the High Court Division to declare any law to be void, this Court is competent to make observations about any law, including what ought to be in the Act." To justify its position, the HCD went on to hold that as the framers of the Constitution intended the Supreme Court to be the guardian of the Constitution, it is the duty of the Court to assist the Parliament by pointing out the loopholes in the law. To its credit, the Court went on to note that the Court's view is not binding upon the Parliament. The Court does not provide any detailed justification for taking this position in this judgment. The Court seems to believe that since it has the jurisdiction to decide the constitutionality of a law, it also possesses the power to make observations as to what the content of a particular law ought to be. This would then mean that the power of judicial review arms the Court with suggesting contents of the law. This position is different from what judiciaries in most liberal democracies take.

The principle of separation of powers has been at the center of legal and political debate ever since its inception. Although many credit its modern form to Montesquieu's writings, traces of its existence can be found long before his writings. The principle is adopted to reduce the possibility of one organ of the state holding all governmental power and becoming a tyrant. If one wants to simplify this complex principle, one may say that it requires the distribution of governmental authority to different organs of the state in a manner that allows each organ to check on the actions of the other. In most liberal democracies, the governmental authority is divided into the legislature, executive, and judiciary. Different versions of this principle have been adopted in different legal systems. It varies from Constitution to Constitution. For instance, separation of power in the US is very strict, whereas, the UK follows a relaxed version of it (if any at all).

In Anwar Hossain Chowdhury v Government of the People's Republic of Bangladesh [41 DLR (AD) 165], separation of powers has been held by the Appellate Division of the Supreme Court of Bangladesh, to be a fundamental feature of the Constitution, which is beyond the scope of amendment power of the Parliament. As illustrated by the Supreme Court on several occasions, the Constitution of Bangladesh provides for a partial version of separation of powers. This means that there can be no watertight compartmentalisation and there in



fact are certain overlaps of powers among the three organs of the state. Despite there being some overlaps, the principle of separation of powers lays down certain barriers for each organ which they cannot cross. For instance, the AD in *Abdul Mannan Khan* v *Government of Bangladesh and others* [64 DLR (AD) 169] notes that the question of violation of the principle of separation of powers may arise if a Court or its presiding officer goes for judicial legislation.

The people, through the Constitution, entrust the law-making power to the Parliament. It grants the power of judicial review to the HCD which allows the HCD to strike down any law that contradicts the Constitution. It is generally accepted that ordinarily, in a judicial review of legislation, a Court will look at whether it contradicts a superior law. The Court can also look into the reasonableness of a legislation while exercising its judicial review power. However, the Court should not enter the realm of policy-making. When a particular law is challenged before a Court exercising the power of judicial review, it is expected that the Court will look into its constitutionality, not suggest amendments to the law that may make it more constitutional.

The Court's position in Southern Solar Power Ltd case may be considered to be in a way extending the power of judicial review. If a law is not unconstitutional, deference should be given to the policy choice of the legislature. Upon reading the HCD's dictum one may be tempted to ask, should a judgment be the place to express a Judge's view on how a certain provision should be amended to be more efficient? It is noted that the HCD carefully stated that it does not hold that the suggestions are binding. The Court's benevolent intention while suggesting the amendment is not doubted by any means. However, if it is accepted that the HCD is competent to make observations regarding what ought to be enacted, it would introduce a new dimension to judicial review. Such action may make the HCD a direct participant in the law-making process since it is suggesting the content of the law.

# Another deadly capsize, another avoidable tragedy

Govt must answer for failure to prevent recurrence of such accidents

E are shocked by the news of yet another launch capsize that took place in the Shitalakkhya river in Narayanganj late Sunday. At least 27 people reportedly drowned after a cargo ship rammed through the Munshiganj-bound passenger boat, leading it to capsize. The launch, named Sabit Al Hasan, was reportedly carrying nearly 50 passengers when it was hit near an underconstruction bridge. The remaining passengers managed to swim to shore. The ship responsible for the collision, we are told, still remains untraced, as the authorities scramble to present an accurate account of what happened, and why.

This is the latest disaster for a country haunted by regular maritime accidents. One may still recall the horrors of the launch capsize in Buriganga River on June 29 last year, which occurred after a collision with a ferry, leading to the deaths of 34 passengers. Those who thought the sheer number of casualties would be enough to bring discipline to this unruly sector were in for a rude awakening when another boat, carrying 30-35 passengers, sank following a collision with a stone-laden barge in Karnaphuli River in mid-February, killing at least three. The manner in which such accidents keep happening—with heavy casualties inflicted almost every time—is deeply disconcerting. Every time, we see a routine reaction from the authorities: probe committees are formed (as they were this time, too), "carelessness" of the vessel operators is blamed, and compensation for the victims is promised. But no substantive reforms are undertaken to check such accidents.

Experts have often cited a number of reasons for the launch disasters in Bangladesh, including faulty designs, structural weaknesses, lack of adequate safety measures, weaknesses in inspection procedures, obtaining of fitness certificates through unfair means, overcrowding, disregard for weather forecasts, and of course, negligence and carelessness of the ship's crew. No doubt the latest probe committees will also highlight one or two of these reasons—and those responsible should be detained and punished according to law—but whether or not this will lead to a significant reform necessary for safe maritime transport is uncertain. Unless the authorities overseeing maritime transport, especially Bangladesh Inland Water Transport Authority (BIWTA), overhaul the sector and address the bigger issues of corruption and accountability to check their own inefficiencies and failures, such accidents

Our hearts go out to the families of the victims of the Shitalakkhya launch capsize. No words of consolation or monetary compensation can make up for the wanton loss of lives and the agony of those who have lost their loved ones. The government must answer for these deaths, and for why it has been consistently failing to provide safety to the maritime passengers. Without significant reforms in how this sector is run, we may never be rid of the scourge of preventable maritime accidents.

# Do we have the scientific data to fight the pandemic?

Govt must focus on generating local research

E know how deadly Covid-19 infections can be, especially now with the second wave of the pandemic and a record number of daily death counts and infection rates. This is why it is so important to have accurate data that can give the kind of information required for policy-making and treatment. This has been reiterated by Dr Nazrul Islam in a report published in The Daily Star yesterday. In another report published by the same daily just four days ago, the chief of the National Technical Advisory Committee on Covid-19 (NTAC) echoed this view, highlighting the importance of vigorous scientific research to find out the reasons behind the second-wave of the Covid-19 epidemic. Both suggestions point to the dearth of scientific data having adverse impacts in tackling the ongoing coronavirus crisis. According to the WHO, public health surveillance is needed as an early warning system to identify public health emergencies, guide public health policies, and monitor the epidemiology of a condition to set priorities. An effective surveillance system is comprised of detection of health events, collection of pertinent data, investigation of cases or outbreaks, preparing routine reports and forwarding them to respective administrative levels for further actions. The entry also mentions that some systems called "AFP Surveillance" have been set up in many countries which work as the backbone in curing vaccine-preventable diseases. Also, a global laboratory network has been established to find out the underlying reasons that cause vaccine-preventable diseases.

The joint advisory group that Dr Nazrul is part of was formed as a collaboration between the WHO and the UN Department of Economic and Social Affairs with a view to help the member states of these organisations to collect estimates of the number of deaths due to the direct and indirect impacts of the pandemic. Since 2016, the group has been analysing death reports from 29 countries around the world. Unfortunately, Bangladesh is not in this list as the country lacks in accurate and robust data collection on vital statistics, which help to analyse the trends and patterns of usual deaths and compare them with the deaths caused by the Covid-19 pandemic.

The government must take urgent steps to include Bangladesh in the aforementioned surveillance systems and global laboratory networks. Also, creation of a research culture in our local educational institutions is also crucial to lessen our dependence on foreign research activities in managing our domestic challenges. The government has to increase its spending, both to enable the academic community to carry out impactful scientific research projects, and also to set up new research organisations. Hiring the best academic staff, ensuring necessary infrastructure for high-quality research and foreign and domestic scholarship opportunities for bright but needy students can also be some of the measures that the respective authorities can initiate to reduce the dearth of scientific research work in our country.

# How about experiential indicators of wellbeing?

We must measure the state of our development on the ground rather than blindly trusting trickle-down economics

HAT gross domestic product (GDP) is not a fully satisfying measure of a country's progress is no longer news. The awareness of GDP's inadequacies in revealing a nation's

state of development is now almost mainstream. The driving mantra that "anything that can be measured can be improved" has been faulted for excessive linearity and misleading objectivity. A year after winning the Nobel Prize in Economics in 1998, Amartya Sen published Development as Freedom. The book starts with this straight-shooting statement: "Development can be seen... as a process of expanding the real freedoms that people enjoy. Focusing on human freedoms contrasts with narrower views of development, such as identifying development with the growth of gross national product, or with the rise in personal incomes, or with industrialisation, or with technological advance, or with social modernisation.'

A decade later, in 2009, three economists—Sen, Joseph Stiglitz, and Jean-Paul Fitoussi—led a groundbreaking study on alternatives to GDP, commissioned by the then French president Nicolas Sarkozy.

Then, after more than a decade of contestations and, now, in the wake of a global pandemic that has both revealed and magnified the systemic social inequities across the world, measuring a nation's progress in a holistic and meaningful way seems more urgent than ever before.

Meanwhile, since 1972, Bhutan has been promoting a "gross national happiness (GNH)" index as a way to balance the influence of modernity and the preservation of tradition with a Buddhist ethos of compassion, contentment, and calmness. After the 2008 financial crisis, the world took a serious look at GNH as a viable alternative to growth-centric development models.

Ironically, when in 2017, the United Nations released a report ranking countries by happiness, Bhutan came 97th, while Norway claimed the title of the happiest country. Lately, the people of Bhutan have not been unified in their country's self-branding as a "happy country." A Bhutanese radio host summarised the rising cynicism within the country this way: "The idea of GNH may have put Bhutan on the map, but the concept has been hijacked by the West—and quantified to a degree that makes it unrecognisable to ordinary Bhutanese."

Measuring happiness remains elusive due to its disconcerting range of subjectivities—from happiness as personal emotion at a particular time (I am feeling happy because I had an ice cream today) to happiness as a cognitive evaluation of something (I love riding the commuter train because it brings me to my destination safely and punctually every day).

Many experts have been talking about "wellbeing" as a more inclusive and sustainable metric than the ones that predominantly focus on measurable indicators such as per capita income. Consider this: Bangladesh's per capita GDP is nearing USD 2000. Bangladesh is now the third fastest growing economy in the world. A paltry USD 8.75 billion at the time of its independence, its economy is expected to reach nearly USD 500

anxious about being sexually harassed on public transportation.

If seven out of 10 random respondents on the street express more or less the same feeling, then there is a serious policy need to come up with new indicators of the quality of everyday life. This, of course, does not mean that GDP is obsolete. The argument here is that the conventional indicators should be complemented with other types to understand the effects of

address. Walk Score is based on how long a person needs to reach a nearby urban amenity (such as a park or a hospital or a metro station). The highest score is awarded to an address where an amenity is reached in five minutes by walking, while zero point is given to those that have facilities requiring more than a 30-minute walk. A "walker's paradise" has a Walk Score of 90-100. Walkability makes a city humane, democratic, and

start using the Urban Neighbourhood Green Index (UNGI) to assess the quantity and quality of green spaces at the neighbourhood level. Neighbourhood competitions to improve UNGI should have an impact at a city scale. The fruits of economic growth must be experienced in our daily lives.

Quality of public space: A city without accessible, pedestrian-friendly, and democratic public spaces is like a

How should policymakers recalibrate prevailing metrics to assess conditions on the ground? However, the experience of impressive national development in the country's everyday life is considerably uneven. If you ask a woman on the way to work near a bus stop in Dhaka about how her *life* is these days, she may answer you like this: life is much better than before since I can make ends meet, but my house rent is too high and finding an affordable, quality primary school for my children is a constant struggle. Besides, I am always

The following experiential indicators could be considered.

Footpath and Walk Score: People of all economic classes and gender should be able to use footpaths comfortably, safely, and pleasurably. Footpaths must have adequate width to facilitate a two-way pedestrian traffic and be free of obstructions. Many cities now use Walk Score to measure the walkability of an

healthy. It represents an urban area's state of wellbeing and the best weapon against oligarchic segregation of the city.

Public transportation: It is now common wisdom that the backbone of sustainable urbanism is mass transit because it is the most cost-effective and environment-friendly way to facilitate urban mobility. Cities use Transit Score to measure how well a location is served by mass transit. It is calculated by the usefulness of public transport in terms of the routes used, frequency of service, and accessibility to the nearest station on the route. The forthcoming elevated metro in Dhaka should be an opportune moment to institute Transit Score as a measure of urban wellbeing in Dhaka.

Waste management: Going around in the streets of Dhaka or any other big city in Bangladesh, one would face the inevitable environmental calamity: the rotting solid waste on the street. We have a precariously low public hygiene threshold for reasons that require national debates and robust anthropological studies. With Bangladesh's rapid urbanisation, the total solid waste generation in cities is expected to reach up to 47,000 tons per day by 2025. If 50 percent of Dhaka's daily solid waste remain uncollected on the streets, how would GDP reduce the stench? We need Solid Waste Management Score (SWMS) to measure the state of public health in a location. If I go to Lalmatia to rent a house, I should be able find out the area's SWMS and then decide whether I should rent there or not.

Access to green and natural environment: Nature is therapeutic. Urban greenery are our best and cheapest public-health infrastructures that rejuvenate us and keep us healthy. Livable cities create miniature forests as urban oases, building an ecosystem of trees, birds, wind, air, smell, and quiet. A green park can create Zen moments, lowering the mental stress of hectic city life. City corporations and municipalities should

room without a window, suffocating, claustrophobic, and unhealthy. Public spaces nurture community spirit among urban inhabitants. If you are in Barcelona for the first time as a tourist, you are most likely to visit Las Ramblas before finding out Spain's GDP. Most "public spaces" in Dhaka are street nodes like Shahbagh Mor, TSC intersection, or Manik Mia Avenue. None of these nodal places are designed as safe and healthy public spaces. What would be Dhaka's Public Space Index?

Internet accessibility: The global competitiveness and digital democracy of cities will increasingly be determined by their access to broadband. Almost a quarter of urban Americans—23 percent or 62 million people-do not have broadband access. In Brazil it is 38 percent, India 31 percent, and Germany 11 percent. According to a survey conducted by the Bangladesh Bureau of Statistics in 2019, in Bangladesh, 62 percent of households do not have internet access at home. The reasons for this disparity are quality of the internet, affordability, IT literacy, and socioeconomic conditions of a country. In a post-pandemic world, the measure of a city's digital democracy will be one of the ways to determine its livability and wellbeing. The quality of the virtual space will be as important as the physical space. However, measuring the adverse effects of excessive online usage, particularly social media, on people is equally important. As we celebrate the 50th anniversary

of Bangladesh's independence and introspect on its progress, it would be prudent to be creative about experiential indicators to measure the state of our development on the ground rather than blindly trusting trickle-down economics. It is also important to measure the environmental and social costs of development. Nicholas Kristof's recent op-ed in *The New York Times* on Bangladesh's hard-earned ability to teach the world "how to engineer progress" through investment in "education and girls" was a great birthday gift. It is beneficial to get good press. But the gushing reaction of Bangladeshis around the world almost suggested that unless we receive the validation of western media and pundits, we cannot be so sure of ourselves. The most important sign of a nation's self-confidence is its ability to self-assess, while aspiring to loftier goals.

# Building a democratic high-tech alliance

NE of the existential challenges facing the free world today is its disunity over emerging technologies. Divergence between the United States and the European Union in this area has helped China and other autocratic regimes as they forge ahead with developing new tools and establishing rules and norms that will guide many aspects of our lives, economies, and security for generations. Russian President Vladimir Putin is absolutely right: "Whoever becomes the leader in this [artificial intelligence] sphere will become the ruler of the world."

US President Joe Biden's agenda for strengthening democracy at home and abroad presents an opportunity to close this strategic gap. Leaders on both sides of the Atlantic must seize it, and build a technological alliance of democracies that will win the digital race and set the global rules in our mold.

In their election platform, Biden and Vice President Kamala Harris pledged to convene a global "Summit for Democracy" later this

year. It's an excellent idea, and mirrors the Copenhagen Democracy Summit that the Alliance of Democracies Foundation has organised annually since 2018—with Biden himself delivering the first keynote address. But several questions remain regarding the format of Biden's summit, whether more wayward democracies will be invited, and what concrete tasks participants might agree to take forward from the meeting itself.

On the last point at least, Biden now has the makings of a blueprint. Since late 2018, the US National Security Commission on Artificial Intelligence, an eminent group of technology leaders chaired by former Google CEO Eric Schmidt, has developed a series of recommendations that "comprehensively address the national security and defense needs of the United States" when it comes to AI. The Commission recently published its final report to the president and Congress. Europeans and America's other democratic allies should read and act upon it, too.

When I addressed the Commission's conference at the end of 2019, I argued that

America's trump card over China and Russia is its ability to build partnerships around the world. I am therefore pleased that one of the report's central recommendations is for the US to build an "Emerging Technology Coalition" to establish democratic norms and values and coordinate policies to counter the adoption of digital infrastructure made in China. This coalition would also launch an "International Digital Democracy Initiative" to develop, promote, and fund the adoption of AI and associated technologies that accord with democratic values and advance the interests of

This is the sort of positive agenda we need. But it will succeed only if transatlantic and Pacific partners start to realign themselves on some critical questions relating to emerging technologies, in particular concerning two commodities that many regard as the new oil: data and semiconductors. We need to develop a new democratic consensus on both.

On data and data protection especially, it is the US that has grown out of sync with the rest of the free world. Japan has adopted similar

standards to the EU's so that data can flow freely, and the United Kingdom is committing to a similar post-Brexit regime. Japan used its G20 presidency in 2019 to push for a global data-flows deal, but, despite some progress, China's objections stymied the effort. The free flow of data within a confidence-enhancing framework would be the single biggest boost that liberal democracies' AI development could receive. Authoritarian regimes and their surveillance states have far easier access to metadata, so we need to work together to

Likewise, the recent global semiconductor shortage and the ensuing shutdown of car factories around the world have highlighted our dependence on production plants in Taiwan and South Korea. They already have the necessary know-how and global supply chains, but we should nonetheless continue to find ways within our democratic alliance to support them. Moreover, we need to build a democratic preference zone for both semiconductors and the critical raw materials and rare earths that will fuel our green and technological

We know that Biden is personally committed to building transatlantic solutions to technological challenges. I saw this firsthand in 2018 when we co-founded the Transatlantic Commission on Election Integrity. We agreed that it was not enough for the US to look back at Russian interference in the 2016 presidential election, or for Europe to prepare for its multitude of elections in a silo. Rather, our aim was to connect the efforts of democratic allies and prepare for future waves of election meddling, including those that deploy AI methods such as deepfake videos.

Biden can now apply a similar logic to ensure that the free world emerges on top in the next industrial revolution. But it takes two to tango, and if Europe closes the door on transatlantic tech cooperation, we should not complain when autocrats begin to set the rules.

# Tribute: In remembrance of Mahbub Anam

His birth anniversary was commemorated on March 28

ARCH, the month we just passed, is a very important month for the Bengali nation. Especially, in the year 2021, the significance of the month of March has reached extraordinary levels in the national and historic perspective. Due to this phenomena, many memorable events often stay hidden in the shadows, and get less priority. Amid all these memorable events, one man's memory is very much alive in my mind due to reasons that will become obvious for its significance, which compels me to write this article. That memorable person is the late Mahbub Anam, whom I have always called Mahbub Bhai.

The Language Movement sowed the seeds of the Liberation War, and paved the way for our independence. Mahbub Bhai's direct involvement in the Language Movement, and the limited leadership role that he played during that time, had an exceptional impact. That is why I have mentioned that there are significant reasons behind remembering his life and

Mahbub Anam was born in an educated and enlightened family of Mymensingh, on March 28, 1931. The British Empire's sun was nowhere near setting, and the government still had a firm control over the Indian subcontinent. Although the noncooperation and Khelafat movement and some minor rebellious acts may have initiated India's independent struggle, the centre of power was still in London, where the possibility of an independent Indian subcontinent was beginning to be discussed at the roundtables being held there. At the same time, the whole world was enshrouded in the dark shadows of an economic depression.

It is with these national and international perspectives that Mahbub Bhai's educational life started in the then capital of Bengal, Calcutta, now Kolkata. His father, late Abul Mansur Ahmad, was a famous journalist, litterateur and politician. He was already a wellestablished editor and writer. In the mid-forties, he launched the Kolkata based influential newspaper the Daily Ittehad as its editor. The author of Food Conference, Abul Mansur Ahmad can be termed as one of the forerunners and among the most powerful satirical writers in Bengali literature. He was a firm believer of secular and democratic politics. He was a top level leader of Awami League and a powerful central minister of Pakistan during the Shaheed Suhrawardy government in 1956-57. His wife Akikunnesa Ahmad was also a highly educated literary person. Her writings, Adhunika Stree (The Modern Wife) and Adhunik Shwami (The Modern Husband) created waves among Bengali readers, especially women. Mahbub Bhai was born and brought up in this enlightened family environment.

After completing his school life, he studied at the Ananda Mohan College of Mymensingh, and became the general secretary of the college's student union and also the general secretary of the Mymensingh district Chhatra League in 1952-53. My father was transferred to Mymensingh, and I also became a student of Mymensingh Zilla school; transferring from Saint Gregory's school of Dhaka. I remember, as I was on the list of top 10 meritorious students (we would call the feat "stand" back then), Mahbub Bhai told me that "You have broken the age old intellectual barrier of the Zilla school by procuring a place among the top 10 students. Congratulations to you." He was a contemporary of my elder brother late Faruq Choudhury (an author and a diplomat), and they had a deep friendship. He mentioned in his autobiography Jiboner Baluka Belay how he and his three other classmates and friends from University of Dhaka went to Kolkata as part of "efforts for

improving Indo-Pak relations". Faruq Choudhury described the "mission" with his natural humour-filled linguistic tone in the book's 55th and 56th pages. The leader of the team was Mahbub Anam. Faruq Choudhury

"As far as I remember, we arrived at a college cultural programme, which was meant to improve Indo-Pak relations. Mahbub mentioned that he knows the editor of Satvavuga magazine, who was his father's friend. We four friends landed up at the office of Satyayuga. There, Mahbub Anam gave a short interview regarding the objectives of our "highly important" Kolkata journey. The year was 1954, and lots of activities were going on for the polls in the then East Pakistan. At this critical juncture, Satyayuga printed "Answering a question regarding the East-Pakistan polls, the leader of the team, Mahbub Anam mentioned that United Front, the opposing party of the ruling Muslim League, is steadily gathering strength"."

Later, during the general elections 1954), Mahbub Bhai was appointed the acting publicity secretary of United Front on behalf of the Awami League. Later on, he became an elected parliament member during the sixth general elections. He also successfully completed his MA degree in philosophy from the University of Dhaka.

Mahbub Bhai was a brotherfigure to me, and I received a lot of motivation and encouragement from him while he was staying in Mymensingh. One of my friends (DA Rashid) and I published a short story collection for the youth, which was titled Notun Chobi (A New Image). Apart from close relatives who felt morally obliged, only a few people paid money to buy that book. Among them, two names are still written in my diary. One of them was the young lawyer Mr Sultan (who later became the first high commissioner of independent Bangladesh to the UK), and the other person was Mahbub Bhai. While I was still a school student, Rashid and I became the editors for a monthly youth magazine named *Provati*, but the publication had to be stopped after two editions. In that publication, very few patrons were included in the list of recipients of the "complimentary copy", among whom were Rashid's hometown Dhonbari's Nawabzada Hasan Ali Chowdhury, and Mahbub Bhai, for the supporting role he played in the publication of Mymensingh's Chaader Haat (introduced by Monthly Minaar) I remember, Mymensingh had a very lively cultural environment at that time, and Mahbub Bhai played a key role in its creation.

In 1954, Mahbub Bhai became the general secretary, by defeating a

powerful opponent named Khorshed Alam (bhai), at the University of Dhaka's Salimullah Muslim Hall's student union elections. Khorshed Alam Bhai (a future CSP officer, finance secretary and the governor of Bangladesh Bank) was a brilliant student who earned distinctions in both Matric and IA examinations. He was also a columnist. Mahbub Bhai, a candidate of a Chhatra League supported platform called Oikkodoot, became the sole winner from his platform. The other winners standing from the Chattra Union-supported platform Democratic Jukto Front (United Front) were AMA Muhit (Bhai), the vice president, who in his later life became a CSP, a lucid writer, the finance minister and a politician, and myself, elected as the joint secretary.

As far as I can remember, apart from Mahbub Bhai, all other positions were filled by Democratic United Front candidates. This clearly showed the impressive personal characteristics and immense popularity of Mahbub Bhai. In the activities of our student cabinet, we always maintained a cordial and friendly environment, and we worked effectively as a team. I remember, at the very end of our term, we came to the decision that improving the quality of the lunch and dinner meals served in the dining room had become a dire necessity. However, in order to do so, it became imperative to increase the mess charge of the residential students by at least five Taka (Rupees, at that time) per month; from the existing charge of Rs 30 or 35. We came to the consensus that we will treat this as a "money bill" and raise it during a meeting called for the residential and general students. We went ahead with the plan, but the motion was defeated by

small margin of opposing votes. As we were firm believers of democratic rules and practices, and as our "finance bill" was rejected by the voters, we decided that the "Muhit-Anam" cabinet, along with the other members, should resign. Mahbub Bhai took a lot of initiatives regarding this matter. I remember, Muhit Bhai, Mahbub Bhai and I submitted, in person, our resignation letters to the student union chairperson, and Provost Dr MA Gani. The usual authoritative figure, Dr MA Gani, gave us a disbelieving look. Then he received the signed resignation letters, but informed us that "Your resignation cannot be accepted as of now. You should continue your work." Needless to say, we managed to complete our remaining term of approximately one and a half months with ease. During Muhit Bhai's tenure as the finance minister, I once mentioned this story to cite as an

example of how a democratic process can be followed. The recollection created a humorous effect on the discussion. However, when we originally submitted the resignation letters, we were dead serious.

As a young student, Mahbub Bhai always maintained an air of leadership, and in 1950-51, he became the student union secretary and the magazine editor of the Kolkata Islamia College (Currently Maulana Azad College). During his school days (at the Kolkata Aliya Madrasa's English Department), he took part in some student activities. In Kolkata, he was jailed for the first time for taking part in the movement to free captain Rashid Ali on "Rashid Ali Day". Mahbub Bhai was also a highly involved and dynamic activist of the Language Movement. He was jailed in 1952 as the general secretary of "Mymensingh Zilla Tamaddun Majlish" and joint secretary for the "Rastrobhasha Songgram Porishod". He was again jailed for taking part in the Language Movement as the general secretary of SM Hall. Later on, the government honoured him by awarding him the "Brave Soldier

of the Language Movement" medal in 1980. Tamaddun Majlish also adorned him with the posthumous "Mother Language medal".

Mahbub Anam was a well-known journalist, political commentator, columnist and an author. He was the editor of one the country's oldest, major English newspapers, the Bangladesh Times. During his long career, he successfully adorned different roles, and developed a strong reputation in each of them. He worked as a senior executive in the former Pakistan Observer and was a member of the Bangladesh Newspaper Council, Press Council, the board of directors of Bangladesh Shongbad Shongstha (BSS), the Bangladesh film censor board, the special committee for Bangladesh public library, the publication wing of Shilpakala Academy and also, as the senior cochairman and executive member of the Bangladesh Editor's Council, etc.

His was a strong presence in literary and cultural fields. His works include Amra Bangladeshi, Amra Bangali and Itihasher Shikriti Bonam Bikriti. Additionally, he also worked as the secretary of Bangladesh Sahityo-Shongskriti Kendro.

He was awarded the Swadhinata Padak (Independence Award) for his unique contributions in the professional and cultural arena. He also received other prizes and medals like the Sher-e-Bangla gold medal, Maulana Akram Khan gold medal, etc.

In his later life, he also earned a very good reputation for skilfully running the Bangladesh Petroleum Corporation as a director. His last significant professional task was as the editor of The Bangladesh Times.

In a nutshell, we can say that our favourite Mahbub Anam Bhai was a multitalented person. We can undoubtedly say that he left behind his distinct mark of merit and skilfulness in every field he worked in. He improved upon every role he was called upon to play, through his kind, humble and friendly demeanour. In my memory, he lives on as a brother who had an exceptional personality, and a person who possessed an immense level of creative force.



THE DISSENT CABLE

Denouncing the US policy towards the crisis in Bangladesh, American Consul General in Dhaka Archer K Blood and his colleagues, including officers of USAID Dhaka and USIS Dhaka, sent the famous "dissent cable" today to the US State Department: "Our government has failed to denounce the suppression of democracy. Our government has failed to denounce atrocities. Our government has failed to take forceful measures to protect its citizens while at the same time bending over backwards to placate the West Pak dominated government and to lessen likely and deservedly negative international public relations impact against them. Our government has evidenced what many will consider moral bankruptcy, ironically at a time when the USSR sent President Yahya a message defending democracy, condemning arrest of leader of democratically elected majority party and calling for end to repressive measures and bloodshed."

TALES OF GRIM FIGHT

More than 100 foreign evacuees arrived in Kolkata today after a 34 hour voyage from Chittagong. They shared the latest eyewitness reports about the Pakistani army's attempt to suppress the independence movement.

"It's a massacre," said John Martinussen, a Danish student who later became an authority on international development policy.

Refuting the Pakistan government's propaganda, Martinussen, who came with his wife Karen to study Pakistani

politics as part of his master's degree programme at Aarhus University in Denmark, said, "Nothing is calm, and nothing has come back to normal.

"They systematically burned down the districts of the poor people, apparently because they felt they couldn't search them thoroughly," he went on. "They seemed to be enjoying killing and destroying everything.

"Many Bengalis have been killed,"

the 23 year old student said. "In the river just four days ago, you could count 400 bodies floating in one area."

The evacuees informed that after several days of fighting, the army -- all West Pakistani troops -- had pushed the Bangladeshi resistance forces out of the city. But, they added, the army's control ends five miles outside the city, at the banks of the Karnalphuli River.

Everything from the river south, they said, is in the hands of the "liberation army" which consists of civilians and members of the East Pakistani police, the East Pakistani Rifles and the East Bengal Regiment who have come over to the independence movement.

The evacuees further said they could hear shooting on the outskirts of the city even as they were leaving for Kolkata yesterday morning. Most of the residents had fled the city and gone into the countryside, they added. INDIA DENIES DEPLOYMENT

The government will bear their expenses during their stay in quarantine, said Sazzad.

A sick and aged worker was admitted o a city hospital, while a pregnant worker was allowed to stay in home quarantine on humanitarian grounds,

At first, the returnees refused to go to the institutional quarantine and staged demonstrations at the airport. Relatives of many workers also joined them, airport sources said.

"But following discussions with the respective officials, they finally agreed to go to the Hajj Camp to be quarantined," Sazzad said.

Sources at the airport said carrying the Bangladeshi workers, a special chartered flight of Biman was supposed to land in Bangladesh on April 1 but the flight had to be delayed.

An airport official, wishing anonymity, said yesterday the flight was not initially allowed to land. The flight landed at 3:30am following foreign ministry intervention.

The Civil Aviation Authority of Bangladesh on April 1 announced that passengers from the European countries, except the UK, and 12 other countries will not be allowed to enter Bangladesh from April 3. The ban would continue till April 18.

Lebanon is among the 12 countries. According to sources at the Bangladesh embassy in Lebanon, the embassy took special permission from CAAB for operating the special flight.

The embassy added that the respective authorities of Bangladesh also did not inform them about

mandatory institutional quarantine. The return of 272 is part of an ongoing repatriation of Bangladeshi nigrant workers from Lebanon.

Those who returned yesterday were undocumented workers, sources said.

Although a total of 283 workers were supposed to return, 272 came back home. The rest couldn't avail the flight as some of them tested positive for Covid-19 and others due to caserelated issues. Around 1.30 lakh Bangladeshi

migrant workers in Lebanon have been facing an acute financial hardship amid an economic downturn, worsened by its US dollar shortage, according to reports by international media.

Plagued by this crisis, 5,990 migrant workers have applied for repatriation via the Bangladesh mission as of March 19, while several thousand others were waiting to be registered for return.

According to the Bangladesh mission in Beirut, as of late March, over 4,600 of the registered workers have been repatriated in special flights starting from February 15.

Bangladeshi Around 10,000 workers, in addition to those already registered, were waiting to come back home but many of them are unable to manage the money to pay for the air

Shariful Hasan, head of Brac's nigration programme, yesterday said nearly 6,000 Bangladeshis returned from the Middle East country between April and December last year.

He said Lebanon's economic downturn, dollar crisis, and absence of good governance caused serious impact on Bangladeshis working there.

Shariful added that the situation worsened after the Beirut explosion in August last year.

person's brain motor cortex.

Trial participants with paralysis used the system to control a tablet computer, the journal IEEE Transactions on Biomedical Engineering reports.

The participants were able to achieve similar typing speeds and pointand-click accuracy as they could with wired systems.

John Simeral, an assistant professor of engineering at Brown University, said: "We've demonstrated that this wireless system is functionally equivalent to the wired systems that have been the gold standard.

"The signals are recorded and transmitted with appropriately similar fidelity, which means we can use the same decoding algorithms we used with wired equipment.

"The only difference is that people no longer need to be physically tethered to our equipment, which opens up new possibilities in terms of how the system can be used.'

It marks the latest advance in the rapidly growing field of neural interface technologies, which has attracted the likes of Elon Musk and Facebook.

"We are not using the electronic board because it can't provide timing of all lanes at a time, so we can't take any risk which is why we use stopwatch.'

Computer World BD, the service providers of the newly-installed electronic timer, had previously denied all allegations and claimed US-based Daktronics Electronic timer was working fine but the swimmers were not touching the pads properly.

# 'We are not planning to have a bigger squad'

Despite the rising number of coronavirus infections across the country over the last

one month which forced the government to impose a seven-day nationwide lockdown and prompted the Bangladesh Cricket Board (BCB) to suspend the third round of the Bangabandhu National Cricket League, the board is positive about the national team's upcoming tour of Sri Lanka this month.

The Tigers are scheduled to travel to the island nation on April 12.

It has been learnt that the BCB has asked the players to stay at home and that the selectors are going to announce the squad for the two-match Test series, part of the ICC test Championship, within a couple of days.

As the cricketers returned from their tour of New Zealand on Sunday, the members of the Test side will not hold a training camp in Bangladesh ahead of the tour.

"We are planning to announce the Test squad for the Sri Lanka tour within the next couple of days. However, we are not planning to have a bigger squad this time

like we picked for the New Zealand tour. We are confident about having Mushfiqur Rahim, who got injured and was unable to take part in the T20I series in New Zealand, recovered fully ahead of the Sri Lanka tour," selector Habibul Bashar told media

According to sources, the players are keen to travel to Sri Lanka for the upcoming series where the visitors will play an inter-squad two-day warm-up game on April 17 and 18 at the Chilaw Marians Cricket Club Ground in Katunayake.

Both Tests will be played at the Pallekele International Cricket Stadium in Kandy, with the first Test scheduled to start on April 21 and the second one to begin on April 29.

Sri Lanka Cricket backtracked from its decision of imposing a strict quarantine protocol, which had forced the BCB to cancel a planned tour to the island nation in September last year.

Quarantine protocols were later relaxed for a touring England side in January this year where the visitors were asked to isolate for three days after landing in Sri Lanka before being allowed to practise among themselves in the next four days.



#### **HURKACZ STUNS SINNER**

Jannik Sinner congratulates Hubert Hurkacz, who was vaulted into the top 20 for the first time in his career on Sunday after clinching his maiden Masters 1000 title at the Miami Open, a win he said provided added "motivation" to succeed. Delhi Capitals spinner Axar Patel and Kolkata Knight Riders batsman Nitish Rana tested positive for the virus after joining their teams.

Participants will have to stay in a restricted health environment for this year's IPL, which will be played across six venues in India, initially without spectators. Bangalore are scheduled to face five-time champions Mumbai Indians in the season opener on Friday at Chennai's MA Chidambaram Stadium.

Meanwhile, Sourav Ganguly, the Board of Control for Cricket in India (BCCI) President, has confirmed that the IPL 2021 will proceed as scheduled notwithstanding the weekend lockdown imposed in Maharashtra by the government in wake of the recent surge in Covid-19 cases.

From Friday 8 pm to Monday 7 am the state will be in lockdown, only essential services, and transportation including buses, trains, and taxis will be allowed. Wankhede Stadium will host 10 matches this season from April 10 to 25. However, the former India captain has assured the tournament will continue as planned.

#### Guardiola knows Dortmund better than anybody

Manchester City's pursuit of an unprecedented quadruple continues on Tuesday when they welcome Borussia Dortmund to the Etihad Stadium for the first leg of their Champions League quarter-final tie.



# Fresh move made to stop toxic ships

Two ministries decide to make Inventory of Hazardous Materials mandatory for ship breakers

Two ministries which regulate the shipbreaking industry decided earlier this year to make an Inventory of Hazardous Materials (IHM) mandatory for shipbreakers, in phases, to stop toxic vessels sailing into Bangladesh.

Officials of the Ministry of Industry and the Ministry of Environment, Forest and Climate Change took the decision in a meeting held on January 24 this year.

Ziaul Hasan, secretary of the environment ministry, said in the meeting that the IHM was made mandatory in the Hong Kong Convention. If it is also done here, it will be possible to keep the environment pollution-free, he said.

The Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009 makes it mandatory for cash buyers and importers to have an IHM -- a document which helps identify the amount, type, and location of toxic substances on board -- done for safe dismantling of ships.

As the IHM is not yet compulsory for importers in issuing clearance to enter Bangladesh's shores, the possibility of pollution is substantial, he said in the meeting, reiterating the fact that it is currently not possible to assess hazardous materials as per The Ship Breaking and Recycling Rules,

#### Gallant freedom fighters to get festival, Victory Day allowances


