'Modi govt mismanaged **Covid situation: Sonia**

Says decision to export vaccines allowed shortage at home

Congress President Sonia Gandhi yesterday accused Prime Minister Narendra Modi government of mismanaging the Covid19 situation in India and said India must focus on its own vaccination drive first before exporting them.

The (Narendra) Modi government has mismanaged the COVID situation. It has exported the vaccines and allowed a shortage to be created in India," she said while addressing a virtual meeting with Chief Ministers of Congress-ruled states and ministers of the party in states where it is in power in alliance with others.

"We must focus on India's vaccination drive first and foremost and then only export vaccines and gift them to other countries," Sonia said.

She also reviewed the efforts to fight Covid situation, including the availability of vaccines, access to medicines and ventilators, chief spokesperson of the party Randeep Surjewala said.

"Mass gatherings for elections and religious events have accelerated COVID for which all of us are responsible to some extent. We need to accept this responsibility and keep the interest of the nation above our own," Sonia said and wanted all poll rallies to be cancelled.

Her remarks about cancellation poll rallies came four days after assembly elections in Assam, Kerala, Tamil Nadu and Puducherry came to an end.

Congress is a key player in Assam and Kerala seeking to return to power in the two states.

toll increased by 45 percent, while 488 people died last week.

Total cases

With the latest death count, the total number of casualty due to Covid-19 reached 9,661, which was 1.42 percent of all detected cases in the country.

From March 10 to 16, there was a 271 percent increase in the death rate.

According to the Directorate General of Health Services, the number of new Covid-19 cases has risen by more than 26 percent.

În the previous week, a total of 38,471 people were detected as Covid-19 patients, while the number of detection was 48,660. Experts apprehended that the number of new cases, as well deaths, will continue rising for next few months unless physical distancing is ensured.

Incidentally, during the same week, the number of people recovering has also increased just as much as the death rate. Meanwhile, the number of recoveries has risen by more than 42 percent.

In the previous week, 38,471 Covid-19 patients recovered while this figure was 22,603 last week till yesterday. Meantime, the number of total confirmed cases has reached 6,78,937. During the past 24 hours, the number of tests has decreased to 26,077 and of those, 20.49 percent were positive.

However, Prof Muntasir Mamun, a member of the technical committee, denied the allegation, and said Prof Sufi personally published a brochure containing information on the excavation.

Prof Sufi wanted to hold a press conference to disclose the findings without taking the consent of the technical committee, he added.

"We repeatedly asked him [Sufi] to submit a report with the findings before the technical committee. But it is a matter of great regret that he did not do it."

Prof Muntasir added, "The old prison area is historically significant. That is why, I emphasised on the importance of excavation. The technical committee approved my proposal and subsequently the excavation began.

"But it is a matter of great regret that the task is half-done. The next step may be taken after getting a report of the excavation.

But Prof Sufi said a complete report cannot be published without further excavation. It needs more funds to conduct further excavation and research. The funds are yet to be allocated.

Talking to The Daily Star, Prof Sufi admitted that he published a brochure that was submitted to a government department.

He, however, did not make any comment over his alleged attempt to hold a press conference.

commodities from shops or to go to offices and businesses. People began to hangout at neighbourhood tea-stalls. Very few steps by the authority were visible to enforce the restrictions.

Experts wondered whether the halfhearted enforcement of restrictions would be effective at all.

Then two ministers on Friday announced that the country will be under a strict lockdown for a week from April 14.

Except for emergency services, all government and private offices and factories will remain closed during the lockdown and public transport services will be suspended, said State Minister for Public Administration Farhad Hossain.

CONFUSION OVER

APRIL 12 AND 13

As per the April 4 circular, the current restrictions will end today.

A government official on Friday night called this correspondent asking about the government decision for April 12 and 13 and wanted to know whether long-haul buses would operate.

Many members of the popular Traffic Alert page on Facebook also asked whether public transport would resume for the two days.

Contacted, Khondaker Enayet Ullah, secretary general of Bangladesh Road Transport Owners Association, said the association had yet to receive any directive in this regard.

"I have talked to the BRTA chairman,

but he could not give any decision either. Transport association leaders from different districts are also asking me about the decision," Enayet told The Daily Star yesterday.

Contacted, Bangladesh Road Transport Authority (BRTA) Chairman Nur Mohammad Mazumder said a circular regarding restrictions is likely to be issued following a meeting today.

"I think everything will be clear once the circular is issued," he added.

Commodore Golam Sadeq chairman of Bangladesh Inland Water Transport Authority (BIWTA), said, "We did not get any directive [about April 12 and 13]. However, I think restrictions on [long-route] public transport will remain in force."

'We may know about it tomorrow [today]," he told this correspondent.

Jahangir Hossain, general manager (east) of Bangladesh Railway, said passenger trains were unlikely to operate in the two-day period. "We are expecting to get the directive tomorrow," he said.

Minister for Public State Administration Farhad Hossain said, "I have no idea about any decision about the two days.'

"Our main goal is to reduce the infection rate. So, I think there is no scope to relax the restrictions. So, the restrictions may remain unchanged [in the two days]," he told The Daily Star, "However, the prime minister will give a directive tomorrow [today]," he added.

A high official at the Rab HQ said Tamzid borrowed money from many and never paid them back. Ranu was one of them.

Unable to get her money back, Ranu sought help from Rony, a man she knows. Rony contacted Dulal, who planned the abduction and realise money from Tamzid, said the official, wishing not to be named.

On Friday, police arrested the three Rab members and the member of the air force on charges of abducting, torturing, and demanding ransom from Tamzid. Ranu got arrested as well and is now on remand.

Police later handed the three arrested Rab officials to the elite force. Rab will now primarily investigate the

gave a statement under section 164 of the CRPC before a Dhaka court yesterday evening. According to court sources, Tamzid gave a description of the abduction before the court. He described how he was held inside a

vehicle that roamed around various parts of the city.

On Friday, the victim's sister Rayana Hossain filed a case with Hatiriheel Police Station. However, she didn't mention the names and designations of the accused.

According to the First Information Report (FIR), Tamzid went out of their Mirbagh residence around 9:00am on Thursday for Uttara. Around noon, a man called the victim's sister from an unknown number and introduced himself as a senior Rab official and told her that her brother was in their custody. The caller also threatened to kill her brother if they informed police about the matter.

The caller called again around 1:30pm on Thursday and informed Rayana that her brother was being interrogated at Rab office by senior officials and that he might be killed in "crossfire" if they did not pay Tk 2 crore.

The man on the phone also let the plaintiff hear her brother's screams as he was being tortured. Tamzid then told her that he was blindfolded right after he was picked up. Later, twothree other men called her from the same number and wanted to know whether she had the cash.

Finally, they agreed to let Tamzid go for Tk 12 lakh. They told the victim's sister to go to Jamuna Future Park with Tk 12 lakh, according to the FIR.

Although the Rab has been successful in apprehending several high-profile criminals, the allegation of various abuse of human rights against the elite force is nothing new. Earlier, the Rab found involvement

of 21 of its staff including its former Commanding Officer Lt Col Tareque Sayeed and Maj Arif Hossain in the sensational seven murders of Narayanganj. The top officials were expelled from respective positions in the elite force and armed forces concerned.

Limon Hossain, a college student at Jamaddarhat at Rajapur Upazila in Jhalakati, was shot at

by Rab personnel near his house on March 23, 2011, triggering local and international outcry. His left leg had to be amputated as a result. The battalion filed two cases that day with the Rajapur police implicating Limon in an arms case and accusing him of obstructing police duties. In the face of protests at home and abroad, the government in July 2013 withdrew the two cases.

TAMZID'S STATEMENT

In his statement at the court, Tamzid Hossain said he met Ranu Begum last year. They later met three times and discussed starting a business of garment products. Around a week before the incident, he told Ranu that he would buy garment products worth Tk 25 lakh. On Wednesday, Ranu called him and asked him to be in front of Rajlaxmi Market in Uttara on Thursday morning.

Tamzid said Ranu called him when he went in front of the market around 10:00am and she went there with a man named Rakib. A little later, another man named Iqbal went there. Rakib then said they should sit and talk at a nearby hotel called the New VIP

Tamzid said Ranu then asked him if he would buy the goods that very day. Tamjid replied, "Yes, you will get the money as soon as you deliver the goods." Right after that, six or seven men in Rab uniform appeared with handcuffs and walkie-talkies. They wanted to know who Rakib was. As Rakib raised his hand, the Rab men grabbed Tamzid and Iqbal by the collar and asked Ranu and Rakib to come with them.

"They called my father's number from my phone. My father asked whether I was okay. I said I was okay. but I got in trouble. They demanded Tk 2 crore. Then a man took the phone away and beat me up. I came to know that they had spoken to my sister. They settled for Tk 12 lakh and asked my sister to go to Jamuna Future Park. He threatened that he would put me in a crossfire if the money didn't appear.

"Just before the evening, two of them named Rokon and Rony got out of the vehicle. After a while, two more people got down. Then Ranu's phone rang and she gave the phone to me. A man named Dulal said my sister had got two of their men detained. If they didn't release the two in five minutes, they would kill me and throw the body in the Turag river.

"Then I told my sister about it... When she asked where I was, I said --300 feet [road]. Then they took away the phone and drove to Uttara. Once there, all of them got down, except the driver, Ranu, Iqbal and me. I opened my eyes. A boy came and picked up the Rab equipment and left. Then a man named Mubarak came and said that there was no point in keeping these two alive. After that, I was taken to Hatirjheel where police rescued me.'

Police sources said the microbus driver was in their custody and he may testify in the case.

Rights activist Nur Khan Liton told The Daily Star that this was not the first such incident. Among the sensational cases, he said there were the seven-murder case in Narayanganj in 2014 and embezzlement of over Tk 2 crore at a Chattogram shrine in 2011

"We don't know about the incidents that weren't reported. After every such incident, the accused are sent to the forces they belong in for further
