Two decades gone by, yet no closure

Death reference, appeals in Ramna Batamul attack stuck in legal tangles

Twenty years on from the 2001 Ramna Batamul bomb blasts which killed ten people at Pahela Baishakh celebrations, justice is yet to be delivered to the family members of the victims as the appeals and death reference in connection with the carnage case are still pending with the High Court.

Legal tangles continue to cause delays in the hearing and disposal of appeals filed by the convicts and the death reference of the case at the HC for nearly seven years, as two separate HC benches have refused to deal with them for different reasons.

Besides, the attorney general's office has not extensively taken any move for their expeditious hearings, considering that an expected judgment may not come from the HC as there are serious weaknesses in the investigation and lack of evidence and documents, say court sources.

The HC bench led by Justice Krishna Debnath and ASM Abdul Mobin is scheduled to hold hearing on the death reference and appeals of the case on May 30.

Contacted recently, Attorney General AM Amin Uddin could not specify how much time will be needed for hearing and disposing of the Ramna Batamul carnage case.

DNA report identifies a man as female

Resume int'l flights, help migrants

Recruiting agencies, travel agents urge govt STAFF CORRESPONDENT

Saying that around 20,000 to 25,000 expatriate workers will face uncertainty about reaching their workplaces abroad, Baira and Atab yesterday demanded to keep international flight operation out of the purview of weeklong lockdown begins from this morning.

Bangladesh Association of International Recruiting Agencies (Baira) and Association of Travel Agents of Bangladesh (Atab) made the demand at separate press conferences at the capital's DRU.

Both the organisations said that the weeklong ban on international flights to and from Bangladesh would cause many workers' visas to expire.

Leaders of Baira and Atab also said that respective employers would also cancel visa permits of many Bangladeshi workers if they fail to reach their workplaces abroad due to suspension of international flights.

Following the government guidance and instruction, the Civil Aviation Authority of Bangladesh (CAAB) on April 11 announced to suspend the operation of all international passenger flights to and from Bangladesh from April 14 to April 20 in a bid to contain Covid-19 infection.

However, medevac, humanitarian, relief, cargo, technical landing (for refueling only), and the flights cleared under special consideration will remain SEE PAGE 10 COL 3

Shipbreaking yard foreman dies in Ctg

A foreman of a shipyard died after a piece of iron sheet fell on him in Chattogram's Sitakunda upazila on Mondav.

His fellow workers alleged that the shipyard authorities did not take quick steps to hospitalise him, leading to his death.

The victim, Ataur Rahman, joined RA Shipbreaking Yard 10 days ago. Ataur was injured at the yard when an iron plate fell on him around 7:00pm on Monday.

According to a High Court order in 2011, shipbreaking work is prohibited at night.

Ataur and three others were dismantling MT Gagason Johor, a chemical tanker, which used to sail under the flag of Bhutan. This 118-metre long ship, which was built by China in 2009, weighs around 7,600 tonnes.

Other workers told The Daily Star that when Ataur was standing beside the ship to oversee the work

India fast-tracks approval for foreign vaccines

US to pause J&J jab; study says UK variant not as severe as feared

India yesterday said it will fast-track emergency approvals for Covid-19 vaccines that have been authorised by Western countries and Japan, paving the way for possible imports of Pfizer, Johnson & Johnson, and Moderna shots.

Meanwhile, US health authorities yesterday recommended a pause in the use of the Johnson & Johnson vaccine over blood clot fears, as surging coronavirus cases in many parts of the world overshadowed the start of the Muslim holy month of Ramadan.

The Indian move, which will drop the need for companies to do small, local safety trials for their vaccines before seeking emergency approval, came following the world's biggest surge in cases in the country this month.

Vaccines authorised by the World Health Organization or authorities in the United States, Europe, the United Kingdom and Japan "may be granted emergency use approval in India, mandating the requirement of postapproval parallel bridging clinical trial", the health ministry said in a statement.

"The first 100 beneficiaries of such foreign vaccines shall be assessed for seven days for safety outcomes before they are rolled out," it said.

India, the world's biggest maker of vaccines, has so far administered more than 106 million doses of Covid-19 shots, but many states are now running short of supplies as inoculations expand due to surging cases
