## 35 lakh families to get cash aid

Govt plans to provide Tk 2.5k to each family before Eid via mobile banking services

The government is going to provide another round of cash assistance to nearly 35 lakh poor families facing income losses and hardship amid the ongoing nationwide lockdown.

Each family will receive a one-off cash support of Tk 2,500 before the Eid-ul-Fitr through mobile financial services, say finance ministry officials.

The Finance Division on April 8 sent a proposal to Prime Minister Sheikh Hasina for approval. "Once approved, we will start disbursing money," said a top official of the division, seeking anonymity.

The official further said Tk 900 crore has been earmarked for providing the financial aid to 34.97 lakh families that got Tk 2,500 each in cash support under a Tk 1,258-crore stimulus package last year during the countrywide shutdown imposed in the wake of the first Covid wave.

At that time, the government with inputs from field-level officials prepared a list of 50 lakh families in need of financial support. The target beneficiaries included rickshaw-pullers, day labourers, construction workers, farmers, shop employees, people working at small businesses and transport workers.

The PM inaugurated the fund disbursement on May 14 last year. But the distribution of money was stopped midway following allegations of anomalies in the list of beneficiaries with names of solvent people found in it.

## Deaths from Covid-19 cross 10,000-mark

190 die in 2 days

The number of Covid-19 deaths in the country has passed the 10,000 mark, with the health directorate reporting 94 new deaths in the past 24 hours till 8:00am yesterday.

The highest number of deaths - 96 -- was reported just the day before.

With this, the total number of Covid-19 deaths now stands at 10,081, which is 1.43 percent of all cases detected in the country since the first three reported on March 8 last year.

After the coronavirus infection decreased to its lowest in January and February, it started rising from the second week of March and continued breaking previous records frequently.

On March 31, the total death toll crossed the 9,000 mark from the 8000 in 67 days. But it took only 15 days to reach the latest milestone figure of 10,000.

Experts said the number of deaths seems to be increasing.

## MOVEMENT PASS

# Confusion, hassles add to chaos

Different streets and intersections in the capital witnessed increased traffic on the second day of the weeklong "strict lockdown" amid the second wave of coronavirus.

There was also confusion among people over who must apply for the passes to be outdoors and who should not.

The Police Headquarters (PHQ) says people engaged in emergency services would not need a pass. But many people in services that can be considered emergency complain that they were stopped and harassed on the streets by the police.

With several departments, banks, and factories remaining open, there were long tailbacks at police checkpoints.

There was congestion in front of Radisson hotel as early as 7:45am, because police stopped almost every vehicle at the checkpoint, asking people why they were out and about. This affected traffic flow on other sections of Airport Road.

"We have instructions to check each and every vehicle on the road," said an officer at the checkpoint.

Meanwhile, thousands of garment workers had to commute to and from their factories amid the restrictions.

In Savar around 6:30am, photographer Palash Khan of The Daily Star saw hundreds of garment workers walking on highways to their factories. Many others were travelling in packed human haulers.

Most of them said their employers had not arranged buses for them as per the government direction.

The workers in human haulers said they had to pay up to three times the usual fare.

A government circular mentioned that factories and industries would remain open during the "strict lockdown", but the management must make arrangements for picking up and dropping off workers.

The situation was similar in Hemayetpur and Ulail bus stations in Savar.

At Gabtoli bus terminal, police were checking vehicles, mostly cars, IDs of the passengers, and asking why they were travelling. Very few cars, rickshaws and motorcycles were seen in the capital.

But as the day progressed, the number of vehicles, mostly cars and motorcycles,

# Vaccine campaign braces for setback

Uncertainty looms large over the smooth vaccine campaign as the government is yet to get any specific date from Serum Institute of India about receiving the pending consignment of AstraZeneca doses.

Officials said the existing stock would be exhausted in the next 15 days if administration of both first and second doses go simultaneously at the current rate.

Currently, around two lakh people are receiving the second dose of the vaccine

while less than 50,000 are taking their first dose every day.

The country has administered around 65 lakh doses from a stock of 1.02 crore jabs.

Nazmul Hassan Papon, managing director of Beximco pharmaceuticals Ltd, told The Daily Star that they were in close contact with Serum. Beximco is the local agent of Serum in Bangladesh.

"Serum informed us that they are ready to export [vaccine doses], but they need a clearance from the government.
