However, their needs have not been addressed as per expectation, he added. The government stimulus packages announced to fight the pandemic's economic fallout and help farmers and informal sector workers is lacking in implementation, he said.

Noted economist Prof Anu Muhammad said although the government, World Bank, and development consultants show satisfaction regarding poverty alleviation in Bangladesh, thorough analysis would reveal large segments of the population locked in at the "marginal" stage of economic safety.

He said before the pandemic, many were already in economically vulnerable situations, with more than five crore people in the informal sectors without any job security.

As a result, the number of people economically affected by the pandemic is much higher than the number of people infected by Covid-19, he added.

He said if the government was responsive and was connected to the mass sentiment, then significant reform initiatives could have been undertaken in the development agenda from the lessons of the first lockdown.

Major points of the reform could have been full rationing, universal healthcare system, and re-thinking ecologically devastating development projects such as the Ruppur nuclear power plant and Rampal coal-based power plant, he added.

Syeda Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers' Association, said if the country really wants to be climate-friendly, it needs to come out of the development agenda that exploits nature.

Hospitals dealing with overflow of patients

Cases of diarrhoea have risen alarmingly in Barishal since March. The 250-bed Barishal General Hospital (BGH), one of the biggest diarrhoea treatment centres in the country's southern region, is currently treating diarrhoea patients, going beyond the facility's normal operation, said physicians.

Diarrhoea outbreak is common during summer, said Maloy Krishna Baral, residential medical officer of the hospital. Besides, it is also one of he symptoms of Covid-19, he added.

Presently, the authorities are diarrhoea patients discharging immediately after they are showing improvement to cope with the pressure, he said.

Hospital sources said 751 diarrhoea patients were admitted in March alone. As of Thursday, 554 people remained admitted, said Dr Malay.

The diarrhoea ward has only 14 seats, where around 60 patients stay admitted, said nurse Archana Rani, adding that 20-30 patients are being admitted on a daily basis.

such areas. To that end, abstraction or use of water in a water stress area, shall be made subject to the availability of water, in a particular order of priority: use of water as potable, for household, for agriculture, aquaculture, for balancing of ecosystem, for wildlife, for natural river flow, for industry, for salinity control, for purposes of power generation, for amusement, and finally, for any other purposes not listed before.

The section also states that the order is not unchangeable as such; depending on the perception and opinion of the general people and considering the socioeconomic condition of the water stress area, by notification in official gazette, changes may be brought in the order.

Section 19 also envisages the imposition of restrictions on abstraction of water and the fixing of lowest safe yield level of any aquifer of any area. The Act does not for that matter recognise individual right to water but does create ample scopes for protecting water sources all across the country.

Considering the reported conditions in the Barind Region, the government may conduct necessary inquiry, scrutiny or survey in the region (under section 17) to decide on whether this region can be declared as water stress or not.

bus staffers like drivers and helpers were not happy with the government action.

"The ruling party used us for everything. When BNP or any other party call strike, we are told to drive buses. If any bus gets vandalised, bus owners enjoy the privileges. But we don't get anything when we need it," a bus driver said, wishing not to be named.

"We have no savings. Now, we can't drive buses; we have no income. Even if we protest, we will lose our jobs... You can understand our situation," added another bus staffer.

They said that they did not get any aid from bus owners or the worker's union in this lockdown.

The temperature in this year's February was higher than that of previous years. High temperature is favourable for mosquito breeding, he added,

suggesting that the mosquito control drive should have been thorough. An official of DSCC's health department recently said it will take some time to control the Culex mosquito population at areas where their numbers are already high. They are cleaning waterbodies gradually.

There are 569 bighas of waterbodies in DSCC, which need to be cleaned, the official added.

DSCC Chief Executive Officer ABM Amin Ullah Nuri said they are emphasising on using both larvicide and adulticide.

Mentionable, DSCC's drives against Culex mosquitoes go on all year round, and the situation has somewhat improved in the last few days.

'USING FROGS A WRONG DECISION'

Mosquitoes

DSCC on March 16 released 10,000 small frogs at a cost of TK 20,000 in 10 waterbodies under its jurisdiction on experimental basis.

Earlier, it released ducks and tilapia fish in 10 other waterbodies to curb the proliferation of mosquitoes.

Experts, however, think such measures are a waste of time and money, as they would not reduce the mosquito population.

"Ducks and frogs would not be effective, as they do not eat mosquito larvae. If authorities release guppy fish on a regular basis, it would be more effective," said Dr Manjur.

The small frogs will become adults after a month, and then they might be of some use. But by that time, it will be the season of Aedes mosquitoes, which become active during daytime, while the frogs become active at night, he said.

Asked, the chief executive officer said they released the frogs on an experimental basis.

He said they will have to try controlling the mosquito population through biological methods, gradually reducing water pollution, as spraying insecticide is harmful for health.

As a result, prices went up, said Nirab. Presently, hilsa is being caught from several rivers in Bhola, he added.

Meanwhile, many workers were seen sitting idle at the hilsa market as they had no work amid the ongoing "lockdown".

They said they are involved with loading and unloading of fish. When

there is a huge supply, they make up to Tk 500-800 per day. Although some were able to find work during the last two days, most of the workers are sitting idle.

Contacted, Bimal Chandra Das, fisheries officer (hilsa) in Barishal, said fishing at the sanctuaries has been banned from March 1 to April 30 to save the national fish.

At present, fishers are being fined for fishing in those rivers such as the Meghna.

Anisur Rahman Talukder, deputy director, Department of Fisheries in Barishal, said at present, the supply is low due to their strict vigilance to protect the mother fish. It will increase once the ban has been lifted, he added.
