













'Give us food, then enforce lockdown'

Low-wage earners demand

As the "lockdown" was extended for seven more days from April 22 to 28, labourers living from hand to mouth feared the distresses that lay ahead.

Rickshaw-pullers, auto-rickshaw drivers and hawkers said if they do not go out to work, their families would

"It's very easy to announce a lockdown'. But people like us bear the brunt. Give us food, then enforce a lockdown," said Md Hossain, who sells wallets and sunglasses on the sidewalk in

In the last week, he was unable to

fully open his shop.
"Even if I opened for some time, dodging police, there were no customers," he said, adding that he is now empty-handed.

Hailing from Monohorgonj of Cumilla, Hossain recalled the lockdown last year when he went back to his village and was jobless for two months.

"We are a family of 11 and had to take loan from others. We got no help from the government. We heard that the government gave relief, but we didn't see that," Hossain said in frustration.

Like Hossain, some other hawkers in Farmgate also tried to open their shops dodging the police yesterday.

Labourers, rickshaw-pullers CNG-run auto-rickshaw drivers said they were worried about the lockdown as the financial setback it has dealt is more than that of possible health setbacks.

During the ongoing weeklong "strict lockdown", the number of rickshaws and auto-rickshaws on the streets has been increasing every day despite the restrictions and, what rickshaw-pullers and auto-rickshaw drivers termed, harassment at police check points.

As the days go by, the restrictions during the weeklong "lockdown" seem to be relaxing. On the sixth day yesterday, all types of transport except buses could be seen plying the roads of the capital. Moreover, the movement of pedestrians has also increased.

Those dependent on daily earnings for their livelihood said they have no problem staying at home, but the government must ensure food and aid

Mosharraf used to work as a helper on a bus that ran between Dhaka and Chattogram. The pandemic caused a change in his profession -- since last

year's lockdown, he has been working as a rickshaw-puller in Dhaka.

"Last year, we got aid from affluent people. On the streets, you could see them with bags of relief. But this time, there is nothing. No one is helping us," said Mosharraf

He said if he does not take his rickshaw out even for a day, his family

would have to starve. "Now I can earn Tk 300-400 daily. My rent is Tk 4,000. I have three children. How will I run the family if the lockdown extends like this?" Mosharraf asked.

In Farmgate, another rickshaw-puller, Nurul Islam from Jamalpur, was sitting idly with three others in the afternoon, with no possible passengers in sight.

"Now there is no crowd. It's a matter of luck to get a passenger. Earlier, we used to charge Tk 250 to go from Farmgate to Gabtoli. Now the passenger offers only Tk 60," Nurul said.

They said extension of the lockdown is a curse for them.

Meanwhile, auto-rickshaw drivers and workers of light vehicle demanded direct food and financial support from the government to survive amid the allout lockdown that has been announced until April 28.

In a joint statement, Bangladesh Auto-Rickshaw Light Vehicle Transport Workers Federation (BALTWF) President Abul Hossain and Secretary Md Golam Faruk said the operation of lakhs of three-wheelers and light vehicles has been suspended due to the lockdown.

This ultimately left us in big trouble as we have become unemployed and our families will have to spend the days unfed," they said.

They want the government to provide financial and food support so that families of drivers and workers could survive in the month of Ramadan.

According to a new study by Centre for Policy Dialogue (CPD) and Bangladesh Institute of Labour Studies (BILS), over 3 percent of the labour force lost jobs while 16.38 million people became new poor amid the pandemic.

The most affected workers' groups were the labourers in urban areas engaged in construction, informal

CID asked to probe 23 cases

General Mamunul Haque on a sevenday remand in an attempted murder case filed with the Mohammadpur Police Station on March 7 last year.

Metropolitan Magistrate Debdash Chandra Adhikary passed the order after Investigation Officer Md Sajedul Haque, also a sub-inspector of Mohammadpur Police Station, placed Mamunul before the court.

In the remand prayer, the IO said as per the direction of Mamunul and his brother Mahfuzul Haque, five named and some 70 to 80 unnamed students of Jamia Rahmania Arabia madrasa attacked the complainant and others, and obstructed them from performing a sermon at a mosque in the capital's Mohammadpur on March 6 last year.

Moreover, Mamunul provoked the devout Muslims and madrasa students through his anti-state comments, which is why he needs to be remanded to glean information about others responsible for committing such offences, the IO added.

From the court, Mamunul was taken to the DB office on Minto Road yesterday. Police said Mamunul will be interrogated there.

A joint team of Tejgaon division police and DMP's Detective Branch

arrested Mamunul on Sunday.

On March 7 last year, one GM
Alamgir Shahin filed the case with Mohammadpur Police Station, accusing Mamunul and six other named and some 70-80 unnamed persons, accusing them of attempted murder, vandalism, looting a Samsung phone, Tk 7,000, US\$ 2,000 and a Brac Bank debit card during an attack at a local mosque, and also threatening devout Muslims

CID TO INVESTIGATE CASES

Of the total 23 cases handed over to CID, 18 were filed regarding the violence and arson attacks that took place from March 26-28 in different districts including Chattogram and Brahmanbaria, according to law enforcement officials.

The CID was also given charge of investigation of five other cases filed in 2016 in Brahmanbaria following

Some more cases will be handed over to the CID, who specialise in forensic, cyber and digital evidence analysis, said the officials.

Talking with The Daily Star yesterday, Barrister Mahbubur Rahman, additional inspector general of police and also the chief of the CID, said, "We will provide technical and forensic evidence of sabotage activities of those cases.

"We have already started collecting evidence. We have collected CCTV footage and videos of those incidents," he said and requested the media to provide footage and still pictures to assist in the investigation.

The CID chief said if the forensic investigation could prove sabotage, the culprits will not find any scope to get away. Regarding the transfer of Hefajat cases

to CID, several police officials said it could be difficult to get all the details of the cases filed in 2013 as a lot of time has already elapsed.

So, police are placing focus on forensic and technological analysis to prove these cases, they added.

Over 350 people, mostly Hefajat supporters, have already been arrested by police for their involvement in the cases. Besides, some nine top leaders including Mamunul were also arrested by police for their alleged involvement in the violence in 2013.

In the last eight years since May 2013, more than 160 cases were filed against leaders and activists of Hefajat-e-Islam. Of the cases, 83 were filed in seven

districts including Dhaka, accusing 3,416 named and 84,796 unnamed people centring the Hefajat mayhem on May 5, 2013 at Shapla Chattar.

Police have so far pressed charges in 18 cases, and gave final reports in two other cases filed in 2013. Only one of the cases, in Bagerhat, has been disposed of. But all the accused were acquitted as

neither the police nor the prosecutors could prove them guilty of the charges of attempted murder, arson and vandalism, according to law enforcement officials.

Lockdown extends

The NTAC earlier recommended what it said would be a "full-fledged lockdown". The Cabinet Division on April 4

issued an 11-point directive with a set of restrictions effective from 6:00am on April 5 to 12:00am on April 11. The directive allowed offices, mills and factories to operate.

The government later allowed resumption of bus services in the cities and lifted restrictions on shops and malls.

As experts doubted whether the "half-hearted restrictions" would be effective at all, the cabinet division on April 12 issued a circular regarding a "strict lockdown" from 6:00am on April 14 to April 21 midnight.

Yesterday was the sixth day of the current restrictions.

Although all public and private offices remained shuttered and public transport suspended, there were many rickshaws, auto-rickshaws and private vehicles on the thoroughfares.

Emergency services, garments and other factories, and a few branches of banks continued their operations.

While shopping malls and larger stores in the capital remain closed, many shops that are not selling groceries and drugs have been open with half-closed

Meanwhile, Road Transport and Bridges Minister Obaidul Quader at a

press conference yesterday said, "The government is planning to ease the lockdown so that people can live their lives, go shopping before Eid, and visit the hometowns. I'm requesting everyone to make mental preparations and be patient.

SCHEDULE Currently, BR is implementing 39 projects costing a total of Tk 1,41,883.70 crore, most of which are funded by loans from various countries including India,

China, Japan, and South Korea as well as from the Asian Development Bank. Of these projects, 20 are for construction, rehabilitation, expansion of rail lines or bridges, or installing

signalling system and level crossings. Besides, seven projects are being implemented for procuring renovating locomotives or carriages, nine for carrying out feasibility studies for proposed projects, and three projects

for technical assistance. Deadlines of 24 of these 39 projects are set to pass in June this year, show BR

Only four projects may meet their deadlines, a top BR official told The Daily Star recently. "The rest of the projects have to

the official, who requested not to be Three of the four projects that may meet the deadline are for carrying out feasibility studies for construction of a circular rail around Dhaka, construction of a rail line from Bhanga to Payra Port via Barishal, and construction of the

The authorities, however, cancelled another project undertaken for carrying out a feasibility study to introduce a new rail line from Gobra to Pirojpur and rail connection to Bagerhat, sources said.

Railway projects falling behind PROJECT REVISIONS COMMON Scrutinising project documents, this correspondent found nineteen of the 24

projects, including the four which may meet the June deadline, have already been revised at least once and some multiple times. For example, construction of the 64.75km Khulna-Mongla Port rail line was supposed to be completed within three years of the government approving the Khulna-Mongla Port Rail Line Project

in December 2010. This project is the first to start among the 24. But the project's physical work began around six years after the approval. In the meantime, the cost of the project --being implemented with India's first line of credit -- rose to Tk 3,801 crore, 120

percent higher than the original estimate. The delays did not end here. The project authorities recently placed a revision proposal to the BR, seeking another Tk 997.35 crore and one-

year extension of the project's current deadline in June this year. As of February this year, the project

witnessed 78 percent progress. Among the remaining 15 projects which do not have a June deadline, six have had costs and deadline already

revised once. The projects are construction of the Bangabandhu Sheikh Mujib Railway Bridge over Jamuna River, construction of a rail line from Chattogram to Cox's Bazar, construction of the 3rd and 4th lines from Dhaka and Tongi and a double line from Tongi and Joydebpur, construction of the Dhaka-Jashore rail line through Padma Bridge, rehabilitation of Kulaura-Shahbazpur section, and procurement of 70 metre

gauge locomotives. Deadlines of the nine projects which have not already been revised are between June 2022 and June 2025. However, physical works of most of these projects have not started yet although significant amounts of project implementation time have already passed, shows document.

For example, the government had approved a project to build a double rail line along the existing single track from Khulna to Darshana aimed at boosting trade activities with neighbouring countries via Mongla Port. The project was supposed to be implemented from January 2018 to December 2022 at a cost of Tk 3,506.75
