### Petition challenges legality of ongoing 'lockdown'

A Supreme Court lawyer yesterday filed a writ petition with the High Court, challenging legality of the ongoing "lockdown" imposed by the government to prevent the spread of Covid-19.

Md Eunus Ali Akond submitted the petition as a public interest litigation to the HC. He also sought HC order on the government not to impose a lockdown in the country without any emergency

In the petition, he said citizens' fundamental rights including right to free movement and access to justice are being violated due to the ongoing lockdown.

People cannot move freely and approach the courts and offices for remedy due to the lockdown, which is contradictory to the constitution, Eunus Ali told The Daily Star citing the writ petition.

The lawyer also prayed to the HC to issue a rule asking the government to show causes why imposing lockdown without any emergency situation should not be declared illegal and unconstitutional. He said the HC may hold hearing on the petition today.

# Struggling to meet the rising demand

Manpower shortage, lack of diagnostic tests hampering services

The newly-launched DNCC Covid-19 hospital in Dhaka has been struggling with the rising number of patients due to shortage of skilled manpower and

The hospital, set up at Dhaka North City Corporation's Mohakhali market, is yet to launch pathology test and diagnosis services for patients. The authorities, however, said they were expecting to resolve all the issues

by the end of this month. To tackle the second wave of coronavirus that started from the second week of March, the government partially launched operation of the 1,000bed DNCC hospital from April 18.

As of yesterday, the hospital authorities have launched a total of 100 beds in the Intensive Care Unit (ICU) and 30 beds in the High Dependency Unit (HDU) on the fifth floor of the hospital.

Besides, there are 50 beds with high-flow oxygen support (High-Flow Nasal Cannula) in operation in the emergency unit at the first floor of the hospital.

Of them, only eight ICU beds were vacant yesterday afternoon, according to the staffers at the Triage and Emergency Department at the hospital. On Thursday, the number of available ICU beds was just one.

#### CLINICAL TRIALS OF COVID-19 VACCINE

## BMRC to look into pending requests

Its ethical committee to hold meeting in a day or two over the issue, say officials

The pending requests with the Bangladesh Medical Research Council (BMRC) on running trial of vaccines might see some positive outcome as the ethical committee is expected to hold a meeting in a day or two over the issue.

"Hope, there will be some positive outcome," said Prof Dr Shahla Khatun, chairman of the ethical Committee at BMRC.

Uncertainty looms large after India -- the lone supplier of the Covid-19 vaccine -- expressed its

inability in delivering vaccines to Bangladesh. The crisis could have been avoided had the government not relied on a single source and took the advantage of other sources who had offered vaccines to Bangladesh earlier, experts believe.

"Since we've a large population, it is a common sense that we were needed to explore more options [for vaccine]," said Prof Be-Nazir Ahmed, former director of disease control at the Ministry of Health and Family Welfare.

"The way we're heading, vaccine seems our best

option. If you're vaccinated, either you'll not be infected or the attack would be mild. Which means, the 44-45 lakh people who received two doses have less risk," he said.

Be-Nazir said, "We're not bound to take vaccine after clinical trial but if a trial turns out successful, we would get priority. We now need to increase our diplomatic endeavour to ensure vaccine from different sources.'

Two Chinese and one Indian organisations had applied for clinical trial at the end of last year.

One of the Chinese companies -- Institute of Medical Biology, Chinese Academy of Medical Sciences (IMBCAMS) -- requested the health ministry for carrying out Phase III Clinical Trial of SARS-CoV-2 on December 23, 2020.

The actual trials were still awaiting approval of

the ethical committee of BMRC. IMBCAMS SARS-CoV-2 is an inactivated (vero cell) type vaccine like polio and influenza. These consist of viruses grown in culture and then killed

### One more dies at hospital, death toll now five

Another person burnt in the chemical storage fire in Dhaka's Armanitola on Friday, died yesterday morning.

Deceased Shafayet (35) was undergoing treatment at the intensive care unit of Sheikh Hasina National Institute of Burn and Plastic Surgery, confirmed Dr Samanta Lal Sen, chief coordinator of the institute. With Shafayet, the death toll in the

incident rose to five.

Shafayet suffered 25 percent burn injuries including in his windpipe, the doctor said, adding that he succumbed around 7:30am.

Shafayet's father Delwar Hosen (55), mother Layla Begum (45), brother Shaker Hosen (30), wife Mili Aktar (25), and twoyear-old daughter Yashfa were also injured in the incident and are currently admitted to the same hospital. ## Free facilities lie vacant as pvt hospitals fill up in Ctg

Bidyanondo urges greater public awareness

The 70-bed Bidyanondo Field Hospital was inaugurated at Sagarika in the Halishahar area of the port city on April 15. The hospital is equipped with all facilities to treat Covid-19, said the

hospital's coordinator, Jamal Uddin. The hospital has a central oxygen system with four high-flow nasal cannula (HFNC), and all necessary tests except for CT- scan are being performed there free of

However, despite the rising number of Covid-19 cases and shortage of quality treatment facilities, the field hospital has barely been utilised. The hospital management posted about the matter on social media recently, urging all to raise

awareness about this treatment option. Jamal Uddin said many people are still unaware of the hospital being in full operation during this wave of the pandemic. "We think most people do not know that we are providing free treatment to Covid-19 patients," he said, "We have all facilities here to treat covid19 patients except for ICU support. Poor patients who cannot afford treatment in private hospitals may come to us. Publicity is

required in this regard and so we are trying to utilise social media to raise awareness.

At the field hospital, there are ten doctors working alongside two consultants, eight nurses and 30 volunteer healthcare workers. This 50-member staff were treating only 15 patients admitted at the hospital till last Saturday.

At another affordable treatment centre established by Chattogram City Corporation, a similar situation is prevailing. At the CCC's isolation centre in the port city's Laldighi Par, only three patients were admitted on Saturday. The centre has a total of 36 medical staff including 11 doctors, said sources in CCC.

The centre has the facility of a central oxygen system with HFNC and treatment is free of cost.

Contacted, Dr Selim Akter Chowdhury, chief health officer of CCC, said it is unfortunate that a 36-member medical team was treating just three patients. "Running the isolation centre incurs a huge cost for CCC but the resources remain underutilised as patients aren't coming here," he said.

Dr Selim said that patients with mild symptoms don't come to isolation centres SEE PAGE 4 COL 2

## Contractors take away soil as authorities nonchalant

Local contractors illegally sold a huge amount of soil dug up from Rajshahi University land, defying order of the authorities. However, the RU administration has not taken any effective steps against it.

University sources said following a tender in March 2020, RU agriculture project authority leased out 10 bighas of land for four years to excavate a pond, near Shaheed Shamsuzzoha Hall. Under the project, the lifted soil was supposed to be kept around the pond. But the contractors -- Masud Rana, also a brother of local Awami League leader, and Ohona Traders -- sold the soil, ignoring the terms of the tender, said Prodip Kumer Roy, acting officer of the agriculture project.

During a visit last week, this correspondent found 17 tractors being used to transport the soil outside the campus. Requesting anonymity, workers said around 200 tractors of soil were dug up every day, and sold to brick kilns and others.

Contractor Masud Rana told this newspaper, "We were verbally permitted to take soil; authorities were informed about

Dablu Sarker, owner of Ohona Traders, did not respond to the correspondent's calls. Pro-Vice Chancellor Prof Anand Kumar Saha, RU agriculture project advisor panel

chairman, said there is no chance for such permission. "In addition, we issued notices to stop excavation, on March 31 and April 10, but they defied the orders. So, we recommended the university authorities to take legal action against them."

Contacted, RU Registrar Prof Md Abdus Salam said, "We held a meeting with the contractors on Saturday. They will not take soil further, and they agreed to follow the tender's terms." Asked why no action was taken all this time and what will be the next course of action, he declined to comment.

VC M Abdus Sobhan could not be reached for comments over the phone.


