Every year Bangladesh faces various kinds of natural disasters like floods, flash floods, cyclones, heavy rainfall or tornadoes, each of which carries the threat of damage to crops. If flash floods washes away paddy in the haor in one season, cyclones like Amphan ruins crops in another. This year, it was lack of rainfall and an unprecedented heat wave that damaged paddy.

Experts say the government should have a food grains stock of 24 to 25 lakh tonnes to tackle situations like

They say the minimum should be a stock of above 15 lakh tonnes and the price of rice would start rising in the market if the public stock fell down to lower than 12.5 lakh tonnes.

In the beginning of the current fiscal year, the public food grain stock was less than 12 lakh tonnes. And now the public stock of rice has come down to three lakh tonnes. Along with the stock of wheat, the total food grain stock is around 4.5 lakh tonnes.

As the government stock has reduced, the hoarders started to control the market, inflating the price of rice. The price of coarse rice has increased by Tk 13 to Tk 14 per kg in the last year and the price of rice has reached around Tk 45 per kg.

During the last Aman season, a portion of paddy was damaged due to Cyclone Amphan. The government should have taken desperate measures to purchase rice and paddy and increase its stocks, and they set a target to purchase 8.5 lakh tonnes of Aman rice and paddy.

But the government's initiative failed because, like the last boro season, it fixed the purchase price of paddy and rice lower than their production costs.

The government fixed the purchase price of paddy at Tk 26 a kg and rice at Tk 36 a kg, one taka less than the production cost. Farmers and millers were getting better price in the market and so the government could only procure 83,000 tonnes of rice in the last Aman season.

Later, this January, the food ministry took the initiative to import 20 lakh tonnes of rice. The government signed government-to-government deals to import of rice from India, Russia, Ukraine, and Vietnam. It also gave import approvals to private

The food ministry had realised much earlier that they would fail to increase food grain stocks because, for the last few months, they were giving out cash instead of food grains under the popular Food for Work programme.

And now that rice hoarders and traders know that the government does not have the stocks to intervene in the rice market, they have increased the price. The food ministry should have realised that it would come to this juncture much earlier, but they could not tackle the situation.

This price hike has put an extra burden on people who do not have a stable income and are struggling to pay house rent or meet treatment costs amid a worsening pandemic.

He announced that he and his wife were asking the United States for political asylum. An official of the United States Immigration and Naturalization Service said that the request would be considered.

Mahmoud Ali was the first member of the Pakistani foreign service in the United States to come out in support of the Bangladesh independence movement.

Mahmoud Ali said at the news conference held at the Church World Center, 777 United Nations Plaza, that the Pakistan government ordered him to return home last week. He added that the likely reason was that he could not hide his sympathy for his fellow Bangalees. He said Bangalees at the consulate and others serving abroad had been kept from doing their usual work, prohibited from handling government business and were also spied upon when they visited other Bangalees.

Mahmoud Ali estimated that there were 200 Pakistani officials serving abroad and that 25 percent of them were Bangalees.

UN SHOULD SEND OBSERVERS TO BANGLADESH: MANN

Labour member of British Parliament Bruce Douglas Mann demanded that the UN immediately send an observer team to Bangladesh with full military protection. And if the Pakistan government refused to allow entry of any such team the UN should send an expeditionary force, as such procedures had international precedence.

Mann, who had been to Bangladesh and met Prime Minister Tajuddin Ahmad and General Osmany, told a news conference at Calcutta today that he would make attempts in London to organise an international brigade for fighting in Bangladesh along with the freedom fighters there. He would also urge his organisation in London to send arms to Bangladesh freedom fighters. NEW ZEALAND MP CALLS FOR ARMS EMBARGO

"All the nations should place an embargo on military hardware being carried to Pakistan. Any nation selling arms to that country will perpetuate a crime against humanity.

This was what TJ Young, a member of New Zealand Parliament told newsmen in Calcutta today. He wanted an international team of observers to visit Bangladesh immediately. "I shall ask my government to use its influence at international level in this regard," T J Young promised.

INDIA RESTRICTS TRAVEL BY PAKISTANI AIDES

The BJP, during its electioneering, blasted both the TMC and the Muslims, in its efforts to unite Hindu

Among the 36 seats in the last assembly polls in 2016, TMC got 14 seats and had secured 37 percent votes while the left-Congress combined won in 22 seats and had got 44 percent votes. BJP failed to win a single one.

But the picture was different in Lok Sabha elections (national polls) in 2019 when BJP got 37 percent votes, which was very close to TMC's 39 percent. If the 2019 Lok Sabha election is something to go by, BJP is leading in 16 assembly seats, TMC in 16 seats and Congress in the rest of the four seats.

In this phase of the polling, all eyes will be on the Bhabanipur assembly seat, which is the home turf of West Bengal Chief Minister Mamata Banerjee.

But Banerjee is contesting from Nandigram this time around and nominated one of her senior most party leaders and her cabinet member Sovandeb Chattopadhyay to contest from Bhabanipur.

The BJP has fielded actor-turnedpolitician Rudranil Ghosh, who left the TMC a few months ago to join the BJP, from this seat.

WB Chief Minister achieved a massive victory from Bhabanipur in the 2011 by-elections. Then in the 2016 assembly elections, she repeated her triumph.

But this time, Mamata contests

against her once-trusted aide Suvendu Adhikari of the BJP.

Bhabanipur seat was earlier represented by Siddhartha Shankar Ray in 1957 and 1962. Later, he became the chief minister of West Bengal in 1972.

Kolkata Port seat is the stronghold of the TMC where Urban development minister and former Kolkata mayor Firhad Hakim, also a close aide to National Congress for patronising Mamata, is contesting. He won the constituency twice since 2011.

At Ballygunge, veteran minister and senior TMC leader Subrata Mukherjee is contesting against CPIM's Fuad Halim, a popular doctor, and the BJP's Loknath Chatterjee while at Rashbehari assembly seat, TMC has fielded Debasish Kumar, a Kolkata civic body leader, against the BJP's highprofile candidate, retired Lt Gen Subrata Saha, who served as deputy chief of the Indian army.

Following the surge in coronavirus across India, Election Commission has banned roadshows and vehicle rallies in the state and noted that the Covid safety norms were being flouted in West Bengal during campaigning.

It also restricted any public meeting with more than 500 people.

Top leaders of TMC, BJP, Congress and CPIM decided not to hold big rallies and public meetings and conducted electioneering through electronic devises.

In this phase, a total of 86,78,221 voters will determine the fate of 284 candidates while 653 companies of central forces will guard 12,068 polling stations to ensure free and fair voting.

The 8th and last phase of the assembly election will be held on April 29 and votes will be counted on May 2, according to the polls schedule.

He said Erfan would be freed from jail after the copy of the SC order reaches the jail authorities.

The Appellate Division upheld the HC bail for Erfan on the ground that the charge brought against him is bailable and he has been suffering in jail for around six months.

The lawyer said other accused of the case are now in prison. During yesterday's hearing, Additional Attorney General Sk Md Morshed opposed the HC bail for Erfan, saying that he has committed a heinous offence by attacking and injuring Lt Wasif Ahmed Khan, an official of Bangladesh Navy.

The trial proceedings of the case against Erfan is underway and therefore, he may not be granted bail at this Erfan's principal counsel Abdul Baset Majumder told

the apex court that his client has been languishing in jail

for around six months. Erfan's mother died in November last year and his father is infected with Covid-19 and therefore, the Appellate Division's stay order on his HC bail needs to be vacated for his release from jail, the lawyer said.

Following a bail petition filed by Erfan, the HC on March 18 granted him permanent bail in the case. Later, the state filed a petition with the SC seeking stay on the HC verdict that granted bail to Erfan in the case

and after hearing the stay petition, the apex court chamber judge on March 28 stayed for four weeks the HC verdict. The SC chamber judge also asked the state to move a regular leave to appeal petition before its full bench in four weeks against the HC verdict.
