## No one can distort history now: PM

Prime Minister Sheikh Hasina has said she firmly believes that no one can erase the country's real history now.

had been "History and changed completely. Now I am confident that no one can distort or erase the real history of

Bangladesh," she said. Presiding over a weekly cabinet meeting virtually from the Gono Bhaban yesterday, Hasina said Bangladesh has now become

a developing country by overcoming many hurdles at home and abroad. She vowed to take Bangladesh forward and change the destiny of its people by making the country a developed and

prosperous one. The PM's cabinet colleagues and secretaries concerned got connected to the meeting from the Cabinet Division.

Hasina, also the president of Awami League, said she had returned home facing numerous hurdles and conspiracies even after knowing that her life would be at risk as the then government released war criminals from jails and granted immunity to killers.

"I returned to the country under such

a situation without thinking anything as the independence of the country cannot go in vain. I have to make the independence a success.

The PM recalled the contributions of the then leaders and activists and the people who stood beside them (Hasina and her younger sister Sheikh Rehana) for their

return home on this day in 1981 from forced exile for six years.

The premier said Obaidul Quader, now the AL general secretary, as the then president of Chhatra League had issued the first statement on their return home.

Then Jubo League chairman Amir Hossain Amu, now an AL advisory council member, also issued another statement in this regard while Mizanur Rahman Chowdhury, who later left the party, first placed the matter before parliament, she added.

Hasina said she got a lot of love, affection and blessings from the people across the country upon returning home after losing her father, mother, and brothers.

She reiterated that the country would be a "Golden Bangladesh" as envisioned by Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

### Vaccine drives

Serum was supposed to ship 50 lakh doses a month to Bangladesh over a six-month period starting from January. Serum delivered the first 50 lakh doses as per the deal, but shipped only 20 lakh in February. No other shipment has been made since.

The Indian government restricted export of the vaccine to meet the local demand.

Hassan Contacted, Nazmul Papon, managing director of Beximco Pharmaceuticals Limited, local agent of Serum, said, "We contacted Serum, but have not received any response regarding [when] the next consignment [might

Bangladesh is also supposed to get 6.8 crore vaccine doses this year from Covax, a global alliance. The alliance earlier announced that Bangladesh would get 1.27 crore doses between May and June. But as of yesterday, the country has not heard from Covax about a shipment.

Amid such uncertainties, the government started looking alternative sources and contacted Russia and China to secure supplies of their vaccines. But no considerable progress has been made so far.

Health Minister Zahid Maleque yesterday told reporters that the concerned over government is administering the second dose of the AstraZeneca vaccine.

There are talks of co-production of vaccines in Bangladesh, but the government is more interested in purchasing the doses from different sources and continuing the inoculation

Vaccine production is a timeconsuming process, the

said, "The drug administration will send a report to us regarding those [companies] who have applied [for vaccine production]... The final decision will come after the prime minister is consulted."

Those companies will need four-five months to start production, he said.

Only 2 percent of the population have so far got both shots of the AstraZeneca vaccine and less than 4 percent got the first shot as of Sunday, according to the

The World Health Organization (WHO) last month said that the wealthy countries have received the vast majority of the world's supply of Covid-19 vaccines, while poor countries obtained less than 1 percent.

Of the 700 million doses distributed across the globe, "Over 87 percent have gone to high-income or upper- and middle-income countries, while lowincome countries have received just 0.2 percent," WHO Director-General Tedros Adhanom Ghebreyesus said.

#### SINOPHARM FOR MEDICAL STUDENTS, NURSES

The five lakh doses of the Chinese Sinopharm vaccine Bangladesh received on May 12 as a gift will be administered among medical students and nurses.

"We have to ensure that the medical students, especially the ones in the 5th year, are inoculated. We cannot disrupt medical education in the pandemic because they are the frontline heroes, minister said Khurshid Alam.

Earlier in the day, soon after the arrests took place, hundreds of TMC activists took out protest rallies in the city and elsewhere in West Bengal, flouting Covid lockdown guidelines

In a sharp escalation in the face-off between BJP-led central government and Mamata Baneriee's dispensation in West Bengal, the CBI arrested the four in connection with a five-year-old case relating to a news portal's sting operation on alleged bribery.

A ČBI team, along with central security forces, picked the four up from their homes.

According to the CBI, Firhad Hakim, Subrata Mukheriee and Madan Mitra were caught on camera accepting wads of currency notes in the sting operation conducted by the news portal's Editor-in-Chief Mathew Samuel from New Delhi in 2014. The video tapes were released ahead of assembly elections in the state

in 2016. Infuriated, Chief Minister Mamata Banerjee reached the CBI office in Kolkata's Nizam Palace and reportedly said, "The way they have been arrested without due procedure, the CBI will have

to arrest me also.' Mamata also held a six-hour sit-in in front of the CBI DIG's office on the 14th

floor of Nizam Palace. As Mamata staged the sit-in, hundreds of TMC workers gathered at Nizam Palace in South Kolkata, despite the ongoing state-wide lockdown due to the rising Covid cases, and hurled stones and bricks protesting against the arrest of three senior TMC leaders.

The TMC activists, many without masks, also staged protests outside the Rai Bhavan, the official residence of Bengal Governor Jagdeep Dhankar, in Dalhousie Square in central Kolkata, protesting the arrests of Hakim, Mukherjee and Mitra. Reports of street protests by TMC workers also came in

from several other parts of Bengal. Dhankar earlier this month gave permission to CBI for prosecution of Hakim, Subrata Mukherjee, Madan Mitra and Sovan Chatterjee.

Referring to the street protests shown on TV channels, Dhankar accused Kolkata Police and West Bengal police of being "mute onlookers" and appealed to

them to act and restore law and order. "[This is] total lawlessness & anarchy. Police and administration are silent.

Hope you [they and the people] realise the repercussions of such lawlessness and failure of constitutional mechanism. Time to reflect and contain this explosive situation that is worsening every minute," Dhankar tweeted.

Hakim and Mukherjee are currently ministers in Mamata's cabinet with Transport, Urban and Housing and Panchayati Raj portfolios respectively. Mitra was not included in the cabinet of ministries after the TMC had a landslide victory in the recent assembly poll.

Sovan Chatterjee snapped his ties with both the TMC and Bharatiya Janata Party, which he had joined in 2019.

All four arrested yesterday were ministers in the previous Mamata Banerjee government, when the Narada sting operation was taped in 2014.

Mathew Samuel, a journalist from Delhi came to Kolkata, posed as a businessman planning to invest in Bengal and gave cash to seven Trinamool MPs, four ministers, one MLA and a police officer as bribe and taped the entire operation.

West Bengal Assembly Speaker Biman Banerjee said the arrest of Hakim, Mukherjee and Mitra in the Narada case on the basis of the Governor's sanction

was "unlawful."

"I have not received any letter from the CBI, nor has anybody sought permission from me as per the protocol... I do not know for what unknown reason they went to the Governor and sought his sanction."

The CBI filed the charge sheet against five accused, including three TMC leaders arrested earlier in the day, in the Narada sting case wherein politicians were purportedly caught taking money on camera, officials said.

The sting operation was allegedly conducted by Mathew Samuel of Narada TV news channel in 2014 wherein people resembling TMC ministers, MPs and MLAs were allegedly seen receiving money from representatives of a fictitious company in lieu of favours.

The tapes were made public just before the 2016 assembly elections in West Bengal.

The Calcutta High Court had ordered CBI probe into the sting operation in March 2017.

Samuel yesterday said he was happy that the four politicians were arrested in the case relating to his sting operation but questioned why Suvendu Adhikari was spared by the CBI because he too figured in the case.

Suvendu, who was at that time in TMC, joined BJP in December last year and is now the leader of opposition in the Bengal assembly.



A streak of light appears as Israel's Iron Dome anti-missile system intercepts rockets launched from the Gaza Strip early yesterday. Israeli warplanes bombarded the Gaza Strip overnight, said witnesses in the Palestinian enclave, from where armed groups have launched rockets into the Jewish state.

### Israel continues pounding Gaza

Another Gaza resident, Mani Qazaat, said Israeli Prime Minister Benjamin "should realise Netanyahu civilians, not fighters".

"I felt like I was dying," he said about enduring a heavy aerial bombardment. International calls mounted for a easefire, but there was no sign of any imminent end to the most serious hostilities between Israel and Hamas Islamists in years. Israel's army said yesterday it had

hit the homes of nine "high-ranking" Hamas commanders, a day after bombing the house of Yahya Sinwar, head of the group's political wing. It gave no details of any casualties.

A senior Palestinian militant commander was also killed yesterday, a source within the group and the Israeli army said. The killing of Hussam Abu Harbeed, armed commander for north Gaza, was likely to draw a fierce response from the militant group that is fighting alongside Hamas, the Islamist enclave, reports Reuters.

Fighter jets also hit what the Israeli army calls the "Metro," its term for Hamas' underground tunnels, which Israel has previously acknowledged runs in part through civilian areas.

The renewed strikes come a day after 42 Palestinians in Gaza -- including at least eight children and two doctors, according to the health ministry -- were killed in the worst daily death toll in the enclave since the bombardments began.

In total, 200 Palestinians have been killed in Gaza, including at least 59 children, and more than 1,300 wounded since Israel launched its air campaign against Hamas after the group fired rockets, according to the authorities there. Israel says 10 people, including one

child, have been killed and more than 309 wounded by rocket fire that has been the most intense to ever rain down on the Jewish state. Islamic Jihad said it fired more rockets

towards Tel Aviv, and air raids sirens

wailed across Israel again yesterday, especially near the Gaza border Israeli bombardment of Gaza has

displaced 38,000 people and made 2,500 homeless, the United Nations said.

It has also battered crucial infrastructure, with the electricity authority yesterday warning it only had enough fuel left to provide power for another two to three days.

### The US ambassador to Bangladesh Earl R Miller yesterday said the US is exploring the possibilities of producing vaccines in Bangladeshi pharmaceutical companies. He said this at a meeting at the foreign minister with the Minister of Foreign

Affairs Shahriar Alam. They discussed the ongoing cooperation between the two countries in combating the Covid-19 pandemic, including providing vaccine for meeting Bangladesh's immediate needs.

Miller informed that the US government is working on the issue of vaccine supplies and has recommended having a regional approach in South Asia in distributing vaccines from the US.

Bangladesh had requested the US to

provide vaccines after it said it would start sharing up to 60 million doses of the Oxford-AstraZeneca vaccine with other countries over the next few weeks. "He [Miller] also told us that the US government is exploring the possibilities of producing US vaccines in Bangladeshi pharmaceutical companies," Shahriar

Alam told reporters after the discussion. The announcement came at a time when many countries are struggling to obtain vaccines amid a huge global demand, with India witnessing record cases of infections and deaths.

Bangladesh is going to run out of its available vaccines brought from the Serum Institute of India, who, in March, halted export of vaccines due to massive

domestic needs. Bangladesh is also in talks with Russia and China for co-production of their vaccines in Bangladesh.

Meanwhile, State Minister Alam also urged the US to take up a proactive role to immediately stop the bloodshed in Palestine, while reiterating Bangladesh's support for the two-state solution. He also urged the provision of
