

Land 'illegally handed over to fake landless'

Alleges chairman of union parishad in Roumari upazila of Kurigram

At least two land office employees of Roumari Sadar union and Roumari upazila in Kurigram have been accused of helping some people illegally occupy a piece of land that belongs to Jadurchar Union Parishad of the upazila.

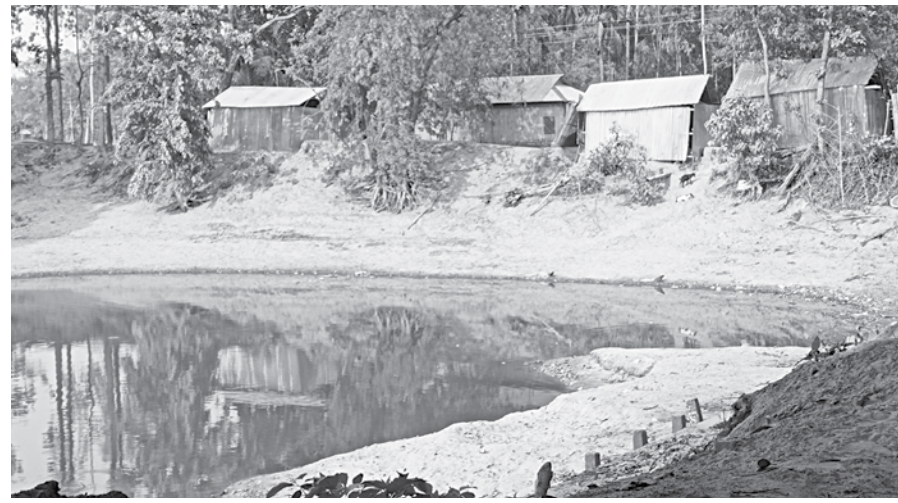
Sarbesb Ali, the chairman of the union parishad (UP), in a written complaint submitted to the deputy commissioner (DC) of Kurigram, upazila nirbahi officer (UNO) of Roumari and various other departments concerned, made the allegation against the two and seven others.

In a general diary filed earlier with Roumari Police Station, the UP chairman had anticipated that attempts might be made to illegally occupy the same land, which is part of a pond owned by the union parishad.

In his written allegation sent out to the authorities, Sarbesb Ali said in the wee hours on April 5 (Monday), the seven people with the connivance of the two land office employees -- Land Assistant Officer (Tahashildar) Shahadat Hossain of Roumari Sadar union and Land Surveyor Abdul Awal of Roumari upazila -- forcibly built four houses with corrugated iron sheets, on around 30 decimals of land of the pond.

The intruders overpowered the members of Village Defence Party (VDP) on duty at the site that night and drove them away, said Sona Miah, a member of VDP.

No salaries, Eid bonus for teachers, staffers of a college

Salaries and bonus could not be paid as the chairman of the managing committee denies signing bill documents

The Eid festival of 41 teachers and staffers of a college in Chirirbandar upazila of Dinajpur has been somber for the non-payment of salaries and festival bonus as the chairman of the college's managing committee did not sign the documents on time.

Karenthat Degree College in the upazila has 28 teachers and 13 staffers, said the principal.

Jalal Uddin Mazumdar, principal of the college, said the teachers and staffers of his colleagues have been passing a hard day as they are totally dependent on their monthly salaries.

The teachers and staffers had to celebrate a somber Eid festival this year, he said.

salary and festival bonus on May 5 to disburse the salaries of the teachers and staffers, he also said.

Unfortunately, the payment could not be made timely as the chairman refused to give his signature on the documents.

As the teachers and staffers of the college had put pressure on the principal, then the principal and 12 other senior teachers went to the residence of Hasibul Hasan to get his signature on May 12 and pleaded him to give his signature, but he again refused.

The principal, however, said he does not know the reason why the chairman refused to sign the documents.

Contacted, Hasibul Hasan denied explaining the reason behind the incident.

However, he confirmed that he gave his signature finally on the relevant documents recently, and teachers and staffers will get their payment within a day or two.

incident to the UP chairman, he added.

The UP chairman, Sarbesb Ali, said he informed the DC and UNO of the incident the next day (April 6).

"I've come to learn that the two land employees received bribe money and illegally handed over the land [owned by the UP] to some people in the name of allocating government land to the landless, without proper survey and verification."

One of the occupants, Mosharrif Hossain, claimed that he was a genuine landless and he had received necessary land allocation documentation from the government before building the house by the pond.

However, he refused to make any comment when asked whether he made any payment to the land employees for the allocation of the land.

Denying any monetary exchange taken place in exchange for the allocation of land, accused surveyor Abdul Awal said genuine landless people were allocated the land as it is demarcated as Khas land of the government.

Another accused, Land Assistant Officer Shahadat Hossain, said they adhered to government rules properly while allocating the land to the landless and the accusation made by the UP chairman was false and baseless.

Contacted, Roumari UNO Al Imran said the allocation of the land will be revoked if it is found to be illegal during investigation and due action will be taken accordingly against the ones involved.

Abducted girl rescued, 2 arrested

Rapid Action Battalion (Rab-12) in a drive early yesterday rescued a minor girl, abducted from Sirajganj's Tarash upazila on May 12, and arrested two people for their alleged involvement in the abduction.

The arrestees are Mohammad Jony, 22, and his father Kafi Fakir, 45.

Assistant Superintendent of Police Mostafizur Rahman, also media officer of Rab-12, said Jony with the help of some of his accomplices picked up the twelve-year-old victim on May 12 when she came out of her room to respond to the call of nature.

Failing to trace her whereabouts, the girl's family later lodged a general diary with Tarash Police Station and also submitted a complaint to Rab-12 in this regard on Sunday.

After tracking the kidnappers' mobile phone location, a team of Rab-12 led by Major Moshir Rahman, deputy commander of Rab-12, raided Jony's house around 1:30am early yesterday and rescued the girl.

The law enforcers also arrested Jony and his father Kafi from the spot.

Addict kills wife

A pregnant housewife was strangled to death allegedly by her husband at Shibnathpur Baropota village under Benapole Port Police Station on Sunday.

The deceased was identified as Ruma Khatun, 19, wife of Ariful Islam Tutul of the village.

Quoting locals, police said Tutul, a drug addict, killed his wife Ruma after the later refused to give him money for buying drugs.

The culprit went into hiding soon after the murder.

Export, import hampered as bridge lies damaged

A worn-out Bailey bridge in Batuli Customs Station and Immigration Check Post area of Juri upazila lies useless for long, badly hampering the export and import business activities.

According to the customs authorities, at present, plastic materials, PVC doors and cotton are exported to India through Batuli customs station. Besides, different types of fruits are imported from India to Bangladesh.

The activities of this customs station and immigration investigation centre started in 2001. The bridge over a hill called Ragnachhara lies in the Indian part within 150 metres of the zero line. With the consent of the both countries, India built the bridge on a small scale in 2008. But there was no approval for the movement of freight vehicles between the two countries through the bridge.

At one stage, freight cars from both countries were parked around the middle of the bridge. The goods were then loaded and unloaded from one vehicle to another. But later, due to heavy rains, the soil on both sides of the Bailey bridge was removed from the hill slopes, putting the bridge under threat. Since then, the export and

import business activities in Batuli Customs Station and Immigration Check Post area have been badly hampered.

About two years ago, India took initiative to build a new bridge at that place, but when the Border Guard Bangladesh (BGB) raised objection to construction of the bridge, the work remained suspended.

Contacted, the BGB said they had no objection to renovation of the old bridge.


But they raised objection to construction of a new bridge at Batuli following the direction of the higher authorities, said BGB-52 Battalion Commander Lt Col Md Shah Alam Siddiqui.

At present, freight cars from both countries are parked on both the approach roads of the bridge for loading and unloading goods, badly hampering business activities as the bridge lies damaged.


The BGB official added that some

infrastructural works including roads are left in the customs station area. Once these works are completed, progress can be made in building bridges as needed. For the time being, if India renovates the old bridge, there will be some benefit in import-export.

Moulvibazar Deputy Commissioner Mir Nahid Ahsan said necessary steps will be taken after contacting with the authorities concerned.
