Rambhajan Kairi, general secretary of Bangladesh Tea Workers' Union, said, "We have been making demands for a long time to ensure basic rights of tea workers, wage increment, land rights, housing and medical treatment so that they too can live a dignified life."

Asked about recognition of the day at national level, GM Shiblee, chairman (Sylhet branch) of Bangladesh Tea Association, told The Daily Star yesterday that any demand of this sort has to officially come from the workers' union.

During the visit to tea gardens at Moulvibazar, this newspaper also spoke to many workers. They said it has been 100 years since Shamnarayan's father and many others marched for a better life, but no significant steps were taken to recognise "Tea Workers Day" or improve their conditions. By the time we finished talking to Shamnarayan, the

evening had already spread out against the sky. As we bade him farewell, he smiled at us. There was still hope in that smile -- hope of a better life and a better future -- not for him but for the thousands toiling away for years at the tea gardens.

A HISTORY OF SRTUGGLE

According to Bangladesh Tea Board, the first tea production

started in the subcontinent in Sylhet around 1849. Historians said the East India Company first started tea cultivation in Sylhet's Malinichhara tea garden on an experimental basis.

The British companies brought the workers from Bihar, Madras, Orissa, Andhra Pradesh, Madhya Pradesh, West Bengal, Uttar Pradesh and other places in India to work in

The misfortune of these indentured labourers started with their journey to the tea gardens. According to an account, in the early years, many tea plantation workers died during their long journey to the tea gardens and due to the tough work and living condition.

Upon arrival, their luck did not change much. They had to clear jungles, plant and tend to tea seedlings and saplings, plant shade trees, and build bungalows for tea planters, according to Philip Gain, researcher and director of Society for Environment and Human Development.

But they had their destiny tied to their huts in the "labour lines" that they built themselves. In protest of their continued persecution, the then tea

workers' leaders called for the "return to motherland" movement.

Marking the incident, Tea Workers Day will be observed today like every year with due solemnity.

buy time for the government to frame a false case against her. "The police could have immediately rushed to the spot if they had wanted to," he said.

Syeda Rizwana Hasan, executive director of Bangladesh Environmental Lawyers Association (BELA) said, "When at the secretariat clearly falls under the government officials assault us, do they forget that they are public servants?"

"The statements made by ministers suggest that there is potential for Rozina to get bail. Kajol, Kishore and Mushtaq were denied bail so many times, and Mushtaq ultimately died in prison. This shows that law does not take its own course. It takes the course directed by the government, who dictates who will get bail and who will not," said Professor Anu Muhammad of Jahangirnagar University.

"Rozina Islam's only 'crime' is that she is an investigative journalist and she has unearthed corruption. By arresting her, the government is sending a message that they are sheltering corrupt officials," said Dr Badiul Alam Majumdar, Secretary of SHUJAN at the webinar.

"What kind of information does the health ministry have that would jeopardise the safety of the state? Who gave the health ministry officials the power to detain her in the ministry?" questioned Faruq Faisal, regional director of ARTICLE 19 Bangladesh and South Asia.

"Journalists cannot ensure their safety until and unless they are united. Until the journalist unions stop pandering to different political parties, the government will continue doing this," added Faruq Faisal.

Journalism is under pressure from corporate owners, the government, the security forces and fundamentalists, said Robaet Ferdous, associate professor of journalism at Dhaka University.

Manusher Jonno Foundation (MJF), Bangladesh National Women Lawvers Association (BNWLA), Naripokkho, Ain

O Salish Kendra (ASK) and Bangladesh Legal Aid and Services Trust (BLAST) made similar demands at a virtual press conference yesterday.

The organisations said in their statement -- the way Rozina Islam was detained and harassed by both male and female officials 2009 High Court Guidelines of sexual harassments, which is a criminal offense. The organisations have been planning on lodging a charge against the officials.

"If she has to be tried even under the existing law, it has to be proved that she was a "spy" and intended to supply the papers to different states. If this could be proved, only then it would be a punishable offence,' said Shahana Huda, senior coordinator of Manusher Jonno Foundation.

"Although the undisclosed part of the China-Russia vaccine agreement is a secret document, journalists have the authority to know or photograph that information, she added.

University Teachers' Network issued a statement demanding immediate release of Rozina. They also demanded that the Official Secrets Act 1923 and Digital Security Act 2018 be immediately repealed. The statement was signed by a hundred university teachers.

social Sixty-seven activists Bangladesh Mahila Parishad also hosted a press conference demanding Rozina be immediately released. "We need to protect people working to uncover information that is beneficial to public interest," said their statement.

Management and Resource Development Initiative sent a statement decrying the harassment, prosecution and arrest of Rozina and demanded that the case against her be withdrawn immediately.

"In the age of free flow of information, the prosecution of a journalist under a colonial law like the Official Secrets Act is taking Bangladesh a step backwards," said the organisation.

Rajshahi suffers from 1.5hr power outage

Usage cause 'emergency shutdown' STAFF CORRESPONDENT, Rajshahi

Residents of Rajshahi city had to suffer a one-and-a-halfhour blackout due to an "emergency shutdown" by the Power Grid Company of Bangladesh (PGCB) yesterday morning. In some parts of the city, the power outage lasted

for more than two hours. The outage began from 8:30 in the morning as electricity suppliers Northern Electricity Supply Company Limited (NESCO) delayed resuming power after PGCB's maintenance works at the Katakhali Grid Maintenance

Department. Electricity consumers from all over Rajshahi city and Paba, Nawhata, Bagha and Charghat upazila called the authorities to complain over the issue, sources said.

Contacted, PGCB executive engineer ASM Mostafijur Rahman said the issue was caused due to an increase in power demands stemming from the ongoing heat wave sweeping over the region.

On Tuesday night, PGCB detected a "red hot issue" (overheating) on a 132KV power line at Katakhali Grid Maintenance Department, PGCB's Mostafijur Rahman said.

"An electronic device and wire had become red with high

temperature from the high flow electricity. It required an emergency maintenance to avoid any major problem," he

PGCB immediately informed the matter to NESCO who talked with administrative officials and decided that a twohour emergency shutdown was necessary.

However, PGCB completed the maintenance and resumed power supply on the national grid within one-anda-half-hours at 10am. But due to their plans, NESCO took until 10:30am to resume power across different areas.

"We resumed power as soon as the grid company started providing it. In some areas, we needed to finish some incomplete works before resuming power," Zakiul Islam, managing director of NESCO, said.

The maintenance took place in the day to avoid the emergency shutdown at night, to minimise people's sufferings, he said.

The official also said they had notified consumers about the shutdown on their website and social media profiles.

However, the shutdown caused immense suffering to the locals either way, especially due to the scorching heat, with temperatures reaching as high as 36 degrees Celsius.

The current daily power demand rose to 170MW in the district, though it never exceeds the limit of 110MW in winter, he said.

The gazette has been in effect since January 28 when Papul was sentenced to four years of rigorous imprisonment by a Kuwait court.

Sylhet-3 seat fell vacant following Awami League MP Mahmud Us Samad Chowdhury's death on March 11, Dhaka-14 following AL MP Aslamul Hoque's death on April 4, and Cumilla-5 for AL MP Abdul Matin Khasru's death on April 14.

According to the constitution, by-elections to fill the vacant seat of a member of parliament should be held within 90 days. Provided that in a case where, in the opinion of the CEC, it is not possible, for reasons of an act of God, to hold such election within 90 days period, such election shall be held within ninety days following next after the last day of such period.

Free Rozina

"The health minister said she stole a secret document of the government. How important was that file? It's a conspiracy to trap Rozina. I believe she is innocent," he said.

BSRF general secretary Shamim Ahamed called for ensuring congenial atmosphere for journalists in the secretariat to prevent any such conspiracy against journalists. Former president of a faction of BFUJ Shawkat Mahmud alleged that the government was against independent journalism and favoured corruptors.

The government was angry at Rozina as she revealed its corruption. To muzzle her voice, she was tortured and sent to jail without bail," he said.

Meanwhile at the DRU rally, Prothom Alo associate editor Anisul Hoque said journalists of the country have united and they want withdrawal of the case against Rozina as well as punishment of the harassers.

Jatiya Press Club general secretary Elias Khan said journalists are facing the wrath of the administration for publishing stories on corruption. "If the case against Rozina is not withdrawn, we'll go for

a tougher movement," he warned. Terming the health ministry's probe committee farcical, DRU president Morsalin Nomani said, "Officials who attacked Rozina will investigate the incident. We reject the committee.'

DRU general secretary Moshiur Rahman said, "We are

professional journalists. We don't want to hold protests on roads. We want immediate release of Rozina." Besides Dhaka, journalists from across the country held

protests, demanding immediate release of Rozina, report our local correspondents.

They formed human chains and held rallies in front of their respective press clubs in Savar, Munshiganj, Chapainawabganj, Sylhet and Benapole and vowed to continue protests until Rozina gets justice.

Air at two

The project initiated the research in collaboration with the Department of Urban and Regional Planning (URP), Buet and International Centre for Climate Change and Development (ICCCAD).

Buet Professor Afsana Haque and ICCCAD Coordinator Sarder Shafiqul Alam shared research findings in the event. Under this research, Center for Atmospheric Pollution Studies (CAPS), Stamford University Bangladesh tested the water and air of the research areas.

The air quality report of the CAPS team reveals that Particulate Matter (PM) 2.5 and PM10 are found four to five times higher above the permissible limit under Bangladesh standards in a 24-hour period. The water sample tested by CAPS was contaminated with

foreign particles exceeding standard limits in both study areas. They found E. Coli and 'uncountable colonies of total coliform' in the water. The Biological Oxygen Demand (BOD5) and chlorine concentration were found excessive. Residents of the two slums said water is often inaccessible,

scarce and polluted. Supply is often interrupted and women have to wait hours in queues to collect water. On average, the households pay Tk 400-500 per month for water services.

Speaking as chief guest, LGRD Minister Tazul Islam said, "Awareness is key at every stage of society. Community-led initiatives should be encouraged. Government, NGOs and the private sector must collaborate to address challenges related to waste management, water supply, water and air pollution."

Plan International Bangladesh Director (Programme Management and Implementation) Afroz Mahal said people migrating to Dhaka often end up in marginalised low-income areas with inadequate basic services and the problem will be exacerbated by impending climate change.

Buet VC Professor Satya Prasad Majumder Vice, PSTC Executive Director Dr Noor Mohammad and ICCCAD Director Prof Saleemul Huq were also present at the event.
