# MITU MURDER Handwriting experts called into service

They are to see if Babul wrote on 2 books presented by person he was "having an affair with"

PBI officials probing the Mitu murder case will send the two books, seized from her husband and ex-police official Babul Akter as "evidence of his extramarital affairs", to the CID for forensic examination.

Babul got the two books -- "Taliban" written by Ahmed Rashid and "Best Kept Secret" by Jeffery Archer -- as gifts from a woman in 2013, and he reportedly wrote about his extramarital affairs on different pages of the books, said sources in the Police Bureau of Investigation.

The books were seized from Babul, now in jail, after his father-in-law Md Mosharraf Hossain on May 12 filed the case with Panchlaish Police Station against him and eight others over Mahmuda Khanam Mitu's murder in 2016, they said.

In the case statement, Mitu's father mentioned that her daughter found the books on Babul's bookshelf and a brawl had taken place between the two when she asked about the writings in those.

Inspector Santosh Kumar Chakma, investigation officer of the case, said "We found in the books Babul's writings about several events in 2013

"We will send those to handwriting experts at CID's forensic lab to confirm whether it's Babul who wrote those ...," he told this newspaper yesterday.

The IO also mentioned that the books also contain writings of a woman with whom Babul, ex-superintendent of police, reportedly had an extramarital affair.

Meanwhile, a Chattogram court yesterday ordered the Chattogram jail authorities to take necessary steps to ensure Babul's treatment inside the prison as per the jail code.

Metropolitan Magistrate Mehnaz Rahman passed the order following a plea from Babul.

Arifur Rahaman, counsel for Babul, said, "Babul is ill. We appealed to the court to send him to hospital for treatment. After the hearing, the court directed the senior jail super to take steps to provide him with treatment as per the jail code."

On June 5, 2016, Mitu was stabbed and shot dead while she was taking her son to his school-bus stop at the port city's GEC intersection. After the murder, Babul filed a case against three unidentified men with Panchlaish Police Station.

On May 11 this year, the Chattogram PBI summoned Babul to its office for questioning over the murder. He failed to give satisfactory answers to the detectives and was taken into PBI custody.

The following day, Mitu's father filed a murder case against eight people, making Babul the prime accused in the case.

The seven-minute video shows ministry officials and on-duty police interrogating and manhandling the journalist. At one point during the interrogation, she said, "I made a mistake and I would be willing to give a written undertaking."

Youth 'beaten to death at rehab' A CORRESPONDENT, Jashore

A boy was beaten to death allegedly by staffers of a drug rehabilitation centre in Jashore.

The victim was identified as Mahfuzur Rahman, 20, from Chuadanga.

His father Moniruzzaman said Mahfuz had gotten addicted to some drugs, and so, on April 26, they admitted him to the rehabilitation centre -- "Madokasokti Niramoy O Punorbashon Kendra" -- in Jashore's Rail Road.

"On Saturday [May 22] evening, we got information that the rehabilitation centre's staffers have beaten my son to death and sent the body to Jashore General Hospital as an 'unidentified' body...We rushed to the hospital and found my son's body in the morgue."

Contacted, the hospital's emergency doctor Tanmoy Biswas said the body was brought from the rehabilitation centre. But those who brought it fled the hospital quickly without registering any of their names or addresses.

Sankar Biswas, sub-inspector of Jashore Kotwali Police Station, said injury marks were found on different parts of the body.

Tajul Islam, the police station's officer-in-charge, said police have scrutinised the rehabilitation centre's CCTV footage and found that Mahfuz was beaten to death.

Police have detained 14 staffers, including the centre's directors, for interrogation. However, the process of filing a case is still ongoing, the OC added.

Black fungus, scientifically known as Mucormycosis, is a rare but deadly infection. It is being increasingly reported in parts of India in patients who have had the coronavirus.

The condition causes discolouration of the eyes and nose, blurred vision, chest pain and breathing difficulties. In some cases, doctors have had to remove one or both eyes, or part of the jaw to stop the disease from spreading. People with diabetes, those who have

taken steroids and humidified oxygen for a long time, and Covid-19 patients with a pre-existing comorbidity are the nost at risk, experts said.

Different Indian states also ordered mergency measures to counter a surge in the rare infection among Covid-19 oatients.

As per data available thus far, Indian nedia reports that mortality rate from black fungus infections is as high as 80 percent if a patient goes untreated, or remains untreated long. If treated, it is still 40-50 percent. In cases where the infection is caught at the sinus stage,

patients mostly completely recover. No unusual black fungus infection has been reported in Bangladesh yet, officials said, adding that some precautionary measures should be taken nevertheless.

The Department of Microbiology and Immunology at the Bangabandhu Sheikh Mujib Medical University (BSMMU) has one of the country's top laboratories, testing numerous samples for different reasons. No case of black fungus has been letected there in the last three months. "The Birdem Hospital gets two or three cases of black fungus infection each month. It is normal. But we have to stay alert," Prof Ahmed Abu Saleh, chairman of the department, told The Daily Star. Black fungus exists naturally in the environment, he said. "I do not think it will cause too much of a problem for us. But it turns out to be dangerous for immunocompromised people. We have to ensure that there is a stock of necessary lrugs to treat it in case of an emergency. Abu Zamil Faisal, member of the public health advisory committee of the DGHS, said the indiscriminate use of steroids to treat Covid-19 patients is making the people vulnerable. "Physicians have not yet reported such cases. But as we have no strong surveillance system, we cannot dismiss the threat. We have to stay alert," he told The Daily Star yesterday. "Black Fungus is affecting Covid-19 patients more due to prolonged administration of steroids and certain other drugs. Patients should not use steroids outside of the hospitals. "We are discussing the issue. We hope here will be a guideline on black fungus soon. Both the experts stressed on maintaining proper hygiene at the hospitals to prevent black fungus infections. At yesterday's press conference, Dr Nazmul also said different health bodies of the government have been discussing the issue. "The National Technical Advisory Committee on Covid-19 has been preparing a set of recommendations while the Public Health Advisory Committee [at the DGHS] is also working to set a prevention protocol. A prevention and treatment protocol on black fungus infection will be out soon," he added. Cyclone Yaas

The health sector is a particular concern, as it was not able to absorb even a significant fraction of the earmarked resources, Sen added.

Planning Minister MA Mannan echoed the same as Sen.

"Simply allocating money is not enough.

Last year, the planning ministry had hastily approved two health-related projects with support from the World Bank and the Asian Development Bank. But the health ministry could not

complete the projects.

"You cannot consider a point with still picture," Mannan said, adding that damage control is the government's main strategy at present.

The government is trying to take steps coordinating between saving both lives and livelihoods, he added.

It has been alleged that poor people are not getting government assistance, said Moshiur Rahman, economic affairs

even express it," he said, adding that the government can centrally fix the allocation.

Similarly, ensuring the informal sector workers are getting the aid from the stimulus packages has proven to be a tricky affair, Rahman added.

Meerjady Sabrina Flora, additional director general at the DGHS, said, "If a working person, who could have contributed to the government's revenue earning, dies, livelihood would be affected permanently.

Underscoring the need for arresting the spread of the virus, she urged for coordinated efforts as the government cannot do it all alone.

Not only Bangladesh but many developed countries faced difficulty in providing health services after the arrival of coronavirus, nobody had experience in this regard and thus it would not be wise to blame Bangladesh alone.

Supreme Court lawyer Manzill Murshid, who has moved more than 400 public interest litigations, said instances of court orders on journalists to surrender their passports while being granted bail are not ordinarily found.

He added that the conditional bail is illegal.

Lawyer Mohammad Shishir Manir, head of Law Lab which conducts research on laws and the constitution, told this newspaper, "Our criminal jurisdiction does not allow conditional bail. Under Article 36 of the constitution, it is the fundamental right of a citizen of Bangladesh to have a passport and leave and return to the country. Journalist Rozina Islam will not be able to enjoy this fundamental right at this moment due to the imposition of the condition on her."

In December 2020, acting on a report of the UGC probe on corruption allegations against Sobhan and others, the education ministry had issued an embargo on all kinds of recruitment at RU.

The education ministry and probe committee members said the probe committee found that Sobhan violated rules and regulations of RU, as well as the constitutions article 29(1) that says that there shall be equality of opportunity for all citizens in respect of employment or office in the service of the Republic.

"This is a punishable offence, and steps should be taken against Sobhan." said the ministry official.

An education ministry official said, "The probe committee did not specify what kind of steps should be taken against Sobhan. For a smooth justice process, there should be a ban on the

A probe committee member said, "The probe committee found only nine persons curriculum vita although 137 appointments. This was

In October last year, a UGC probe committee submitted its report to the education ministry and the Prime Minister's Office after finding evidence of corruption and irregularities by the then RU VC and pro-VC in appointing teachers at the university.

In the probe report, the commission recommended taking action against VC Prof M Abdus Sobhan, pro-VC Prof Choudhury M Zakaria, and others of the university over the matter.

It also recommended scrapping the appointment of 34 teachers, who were recruited "relaxing university rules".

The report said the vice-chancellor, in collusion with others, also relaxed the rules to appoint his daughter and son-in-law as two of these 34 teachers at the public university.

In December, the ministry halted all kinds of appointments at RU, asking Sobhan to explain in seven working days why the appointments

of his daughter and son-in-law should not be cancelled.

The education ministry, in a separate order, asked the VC to take the necessary steps to remove Prof Abdul Bari from the post of the university registrar for not properly assisting a UGC committee to probe allegations of irregularities at RU.

In October last year, Sobhan held a press conference where he raised questions over the neutrality of the probe body and termed it "one-sided and biased".

Sobhan said all the allegations against him were "silly, false and fabricated".

He alleged that a section of people was trying to replace him and tarnish the image of the university and the government.

"In December, Bari resigned from his post. But since then, no visible punishment against the VC and the others has been seen," said a member of the UGC.

Against this backdrop, on May 6, Abdus Sobhan appointed 137 teachers and staffers on his last day in office.

Two days after, RU authorities suspended the joining of 137 teachers, officers, and employees, who were recruited by the outgoing VC, as the ministry formed a probe committee are investigating the recruitment process
