

REVISION OF RAILWAY PROJECTS Minister, high-ups blame it on pandemic

Shrugging off their responsibilities, the railway authorities have blamed the Covid-19 situation for wholesale revision of the railway projects that are being implemented to improve services.

"There are valid reasons for the delays. But since I took charge of the ministry, I have been making field visits and trying to complete all the projects timely," Railways Minister Nurul Islam Sujon said at a programme yesterday.

"We left no stone unturned and hope to complete the projects timely," he said in reply to a query.

Salim Reza, secretary at the railways ministry, and Dharendra Nath Mazumder, director general of Bangladesh Railway, echoed his views.

Almost half of the 39 ongoing projects of the BR will have to be revised as their deadlines will expire by the end of the current fiscal year, thanks to poor implementation.

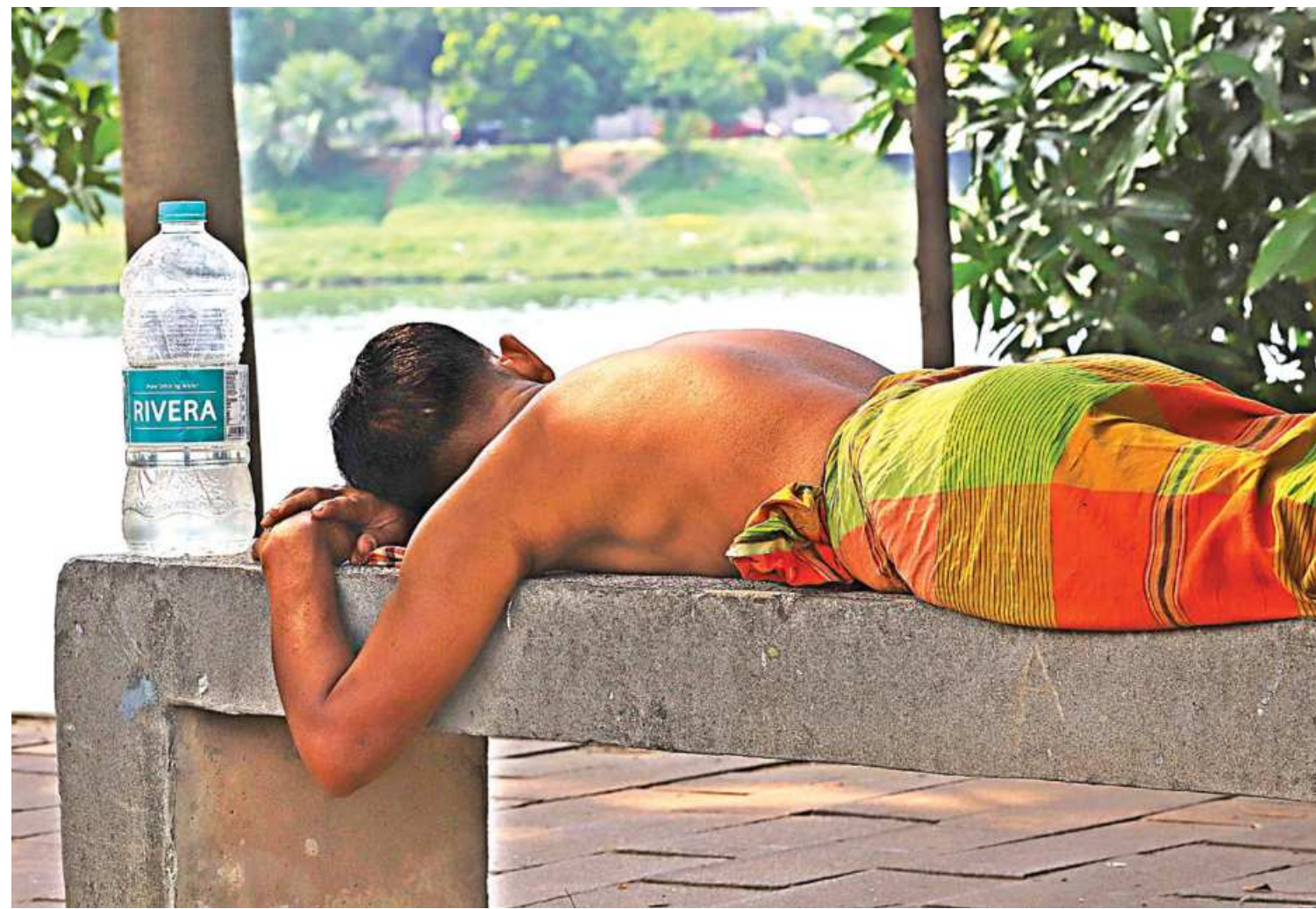
This will push up costs of many of the projects, aimed at improving services of the struggling railway.

The minister and the high officials were talking to the media after the signing of contracts on a project taken up for constructing a 23.90-km broad-gauge rail line, including a loop line, from Faridpur's Madhukhali to Magura.

The Tk 1,202.49-crore project was supposed to be implemented between May 2018 and April next year. But it ran into a snag and the physical work is going to start around three years after its approval.

Yesterday, the BR signed 18-month contracts with two

SHAHINUDDIN MURDER Another suspect killed in 'gunfight'

Another accused in Shahinuddin murder case was killed in a "gunfight" with detectives in the capital's Pallabi area early yesterday.

The deceased, Monir, 21, took part in the killing of Shahinuddin on May 16 in front of his son in Pallabi, police said.

The man was injured in the "gunfight" around 2:30am inside Sagufta Housing area. On information, a police team took him to Shaheed Suhrawardy Medical College Hospital where doctors declared him dead, said Aklima Akter, a sub-inspector of Pallabi Police Station.

A text sent by Dhaka Metropolitan Police's media wing said a team of detectives arrested Monir near Pallabi Eidgah Maidan around 9:00pm on Saturday.

Monir was killed during exchange of bullets between

Missing DU student found dead on campus

The body of a Dhaka University student, who had been missing for around a week, was found at the Shaheed Minar on Saturday and was later identified at the Dhaka Medical College Hospital morgue yesterday evening.



The dead, Hafizur Rahman, was a student of 2015-16 sessions of information science and library management department.

His elder brother Habibur Rahman identified the body.

Hafizur was also the general secretary of Mime Action, a cultural organisation of the university.

According to family sources, Hafizur returned to Dhaka from Brahmanbaria on May 15, a day after the Eid, and informed his family that he reached safely.

YAHYA'S LETTER TO NIXON

In a letter dated May 24, 1971, Pakistan President Yahya Khan expressed his gratitude towards American President Richard Nixon and said, "It is gratifying to learn that you share our view that it is to no one's advantage to permit the situation in East Pakistan to be internationalised and that any foreign intervention in this situation could create new problems and compound the difficulty of securing an ultimate settlement."

Yahya reaffirmed his resolve to transfer power to a civilian government at the earliest possible time. He said, "For this purpose, I have initiated, once again, consultations with political leaders and elected representatives of the people."

Yahya accused India of arranging a hijacking incident and said, "[Through this] India sought justification for its decision to ban overflights of our aircraft. Thus, a situation was created which not only imposed a heavy financial burden on Pakistan but also made the task of a political settlement between the two wings of our country more difficult."

Pfizer, Astra jabs highly effective

Says UK study; Delhi to ease restrictions as cases drop

The Pfizer-BioNTech and Oxford-AstraZeneca vaccines have been found to be highly effective against the coronavirus variant that was first identified in India, according to a study by Public Health England (PHE).

The Pfizer vaccine was 88-percent effective and the AstraZeneca jab was 60-percent effective against the B1617.2 strain after the second dose.

Both the vaccines were more effective against the so-called "Kent" strain - B.1.1.7, the Covid-19 variant

dominant in Britain - with Pfizer being 93-percent effective while the AstraZeneca jab was 66-percent effective over the same period.

However, they were only 33-percent effective three weeks after the first dose.

Health Secretary Matt Hancock described the outcome as "groundbreaking," while PHE said it expects to see even higher levels of effectiveness against hospital admission and death.

"This new evidence is groundbreaking and proves just how valuable our Covid-19 vaccination

programme is in protecting the people we love," Hancock told broadcasters.

"I'm increasingly confident that we're on track for the roadmap, because this data shows that the vaccine, after two doses, works just as effectively (against the Indian variant)," he added.

Earlier this month, the World Health Organization (WHO) dubbed the India's B1617.2 strain a "variant of global concern."

The study, which took place between April 5 and May 16, found that both the vaccines were 33-percent
