Under these circumstances, the two organisations said it has become impossible for many expatriate workers to gather the money and go abroad despite completing all other procedures including having visas and

They said several hundred crore take are remaining idle in the wage earners welfare fund. They demanded that the government in coordination with the respective embassy adjust the expenses of hotel cost through the welfare fund.

Several thousand Saudi-bound Bangladeshi migrant workers are facing untold sufferings due to new travel advisory of Saudi Arabia that requires medical insurance that covers the risk of Covid-19 infections and hotel reservations for institutional quarantine.

Talking to The Daily Star in the last two day at the Saudia office at city's Karwan Bazar, Saudi-bound expatriate worker said they need to spend Tk around 65,000 to Tk 70,000 to comply with the new conditions.

Following the fresh travel advisory that came into effect on May 20, Biman Bangladesh Airlines was forced to suspend all its 18 weekly fights to Saudi Arabia for nine days since May 20 saying they need time to make arrangements to comply with the fresh travel advisory.

Sources said Saudi authorities issued the travel advisory on May 10 which came into effect on May 20, meaning Biman got at least 11 days to make arrangements to comply with the

For instance, they said, Saudi Arabian Airlines didn't suspend even single flight following issuance of the new advisory. On the other hand, the national flag carrier of Bangladesh suspended its all flights for nine days.

Several thousand expatriate workers vho failed to travel to Saudi Arabia due to suspension of Biman flights said they are in fear that their visas would expire if they fail to return to their workplaces in Saudi Arabia on time.

According to the advisory, all travelers arriving in the KSA shall be undergone seven days institutional quarantine (except those who are exempted mentioned above) at own expenses and shall complete a PCR test on day 1 and on day-7. Children under the age of eight are exempted from the

The reservation of the institutional quarantine shall be through the espective airlines.

It says airlines shall contracted medical care centers to perform the two PCR tests all travelers at institutional quarantine facilities and facilitate the transportation of all travelers.

A top official of Biman said they have informed its offices concerned about the conditions imposed by the Saudi government. "Our officers there are trying to manage hotels.

"We are trying to figure out how cheap we can get these hotels. It takes some time to do these," he said.

Saudi Arabia is the largest manpower export market for Bangladesh. At least 26 lakh expatriates are working in different sectors in the country.

# Nazrul's 122nd birthday

Abdul Hamid and Prime Minister Sheikh Hasina in separate messages yesterday paid rich tributes to the memory of the poet on the occasion of his birth anniversary.

They prayed for eternal peace of the departed soul of the national poet and wished overall success of all programmes taken up on the occasion.

Nazrul was born on the 11th Joishtha in Bengali calendar year 1306 in Churulia near Asansol of West Bengal's Burdwan district.

He was the poet of rebellion against injustice and taboos. He is famous for his poem Bidrohi (The Rebel) and his many melodious songs.

He was a poet, lyricist, musician, revolutionary and philosopher. There are 2,400 of his songs, and together, they are known as Nazrul Sangit.

Although known for his rabid criticism of imperialism, social and religious taboos, Nazrul explored the of Dhaka University.

themes of love, romance and devotion

He introduced a robust style that was very bold and innovative. His use of Persian and Arabic words in Bengali poetry also opened up new literary horizons.

In the 1930s, the leading gramophone company of India, HMV, employed him as a lyricist. Later, All-India Broadcasting Authority employed him.

He also wrote and directed a play, Byathar Dan (The gift of pain).

But his luck ran out once again and in 1942, he developed a rare neurological disorder that led to the loss of his voice and memory. Doctors in Vienna diagnosed it as Pick's

After Bangladesh's independence, Nazrul was declared the national poet and he was brought to Dhaka from

measures" ordering Myanmar to prevent and halt genocidal acts against the Rohingyas. Myanmar is required to report periodically to the court on its compliance with these measures, with a report due by May 23, 2021. The military coup in Myanmar on February 1 added much uncertainty around the case.

Against this backdrop, it is unclear if the military dictatorship intends to engage with the ICJ, or if it will submit a report. Myanmar's agent in the ICJ case, former State

Counsellor Aung San Suu Kyi, has also been placed under house arrest by the Tatmadaw. BROUK has called on the international community to redouble efforts to hold the Myanmar military to account for atrocity crimes. "The National Unity Government should throw its full weight behind international

justice efforts, and submit its own report to the ICJ spelling out how it will end persecution against the Rohingyas.' "The military coup in Myanmar has again shown the Tatmadaw's brutality and callousness to the world. At the same time, the genocide against the Rohingyas continues

at pace, putting the very existence of our people at risk," said Tun Khin. "Authorities in Myanmar have taken no meaningful steps to amend the laws and policies underpinning the genocide. Severe internet restrictions in effect off-and-on in Rakhine State since June 2019, have continued since the coup, affecting all aspects of Rohingyas' lives.

"The Rohingya continue to live a hellish existence in Rakhine State. The restrictions on all aspects of our lives are clearly designed to make our lives so unbearable that we have no option but to flee, said Tun Khin.

"It is unconscionable that nine young children have recently lost their lives because of the conditions they were living in and the denial of proper medical care." Ending the Rohingya genocide and building a democratic Myanmar are closely linked

"I have pleaded with all countries to recognise this threat to peace on the subcontinent," she declared. "If the world does not take heed we shall be constrained to take all means as may be necessary to ensure our own security and for the preservation of the structure of social and economic life. I say this with full sense of responsibility," said Indira Gandhi.

Indian Defence Minister Jagjivan Ram said Pakistani troops had crossed the Indian border seven times since the trouble began in East Pakistan on March 25. There had been 43 incidents of firing across the border and 11 violations of air space. Instructions had been given that intruding aircraft were to be shot down if they disobeyed orders to return to Pakistan territory, he added.

NOBODY SEEKS WAR: YAHYA Pakistan President Yahya Khan said "nobody wants war" since it would solve nothing. Yahya said he believed Indira Gandhi did not want a war despite her recent statements.

Yahya told journalists that he would announce a plan within a few weeks to turn over governmental power in Pakistan to representatives elected last December. He also offered

amnesty to members of Awami League who did not commit crimes in the initial fighting last March in East Pakistan. He said US President Richard Nixon had offered Pakistan aid in what Yahya called a
