

Waterlogging Problem

Rain ruins port city residents' day

Most low-lying areas in Chattogram city went under knee-to-waist-deep water yesterday due to incessant rain, causing immense sufferings to city dwellers.

In the 24 hours before noon yesterday, the Chattogram Met Office recorded 74.4mm of rainfall, said Met officer Jahirul Islam.

During a visit to different areas, this correspondent saw roads, lanes, and by-lanes in Katalganj, Shulakbahar, Prabartak intersection, Bahaddarhat, Muradpur, Sholashahar Gate No. 2, Kapasgola, West Bakalia DC Road, KB Aman Ali Road, Rahamatganj, Agrabad, Halishahar, Chandgaon, and Saraipara under knee-to-waist deep

What's worse, the water even entered tin-roofed houses and breached the ground floor of buildings located in

Drains across the city became an additional source of pain, as pedestrians were forced to traverse the filthy water overflowing from the drains, some of which also entered

and attendants at Agrabad's Ma o Shishu Hospital fell into suffering as water entered the ground floor of its premises.

Rezaul Karim, treasurer of the hospital, said whenever it rains, front and makes its way into the

At West Bakalia's DC Road, this correspondent caught Ratan Saha wading through knee-deep water to enter his house.

"I cannot explain to you how miserable we are during monsoon. Even a moderate amount of rain means we're going to get flooded and our valuables are going to get damaged. We have been facing this woe for 10 years," he said. "I cannot even move to another place due to financial insolvency.

In the aftermath of heavy rainfall, people living in low-lying areas have to bear the brunt of waterlogging, which has become a regular cause of misery for them every year during monsoon for over a tersedecade.

However, many point their fingers at the authorities concerned, especially Chattogram Development Authority (CDA).

Four years ago, CDA initiated a mega project to address the waterlogging woes of the city, but city lwellers are yet to see any effects.

"I don't understand what is taking CDA so long to complete the project, said Aminul Islam, a banker residing in Saraipara.

West Bakalia's Phooltola resident Dhiman Ghosh said, "It's been more

waterlogging occurs on the road in than three years. They really should complete the project soon to relieve us of the waterlogging.

The project includes clearing the city's canals, building roads on their banks, as well as bridges, culverts, silt

traps and more. As per the project profile, a total of 9.50 lakh cubic metres of mud will be extracted from 36 canals, while 85.68 km of roads will be built on the bank

of the more important ones. In addition, 48 PC guarder bridges, six culverts, five tidal regulators, 42 silt traps, 200 cross-drain culverts, and 10.77 km of new drains will be built, while another 15.5 km of side drains

will be expanded. CDA initiated the Tk 5,616 crore project in July 2017, with the initial deadline set for June 2020.

But in June 2021, CDA officials said only around 50 percent of the works have been completed.

According to sources, the government has increased the tenure for two more years.

While the delay in the project's completion is one issue, in many areas residents also complained that the project works made waterlogging worsen in their areas.

The complaints have been levied by residents of Agrabad, Chandgaon, Prabartak intersection, and more.

Have dredging projects followed due procedure?

Former river commission chairman questions

Concerned ministry and relevant authorities should look into whether projects taken for the country's river dredging have followed due procedure, former chairman of National River Conservation Commission Muzibur Rahman Howlader said yesterday.

It should be looked at whether those who are undertaking the projects have done their pre-work conducting hydro-morphological and geophysical studies, he told a webinar.

"There has to be consistency between [river's] width and depth...at a proportional

was observed globally on Saturday.

Addressing as a guest speaker, Muzibur said if a river's width is narrowed by earth fill and depth is deepened by excessive dredging, then it might trigger erosion. The condition of rivers in Bangladesh

turns horrible in the dry season, said the former chief of the national river conservation commission.

The horrible condition of the river Teesta affects many other rivers, he said, adding, "We need to overcome such situation."

Muzibur said Bangladesh lacks proper design for silt and sedimentation management of rivers. Having such design and planning is a necessity, he added.

For sedimentation management one needs to know its engineering, while necessary manpower and professionalism are the other prerequisites in this regard, he He stressed for ensuring accountability

and transparency in river management, saying good deeds done for rivers will ultimately uphold the government's image. Muzibur said the Supreme Court

Found unconscious in room, female DU student dies in DMCH

A Dhaka University student died yesterday after fire officials found her unconscious in a sublet room at government staff quarters in Palashi area and rushed her to a hospital The deceased is Ishrat Jahan Tushti (20), a second year

student of English department of the university. As the university dorms remained closed, Ishrat along

with three others lived in the sublet room of the building. Saiful Islam, station officer of Palashi Fire Station, said they were informed about the incident through a call at

"We broke open a bathroom door which was locked from inside and recovered the girl in an unconscious state around 7:15am. She was rushed to Dhaka Medical College Hospital where doctors declared her dead," he said.

Her roommates said they called 999 as she was not responding despite repeated knocking on the door, he said. Sumaiya Parveen, a roommate of the deceased, said hailing from Netrakona district, Ishrat was attached to Bangamata Sheikh Fazilatunnesa Mujib Hall.

Ishrat had cold related problems. She was feeling unwell since she along with others got drenched in the rain on Saturday, Sumaiya said.

Proctorial team of DU visited the spot after the incident. The body was kept at the hospital for autopsy.

Right now, health authorities in Rajshahi are struggling to manage the increasing number of patients with limited ventilators and high-flow oxygen beds, and simultaneously, are trying to deal with rising Covid-19-positive test results.

Amid this situation, some people have alleged that they could not know their test results at the proper time, while others said results do not reach people who give samples, leading to further spread of the deadly virus.

In 24 hours till Friday morning, at least 16 people died at the Covid-19 unit of RMCH. Of them, 10 were Covid-19 positive, while the six others were suspected to be infected.

Friday's death toll at RMCH was the ghest in a day since the outbreak. the dead, nine were from Chapainawabganj, six from Rajshahi and one from Naogaon.

From May 24 to June 4, a total of 93 people died at RMCH's Covid-19 unit. Of them, 58 were Covid-19 positive, while the rest were suspected to have Covid-19.

Meanwhile, six more died at the coronavirus unit of RMCH in 24 hours till 8am yesterday. Two of them, who were from Chapainawabganj, were Covid-19 positive. Earlier in the day, health authorities in

Rajshahi started random rapid antigen tests at five points in the city -- Shaheb Bazar Zero Point, Haragram Bazar, C&B intersection, Laxmipur intersection, and Talaimari. A total of 297 samples were collected from these points and of these, 27 tested positive for Covid-19. The infection rate is nine percent at the moment.

RMCH Director Brig Gen Shamim Yazdani said he predicted the spread of coronavirus two weeks back and requested health authorities to impose "complete lockdown" in four districts of Rajshahi

Six-point Day today | 'Every record has

The historic Six-point Day, marking the demand for autonomy for the then East Pakistan, is being observed today virtually across the country amid the Covid-19 outbreak.

On June 7 in 1966, Father of the Nation Bangabandhu Sheikh Mujibur Rahman had launched a massive movement against the misrule of the Pakistanis on the basis of the 6-point demand. Eleven people, including Manu Mian, Shafique and

Shamsul Haque, were gunned down by the police and paramilitary EPR on that day in Dhaka and Narayanganj during a hartal called for the release of Bangabandhu and other leaders detained over launching the six-point movement against the then barbaric ruling clique.

Bangabandhu had launched his historic six-point political and economic programme in Lahore on February 5 in 1966, aiming at attaining greater autonomy for the East Pakistan, now Bangladesh, in the backdrop of exploitation and discrimination by the then Pakistani rulers.

The six-point demands were: creating provision in the constitution for a Federation of Pakistan in its true sense based on the Lahore resolution; the federal government will deal with only two subjects: defence and foreign affairs; introduction of two separate, but freely convertible currencies for East and West Pakistan; vesting the power of taxation and revenue collection with the federating units; maintaining two separate accounts for the foreign exchange earnings of the two wings; and creation of a separate militia or paramilitary force for East Pakistan.

In regards to sending any file abroad, which is over 75 years old and has historical, cultural, and literature value, permission from the director-general will be required.

Freezing Awal's Bank Account HC questions legality

The High Court yesterday questioned a lower court order that asked the Anti-Corruption Commission (ACC) to freeze bank accounts and seize property documents of former Awami League lawmaker AKMA Awal and his wife Laila Parvin in connection with two corruption cases.

The HC issued two rules asking ACC to show causes in four weeks why the order should not be declared illegal. The bench of Justice M Enayetur Rahim and Justice

Sardar Md Rashed Jahangir issued the rules after hearing two petitions filed by Awal and Laila, seeking its directives to scrap the lower court order. In the petitions, they also requested the HC to order ACC to release their bank accounts and property-related
