# Pabna village haats now under surveillance

Traders of Bonogram and Dublia haats install cameras with the help of Ataikula police

Traders of Bonogram haat in Santhia upazila, one of the biggest village markets of Pabna district, were often harassed by extortionists and thieves but now they are feeling pretty much secure as the entire market has come under Close Circuit Camera (CC camera) surveillance, thanks to the Bazar association and district police administration.

Earlier, Dublia haat in Pabna Sadar upazila was brought under CC camera surveillances a week ago. In the same way, all haats in the district are likely to be brought under CC camera surveillances soon for ensuring safety in rural areas, district police administration sources said.

"Bonogram haat is one of the leading rural markets of Pabna. Over four hundred traders have regular business and several thousand traders from different areas come on the weekly haat day with the weekly transaction of the market reaching upto Tk 100 crore," said, Ripon Munshi, president of Bonogram Bazar traders' association.

Due to the huge gathering in the haat day muggers often snatch money from traders and buyers in the busy market while frequent theft was a matter, so the Bazar committee with the help of the police administration has set up 22 CC cameras at important points of the haat, he

setting upCC cameras in the entire market while the footages are being screened by the police personnel at the Bonogram police camp," Ripon Munshi said adding they have plan to set 10 more cameras in the market.

"If any crime takes palce, the criminals would be identified easily due to the CC cameras so the traders and buyers of the market are feeling safe, said Md FarukHossain, a trader of the market.

Md Jalal Uddin, Officer-In-Charge of Ataikula Police Station, however, said not only

"Instructed by the superintendent of Pabna police, Ataikula Police has taken the first initiative to bring village markets (haats) under CC camera surveillances. Traders of Dublia haat the district," The SP added.

Ataikula police station has also been brought cameras while two other haats under my police station will also be brought under CC camera surveillances soon," OC Jalal added.

Md Muhibul Islam, superintendent of police in Pabna, said steps will be taken to bring all the rural markets (haats) under CC camera surveillances.

"Through the CC cameras police will easily monitor the busy rural markets of the district. It will help to improve law and order situation in

# 4 killed in 2 months in clashes over UP polls in Mehendiganj

At least four people have been killed in a series of clashes over the UP elections of Uttar and Dakkhin Ulania Union Parishad in Mehendiganj upazila of Barishal in the last two months.

More than 50 people have been injured and 20/25 houses vandalized in the clashes.

On May 20, Jamal Dhali's house in Saldi village of North Ulania union was attacked by Kalam Bepari's supporters while a wedding ceremony was in progress. Jamal Dhali's cousins-- Abdus Sattar Dhali and Siddikur Rahman--were killed and 15/20 people were injured in this incident.

Locals said in the last Dhulkhola UP election, Awami League nominated candidate Jamal Dhali and rebel candidate Kalam Bepari contested and both of them lost to the BNP candidate. Since then, there have been sporadic clashes between supporters of both candidates, leading to the attack at the wedding party.

On April 11, clashes broke out between supporters of Awami League candidate Milon Chowdhury and rebel candidate Ruma Begum at Sultani village in Dakshin Ulania union Parishad in the upazila. Saiful Sardar, a supporter of Ruma Begum, and Sayed Chowdhury, a cousin of Milon Chowdhury, were killed in the incident. The two lost their lives as a result of clashes over the union parishad election, locals

On December 4, 30/35 people, including police, were injured in a clash between the two chairman candidates and police in the Dakshin Ulania Union Parishad election in Mehendiganj upazila.

At least four people were also injured in clashes between supporters of a rival Union Parishad elections.

Though the election has been postponed in these two centers, the clashes have not stopped.

Kalam, officer-in-charge of Mehendiganj Police Station, said that the number of accused in the four murders in the upazila was more than hundred and police are trying to arrest all of accused.

Local people alleged that MP of this constancy Pankaj Nath has fueled a part of

Asked about the matter, he said, the situation has heated up after the secretary of the district Awami League, Talukder Md Younus, delivered a speech during the UP election here. The MP denied his involvement in any violence.

District Awami League Secretary Talukdar Md Younus denied the allegations, saying he was not involved in local politics.

Meanwhile, former upazila chairman Ad Mansur Ahmed has expressed concern over

"People want to live here peacefully, we have to make sure of that anyway," he said. Additional Superintendent of Police (Mehendiganj) Sukumar Roy said that political clashes were going on one after another. Although law enforcers are active, political action is necessary to resolve crisis. We have already informed the higher authorities.

Superintendent of Police (SP), Barishal Range, Md Maruf Hossain said that everything is being done to control law and situation by the police here. Two police camps have been set up in the two unions. Forty people have been arrested in the case. Police are in a tough position here.

regrowth. "We're aiming to install about 5,000 reef stars over the next five years," Hutasoit, 52, a former World Wildlife Fund employee, told Reuters. "And in the future, we also if possible want to expand outside Bali for the restoration of coral reefs."

The Indonesian archipelago harbours more than 75% of the world's coral species, many of which are facing erosion and bleaching every year, according to the Coral Triangle Initiative, a transnational coral restoration project. Only just over half

of Bali's coral reefs are considered to be in "good" condition with 30% in "poor" condition and the remaining 15% in "very poor" condition, according to a 2018 report by Bali's Marine and Fisheries Department. The damage has been

attributed to human activity, including destructive fishing, global warming, and heavy waves. Part of the Nusa Dua

Foundation's remit is holding community outreach programs, attempting to educate local residents about the importance of protecting Bali's coral reefs.

I Nyoman Sadnya, a local fisherman, said his parents had mined coral from the island's reefs for decades, unaware of the destructive long-term impact.

"My parents did not have a job and the area here used to be an arid area, and sometimes it was difficult to find food," he said. "So my parents resorted to coral mining for building materials, because they didn't know (it was bad)."

"We will consider voluntary actions to reduce the cost of these products for our people, particularly by encouraging each economy to review its own charges levied at the border on Covid-19 vaccines and related goods, one statement said.

The ministers also said they were committed to work to facilitate the movement of essential goods and minimize disruptions to networks critical to keeping supply chains operating smoothly, reports Reuters.
