# **NID SERVICES** Move to Home unconstitutional Eminent citizens say

The moving of services related to National Identity cards from the Election Commission to the home ministry was contrary to the constitution, eminent citizens said yesterday.

Taking part in a discussion organised by civil body platform Shushasoner Jonno Nagorik (Shujan), they said such a move might create a scope for misuse of citizens' personal information. And it might also give the opportunity to police to harass people and get involved in corruption.

Former election commissioner Brig Gen (retd) Sakhawat Hossain said if the NIDrelated services went to the home ministry, it would be "contrary to the constitution and curb the independency of the Election Commission".

He added that he did not know why the government is interested in moving NID services to the home ministry. But it could arouse controversy.

The decision of moving NID services to the home ministry without discussing with the commission was degrading for the commission," he added.

He also said if necessary, a statutory body could do the NID services after having infrastructures.

Eminent lawyer Shahdeen Malik said the moving process proves that the government does not care about democracy, good governance and the rule of law. The way the government made the orders seems that the government now considers the EC as its division or ministry.

"In the 2014 national election, over 150 MPs were elected unopposed and in the 2018 election, voting took place the night before the election day. It seems to me that moving of NID services is like another method for holding the next polls," he added.

## Raped, assaulted, locked up in foreign land

### Teen victim of human trafficking tells her story

Many cannot even imagine the brutalities an 18-year-old girl endured for more than two months.

Saima (not her real name) yesterday recounted to The Daily Star her horrid tale of going from making TikTok videos to becoming a prey of human trafficking and being physically, sexually assaulted and raped in a foreign land.

When she was not being abused, she was locked in a tiny dark room for days without food.

Saima is one of three Bangladeshi victims, aged between 18 and 25, who managed to flee from the clutches of the trafficking racket in India. She came back to Bangladesh 77 days after being trafficked to India.

PAKISTAN WITHDRAW 500-AND 100-RUPEE BILLS The Pakistani government removed from circulation today

The two largest denominations of Pakistani money, 500- and 100-rupee notes, worth respectively \$106 and \$21 at the legal rate of exchange, were recalled.

Also taken out of circulation were any other bank notes overprinted with the slogans of the Bangladesh movement.

President Agha Mohammad Yahya Khan said recently that \$100 million in rupees had been taken from banks in East Pakistan by militant Bangalee "separatists" in March and April.

Tonight, the government said this money, if it remained within the Pakistani economy, would be likely to have an inflationary effect. It asked that 500- and 100-rupee notes be turned in to
