# Patuakhali remote island finally gets power

About 23,000 consumers of Charkajal and Charbiswas in Rangabali upazila, an isolated island in Patuakhali, are elated to have finally gotten electricity in their homes, 50 years after Bangladesh gained independence.

From Char Fashion Upazila of Bhola, 22,006 consumers of 45 villages of the two unions were brought under electrification through submarine cable through the river.

SM Shahzada, lawmaker from Patuakhali-3 constituency, inaugurated the first line of electrification by lighting electric bulbs at the inaugural function held at the grounds of Charbishwas K Ali College field at 11:00am on Thursday while Chairman of Charbiswas Union Parishad Tofazzal Hossain Babul Munshi was in the chair.

Chairman of Galachipa Upazila Parishad Md Sahin, GM of Bhola Palli Bidyut Samiti

in charge of electrification in Charkajal and Charbiswas Unions Abul Basar, Galachipa Upazila Nirbahi Officer Ashish Kumar, Upazila Awami League President Santosh Kumar Dey and General Secretary Golam Mostafa, among others were present at the programme.

GM of Bhola Palli Bidyut Samity Abul Basar, who is in-charge of electrification in Charkajal and Charbiswas Unions, said the power line has been laid at a cost of Tk 165 crore through a submarine cable at the bottom of the river, which is the longest submarine cable line in the country.

A power substation has been set up in Charmujib area and transmission lines have been provided to Charkajal, Charbiswas, Charborhan of Dashmina upazila, Charhadi of Ward 9 of Charmini and Charmontaj of Rangabali upazila in Patuakhali district. There is a 792-km-long transmission line from Bhola via the submarine cable.

Asiya Begum, 65, of Chhotashiba village in Charkajal Union, said, "I used to see electric lights in the city and electric fans. I thought how happy the people of the city were amid bright lights and electric fans when the earthen lamp would light our house. Now, we will also live in luminous house after dusk.

Sabiha Shila, an SSC examinee from Charbishwas Janata Secondary School, said, "We used to study by lighting the earthen lamp. Solar lights were also in place for several years. But it could not meet our need. This time, electricity will revolutionise the ICT, education, agriculture and healthcare sectors in this neglected island area."

## Digging holes by highway Natore court issues suo moto rule

PP says contractor deliberately damaged highway

The Natore Senior Judicial Magistrate's Court of Abu Sayeed has ordered a suo moto action to launch an inquiry into the reports published on print and electronic media regarding a breach of contract in the digging of holes beside the Natore-Bogra highway (N-502).

Sirajul Islam, public Advocate prosecutor (PP) at the Natore Judge's Court, quoted the court as saying that after analysing two news items, it became clear to the court that the contractor was digging holes beside the highway, causing longterm damage to government roads. The offense is punishable under Section 431 of the Penal Code.

The court directed the special superintendent of police (SSP) of the Police Bureau of Investigation (PBI) in Natore to investigate into the case.

The court in its preliminary investigation identified the accused, took statements of witnesses, prepared draft map of the site, seized all the documents related to the project and obtained measurements of the total amount of soil (in cubic feet) removed from the side of the government road and an estimation of the extent of the damage

Lenny Apparels Ltd blocked the Nabinagar-Chandra highway in front of the EPZ around 7:30am and started demanding their arrears.

The protestors alleged that the two factories announced the closure of their businesses in January without paying dues to their workers. Amid repeated demonstrations, the authorities paid no heed to it.

According to police, they had to use tear gas and water cannon against the demonstrators as they caused over an 8kmlong tailback on both sides of the highway.

SP Asaduzzaman said they repeatedly tried to talk to the protestors and free the busy highway but the demonstrators did not listen to them.

At one stage, after around 45 minutes of road blockade, police fired tear gas and water cannon and brought the situation under control, he added

At least 10 readymade garment workers were injured during the police attack, said

Contacted, Kamruzzaman, officer-incharge of Ashulia Police Station, said the body was sent to Dhaka Medical College Hospital for autopsy.

Bigo Live is a live streaming platform and Likee is a short video-making and sharing app. Both the apps are owned by Singaporebased BIGO Technology, which was founded in 2014 by David Li and Jason Hu.

CID officials said that young Bangladeshis and expats are targeted by these agents. To gain more followers and subsequently, more cash, a lot of broadcasters get a little raunchy. The Bangladeshi agents recruit five to seven young girls to "go live and lure men" during live streaming.

To join the live streams, its users have to top up "Bigo Live Diamonds" from their Bangladesh based agents. These "diamonds" are digital currency that local agents buy from foreign admins through banks, MFS or hundi, they added.

"We may have to hold one more meeting to finalise it [fixing the service life of commercial vehicles]," he said.

In March 2019, a committee, led by transport sector leader Shajahan Khan, made 111 recommendations to curb road accidents and bring discipline in the sector.

Later, the government formed a taskforce headed by the home minister to implement the recommendations.

In its report, the committee, which included transport experts, called for fixing the economic service life of buses, trucks, covered vans and human haulers and stopping operation of over 20-year-old buses and over 25-year-old trucks.

Identifying the plying of old vehicles as a key reason for road accidents, it said on the one hand, such vehicles, specially outdated buses and trucks, go out of order on roads, leading to traffic congestion. And on the other hand, these cause accidents and loss of lives.

The report also pointed out that neighbouring India already fixed the service life of commercial vehicles.

Seeking anonymity, a BRTA official said the government in 2010 issued a circular banning over 20-year-old buses and over 25-year-old trucks in the capital.

Following the decision, most of such vehicles were removed from the city roads and put into service on district and interdistrict roads, the official pointed out.

Khondaker Enayet Ullah, secretary general of Bangladesh Road Transport Owners Association, claimed that no over 20-year-old bus runs in the capital.

"But I am not sure whether any truck [used for more than 25 years] operates or not [in the capital]," he told this newspaper

"A meeting has been called and I hope the service life of commercial vehicles will be fixed."

Replying to a query, he said, "I think there should be fixed service life for vehicles. There was no opposition from transport owners in setting service life of vehicles... This issue did not come to the fore in the past."

Prof Md Hadiuzzaman, director of Accident Research Institute at Bangladesh University of Engineering and Technology, said upon expiry of service life, chassis, brake system and axle of such vehicles weaken and pose risk of road accident.

Besides, such vehicles cause environmental pollution as those emit harmful gases, including carbon dioxide.

Referring to a recent study, he said emission of harmful gases from outdated vehicles is responsible for 15 percent air pollution in the capital.

He further said the authorities should not fix the economic service life of vehicles only on the basis of years of service because the service life of vehicles varies depending on their manufacturers. Mileage of a vehicle should also be considered.

He also opposed setting the service life of buses at 20 years as that of buses manufactured by renowned companies usually remains between 10 and 12 years given that those are operated on good roads.

A total of 46.49 lakh vehicles were registered with the BRTA across the country till February this year. Of those, 16.52 lakh were registered in the capital.

However, many unregistered vehicles are in operation all over the country, said people involved in the transport sector.
