INNOCENT IN JAIL FOR 5YRS

PBI IDs 7 cops responsible

Submits probe report to HC

Investigation (PBI) has found seven former officials of Pallabi Police Station responsible for wrongly arresting Md Arman, a technician from Mirpur's Benarasi Palli, in 2016.

to languish in jail for five long years, found the PBI investigation.

The seven police officials were extremely negligent in carrying out their duties while examining the name, address and other information regarding the case's accused. That is why innocent Arman was arrested and he had to suffer in jail for a long time, the PBI said in an inquiry report submitted to the High Court yesterday.

The seven are then officers-incharge (OCs) of the police station Md Dadan Fakir and Md Nazrul Islam; the then sub inspectors (SIs) Md Sirajul Islam Khan and Khan Imdadul Haque (now retired), the then duty officer Moniara Akhter; the then SI Md Russel and the then assistant sub inspector (ASI) Hajrat Ali, according to the PBI bench, led by Justice Md Mozibur Rahman Miah, complying with a

Police arrested Arman in a drug case in January 2016 instead of the original accused, one Shahabuddin Bihari. Following a writ petition, the HC on December 31 last year declared the arrest and detention of Arman illegal and contradictory to his fundamental and human rights.

Dhaka Central Jail.

The HC also directed the inspector general of police to give Tk 20 lakh in compensation to Arman in 30 days. Later, the Appellate Division stayed this part of the HC verdict.

HC ordered the IGP and the DMP commissioner to withdraw police officers, who were discharging duties under Pallabi Police Station during the incident, from their present workplaces and also ordered the PBI to conduct an inquiry into the incident and submit a report to it.

Mozibur Rahman Miah and Justice Mohi Uddin Shamim delivered the order following a petition filed by Law

The manpower crisis in RMCH is not as acute as in the Natore hospital, said officials there.

There are three hospitals in Bogura where Covid patients can turn to. Of them, the 100-bed Mohammad Ali District Hospital and the Shaheed Ziaur Rahman Medical College Hospital are better equipped in terms of manpower, but TMSS Medical College & Rafatullah Community Hospital lags behind.

Fifty-three out of the 56 Covid beds at the Kushtia Sadar Hospital were filled as of yesterday morning, meaning it was almost at full capacity. The district's positivity rate two days ago was 30 percent.

But this hospital only has 11 doctors and 22 nurses. Once again, duty roster divides this batch up into half, and they then are further spread out over three

"We are having some trouble because of the roster. We will get more doctors and nurses. We need five doctors on an emergency basis and 50 nurses. All 11 of the doctors here are medical officers," said Dr Taposh Sarkar, the resident medical officer of the hospital.

The hospital's administration said about a quarter of the personnel's posts in the hospital remain vacant.

A little over an hour away, Chuadanga district hospital's 150 Covid-19 beds are under the care of 18 doctors and 65

"When the 150-bed hospital was inaugurated, we were not given the healthcare staffers needed to operate this. We are maintaining a roster system for our existing staffers, and encouraging patients to recuperate at home," said Dr Maruf Hasan, civil surgeon general and superintendent of the hospital.

The daily positivity rate in the district was 50 percent on Sunday. It was 56 percent the day before, shows DHGS data In neighbouring Meherpur, the 250-

bed district hospital has an appalling 5 doctors for 52 Covid-19 beds. The district has an equally appalling positivity rate of 39 percent, making it a high-risk zone.

"I got two more doctors on a temporary basis, but I urgently need at least four more," said Dr Rafiqul Islam, the superintendent of the hospital. "We have to divide the doctors into two batches and send one group to quarantine for 15 days.'

Our correspondent reports that roster duty means there are just not enough doctors to tackle the crisis and that a newly built 150-bed hospital lies empty for that reason.

diseases specialist Infectious Ridwanur Rahman commented that there was a huge geographical disparity in the distribution of healthcare staffers.

"There is a geographical disparity regarding which districts have more manpower. There is no policy -- if a doctor gets sent to an outpost, he or she needs to lobby to get transferred, so doctors are unwilling to receive transfers to other districts," said Ridwanur.

"There was no planning when it healthcare sector. They are more focused on medical supply purchase rather than investing in the manpower, and now service provision has become difficult," he added.

Contacted, **DGHS** (hospitals) Farid Hossain, said, "We have collected lists of posts, which are vacant in hospitals. We are taking steps to recruit an adequate number of manpower. It is up to the higher authorities to decide how quickly those vacant posts will be filled.'

Urging the residents to stay home during the period, Deputy Commissioner Khaled Mohammad said, "Vehicles including buses, battery-run three-wheelers, motorbikes, cars and microbuses will not be allowed on roads during the lockdown. Shops, markets and malls will also remain closed.

"Vehicles used for providing emergency services, however, will be out of the restrictions."

Kitchen markets will stay open for a couple of hours every day, he said.

In 24 hours till 8:00am yesterday, five Covid patients died in Dinajpur where the virus positivity rate was 38.04 percent on Monday, reports our correspondent in the district.

district was 17.94 percent yesterday while the rate in the country was 14.80 percent. Unlike Dinajpur, the local

SITUATION IN KHULNA, **RAJSHAHI DIVISION**

The Covid situation has worsened further in Khulna and Rajshahi divisions as the positivity rate was above 30 percent in most of the districts in both the divisions, report our correspondents.

Yesterday, the positivity rate was 31.41 percent in Khulna, 47.31 percent in Satkhira, 31.48 percent in Kushtia, 36.27 percent in Meherpur and 66.07 percent in Chuadanga.

According to the Directorate General of Health Services (DGHS), 13 Covid patients died in Rajshahi division and seven in Khulna division.

Among the eight divisions, Chattogram saw the highest deaths --14 -- followed by Dhaka -- 13.

According to the Covid Dynamic Facility Dashboard of the DGHS, bed occupancy was almost 100 percent in the government hospitals in Natore, Rajshahi, Kushtia, Jashore, Satkhira and Chapainawabganj.

VACCINATION

Talking to journalists after an event in the capital, Health Minister Zahid Maleque said, "We will resume administering the first dose of Covid vaccines on June 19 with Sinopharm and Pfizer shots.'

Bangladesh has already received 11 lakh Sinopharm vaccine shots from China as gift and 106,000 doses of Pfizer vaccine under the COVAX facility, a global vaccine-sharing initiative. Those who have already registered

for vaccine will get the shots, said On April 26, the health directorate

nalted administering the first dose due to a shortage of vaccines.

More than a week later, the administering of the second dose was also suspended at all the centres across the country.

So far, 58,20,015 people out of 72,48,829 registered for Covid vaccination have received the first jab, according to the DGHS.


